## LISTEN TO LUKE

We got a copy of the Congressional Record in the mail last weekend that shed more light on the efforts of Dr. Ralph Chase of San Angelo to secure medical practitioners for towns in "remote areas" of the state that do not have such facilities.

Dr. Chase is chairman of the Committee of Community Health Service of the Tom Green Eight-County Medical Society. The purpose of the committee is to study the problems surrounding medical facilities and health needs with the goal of making comprehensive medical care available in isolated areas where little, if any, is now present.

He had contacted Sen John Tower and presented a plan to try to entice physicians, dentists, and optometrists to practice in these needed areas by offering a tax exemption to those professional men who would practice a minimum of two years in isolated areas, and the tax exemption would decrease after each year for five years. There are many provisions of the plan presented by Dr. Chase and the bill presented by Sen Tower, such as limiting the professional man to only one such tenure of exemptions, designations of remote areas, and other definitions and clarifications set out in the bill.

The Congressional Record sets down other statistics and data that are of interest and anyone interested may pick up the Record for perusal. Another document of interest and available for an interested reader, is the data sheet from the Bureau of Census setting down many facts and figures of agriculture involvement of Terrell County in 1969 and 1964.

We learn new words every once in a while -- really. One reason is we like to play "Password", and the other is we like to read. Words are funny -- or should we say peculiar? -- in that many times they are coined by people who don't like to use, or don't want to use a conventional or acceptable word for something.

"Drunk", for example, is an obnoxious word to some people, so they use "looped", "bombed", and scores of other words when "intoxicated", "inebriated", and "drunk" all express the condition very well. To the best of our understanding "drunk" is a condition that "someone else" reaches after so many drinks.

Then in "new math" there were many new words that came to the forefront: interger, cardinal numbers, ordinal numbers, etc.

And now, after the recent outbreak of the disease that hit poultry and fowl in California, we have the word "de-populate". This sounds much better to some people, for some reason, than "kill". It would be interesting to explore the thinking of those

## Rev. S. M. Mims, Former Pastor Here, Buried Tuesday

Services for Rev. Samuel McPherson Mims, 80, were held Tuesday afternoon in the First United Methodist Church at Fort Davis and burial was in that city.

Rev. Mims was the first pastor of the Sanderson-Dryden charge, serving from 1934 to 1937 and also preaching at Langtry on Sunday afternoons during that time. He was a member of the New Mexico Methodist Conference for 50 years, retiring in 1954. He was widely known as an outstanding Bible scholar and teacher. He taught Bible courses at Clarendon College, Sul Ross State University, and Lydia Patterson Institute in El Paso.






