LISTEN TO LUKE

Pecos County Judge "Buck" Luttrell was here last Thursday night to explain the operations of the Permian Basin Regional Planning Council to the Young People's Chamber of Commerce and interested citizens who attended the meeting. It was an interesting and enlightening discussion that Judge Luttrell gave, some details of which are given in other columns of The Times.

We feel almost compelled to say that many of the things that Judge Luttrell stated have been stated in this column many times.

There is no "cop-out" in writing a column this week, but another thing we feel compelled to print is the following column: "Pipe Lines" by Frank Baker, publisher of the Fort Stockton Pioneer. What Frank is saying in sum and substance is that Sanderson people have no business going to Fort Stockton to shop. The business people over there do not want the business from Sanderson as we have a moral obligation to not go to Fort Stockton to buy anything that we can buy in Sanderson. He doesn't put those exact words into his column, but he is talking about Stockton people going elsewhere to shop—and what's sauce for the goose, is soup for the goosier!

If they don't want your business, why give it to them? Maybe it's the way you read it!

But here it is, clipped, photographed, and duplicated for your information:

Are you a member of the Odessa Chamber of Commerce? If you're a citizen of Fort Stockton who trades in Odessa, you might as well be! We'll single out no individual or group — unless the wide cross-section of "shoppers out-of-town" could be considered a group.

It's one thing to go to Odessa or another neighboring city to obtain an item that positively isn't available in Fort Stockton — but quite another to go out of town just because you enjoy a trip — or because you're unwilling to give Fort Stockton merchants an opportunity to even bid for your business! And many of you do just that — you BEGIN your Christmas shopping in Odessa — without even entering a Fort Stockton shop first!

The businesses of Fort Stockton have made a sincere and energetic effort to build the stocks of their stores to new highs of selection and quality — and are making a strong effort through promotion to keep you advised of their progress.

If you say you owe nothing to individual merchants of the Blue Ribbon City — you may be partially correct. No one is "owed a living" as such. But you do owe a great deal to your community for being the kind of town it is, and because

Balmorhea 14 Sanderson 0; Wink Is Finale

The Balmorhea Bears blanketed the Sanderson Eagles in their meeting here Friday night of last week by a score of 13-0. The visitors' scores came in the second and fourth frames.

Local fans witnessed a good defensive effort on the part of the Eagles who were unable to put the needed punch into their offensive game to get on the scoreboard. The Bears gave up some depth of players to the Eagles, but made up for some of that difference in size and speed. The win by Balmorhea put them higher in the district standing than Sanderson with a 3-2 record, with the Eagles having a 2-2-1 record.

Robert Gomez threw a pass to Abel Baeza in the second quarter and the play was good for the first Bear score from the 19 yard line. Ruben Gomez added two points after the touchdown on a running play. The second Bear tally was a 22-yard sprint by Juan Jiminez in the final quarter and the try for extra points failed.

The Eagles will play their final game of the season Friday night in Wink.

Rankin clinched the district title Friday night in their defeat of Iraan. The Red Devils are unbeaten in conference play.

Coach Willie Myers turned in the following statistics for the game: Sanderson led 9-7 in first downs, and trailed 107-159 in total yards rushing. Sanderson's passing game netted 64 yards in five completions of 19 tries. There were completed passes which were called back due to an infraction, Coach Myers stated. Balmorhea gained 19 yards passing by completing 1 of 3 tries. They intercepted two Eagle tosses. Each team lost one fumble. Sanderson was penalized 7 times for 55 yards and Balmorhea was penalized 7 times for 45 yards.

Commissioners Have Visitors On Dam Progress Report

The Commissioners Court of Terrell County held their regular meeting Monday. Routine business matters were conducted and the court canvassed the vote of the general election.

There was some discussion of the flood control project by the commissioners and there were five local citizens in attendance for this discussion and they expressed only an interest in the project and its advancement. They were told that there had been no more easements secured since the last report, but that efforts were being made to accomplish more on the project.

Details of the apparent slowness of accomplishments in the securing of the easements are both complicated and reasonable, and the intricacies of the many of the remaining easements are being worked out with the landowners. It was pointed out that there is very little opposition to the signing of the easements by any of the landowners, but that there are certain details that must be worked out with each before they can be signed.

There is also a study of the zoning for controlled speed around the schools and action of this kind will probably be taken up at the next meeting.

About one-fourth of the voters who cast ballots used the absentee method of voting in the general election.

Baptist Minister To Move Here



it is a better and better place to live! If you want to live in a dead or dying town, like so many communities around us, just keep on shopping elsewhere!

Consider your "Shop In Fort Stockton" obligation in this economic light:

1. If you're a person whose wages are paid by local taxes you are using wages produced by tax from your fellow citizens to shop in another city.
 2. If you are employed by a local store, you are doing your own employer and his customers a grave disservice, since local dollars produce your wages.



Food Stamp Eating Can Raise Cash, Too!

The following story is from the Virginia Farm Bureau News as quoted by Rep. H. R. Gross (R-Iowa) in his newsletter, *On the Capitol Firing Line*:
 "It's your tax money. You're a taxpayer, so swallow this if you can."
 "A hippie who hangs around Berkeley, whose principal source of income seems to come from peddling copies

of an underground newspaper once a week, is eligible for food stamps.
 "He boasts that for 50c he buys \$28 worth of food stamps. (The food stamp department at Wells Fargo Bank confirms this price and adds that it's a common practice).
 "Each week the hippie uses the stamps to buy exactly \$27.51 worth of groceries and gets 49c back in cash as change — the maximum amount of change he can get on a purchase. Then he adds one penny to make the 50c to get his \$28 worth of stamps the next week.
 "The fourth week of the month he sells his food stamps to friends for \$15 cash. Thus in a month he's paid out 53c for \$112 worth of stamps for which he gets \$82.53 worth of food and \$14.47 net profit in cash.
 "A food store saleswoman says: 'Can you imagine how this adds up when there are 15 hippie kids living in a commune, and all doing the same thing? No wonder they laugh at the Establishment.'
 "And no wonder welfare programs are in trouble."


