We thought we had the best saying of the times recently in attributing the slow mail service to "a breakdown in the system".

We wonder every time there is a race for any office in the county, just what it is that prompts a person to seek that office -- and we are not talking about the new-candidates in any given race, we are talking about all candidates, even those who are seeking re-election.

We have never thought that it was wrong to let someone know why you particularly are desirous of a particular office. We never won many elections, either!

Maybe that's the reason! During the past several years we have contacted the candidates from time to time in a particular race and asked them to respond to our request or offer to publish a statement from them free of charge if they would spell out some details of the reasons they were seeking a particular office. We have had only one response to this offer out of all the times that it was made, and the person that responded got only a handful of votes!

Now you can say: "That is why he got so few votes, he told what he was running for." We would disagree on this basis: We never knew a contested race when there was not someone who lost, and in all the other cases someone lost

Wool Sale Here Is First of Year

The first wool sale this year in Texas was held Tuesday at the Sanderson Wool Commission Company, a division of the Wool Growers Central of San Angelo.

According to officials of the company, 213,944 pounds of 12-months wool sold at an average of \$1.51-2/3, with the low being \$1.12-1/4 and the high at \$1.68.

There were 28,737 pounds of 10-months sold at an average of \$1.38-2/3, with a low of \$1.16-1/4 and a high of \$1.57. In the eight-months wool, 23,742 pounds sold at an average of \$1.20 with the low being \$1.44 and the high \$1.28.

Total amount offered was 271,960 pounds with a total of 266,423 pounds sold.

Top buyer of the sale was Wellman, buying 125,335 pounds, with The Top Company the second high buyer of the sale, taking home 60,195 pounds of wool. Burlington purchased 33,361 pounds, and Provo 21,314 pounds. Stevens bought 16,488 pounds and Forte bought 8,730 pounds.




