LISTEN TO LUKE

The much-publicized race of the pony express vs. U.S. Postal Service between Alpine and Fort Stockton may prove that the horse is faster, but there is little chance that it will improve the mail service.

We could offer some kind of event that would be more outstanding -- maybe a human walking race between here and Fort Stockton against the regular mail!

We received a letter Wednesday of last week from Fort Stockton mailed on Sunday! The letter contained a news story they wanted last week about a kid's rodeo and we could not use it when we got it -- it was too late for us -- and printing the story this week is too late for them. Their registration deadline was Saturday, the day this is written.

Sorry about that!

In a conversation with Postmaster Ray Hodgkins last week, he revealed possibilities for improving the postal service into Sanderson which he hopes works out. It will possibly cut a day off the present schedule for Sanderson, Marathon, Alpine, Marfa, Van Horn, and maybe two days - depending. The plan was presented at the recent meeting of the postmasters of this area and had full support of all of them affected. We'll see!

Currently, almost every piece of the first class mail goes to El Paso before coming to here -- maybe even going through here to El Paso if it originates in the southern part of the state or the U.S. This is because El Paso is the center for all the mail with a 798 ZIP prefix and so it goes there first. This is probably the problem with the letter from Fort Stockton mentioned above, except that having been mailed on Sunday, it had to go first to Midland to be cancelled, then to El Paso, then to Sanderson. This type of routing is in the name of economy and increased efficiency and service, so they say. The "they" is the people in the U.S. Postal Service who set the policies for the postoffices to work with.

Every once in a while we are forced to read the dictionary, sometimes to find out for ourselves, and sometimes to prove to others a certain spelling or pronunciation or meaning, and sometimes we don't get to prove what we started out trying to prove. We learned this week that "pimiento" was not the only spelling -- "pimento" is also acceptable. There is little plot, and the characters are not so interesting until you get back into the biographical section, but there is a lot to be learned from all those words.

Words, their origin and usage, etc., are really very interesting. Word games are interesting, too, to us -- games like Password (have you found an old game that you don't want?), and the "Test Your Word Power" in Reader's Digest, Scrabble, and Perquacky,

2-Year Probation Given SHS Teams For UIL Violations

Terrell County School Superintendent C. B. Card told The Times Tuesday afternoon that he had received a telephone call from a representative of the University Interscholastic League of the outcome of an investigation of possible violation of UIL rules. The telephone conversation also relayed the information that a letter would follow to Supt. Card completely outlining the details of the decision.

Supt. Card stated that the group that heard the statements last week and read the allegations of the violations had ruled that Sanderson High School had been given probation for two years in the following boys' athletic events: football - 2 years probation; basketball - 1 year probation without district honors and 1 year probation; track - 2 years probation.

Supt. Card explained that the basketball team would not be permitted to be declared district champions and represent the district at the regional level if they actually won the district title in connection with the number of games played and won in comparison with other teams of the district.

The other probationary terms will carry no other punishment if there are no other UIL rules violations for the number of years indicated.

The penalties grew out of violations surrounding two of the athletes who competed in the three events named. The violations were, in simple and concise language, that two athletes whose parents did not live in Terrell County during the last school year, were living with local residents who who did not receive any money for room and board of the athletes.

Supt. Card specified that it was not dissatisfaction on the part of the local residents for not having received remuneration for the keeping of the

Jose Rivera, 75, Dies Monday In Fort Stockton

Jose Reyes Rivera, 75, died early Monday morning in a Fort Stockton hospital where he had been a medical patient only a few days. A victim of cancer, he had been in an Odessa and Fort Stockton hospitals several times in recent months.

Born in Mexico on October 4, 1895, he had been a ranch worker and a resident of Sanderson for 56 years after coming to the States in 1919. He was married to Tomasa Bustos here in 1925.

Mr. Rivera had been retired for the past four years on account of failing health.

Funeral services were in St. James Catholic Church Wednesday morning with Rev. Alvin Wilde of Fort Stockton officiating. Burial was in Santa Rita Cemetery with the Owens Funeral Home of Fort Stockton in charge of arrangements.

Besides his widow, survivors include two sons, Juan Rivera and Ruben Rivera of Fort Stockton; three daughters, Miss Rosa Rivera, Mrs. Manuel Maldonado, and Mrs. Francisco Flores, all of Sanderson; 16 grandchildren, and three great-grandchildren.

Change of Venue Sought in Case In District Court

A change of venue was sought in the felony case in the 63rd Judicial District Court in action here Monday.

The case is the charge of assault with the intent to commit murder with a deadly weapon against Denny D. Callahan and resulted from an incident in January at a local bar when Augustin Maldonado received a gunshot wound in the back.

Callahan was represented by Herbert C. Petry of Carrizo Springs who pleaded for the change of venue before District Judge George Thurmond. He presented Les Walton, O.T. Sudduth, and Barton Massey to support his plea.

District Attorney John F. Pettit of Del Rio presented James Clark, Don Allen, and Dudley Harrison as witnesses opposing the change of venue.

Judge Thurmond stated that the petition for the change of venue was denied and that the court would proceed in a routine manner when the case was called for trial.

Drilling News -

Seco Production Co., Midland, will drill an offset and an outpost to its No. 1 Allison opener and lone producer in the Allison (Pennsylvanian detrital) field of Terrell County, 6-1/2 miles south of Sheffield, according to information printed in the San Angelo Standard Times.

Both projects are contracted to 9,600 feet.

The No. 1 Annie C. Garner, 3/8-mile east, is 1,980 feet from the north and 660 feet from the west lines of 10-B2-CCSD6RGNG.

The No. 1-B Allison, 3/4-mile west, is 1,980 feet from the north and 660 feet from the east lines of 24-B2-CCSD6RGNG.

The discovery was finalized April 25 for a calculated, absolute open flow of 14 million cubic feet of gas per day, with gas-liquid ratio of 24,507-1, through perforations at 9,172-206 feet. Gravity of the liquid is 67.2 degrees.

He was given first aid at the ranch and taken to Iraan for hospitalization. He was taken home Saturday and is reported to be recovered from the bite.

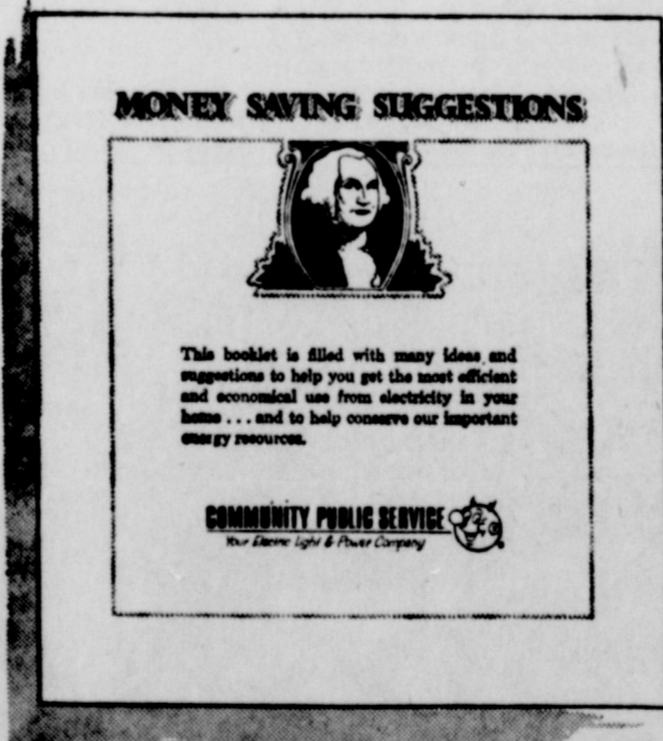
It was the second snakebite Kyle has suffered, having been bitten previously by a copperhead at Valentine while he was employed by the Southern Pacific Railroad.

Fourteen members attended the quarterly meeting of Friends of the Terrell County Public Library in the new library building Tuesday evening.

The report of Mrs. H.B. Louwien, librarian, showed 1,054 visitors during the past quarter, 279 adults and 775 children, with 1,108 books of fiction checked out, 330 non-fiction books, and 7 Spanish books.

Mrs. W.H. Savage, memorials chairman, reported nine books and \$135.50 in cash given to the library during the past quarter. In retrospect, she reported that since the organization of the library six years ago, \$985.50 in cash and 205 books had been given as memorials.

With a vice-president and treasurer to be elected this year, Mmes. N.M. Mitchell Jr., L.H. Gilbreath, and A.C. Garner were named to the committee on nominations.

After a cash donation of \$750.00 given by the Sid Harkins family, for the purchase of needed items for the new library, the group voted to purchase a vacuum cleaner, drapes for the front windows, and a desk and chair for the check-out area and Mrs. Irvin Robbins, president, named committees for each purchase.

The sale of the six metal bookcases in the old library was authorized also the purchase of three historical books at pre-publication prices.

A report was made of the open house at the July Fourth celebration when 167 visitors registered and then the formal opening on July 17 when 130 visitors registered. Mrs. Robbins expressed her appreciation for the work of all committees who contributed to the success of both affairs.

After the reading of the notice dated June 18, 1973, to amend the constitution and by laws, the recommendations of the committee were accepted, most amendments covering the six regular meetings each year instead of four.

Mention was made of the possibility of the use of the library for such community activities as art exhibits and will be considered by the "Friends".

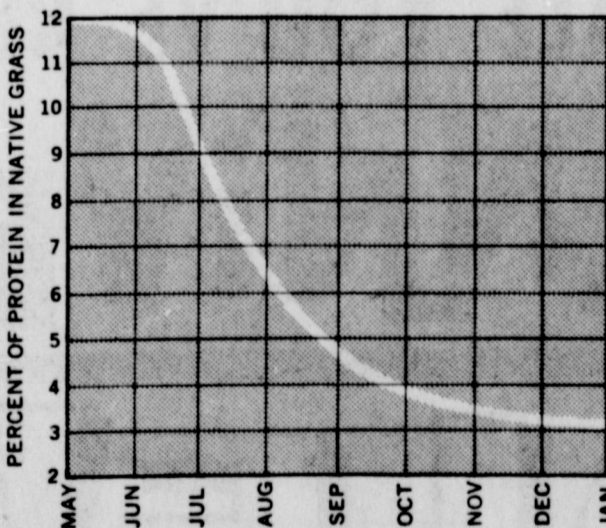

MOURNING DOVE - WHITE-WINGED DOVE Hunting Regulations 1973-74

OPEN SEASONS

MOURNING DOVES: North Zone—September 1 thru October 14, 1973, and January 5 thru January 20, 1974, except in the Trans-Pecos Regulatory District where the winter season is January 5 thru January 15, 1974.

MOURNING DOVES: South Zone—September 22 thru November 4, 1973, and January 5 thru January 20, 1974, except in those counties having a white-winged dove season where it is September 1 and 2, September 8 and 9 and September 22 thru October 31, 1973, and January 5 thru January 20, 1974.

WHITE-WINGED DOVES: Shaded Zone—September 1 and 2 and September 8 and 9, 1973.

DAILY BAG LIMITS

MOURNING DOVES
Daily Bag Limit-10. Possession Limit-20

WHITE-WINGED DOVES
Daily Bag Limit-10. Possession Limit-20

NOTE: Bag limits of both white-winged and mourning doves may be taken during the open white-winged season.

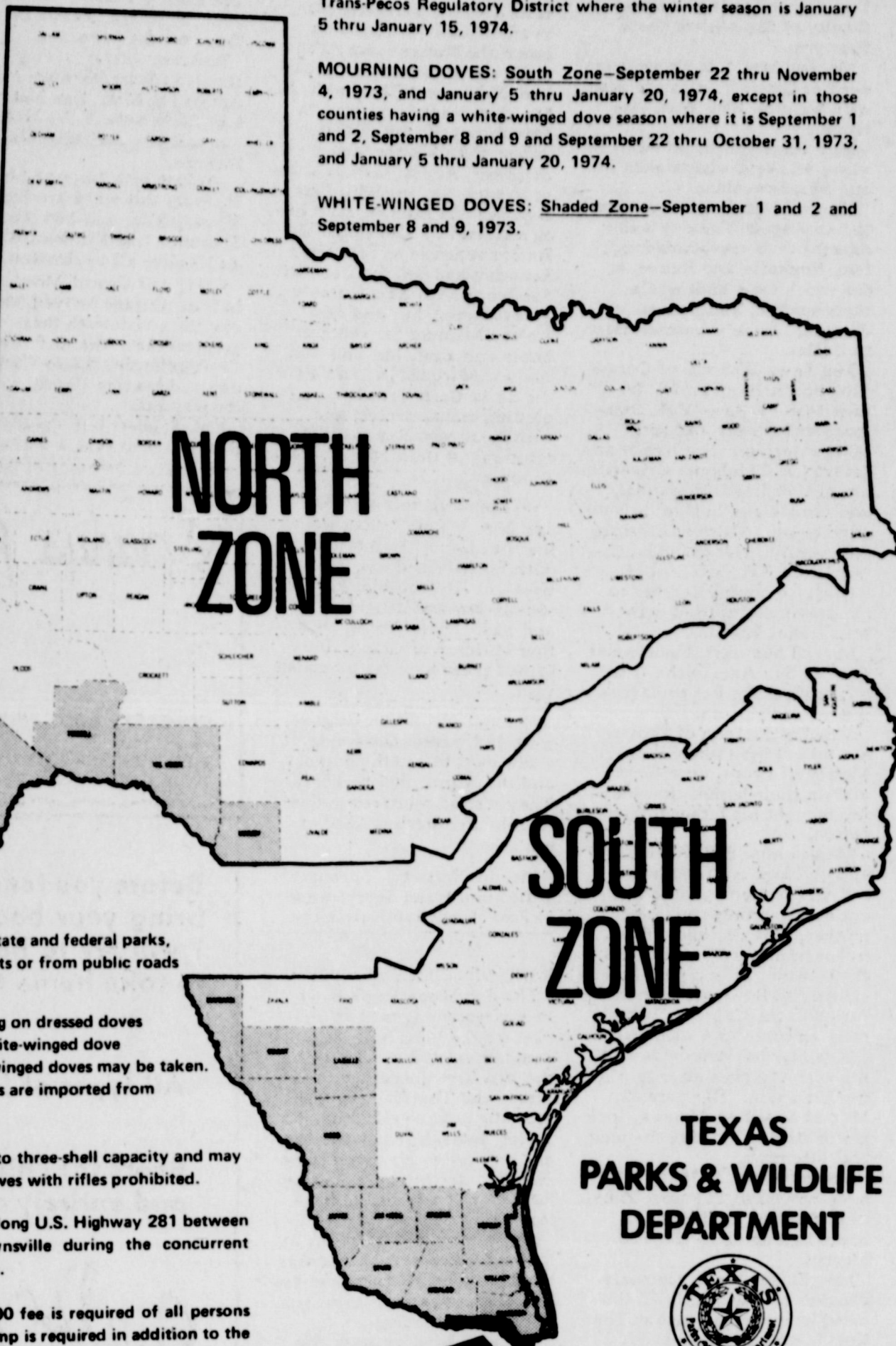
SHOOTING HOURS:
Mourning and White-winged Doves:
12 noon to sunset.

SPECIAL NOTES:

- No hunting permitted in game refuges, state and federal parks, game reserves, within corporate city limits or from public roads or road rights of way.
- The retention of one fully-feathered wing on dressed doves is required in those counties having a white-winged dove season when both mourning and white-winged doves may be taken. This requirement also applies when doves are imported from Mexico or any foreign country.
- Shotguns must be plugged permanently to three-shell capacity and may not be larger than ten gauge. Hunting doves with rifles prohibited.
- Area closed south of a line extending along U.S. Highway 281 between the city limits of Hidalgo and Brownsville during the concurrent white-winged and mourning dove season.
- A white-winged Dove Stamp for a \$3.00 fee is required of all persons who hunt white-winged doves. This stamp is required in addition to the valid hunting license.

OTHER REGULATIONS

- One fully feathered wing must remain attached to dressed migratory game birds while being transported between the place taken and the personal abode of the possessor or between the place taken and a commercial preservation facility. This regulation does not apply to mourning doves except in those counties having a white-winged dove season when both mourning and white-winged doves may be taken. One fully feathered wing must remain attached to all migratory game birds imported from Mexico.
- No person may possess any freshly killed migratory game birds during closed season.
- No person shall kill or wound any migratory game bird without making a reasonable effort to retrieve it.
- Every migratory game bird wounded by hunting and retrieved by the hunter shall be immediately killed and become a part of the bag limit.

LAWFUL MEANS AND METHODS

In the taking of migratory game birds, it is lawful to use:

- Shotguns no larger than ten gauge which are plugged permanently to a three-shell capacity and fired from the shoulder.
- Long bow and arrows.
- Falconry.
- Manual or mouth-operated birdcalls.
- Dogs and artificial decoys.
- Blinds or other forms of concealment (except a sink box or livestock).
- Floating craft (except a sink box) which is beached, anchored or tied within or alongside of a fixed blind. Rails only may be taken from floating craft when the only source of propulsion is paddle, oars or pole.
- Power boats, sail boats or other craft may be used only as a means of picking up dead or injured birds.
