Parents of young children who are walking to school for the first time should take the time and effort to carefully and thoroughly caution their children of the dangers of crossing and walking in the treets and the proper way to do so when necessity requires. Drivers of cars are warned of the dangers of carelessness of driving habits near the schools and the necessity of exercising extreme care when there are children around.

Those little minds and feet carry them out in front of a car before a driver knows it at times and it becomes absolutely necessary for the more mature person to exercise the more mature practices of driving to be sure that there are no injuries to the "little fry" Be careful, and try to help others to be careful also.

There are nine proposed changes in the Texas Constitution to be voted on November 6, the date of the general

The proposals grew out of a constitutional revision commission which was authorized by a vote of the people on November 7, 1972. The amendment also gave the 63rd Legislature the authority to act as a consitutional convention, to be convened on the second Tuesday in January, 1974, to propose a revised constitution the voters of Texas.

The commission was named by authoritative persons and groups. The commission, as required by the resolution, met initially in Austin and has since held a total of 19 meetings in six geographical areas of the state.

Senate Bill 1 appropriated \$900,000 to be used to pay salaries, travel, and per diem of members, staff, and expert witnesses, professional fees, and consumable supplies, and other expenses.

The regular session of the 63rd Legislature was the forum for the introduction of 97 proposed constitutional amendments. Of those introduced, only 9 were passed by both houses and will be submitted to the Texas electorate. Proponents of the amendments felt that the vote on the proposals would give the constitutional convention a clear mandate regarding the inclusion or exclusion of the proposals in any new or revised constitution.

The proposed amendments deal with the following sub-jects, all of which will be published in detail at a later date and reviewed in this and other papers of the state: (1) to provide for annual sessions of the legislature, set the salary and per diem for the members; (2) deals with homestead property; (3) extending ad valorem tax exemption to homesteads; (4) laws passed creating certain conservation and reclamation districts; (5) tax levy by and for coastal towns for seawall construction; (6) court jurisdictions within the state; (7) additional bonds or obligations

#### **Absence Rules** For School Listed

Terrell County Independent School District issues three types of excuses for absences, according to Supt. C.B. Card. The information is given for the benefit of students and parents so that there will be no questions or misunderstandings concerning excused absences.

Excused-makeup - given for one of the following reasons: personal sickness, sickness or death in the family, quarantine, severe storm which makes travel dangerous, for unusual causes acceptable to school authorities! these excuses are to be in writing and signed by the parent or guardian of the student.

Unexcused - this type will be given when a student deliberately misses school and/ or fails to bring an excuse or the parents fail to notify the school. The student will have three points deduced from each subject missed. This includes taking children out of town for shopping or banking on schoo! days.

Absence accounted for - this type of an excuse will be given when a parent takes the student from school for personal reasons. The teacher is not required to give any make. up. It is also recommended that the parent notify the school prior to the child's leaving school. Any work for the time missed must be done before the child's absences. This does not apply during sixweeks tests, during which the student must be at school unless he is sick or an emergency exists. Hunting and fishing, etc., absences are not excused and will cost three points per subject per day.



Watts tell how much electricity is needed to produce that light and bulb life is the estimated length of time the filament will last. Long life bulbs may be placed in hallways or stairwells where bulbs are difficult to change. Standard life bulbs may be used in reading or work areas where brightness is more important. Buying the proper bulbs and using them wisely can save you money.


