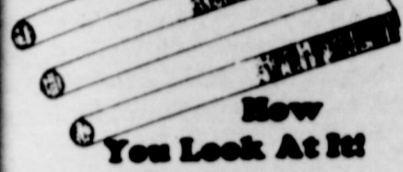

## Water District Vote Allen, Hornsby Re-Elects Three

The vote for three board members for the Terrell County Water Control & Improvement District No. 1 was Saturday of last week, the same day as for the board member for the Terrell County Independent School District. The voting was in the courthouse for both elections, one being in the clerk's office and the other in the county court room.

The three incumbent board members, Greene Cooke, Jimmy Caroline, and Mark Duncan, were returned to the board. They were being contested by Barton Massey, a non-resident of the water district, who received a sufficient number of votes to be considered a serious contender for the post.

The election is for a three-year term.

The reported returns are unofficial and will be official after the votes are tabulated and the voter list checked at the next meeting of the board.

Write-in votes were received by James McDonald, Bill Turner, A.K. Bradford, and Louise Causey, each of whom received one vote each.

## Commissioners Have Routine Meet

The Commissioners Court of Terrell County met in a regular session Monday morning. Following the reading and approval of the minutes of the previous meeting, the bills were read and approved.

The bids for feeding the prisoners in the Terrell County jail were opened and read and the Oasis Restaurant was the lower bidder. The court agreed to accept that bid if provisions could be made to feed the prisoners seven days each week with bills to be submitted monthly.

County Attorney Jack Hayre was present to explain to the court the status of the present and old dump grounds and recommended that the court appoint a commissioner to sell the old site which has been abandoned as a dump ground and obtain a clear title to the present site. Ervin Grigsby was named as commissioner for this project.

The court approved the deputization of Mrs. Tommy Turner in the office of tax assessor-collector of Terrell County.

There was a report of the status of the flood control easements by Mr. Hayre, who said that there had been some noticeable progress in the project and they hoped to be able to report more at the next meeting.

Allen was the only incumbent in the race, E.E. Harkins Jr. having elected to not seek the post again.

## Murder Charged After Mexican Slain Sunday

Mike Trevino Flores, 27, of Andrews, was charged with murder with malice in connection with the shooting death of a 19-year-old Mexican Sunday. Flores was arrested at the Joe Chandler guest ranch Sunday afternoon after a man-hunt involving Pecos County officers, Texas Highway Patrol, Texas Rangers, Immigration Officers, and Terrell County officers.

The incident occurred just south of Sheffield and the story related by officers is that two Mexicans, Rosalio Rodriguez, 19, of Torreon, Mexico, and Javier Rodriguez, 27, also of Mexico had tried to hitch a ride with Flores and his family, who were in a pick-up truck. The younger man was killed by a shot from a .22-calibre rifle and the older man ran away and was shot in the back as he ran. He went to Sheffield and reported the incident to Constable Earl Malone.

Following Flores' arrest, he was brought to Sanderson and charged with bond being set at \$50,000 by Justice of the Peace W.G. Shoemaker. He was later returned to Fort Stockton where the bond was lowered to \$25,000 and he was released Monday on the bond.

## Attempted Rape Charged Local Man

Terrell County Sheriff Dalton Hogg stated that he had arrested Raul Dominguez, 17, on Wednesday of last week and he had been charged with attempted rape. Bond was set at \$25,000 after the examining trial before Justice of the Peace W.G. Shoemaker Wednesday.

The alleged violation was said to have occurred Tuesday night.

Hogg stated that the charged man had entered a local house and committed the violation. The female intended victim was at home alone at the time, according to Hogg, and her screams caused the attacker to flee.

Dominguez has three other indictments by a grand jury against him and he was free on bond at the time of the alleged violation last week.

Dominguez is known locally as "the panty thief".

**Deep Wildcat Set Near Sheffield**

Texas Oil & Gas Corp., Midland, will drill its No. 1-D, Noelke, a 10,600 foot Ellenburger gas wildcat in Terrell County, 2-3/8 miles east-southeast of Ellenburger and 3-1/4 east of Pennsylvanian detrital, South oil production and 3/4-mile northwest of the depleted Connell opener and lone producer from that pay in the Yucca Butte field 2-1/3 miles south of the Sheffield Townsite (Connell, Pennsylvanian and Devonian) field of Pecos County, but separated by a 10,300-foot Ellenburger failure and five miles southeast of Sheffield.

Location is 2,473 feet from the south and 920 feet from the east lines of section 2, Block A2, in TCRR Survey.

**Confirmer For Terrell Gas Well**

The Yucca Butte multipay field gains its third Ellenburger producer and a 3/8-mile southeast extension to that pay and into Terrell County with completion of Texas Oil & Gas Corp., No. 1-C Noelke, five miles southwest of Sheffield, for a calculated, absolute open flow of 11,400,000 cubic feet of dry gas per day.

Production was through perforations at 10,248-307 feet, which had been acidized with 250 gallons.

Drilled to 10,522 feet, with 4-1/2-inch casing set at 10,500 feet, it is plugged back to 10,429 feet.

Location is 1,000 feet from the north and 1,640 feet from the west lines of section 4, block A2, in the TCRR Survey.

The Pecos County portion of the field also has two Connell gas and five Pennsylvanian gas wells and the Terrell County portion has one Pennsylvanian gas and one Pennsylvanian detrital, South oil producer.

**REAP Reinstated To Aid Ranchers**

The 1973 Rural Environmental Assistance Program (REAP) which was terminated in December, 1972, has been reinstated, according to the U.S. Department of Agriculture.

The announcement was made as the Agricultural Stabilization and Conservation Service began notifying ranchers they can now sign up for cost-share assistance under the new Rural Environmental Conservation Program (RECP) which was announced just three months ago. RECP was designed to carry forward some features of the old REAP.

Kenneth E. Frick, who is administrator of ASCS, says reinstatement of the 1973 REAP Program resulted from a U.S. District Court decision reversing the termination action.

An ASCS employee will be in Sanderson each Wednesday beginning April 17 from 9:30 a.m. to 3:30 p.m. at the ASCS office.

### Eagle Track Team To Have Five At Regional Meet

The Sanderson High School track team scored 95 points to finish third behind Rankin 148 points, and Clint 130. Iraan was 4th with 60, Balmorhea had 46, Marfa 10, and Wink 7.

Sanderson's 440-relay team finished 3rd, behind Clint and Rankin. The team is composed of Robert Kline, Danny Montalvo, Bill Mott, and Carlos Munoz.

Mott placed 6th in the 100-yard dash with a time of 11.4.

Kevin Phillips out-ran the field of 440-yard dash entries, clocking 51.4. Ja Chriesman placed 3 with a time of 53.4.

Kline placed 3rd in the 330-yard intermediate hurdles. His time was 23.4.

Phillips repeated his winning ability in the 220-yard dash clocking 22.7. Chriesman placed 4th with 23.4.

Ricky Marquez won the mile run with a sore foot in a time of 4:33.7. Bernie Castro was 5th with 5:10.4.

Sanderson's mile relay team lost to Rankin by 4.2 seconds, running the four laps in 3:30.8. The team is composed of Phillips, Kline, Chriesman, and Marquez.

Mott dominated the field in the discus event with a throw of 147'8".

Kline's 12' pole vault was good for a solid second place. The winner cleared 12'6".

Coach Willie Myers will take Marquez, Phillips, and Mott to the regional meet in Lubbock for their solo events, and Chriesman and Kline to participate with the mile relay team, with Kline also competing in the pole vault, by virtue of his second-place win in that event at the district level.

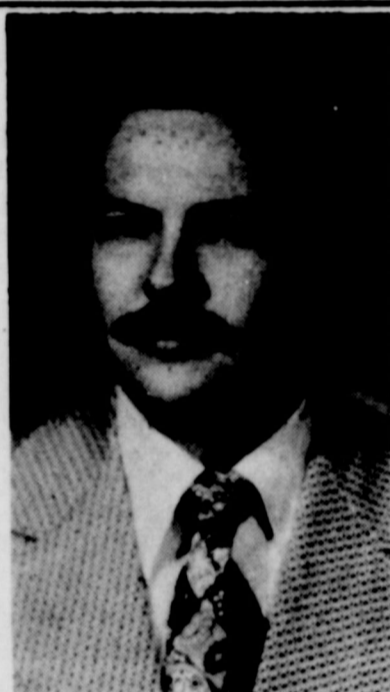

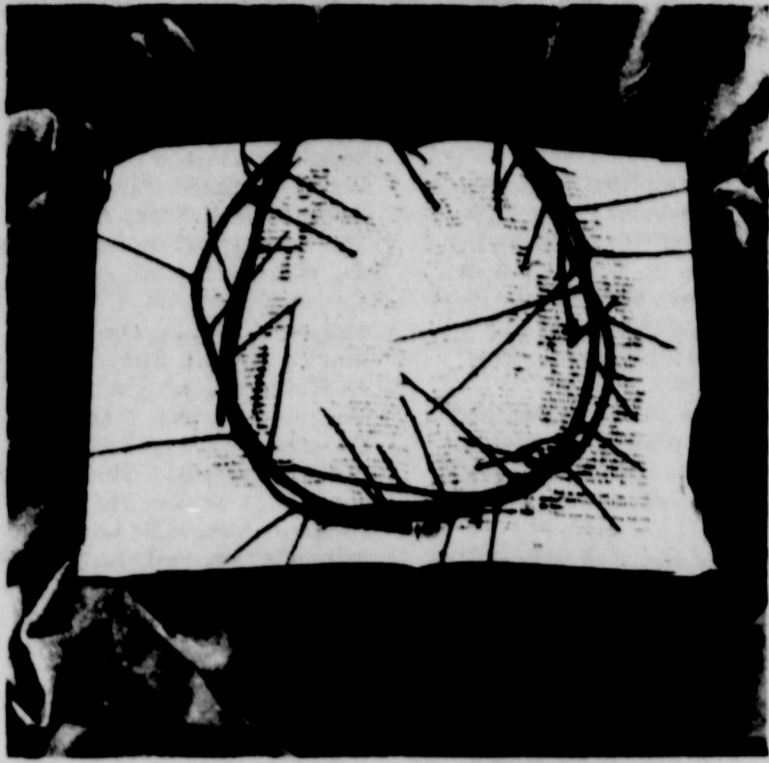

## Grant Offers \$\$ For PBRPC Area

Governor Dolph Briscoe announced last weekend the approval of a State of Texas Planning Assistance Grant in the amount of \$53,035,000 to the Permian Basin Regional Planning Commission.

The governor stated that the funds are provided to the PBRPC to assist in meeting their regional planning and service responsibilities.

The Division of Planning Coordination is that section of the Governor's Office charged with assisting the Governor in carrying out his responsibilities as the State's Chief Planning Officer. In addition to administering the State planning grant program, the Division is actively engaged in coordinating State planning activities and in developing assistance programs for local governments and regional councils of governments.

Funding for the PBRPC planning grant comes from a \$1.7 million dollar appropriation of the 63rd Legislature. The grant program is administered by the Governor's Division of Planning Coordination.

PBRPC is headquartered in Midland. It is an association of local governments, with membership including 17 cities, 5 special purpose governments, and the counties of Terrell, Andrews, Borden Dawson, Ector, Gaines, Glasscock, Howard, Martin, Midland, Pecos, Reeves, Upton, and Ward.

PBRPC will utilize the state grant funds to fund a variety of programs benefitting member local governments within the region. Examples of these programs include criminal justice planning and manpower planning. In addition, PBRPC provides technical assistance to member local governments within the region.

Chairman of the organization for 1974 is O.D. Luttrell, Pecos County Judge. The executive director is Ernest W. Crawford.

## Family Planning Clinic Begun Here

The family planning clinic to be in Sanderson once a month, began Wednesday of this week with the visit of a staff member of the Permian Basin Planned Parenthood, Inc., of Odessa.

The clinic will include instruction about birth control, diagnostic laboratory screening for anemia, protein, and sugar, pelvic and breast examinations, blood pressure, weight and contraceptive prescription, with follow-up instruction. In addition, treatment for yeast and fungal infections is provided.

It has been stressed that patient's records are kept in locked files and are strictly confidential. The data taken conforms with the requirements of the National Center for Health Statistics, Planned Parenthood-World Population and the Department of Health, Education and Welfare.

Currently the five clinic sites have a total of 4,264 enrollment, distributed proportionately according to the population of the communi-

ties, according to information received from the executive offices of the Permian Basin Planned Parenthood, Inc.

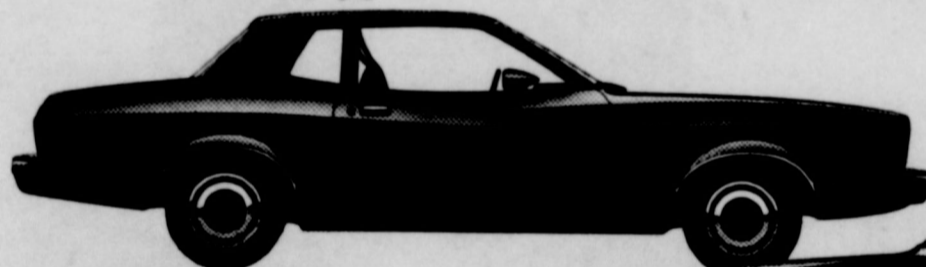

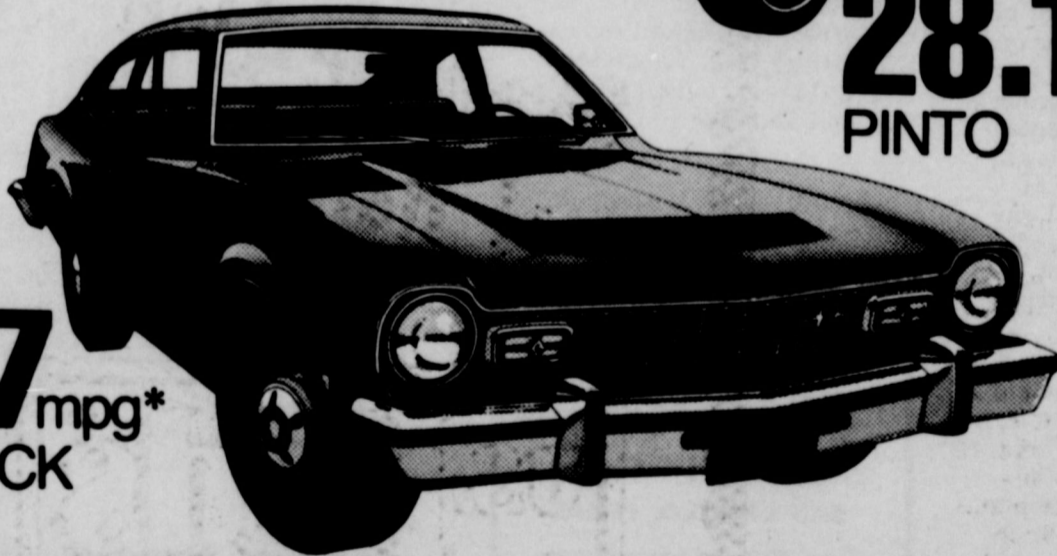

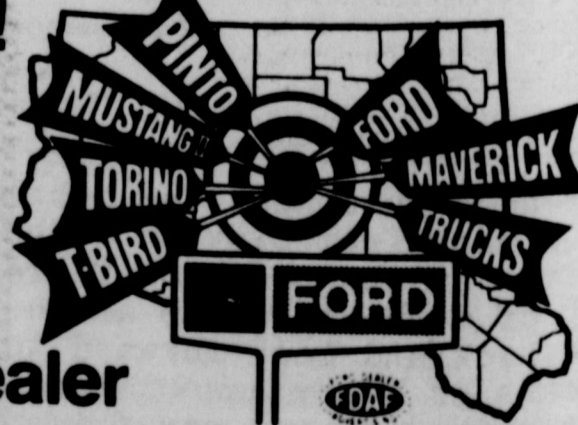

### Managing Brush Aids Wildlife

Managing brush to benefit wildlife while increasing forage for livestock has become big business in Texas.

In fact, more than one-fourth of the brush control work on-the-ground in Texas today has been applied by livestock producers who have been giving special consideration to wildlife.

Jerry Wenmohs, district conservationist for the Soil Conservation Service in Sanderson, said the figures came from a recent study by the Soil Conservation Service.

"Our figures reveal that 7.7 million acres of former brush land in Texas are being controlled or managed for mutual benefit of wildlife and livestock," Wenmohs said.

"Most of this work consists of leaving brush in carefully designed patterns which provide food and cover for wildlife. Alternating strips are cleared or thinned so choice forage plants can thrive without undue competition from the brush for sunlight and moisture."

Wenmohs said the study does not cover thousands of acres of brush land which are being left undisturbed specifically for the benefit of wildlife.

Many brushy areas have become so thick that the woody plants have crowded out the choice forage plants preferred by livestock, deer, game birds, song birds, and other wildlife. Such areas often need reseeding after brush control work. Wenmohs explained that opening up some areas while leaving adjoining land in brush actually improves wildlife habitat.

"Many species of wildlife are what biologists call 'edge' animals," Wenmohs pointed out. "That is, they prefer to feed on woody plants in the brush and on forbs, native legumes, grasses, and other plants in open areas along the edge of trees and brush. When danger threatens, they escape to the protective cover nearby. Leaving strips of woody plants near open areas increases the amount of edge available to wildlife."

Wenmohs said the study revealed that 26,000 land users in Texas are managing brush for both wildlife and livestock.

"This demonstrates the genuine concern ranchers in the state have for environmental values," Wenmohs said. "Most wildlife is produced on privately owned lands. Wildlife enthusiasts, sportsmen, and others interested in maintaining large numbers of wildlife owe these producers a deep debt of gratitude."

SCS biologists and range conservationists in Texas developed the new brush pattern technique in the mid-1960s which is now proving so popular with livestock producers. Through its plant materials center at Knox City, SCS is also evaluating and putting into use native legumes, forbs, and other plants relished by livestock. Such plants are in strong demand for inclusion in range seeding mixtures.

SCS provides technical assistance in planning and applying conservation measures, including brush management and grassland improvement, to land users through 193 local soil and water conservation districts in Texas.
