We went to the commencement service Thursday night of last week and thoroughly enjoyed it.

Without taking anything away from any of the previous graduating classes, it seems that this one was a little more impressive. Maybe it was our attitude, receptiveness, or something -- or maybe it was everything put together.

We asked Jake Murrah for permission to reprint his valedictory address. We thought it was very good. It follows:

"Members of the Board of Education, Members of the Faculty, Parents and Friends:

"Tonight we are at the close of a very important phase of our lives.

"Someday we will look back at these past twelve years with fond memories; with remembrances of friendships which have grown throughout most of our lives; and to the events which took place in and out of our classrooms.

"But tonight we are looking toward the future --- and the future means challenge.

"With all the developments and demands of the space age it is only natural to suppose that the greatest challenge of today is the need for more and better education. Certainly the importance of this cannot be underestimated. Our very existence as a nation could well depend on our ability to equal or surpass the educational advancements of the other nations of the world. But as great as this is, it is not the greatest challenge of our day.

"The late Dr. Thomas Dooley, who gained world acclaim because of his unselfish sacrifices to relieve suffering and pain in the outer reaches of the world wrote as follows to a young doctor, challenging him to spend his life in service. I quote, 'Dedicate some of your life to others. Your dedication will not be a sacrifice. It will be an exhilarating experience, because it is intense effort applied toward a meaningful end.' In these words of Dr. Dooley is cradled the great challenge of our generation - a call to unselfish service to others.

"Today the attitude of self-indulgence is so prevalent that very little thought is ever given to the needs of those around us. All too often the majority of the people are seemingly more interested in their own selfish desires than in lending an occasional help-

White's place to pastor the Sanderson-Dryden charge.

Rev. Edward M. Lang Jr., who has been pastor of the Franklin Grove United Methodist Church for the past four years, will be here to begin his pastorate on June 16 as he is to be ordained an elder in that conference on June 2 and will remain for the remainder of the conference there. He attended high school in El Paso for three years and his wife, Amy, is from El Paso, and so they are anxious to get back to this section of the country, according to Dr. Stewart. The Langs have a daughter, Ann Katherine, four and one-half years old, and a son, Ed III, who is two years ago.

Rev. White and wife left Monday for Albuquerque, N. M., going to see his mother before going to Glorieta for the annual New Mexico Conference which convened on Tuesday. He will fill the pulpit at both Sanderson and Dryden next Sunday morning.

Some Gas Dealers Ask PBRPC's Help In More Allocation

The Permian Basin Regional Planning Commission sponsored a meeting at the Terrell County Courthouse Thursday of last week for all service station operators in Terrell County. The meeting was for the purpose of soliciting help from PBRPC in increasing permanent fuel allocations from state and federal offices, and to seek emergency fuel allocations to take care of local needs until the permanent allocations could be increased, according to Barton Massey, local Conoco dealer.

The request for increase in permanent allocations was deemed necessary since the permanent allocation were established from 1972 uses, and local users had increased due to the influx of rail and oil crews into this area who were depleting supplies available for retail, according to the request.

PBRPC staffers Jack Martin and Bill Smith were here for the meeting with Jesus Mancha, Al Word, Ben Martin, and Massey, local retailer and wholesaler, and H.H. Shelton, local consignee.

Immediate results of the meeting was the allocation of additional gas to Mancha to offset the closing of another Mobil products retailer - McKnight Motor Co. - and a potential supplier through retail sources. Massey stated that he had received an allocation for an amount of gasoline for the month of May only to offset a cut-back in his permanent allocation from his supplier due to a fire at the refinery, but the amount allocated was so small that he could not justify the expense involved in going after the gasoline.

It was not known at this writing if permanent allocations for increased gasoline supplies locally would be granted.

★ Doctor and Nurse Are Coming Here

Troy Druse, who has been working for many months on getting a medical practitioner for Sanderson and Terrell County, stated that the certainty of a doctor's coming here has been nailed down as certainly as it could be until the doctor moves here. He also stated that there has been a definite promise of a nurse-practitioner for Terrell County.

Druse stated that the doctor was not expected before the new year, and probably it would be in the spring before he finished his present commitment, but the nurse-practitioner was expected to be in Sanderson much earlier.

The nurse-practitioner will serve some time training with the doctors of the area and will be more able to give the doctors the information they need when she confers with a

doctor concerning a patient.

The presence of the nurse-practitioner here would in no way interfere with the possibility of the doctor's coming here to practice, according to Druse, but rather, would enhance the expectations of the doctor's coming. The nurse-practitioner and the doctor will work out of the Trans-Terrell Medical Center facility, and it is expected that Dr. J.F. Svajda, the dentist of Alpine who comes to Sanderson on Wednesdays each week, will continue his weekly trips to Sanderson to take care of the dental needs of people here.

Druse assured The Times that as more information concerning either individual or the situation was available, he would relay it for the benefit of the readers.

Serving with Druse on the committee were R.S. Wilkinson, Dudley Harrison, Lewis Cash, and Silvestre Silvas, directors of the Trans-Terrell Medical Center.

 "The common excuse for this callousness is based on a purely selfish motive. You hear it often, 'If I don't look after my own interests no one else will'. The sad fact is that this statement is probably true. But self-preservation should never exclude the neighborly act of extending a helping hand to anyone in need.

"Today's greatest challenge calls for personal involvement in helping other people. To be of utmost value this assistance must be given without reservation and without thought of receiving compensation. The best form of help is that which does not rob the recipient of his self-respect but makes it possible for him to help himself. Under no circumstances should a good turn carry with it a suggestion, implied or otherwise, that the receiver is indebted or obligated to the donor.

"However, the greatest satisfaction that can come in life comes from dedicated service to others on a person-to-person basis. Border Patrol's Birthday Noted

Sunday afternoon the Marfa Sector Headquarters, located at Fort D.A. Russell in Marfa, had open house to mark the Patrol's 50th anniversary.

William H. Hickey, the Marfa stations supervisory agent, had on display equipment the Patrol uses daily to perform its tasks including demonstrations of the probable electronic intrusion devices. Senior Border Patrol Pilot Robert Walker also displayed one of the Patrol's light observation aircrafts.

Oscar D. Stevens, Chief Border Patrol Agent, hosted the open house with the assistance of other officers.

In 1924, when Congress provided for the establishment of the Border Patrol, the Marfa Sector came into being, and replaced the two "mounted guards" stationed in Presidio. Marfa Sector Headquarters was located in available buildings of Fort D.A. Russell in Marfa until 1935 when it was forced to relinquish its space to the U.S. Army. The Marfa Sector then became the Alpine Sector for 14 years not returning to Fort Russell until 1949.

The Sector opened in 1924 with stations in Alpine, Marathon, Sanderson, Presidio, and a headquarters station. In the late 1920's Valentine and Pecos stations were added. By 1933, three additional stations, Big Spring, Fort Stockton, and Lubbock were added. However, these three stations plus the stations in Valentine and Marathon were closed, but with the exception of Valentine and Marathon - were later re-opened and subsequently stations in Amarillo and Van Horn were added. The Marfa Border Patrol Sector is responsible for one of the largest geographical areas in the United States, covering 77 West Texas counties and 18 counties in Western Oklahoma.

The original stations in the Marfa Sector were located near railroad division or subdivisions since travel by rail was the primary means of motorized transportation. Some of the early problems included liquor smuggling during prohibition days and an influx of illegal Chinese aliens entering from Mexico.

The primary mission of the Patrol has not altered since 1924, but techniques have become more modern. Jeeps and Scouts have replaced the horse in patrolling rough terrain along the international boundary, and light observation aircraft with some of the world's best "brush" pilots have been added to the force.

Chief Patrol Agent Oscar D. Stevens is the Immigration and Naturalization Service officer responsible for the administrative as well as the operational performance of the Marfa Sector. Chief Stevens is assisted by James W. Reed, Deputy Chief Patrol Agent, and Assistant Chief Patrol Agents John S. Bradford and Charlie W. Henderson. Also unique to sector headquarters are the Anti-Smuggling Unit, Intelligence Office, Training Office, Pilots, Vehicle Maintenance, Detention Officers and Radio Communications center.

Sanderson is one of the first Border Patrol Stations, having been opened with a complement of four officers in 1924. The primary responsibility during the early years of the station was freight train check at the Southern Pacific yards in Sanderson. Also river watch at the crossings south of Dryden was an important function. By 1941, the officer force had been increased to eight Patrol Inspectors under the supervision of a Senior Patrol Inspector. However, by 1950, the force had dwindled to two Patrol Inspectors.

Today, the Sanderson office is located on the west edge of town along U.S. Highway 90.

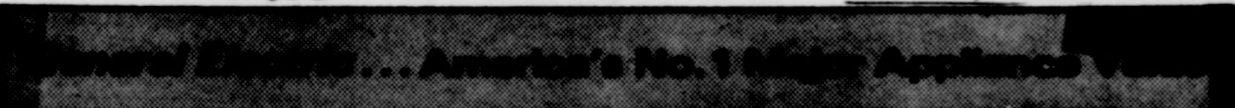

Water Rights Claim On Rio Grande Made by Gov't

The Texas Water Rights Commission last week adopted a preliminary determination of all claims of water rights in the Upper Rio Grande Watershed, which includes the area from the Amistad Dam in Val Verde County to the Dave Gill Dam in Hudspeth County, with the exception of the Pecos and Devil's Rivers.

The watershed covers portions of Brewster, Culberson, Hudspeth, Jeff Davis, Presidio, Terrell, and Val Verde Counties, and the determination includes all known surface water uses with the exception of domestic and livestock.

Copies of the preliminary determination are being furnished to each person who filed a claim to water rights and copies are available for inspection until July 29, 1974, in the offices of the Water Rights Commission and the county clerks in every county containing a portion of the Rio Grande Basin.

Additional copies are available for \$5 from Mrs. Audrey Strandtman, secretary, Texas Water Rights Commission, P. O. Box 13207, Capitol Station, Austin, Texas 78711.

Any water right claimant affected by the preliminary determination, including claimants in other portions of the Rio Grande Basin, may file a contest with the Commission by September 6, 1974, stating the grounds of his contest. If it involves another claimant, proof must also be filed that the claimant has been served by certified mail.

Persons needing further information should contact Milford Lee Hall at the Water Rights Commission or by phone at (512) 475-2711.

tion of all claims of riparian rights, prescriptive rights, declarations of intent, permits, certified filings, and other nonexempt stream water uses.
