It Depends ON

How You Look At It!

We had a very enjoyable and significant conversation last week with an official of the Southern Pacific Railroad. There were some interesting comments that we heard during the conversation, and there were some interesting inferences drawn from what we heard, also!

This is a part of the understanding we had of some of the conversation:

The railroad company is very interested in the flood control project and for some very natural reasons, and would like for it to be nearing the completion stage, rather than yet unstarted - they are wanting to locate some modular units on their property south of the track, and the condition, appearance, and usefulness of the depot has been at least a topic of conversation by some of the railroad officials;

The modular units that are planned for railroad employee occupancy in Sanderson on away-from-home needs are expected to be brought into town within the very near future and will be established under "permanent" specifications in some area "near" the depot, "near" some commercial eating establishment, but for their own protection, would prefer some area "above the water line";

With the "possibility of the permanence of Sanderson as a railroad terminal increasing", local employees, business people, and residents will be able to move into a more stable economy with everyone more capable of some long-range planning.

Some of the things that we heard in the conversations also reflected the pride of the railroad company in their initiating the pilot project of Centralized Traffic Control and all of the advantages that this will have for the faster, safer, and more expeditious movement of freight over their lines; the interest that we heard reflected in little problems voiced by U.T.U. officials in the group and the sharing of opinions in efforts to better some of the problems; the explanations (most of which we didn't understand) of how the CTC is going to work, how blowing a horn on an engine opens (or is it closes? or is it both?) a switch on the rails, how their microwave communications system operates and other possibilities of the use of existing facilities, etc., etc.

It was, indeed, interesting conversation and a delightful time! And one of the great and enjoyable results of the whole thing was the opportunity to meet people we had not known previously, and to get to know old friends in a way and under different circumstances than was possible

More of US285 Work is Slated

Pecos County Commissioners Court, in its regular meeting took two actions to prepare for an announced highway construction program on US 285 between Fort Stockton and Sanderson.

The court passed a motion ordering moving of utility lines by Big Bend Telephone Company and Rio Grande Electric Cooperative from the right-of-way along the area of planned construction, and voted to take bids for fencing of right-of-way in the area.

The construction is scheduled to begin August 1 on a 21-mile stretch of the highway.

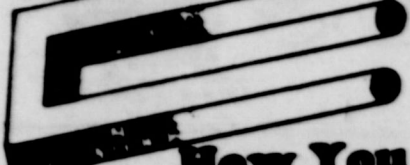

Mohair Promotion To Be Presented To Producers

A proposal for funding future promotion programs for mohair is expected to be presented to growers and directors of the Mohair Council of America when they meet August 15 at the Texas Tech University Center at Junction. The meeting, set for 10 a.m., is expected to draw a large turnout of producers, warehousemen and other mohair industry representatives. The meeting is the first to be held in Junction since the Mohair Council was first organized there in 1966.

Funding of future Council promotion programs has been a concern of grower members for more than a year. The Council, which has been funded in the past through a deduction of 1 1/2 cents per pound from mohair support

payments, has not received any funds since 1972. The Council recently began its second consecutive year of operation using funds from its reserve.

The Council's need for supplementary funding directly relates to higher mohair prices received by growers during the last two years. The funding problem began over two years ago when the price of mohair, influenced by expanding world-wide demand, went over the 80.2 cents per pound price support level. As a result of the higher prices paid growers during the 1972-73 marketing years, no incentive payments were made and consequently no new promotion fund deductions have been available. On June 30, the average price of mohair sold during the first 6 months of 1974 was \$1.55 per pound, thus no incentive is expected to be paid on mohair sold during the current marketing year.

James T. Hunt of Sonora, Council president, said the Council's officers, executive committee and staff have worked for more than a year studying various proposals and ideas for future supplemental financing of the Council.

"We must decide this year how we plan to finance our advertising, promotion and market development programs in the future," Hunt said. He urges all mohair

growers, as well as directors, to attend the meeting.

Other matters to be discussed will include the domestic and foreign mohair market situation, prospective new markets and new uses for mohair fiber, and proposed advertising, promotion and market development projects. Assisting Hunt in conducting the meeting will be L.D. Whitehead of Del Rio, vice president, and Sid Harkins of Sanderson, secretary-treasurer

MOURNING DOVES: North Zone—Sept. 1 thru Oct. 30, 1974.
MOURNING DOVES: South Zone—Sept. 21 thru Nov. 3, 1974, and Jan. 4 thru Jan. 19, 1975. In the shaded counties of the South Zone, mourning doves may be taken on Sept. 1 and 2 and on Sept. 7 and 8 during the white-winged dove open season. In these South Zone shaded counties the fall open season for mourning doves will close on Oct. 30, instead of Nov. 3.

WHITE-WINGED DOVES: Shaded Areas - North and South Zones - Sept. 1 and 2 and Sept. 7 and 8, 1974.

SPECIAL NOTES:

- No hunting permitted in game refuges, state and federal parks, game reserves, within corporate city limits or from public roads or road right-of-way.
- The retention of one fully-feathered wing on dressed doves is required in those counties having a white-winged dove season when both mourning and white-winged doves may be taken. This requirement also applies when doves are imported from Mexico or any foreign country.
- Shotguns must be plugged permanently to three-shell capacity and may not be larger than ten gauge. Hunting doves with rifles prohibited.
- During the concurrent white-winged and mourning dove season, dove hunting is not permitted in the area south of U.S. Hwy. 281 between the city limits of Hidalgo and Brownsville and in the area northwest of Harlingen bounded on the east by U.S. Hwy. 77, on the north and west by F.M. 491 and on the south by State Hwy. 107.
- A white-winged Dove Stamp for a \$3.00 fee is required of all persons who hunt white-winged doves. This stamp is required in addition to the valid hunting license.
- A valid importation permit (fee \$1.00) is required for the importation of wild game birds (or animals) from the Republic of Mexico. Each permit is valid for a maximum of 30 days from the date of issue. Permits are available from all Parks and Wildlife Department district offices and wherever hunting and fishing licenses are sold in the Rio Grande Valley Area.

COMMENTARY ON THE HOLY SCRIPTURES

Dr. Edward Lang Jr.

NUMBERS

One thing about our life in the United States of America makes it extremely difficult for us to understand the nature of the Christian faith. We think in terms of individuality rather than community. Rugged individualism is taught to us from our youth. This aspect of our thought and attitude toward life has to be changed in order for us to be Christian. The Christian Church is a community. The only way to be part of God's people is to be a part of that community. We must learn to think of ourselves in relation to God not as individuals but as a community. This is a major lesson from the book of Numbers.

The book of Numbers opens with the people of Israel preparing for war, the holy war in which they are to take possession of the Promised Land. That preparation is a census in which all the people of Israel are numbered. Paragraph after paragraph describes the families of Israel. In essence these are genealogies, like the many other family listings which you have encountered in the Bible. We commonly tend to skip over these lists of names and count them of little importance. It is precisely at this point that we must change our thinking in order to understand the Bible. Those lists were important to the people of God. They were important because one had to have his name on the list in order to be part of the community. The only way to be

among God's people was to be part of the community. Many people today say that they can be Christians while at home and participating in the life of no church congregation. This is absolutely not true. The only way to be part of God's people is to participate in the life of his congregation. In the words of a famous churchman: "the Bible knows nothing of solitary religion".

The first statement of Numbers, and one that appears throughout the book, is that God spoke to Moses in the tent of meeting. God encountered his people in the Tabernacle. Like Exodus, the book of Numbers describes the physical arrangement of the Israelite camp. Each tribe had its own place around the camp, each facing the center, with the Tabernacle in the very center of the camp (2:2). The center of one's life was the tent of meeting. When the people marched, the Levites carried the tent in the midst of the camp (2:17). At all times, God remained at the center of life. And the attention of the people focused on the place of the meeting with God. The currency, the money, was named the shekel of the sanctuary. Even business was conducted with attention focused on the sanctuary.

God remained at the center of life. He was encountered in the midst of the community. Remember the statement by Jesus, "whenever two or three are gathered together in my name, I will be in their midst." We encounter God and have the experience of fellowship with him when in the midst of his people. Here is a little thing, but an

important thing, that will help you to understand. We do not see God. Rather we hear his testimony. That testimony is heard at church. Remember again a statement by Jesus: "Man does not live by bread alone, but by every word that proceeds out of the mouth of the Father." The sustenance of life is the word that we hear at church.

To be cut off from the community was a very serious matter for the Israelites. The book of Leviticus described the atonement for unwitting sin. But what of intentional sin? It is described in Numbers as "high-handed" sin and the punishment for high-handed sin was to be cut off from the community of people (15:30-31). Miriam, a prophetess, was jealous and once questioned the authority of Moses. She was cast out of the community. Chapter 12 describes her state "as though dead". To be cut off from the community was to be separated from the sustenance of life. Your life in Christ depends upon your participation in the community, in the church.

The second lesson in Numbers is that God will care for his people and that in turn his people must trust him. From among all the Israelites, the Levites were separated and were given no means of support. In the Promised Land, they would have no land of their own. In war, they would have no portion of the booty. Their only support was the tithe paid to the Tabernacle. The money which was God's would care for them. With no other means of support they were at the mercy of God. That God provided all their needs was a lesson to the whole house of Israel that God would also care for them. Consider this statement by Jesus, one concerning food, and clothing, and shelter, "Seek first the kingdom of God and its righteousness and all these shall be yours as well".

Unhappily, the Israelites were very slow to learn to trust God. They complained about the manna which was given to them and asked for meat. God gave them the meat, but in his anger also punished them (Chap. 12). The people complained of a lack of water. To supply the water, God instructed Moses to speak to a rock. Failing to trust God, Moses struck the rock instead. His punishment for failure to trust God was a denial of the opportunity to enter the Promised Land (Chap. 20). In fact, the whole people of Israel were denied entry into the Promised Land as punishment for their failure to trust God. When the Israelites came near to Palestine, they sent a search party to survey the land. The spies were overcome with fear when they saw the people who lived there. "We are not able to go up against the people; for they are stronger than we"

(13:31). They had forgotten that God had prevailed over the Pharaoh of Egypt and they did not trust him to protect them now. In consequence, God denied them all the opportunity to enter the Promised Land. Only their children would be allowed to cross the River Jordan (14:20-23).

There were two exceptions, Joshua and Caleb. Among the spies, these two were fully confident that God would be faithful to his word and give them the land. "The land, which we passed through to spy it out, is an exceedingly good land. If the Lord delights in us, he will bring us into this land and give it to us, a land which flows with milk and honey. Only, do not rebel against the Lord... (14:8-9). For their faith, the Lord took Joshua and Caleb into the Promised Land as the leaders of his people.

Note two things about the statement by Joshua and Caleb. First, God protects and cares for his people. But second, we must seek to please God and must not rebel against him. Many parts of the book of Numbers describe worship and religious ritual. In each instance, it is stated that the religious observance will serve to remind people that God is Lord, that he determines history, that he cares for his own, and that we must obey the commandments of God. The value of worship for us is the reminder that God is our God, our Lord, and protector; we must obey him.

After you have read the book of Numbers, review what it has taught you. God is in the midst of his people. From the Tabernacle, the Lord speaks to his people to teach them a godly way of life. Trust God and obey him. You want and need the necessities of life. Seek first the kingdom of God and its righteousness and all these shall be yours as well.

Mr. Robertson owned and operated a motel just east of the bridge on the east end of Oak St. prior to the complete destruction of the motel, his home, and a cafe building by the flood in 1965. In his letter, he asked: "Do you think there ever will be anything done about the flood control dams?" A family by the name of Johnson - parents and five children - were living in the motel at the time of the flood and Mr. Johnson was working on a highway construction job near here. All of the family, with the exception of a 12-year-old son, were drowned in the flood; the lone survivor of the family escaped drowning by clinging to a tree into which he was washed by the high water.
