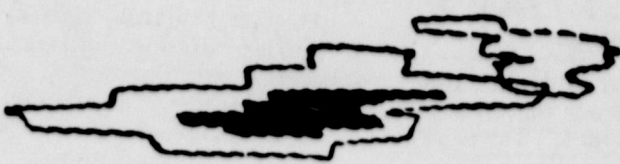

It Depends on How You Look At It!

There are lots of people probably who would be willing for the school bus - either of them - to pick up their children and take them to and from school. But there is the matter of legal limits within which we are all supposed to operate, and when we go beyond these, then we are asking for problems!

But this, too, depends on how you look at it!

There are those with firm convictions that laws were made to be bent, if not broken. But usually those who adopt that attitude are wanting to benefit from the bending or break.

Case in point - bus pickups: Who would want the school to hire an incompetent and illegal driver to operate the bus? Who would want the bus driver to willfully and negligently ignore the laws concerning the operation of a bus full of students. There is more at stake for the people responsible for the operation of the bus than just a slap on the wrist for violations of state laws concerning that activity. There are possible fines, jail sentences, etc., involved for willful and knowing violations - and maybe even for unwillful violations.

And, another case in point: Should we not expect our schools to be operated in all phases in a manner that sets a good example for all of the community?

Well, if you see it differently, that's your privilege, but we seem to favor a system that is governed by laws, rather than the whims of people.

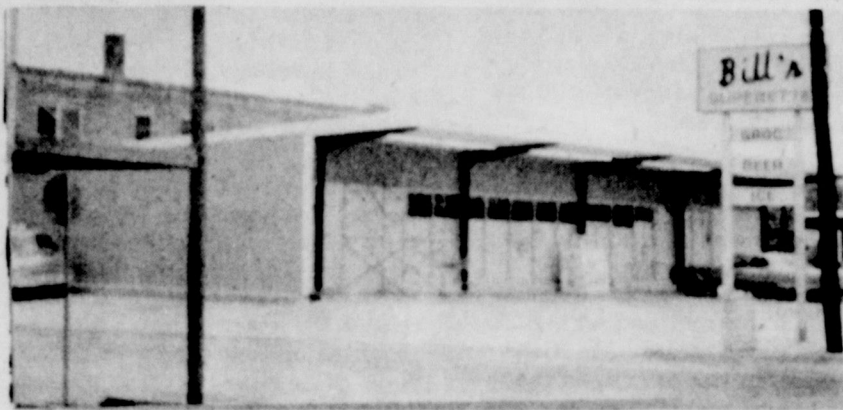

We do not really know, but it appears to us to be another slice off the same piece of bologna.

It appears that those who are involved in offering plea bargaining are trying to get to the top man always, and maybe this is necessary - both the plea bargaining and getting to the top man - but it just seems that there could be a better way.

An effort is being made to begin the Adult Basic Education Courses again in Sanderson and every effort is being made and should be made to get every person possible enrolled. The self-improvement courses are for the express purpose of offering basic educational courses to adults in order to help make their lives fuller and increasing their po-

Contract Let For Seal-Coating

Terrell County commissioners awarded the contract for seal-coating local streets to Jones Bros. of Odessa at their called meeting Monday morning.

The work will include seal-coating all local black-topped streets and new black-top applied to certain streets in town that now have no finished surface.

Work is expected to start before October 1 on the project, but will be finished before the end of October, according to terms of the contract.

Rains Fall Here Late Monday, More Tuesday

About two inches of rain fell locally Monday afternoon late and Monday night, most of which was slow-falling.

There were reports of heavier rainfall to the south and southeast of Sanderson, but not confirmed at this writing.

The rainfall was thought to be general over this area.

Three to four inches of rain was reported west of Sanderson in the area of the S.L. Stumberg ranch. The rain fell all day in that area, according to reports.

Adult Education Registration Set

The registration for Adult Basic Education classes will be on Monday, September 2, in the junior high school building from 6:30 to 8:30.

The requirements to attend the classes are that the person must be 16 years of age or over; must have been out of school for a year or longer; must be willing to learn.

Until the registration is completed, it is not known how many teachers will be needed.

Most needed textbooks are furnished and the classes are free to eligible students.

Juries Called To Work Monday

The Terrell County Grand Jury was called for Monday this week and spent the day in deliberations. The jury was impaneled by District Judge George M. Thurmond of Del Rio.

The grand jury indicted Douglas Harper, Chester Gillion, and Douglas Raymer for forgery and passing a forged instrument. A check was forged on M.J. Howard of Del Rio and passed to the Flores Drive-In. The men later pleaded guilty to the charge before Judge Thurmond, according to John Pettit, District Attorney.

Another indictment returned by the grand jury was against a person charged with the theft of livestock by a worthless check given to Indio Calzada. The defendant had not been arrested at this writing, the reason for withholding the name.

Armando Ponce pleaded guilty to aggravated assault, an altercation which occurred in September 1972, according to Mr. Pettit.

Daniel Ochoa pleaded guilty to a charge of carrying a prohibited weapon into a beer

Mrs. T. A. Bailey Dies In San Angelo

The death of Mrs. Thomas Albert (Mayde) Bailey in San Angelo last Wednesday morning ended a prosperous and popular business career which she began while living near Sanderson 30 years ago.

She began making cloth house shoes to give as Christmas gifts while living on the ranch and with her husband went into business full-time when they moved to Ozona four years later. They then moved to San Angelo in 1950, two years later, to expand the growing business. The firm started out as Bailey Shoe Company and incorporated in 1954 as Mayde's Inc., with "Mayde's" as the registered trademark. The first out-of-town sale came in Fort Worth when a buyer happened to talk to Mayde Jo, Mrs. Bailey's daughter, and ordered 200 pair of the house-shoes.

Her "scuffs" received international recognition when they were described and praised in the Tobe report. "Tobe" in 1955 was recognized as one of the international authorities on new items in the field of design.

In 1967, Mayde's, Inc., was sold to a corporation in Columbus, Ohio.

She is survived by her husband; a son, James R. (Bob) Bailey of Ozona; a daughter, Mrs. Mayde Jo Humphreys of Shelbyville, Tenn.; four

grandchildren and two great-grandchildren.

Following funeral services in San Angelo Friday morning, burial was in Ozona Friday afternoon.

Quite frequently it becomes necessary to remove children from their own homes because of conditions which may be threatening to their well-being. These children have been abused or neglected, and such circumstances cannot provide the sort of environment that children need.

When it becomes necessary to remove these children from their homes, either temporarily or permanently, there is a need for foster homes that can provide them with an accepting and loving atmosphere. Foster parents are called upon to accept such a child into their home. They give him love, and show their concern about his situation and his feelings. Then one day, they will be informed that he is being removed from their home, perhaps to go back to his parents, or to be adopted, or even to go to another foster home. This may be somewhat hard to do, because he may have become a brighter and happier person during his stay with his foster parents.

Being a foster parent is not easy, but it can be a very rewarding experience. There is a need for people who are able to give a child love and understanding at a crucial time in his life.

The process of becoming a foster parent has certain guidelines. To become a foster parent, it is required for your family to visit with a licensing worker. Your family must have a medical check-up, and your home will need to be inspected by fire and health inspectors. The Department provides adequate clothing for these foster children, and takes care of their medical needs. The licensing worker can give you additional information and will be glad to answer any questions you may have concerning foster care.

County Produces 2906 Bbls. of Oil

Terrell County's total oil production during the past year was 2,906 barrels of crude according to information received from the Texas Mid-Continent Oil & Gas Association. Oil production since the year of discovery - 1952 - has been 10,185 barrels of crude oil, the production schedule by counties noted.

Despite 12 months of production at 100% of the maximum effective recovery rate in most Texas fields, a drop of nearly 6.3-million barrels of crude oil from the state's all-time record high production year of 1972 occurred last year.

Texas' production in 1973 amounted to almost 1.3-billion barrels, tops among the nation's oil producing states and representing 38.6% of the total U.S. production, according to the statistics furnished by the Association.

Despite the drop in production, the oil that was produced last year was valued at some \$5-billion, an increase of approximately \$500-million over the value of the oil produced in 1972. Oil is produced in 203 of the state's 254 counties.

In addition to larger payments to royalty owners, the higher prices also have been reflected in the state comptroller's reports of increased severance taxes paid by the oil men of Texas.

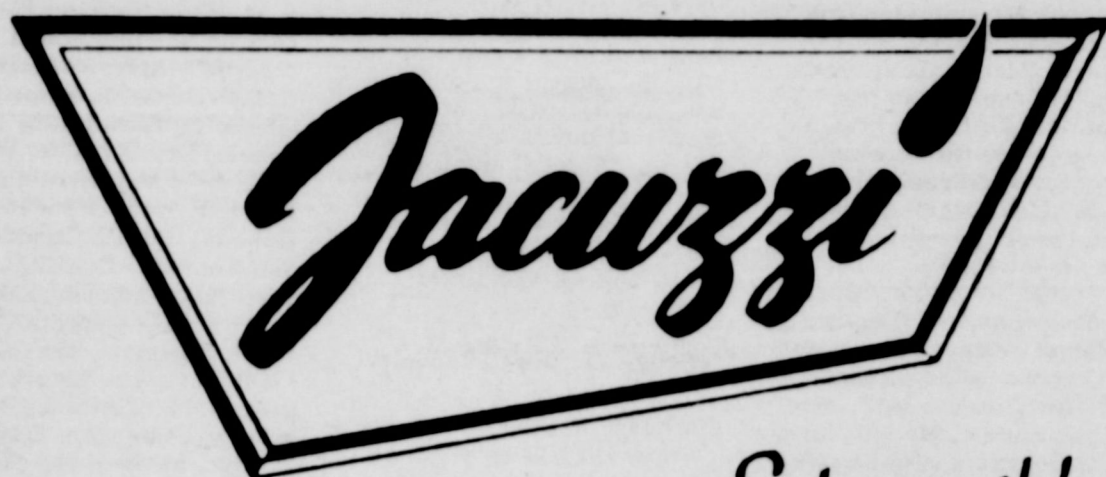

Social Security For County Residents Aids Many Families

Social security benefits were being paid to residents of Terrell County at a rate of \$32,000 a month as of August 1, 1974, Erven L. Fisher Jr., social security manager in Odesa, said this week.

Of the social security beneficiaries living in Terrell County, 165 are retired workers and their dependents. Another 55 are receiving benefits as the survivors of workers who have died, and 15 are getting benefits as disabled workers or their dependents.

Fisher pointed out that although most social security beneficiaries are older people, about one out of every four is under age 60. In Terrell County, 55 people under age 60 are collecting social security payments each month. Nearly 30 are under age 18, receiving payments because a working father or mother has died or is getting social security disability or retirement benefits. Most of the 5 beneficiaries in Terrell County between 18 and 22 years of age, are getting student's benefits under a provision in the social security law permitting the continuation of a child's benefits beyond his 18th birthday, and up to age 22, if the child is attending school full time.

Also in this 18-22 age group are some other types of beneficiaries, illustrating the broad family protection that the social security program

provides workers of all ages. Some are children of retired, disabled, or deceased workers who became disabled before they reached 22 and who will probably never be able to work and become self-supporting. The monthly benefits of these young people, severely handicapped by physical or mental disabilities, will continue indefinitely. Benefits are also payable to the mother if the disabled son or daughter is in the mother's care, Fisher said.
