Today is a busy day at the courthouse, what with both boards of equalization meeting, and a budget hearing for the county for next year.

The tax representatives for the county and school are meeting also with the tax representatives of the oil and gas industry companies, the tax representatives of utilities and railroads, etc., also a busy time and an interesting meeting for those who have the time to attend.

There were some who got cards about the raise in individuals' valuations for tax purposes that thought that the card demanded their presence at the board of equalization meeting. It is not difficult to see how they got that idea -- the cards almost said that!

Judge Charles Stavley said that he had several calls as did County Clerk Ruel Adams, from people far and near who said that they just could not make the meeting.

The presence of tax payers who have evidence of inequality is sought by the card. It was put another way by another person -- those who thought they had a gripe coming were asked to come to the meeting!

We hesitate to say anything about it again, BUT -- well, here goes anyway!

It does take a good fisherman to catch a perch on a bass lure! This has been proven twice, now, and I'm convinced!

Some people are wondering about the proposed tax increase for all real estate in the county and the lack of an increase in oil and gas properties, utilities, and industries valuations.

We contacted Judge Stavley about this and were told that he understood that the firm that takes care of valuations for Terrell County and the school district had said that the oil companies, industries, and utilities were now paying 15% of the valuations, and that the raise of two percentage points on all other properties in the county would bring the valuations within three percentage points of each other.

We have heard some outright statements and some rumors and we are just not able to keep quiet forever about such unfair and untrue (in our opinion - and we welcome refuting evidence) statements being made!

The county judge in Terrell County or any other county, this year, last year, or next year, cannot be blamed or given credit for raising taxes, lowering taxes, or maintaining a constant level of taxes!

Expenditures of the county are voted and/or approved by the commissioners. It takes a

**July 4th Plans Include Full Day Of Activities Here**

Plans for the annual old-fashioned Western observance of July Fourth in Sanderson have been completed and those in the planning sessions are hoping that there is something for the pleasure and entertainment of everyone, residents and visitors alike. A large crowd is anticipated.

The arts and crafts exhibit on the courthouse lawn will open at 10:00 a.m. with each exhibitor to be responsible for his booth and exhibits.

The parade will assemble on School Street west of the Sanderson State Bank and begin moving at 11:00 a.m. east down Oak Street to the Legion Hall. Marshals will keep the units of the parade separated with about three to the block affording better viewing by the spectators.

The serving of the barbecue dinner at the Legion Hall will begin at 11:30 a.m.

At the roping arena north of Sanderson on Highway 285, the rodeo events will begin at 1:00 p.m. and consist of the kids' events and calf roping for the men.

Reunions of the Sanderson High School graduating classes of 1943, '44, and '45 will be in the junior high school building from 1:30 to 3:00 p.m.

The old timers' hour on the courthouse lawn will be from 3:00 to 4:00 p.m.

A Mexican supper will be served at St. James Hall from 5:00 to 7:00 p.m.

**Efforts Made To Get Information On Swimming Pool Site For Sanderson**

Serious efforts are being exerted to assemble information concerning a possible swimming pool for Sanderson, according to County Judge Charles Stavley. The effort is the result of the dedication of \$23,324.00 to recreation, the funds being a part of the revenue sharing receipts of Terrell County for 1975.

Judge Stavley stated that one consideration has been the old swimming pool constructed by John Clark on the

property on the south side of Mansfield St. between First St. and School St. It is understood that the property from the back of the Church of Christ west to the corner of Mansfield and First St. and to the alley to the south would be available for purchase by the county. The property contains the old swimming pool, some old boxcars that have been used in the past for housing, two windmill towers, and a dwelling occupied by Sam McCann. Several large trees are also on the property.

Unofficial estimates were given by an out-of-town person with some knowledge of swimming pools that costs for sealing, repairing, and painting the old swimming pool to a serviceable condition would run in the neighborhood of \$5,000.00, that a filter system for the pool would cost from \$8,000 to \$12,000, depending on the type purchased, according to Judge Stavley. He was also advised that laws no longer required dressing room facilities, but that rest rooms, a shower, and foot bath facilities were required, as well as a life guard on duty during hours the pool is open. The visiting appraiser also had some recommendations and suggestions about repairing or remodeling the pool, but stated that such remodeling or changing the slope of the bottom of the pool could be accomplished at a later date if desired.

The total dimensions of the pool on the property mentioned above are 31x75 feet with an area 18x31 at the north end of the pool that is very shallow. Depth of the pool is graduated from 3 to 10 feet. The information about the property mentioned above and findings concerning repair and renovation costs, etc., were presented to the Terrell County Commissioners Court at a called meeting Thursday morning.

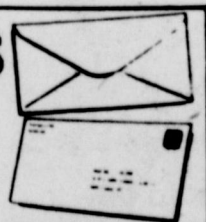

## Stocking Helps Amistad Fishing

A four-part stocking program aimed at improving the sport fishery on Lake Amistad has been initiated by fisheries officials at the Texas Parks and Wildlife Department.

Florida bass, walleye, northern pike, striped bass, and forage fish will be used to upgrade the overall fishing quality of the lake on the Texas-Mexico border.

Large-mouth bass fishing at Amistad has deteriorated since native bass have failed to maintain an adequate population as the lake grows older.

According to TPEWD Inland Fisheries chief Lonnie Peters, this decline in largemouth bass production is typical of many older reservoirs in Texas.

"We plan to introduce Florida bass brood fish into nursery ponds on the lake," said Peters. "The nursery ponds will be constructed with the cooperation of concerned Del Rio citizens in an effort to establish naturally a strain of 'super bass', crosses between Florida and Texas largemouth bass.

"Our hope is a fish which will spawn earlier, have a better chance of survival and grow faster."

Secondly, Peters said that walleye fry are being cultivated for release into the open waters of Amistad within the next few weeks.

"Five million walleye fry is the goal," he said, "and there is a good possibility that this will be reached."

Walleye typically feed on shad and occupy depths in areas where native game fish usually are absent.

Another exotic, the northern pike, has already been found in Amistad, presumably from upstream stockings in New Mexico lakes.

In a third effort, the TPEWD will hatch and culture pike fingerlings to be stocked in Amistad from eggs obtained in Nebraska from the U.S. Fish and Wildlife Service.

Striped bass spawning is likely unstream in the Rio Grande or the Pecos and Devil's Rivers when the fish mature some three years from now.

"But in order to improve the striper fishery by providing a food supply, we also plan to improve the standing crop of small forage fish in Amistad," said Peters. "Threadfin shad and the tidewater silversides will be stocked, both of which are important forage species, as the fourth improvement."

Threadfin shad are plankton feeders and occupy open waters. The shad are very prolific and never outgrow their usefulness as forage fish.

The silversides also is prolific and is an important forage species in many Texas waters.

Future introduction of small-mouth bass is being considered, possibly this year depending on supply. Smallmouths should do well in the waters along the rocky shoreline of Lake Amistad.

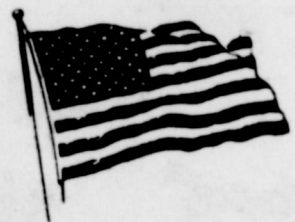

### Krueger Opposes PO Closing Plans

Congressman Bob Krueger of the 21st District today announced his opposition to any attempt by Congress or the U. S. Postal Service to close 3rd and 4th class post offices. Krueger stated, "It is vitally important that the quality of life in rural America is in no way depleted. When small town post offices are closed not only the town itself, but the whole surrounding area suffers. Post offices in these towns are often the focal point of social contact. I will fight to see that the present law which prohibits the closing of small post offices for purely economic reasons is not changed.

"I think that there are other ways to help the economy of the postal service without closing small town post offices," Krueger continued.

His comments came in response to a recent proposal made to Congress by the General Accounting Office which would see 12,000 3rd and 4th class post offices closed across the nation. When contacted about the proposal, a Postal Service spokesman said that the Postal Service would make no move until Congress took some definite action to change the existing law that forbids the closing of such post offices for economic reasons.

**Report of  
BOB KRUEGER  
U.S. Representative**

There has been considerable concern in recent weeks about the CIA and this country's intelligence-gathering activities. Several observations should be made: (1) This nation needs centralized intelligence regarding the activities of foreign nations. Therefore we need some such agency as the CIA. (2) The CIA or any federal agency must adhere to the law. Our law gives the FBI responsibility for domestic intelligence, and restricts the CIA to foreign intelligence. For the CIA to be used domestically violates the law and infringes on the rights to privacy of American citizens. (3) The CIA should not engage in assassinations. If the leaders in our country are to make decisions that take the lives of others, those decisions must be made in open forum through public declarations of war. They should not be made in secret by people who have been appointed, not elected, to the positions they hold.

Such actions violate our deepest sense of the need for public responsibility and public accountability upon which confidence in democracy depends. If our democracy requires assassination as a tool of foreign policy, it has fallen on very perilous times. Such actions imply that our democratic institutions are weak, and require subversive means to be sustained. I do not believe that the American people have so little confidence in their own institutions.

Recent misuse of the CIA for domestic activities has weakened its effectiveness abroad. By concentrating on dissidents at home, the CIA gave less attention than before to activities in Portugal and Italy. Now, Portugal has a government that is increasingly friendly to the Communists. In Italy, the Communist Party won 33% support in this week's elections, just two percent less than the ruling party. Both countries are NATO members, and thus NATO, our Atlantic alliance, is weakened.

We need to get the CIA back full time to its task of

**AUSTIN** — Texas may run out of money for new highways, according to State Highway Commission Chairman Reagan Houston.

Houston said the financing picture for road building is critical.

"Costs are rising and available financing is not adequate," the Chairman told Texas Good Roads and Transportation Association.

The time may come, he warned, when the state can afford outlays only for maintenance and operation of its highways.

A new study, Houston said, will examine "the widening gap between needed construction and gathering intelligence on foreign nations, not domestic troublemakers. I hope that better direction for the agency may come from the two Congressional committee investigations of CIA activities.

This past week, Congressman Nedzi was sustained by an overwhelming vote as Chairman of the House Committee investigating the CIA. I voted to sustain him as the chairman because he has a long tradition of service to his country and of integrity as a legislator. I personally felt that the House did not need to establish its own special committee. The House already has more than enough committees, and more than enough duties to occupy its members. Further, the Senate had already established its committee. If the House committee continues, it must exercise oversight of the CIA and assure that our foreign intelligence is sound and our own rights to privacy secure. If these goals are furthered, the special committee will have served us well.

available revenue... the desire for higher levels of transportation service, as well as the need to demonstrate to the public benefits of proposed projects.

New legislation signed by Gov. Dolph Briscoe merged the Highway Department and Mass Transportation Commission into the State Department of Highways and Public Transportation.

**Park Enlarged**

The state completed purchase of land, nearly tripling size of Lyndon B. Johnson State Park near Stonewall.

A couple accepted \$336,339 for the 133.9 acres of land across the Pedernales River from the late President's ranch. Cost of enlarging the park from its original 269 acres to 717.8 acres will total more than \$1 million.

**Allowable Set**

For the 40th straight month, the Texas Railroad Commission extended the wide-open, 100 per cent oil allowable for July.

However, the East Texas field was again restricted to an 86 per cent allowable. Nominations of major purchasers decreased 2,821 barrels—to 4,018, 347 barrels daily.

**Pool Organized**

A risk-sharing pool, authorized by the legislature, was organized last week to help provide a temporary solution to the medical malpractice insurance crisis.

The pool will not begin issuing policies until a plan of

operation is approved by the State Insurance Board.

The Joint Underwriting Association was instructed to have the operating plan ready by July 7. August 3 is the target date assigned by Insurance Board Chairman Joe Christie to place the pool in full operation. The new law directs that it actually be provided insurance to doctors and hospitals by September 1.

**Courts Speak**

Asking the State Supreme Court to restore an injunction prohibiting a Bell Telephone Texas long distance rate increase, Atty. Gen. John Hill said the company openly claims "unlimited power" to set any rate it wants on such calls.

Third Court of Civil Appeals struck down a district court order that Oak Cliff Savings and Loan Association cannot change its name to First Texas Savings Association.

A Dallas man, through an appeal to the Court of Criminal Appeals, received a new trial on charges of burning a two-year-old child.

Another Dallas case — for murder — was reversed, on grounds evidence which resulted in a man's life sentence was too weak.

**AG Opinions**

Interest from funds transferred to Angelo State University on dissolution of Tom Green County Junior College District may not be used to supplement the president's salary, Attorney General Hill held.

In other recent opinions, Hill concluded:

A district judge would be prohibited from appointing his grandnephew to represent an indigent defendant if compensation is paid from public funds. Also, a district judge should not appoint the district probation officer to represent a defendant in a criminal case.

A two-mile spacing rule for beeyards is valid if

necessary to control spread of honeybee diseases.

Unemployment compensation records are, in general, available under the open records act to employing units and claimants.

**Appointments**

Governor Briscoe appointed Pedro A. Mendoza of McAllen to the Commission on Fire Protection Personnel Standards and Education.

Mrs. Peggy D. Gutierrez of Laredo was named by the Governor to the Texas Cosmology Commission.

James M. Bailey of Fort Worth will serve as chairman of the 1975 State Textbook Committee.

Sen. D. Roy Harrington of Port Arthur will serve as chairman of a special artificial reefs committee of the Coastal and Marine Council to develop artificial reef programs for Texas bays and inshore Gulf areas.

**Short Snorts**

Agriculture Commissioner John C. White is the new president of the Southern Association of State Departments of Agriculture.

Seventeen new industries located in Texas during May and will pump an additional \$40 million into the state's economy. They will also create 1,500 new jobs and generate \$250 in taxes.

Tyler, Devine, Fort Worth, Eagle Pass, Cameron and Mount Vernon received community achievement awards from the Beautify Texas Council.

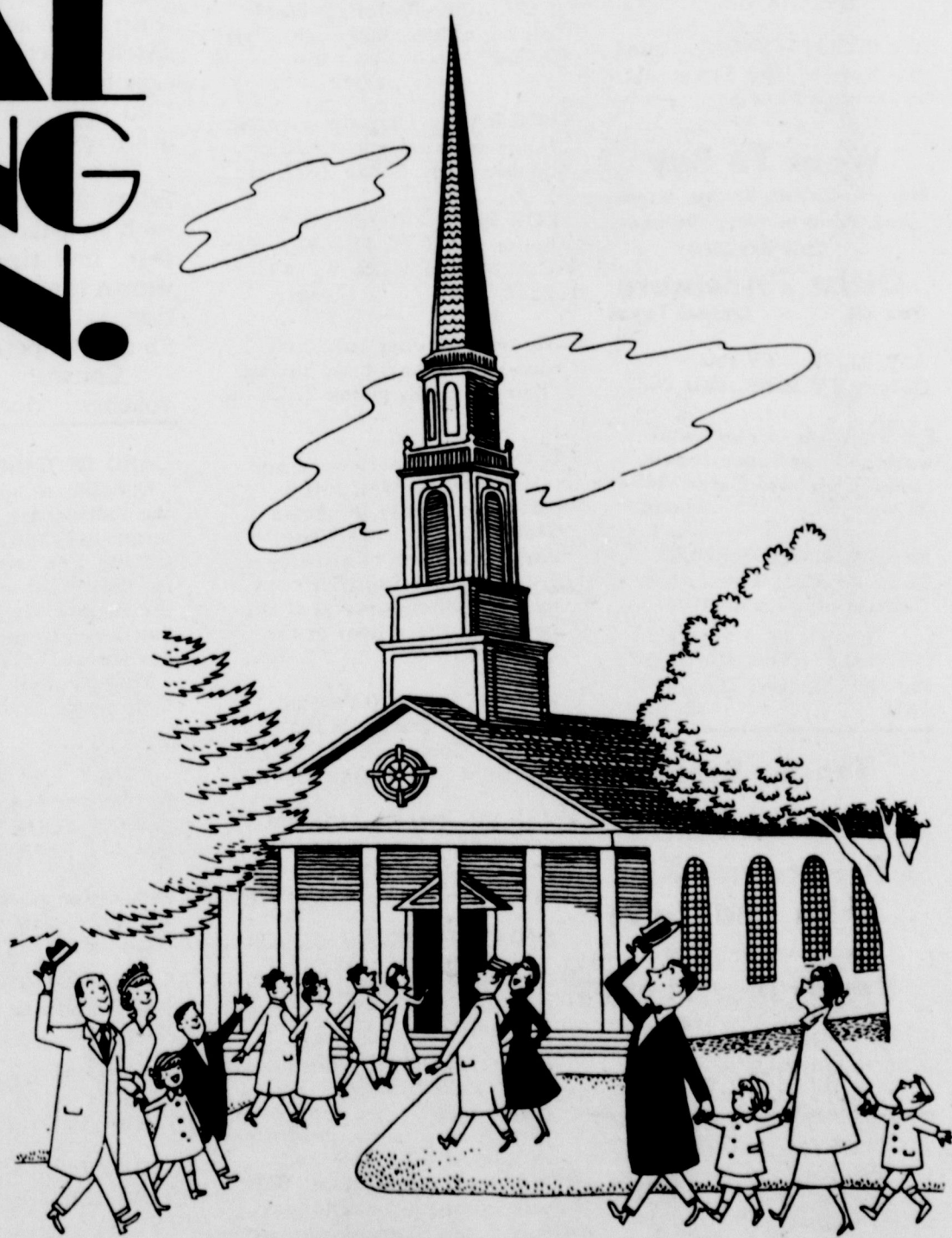

### Cockroach Control Needs Better Use of All Methods

Have you ever reopened a package of food and had a fat cockroach scuttle out? Or reached for a glass of water to find a roach had fallen in it? If so, you know the feeling of revulsion and frustration felt by anyone forced to share living quarters with these pests.

Roaches thrive on all kinds of filth and are suspected carriers of diseases. Because of these things, roaches are so universally detested that staggering amounts of insecticide are used by homeowners in their control.

Entomologists with the Experiment Station say

that insecticides used for roach control are often mismanaged, overused and even used unnecessarily in many cases. Frequently their use becomes routine regardless of actual need.

One of these research entomologists, Dr. Gary Piper, is a member of a team of entomologists developing an integrated control program for several kinds of urban roaches in Texas and other Gulf Coast States. (Integrated control means use of a coordinated program of chemical, biological and environmental control methods.)

In other words, don't

rely only on chemicals. Use the natural enemies of the roach to help discourage and control them.

The Environmental Protection Agency is funding this study being made by Experiment Station scientists in order to improve existing control methods and find other supplemental techniques not dependent on the use of synthetic insecticides.

To do this, Piper says basic research is being done on general habits of roaches, their behavior, "preferred hangouts", breeding habits, annual life cycle and natural biological enemies such as predators and parasites.

This information is furnishing the basis for developing ways to trap roaches, to eliminate places roaches like to live, and to aid their natural enemies as well as use selective chemical treatment for control. These additional controls will ease the need for massive insecticide use.

One of the oldest and most successful methods of controlling insect pests is to use their natural enemies to attack and destroy them.

"In order to develop our integrated control program," Piper says, "we're checking every roach enemy we can discover. They're being studied for their potential as both short and longterm regulators of roach numbers in both indoor and outdoor situations.

For example, we're studying the behavior and control potential of a beneficial tiny wasp which parasitizes cockroach egg cases. These wasps are harmless to humans and wildlife; they only attack roaches. The adult female wasp lays her eggs in a roach egg case. The wasp eggs hatch, and the larvae feed on and eventually destroy the roach eggs.

"About 70 wasps develop in and emerge from such an attacked egg case. Our investigations have shown that the parasitization rate varies between 25 and 75 percent.

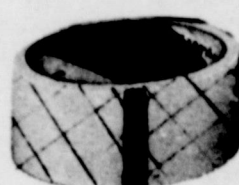

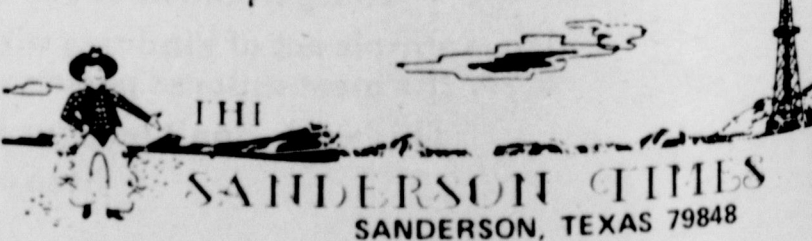
