

The members of the board of trustees of the Terrell **County Independent School** District met in regular session Monday night.

The business conducted, as reflected by the minutes, included the following:

Approved the minutes, financial statement, and bills presented; approved a new dress code for students; namec Sanderson State Bank as the depository; accepted the resignation of James L. Payne as high school principal; named Gandy's as low bidder to furnish milk; approved continu-ation of the Title I program in 1975-76; approved Mrs. W.C. Baker and Paul Cantrell as bus drivers; approved Thos. Y. Pickett Co. as valuation engineers for oil and gas properties in Terrell County; set the tax rate at \$1.40 for local maintenance and \$20 for interest and sinking fund; set August 18 as the date for the public hearing of the budget for the next school year; authorized Supt. C.B. Card to advertise for bids for remodelling the school tax office; approved corrections on the tax rolls for double assessments and renditions; approved new personnel contracts including those of William Anders as the new high school principal, Homer Bruton, math teacher, Mrs. Homer Bruton, homemaking teacher, Mrs. Will J. Murrah and Mrs. C.B. Card for Title I reading program, Mrs. E.J. Hanson, school nurse, Mmes. Eleno Marquez, Armando Esqueda, W.W. Sudduth, and R.M. Hunn, as teacher aides.

The Allison(detrital) field of Terrell County gained its seventh producer and a 5/8 mile northeast extension with completion of Gulf Oil Corp. No. 1-C Annie Garner, 10 miles southeast of Sheffield, for a calculated, absolute open flow of 1.7 million cubic feet of gas per day.

Production was through perforations at 8,866 feet to 8,995 feet, which had been acidized with 6,000 gallons.

Location is 660 feet from the south and 990 feet from the west lines of 11-B2-CCSDE-RGNG.


The classes meeting in the Methodist Church will include from grade 7 through adults. This is the first time that the adults have been included in the school.

The decrease was possible due to an increase in valuations of taxable property by \$3.5-million, according to Supt. C.B. Card.

Flood Insurance Now Available

The U.S. Department of Housing and Urban Development announced that effective July 22, 1975, Sanderson, Texas, has been accepted into the National Flood Insurance Program.

This means that individual property owners here are now eligible to buy flood insurance protection at affordable federally-subsidized rates, offering more expensive coverage

Since flood insurance is now available the law requires that it must be purchased by owners of property in areas identified as floodprone by HUD, in order to be eligible for virtually all forms of federal or federallyrelated financial assistance for building purposes in those

"This would include FHA

vised banks and savings and loan institutions."

While flood insurance is available to all residents of the community that the federal economic sanctions against building assistance will not apply to property outside the danger zones.

Under the expanded program, broader coverage can be obtained for all buildings and their contents. The limit of insurance for single-family homes is now \$35,000, and \$100,000 for other residential and nonresidential buildings, at the subsidized rate of 25 cents per \$100 of coverage. The rate goes to 40 cents per/\$100 for nonresidential buildings.

The contents of all residential buildings can be insured up to \$10,000 per unit at 35 cents per \$100 of coverage, and the rate goes to 75 cents per \$100 for the contents of all nonresidential structures up to a maximum of \$100,000 in coverage per unit.

The FIA is in the process of publishing maps showing the special flood hazard areas in approximately 20,000 communities across the country. He congratulated the local governing body here for taking action before the July 1, 1975, deadline imposed under the Act for enrolling in the program.

The program is designed to stimulate individual participation in it as protection against natural disasters, and to help promote sound flood plain management on the part of local governing authorities.

In becoming eligible under the program, a community must submit an application in which it certifies that it has adopted certain minimum flood plain management measures for the flood-prone areas of that community which conform with Federal requirements. These measures vary according to the

characteristics of the com munity and the nature of specific flood threats. But they are generally designe to regulate the future devel ment of flood hazard area and ultimately require mi mum elevation and constr tion standards for floors an foundations of any new co struction in these areas.

Sportsmen's Guides Available Soon

information on game and fish laws for upcoming seaons is contained in the new "Guide to Texas Hunting 6 Sport Fishing Regulations, 1975-76" soon to be available where hunting and fishing licenses are sold.

This year's 24-page booklet from the Texas Parks and Wildlife Department features county-by-county listings of seasons and bag limits for popular game species along with fishing regulations. Also included is a county locator map to pinpoint any one of the state's 254 counties with specific notes on special game animals and birds which may be hunted in the counties under the Parks and Wildlife Depart-

The production of crude oil and natural gas in 1974 continued to have a significant impact on the economy of Terrell County, with the estimated value of the county's production, royalty payments, and state severance taxes reaching new highs. Terrell was one of 197 coun-

ties -- an increase of four from 1973 -- which produced oil and gas valued in excess of \$100,000 in a year which saw the total value of state production jump from just over \$6.7 billion to almost \$11.4 billion.

The county ranked 123rd in the state in the total value of petroleum produced --\$12.9 million--with \$289,000 of that coming from the sale of 41,253 barrels of crude oil; \$12.6 million from the sale of 43.2 million MCF of natural gas.

This study by the Texas Mid Continent Oil & Gas Association shows that the county's petroleum production last year resulted in the payment of \$1.6 million to royalty owners

The survey also shows that the State of Texas received \$956,000 in production taxes from county wells, with \$13,-000 coming from crude oil output and \$943,000 from natural gas production.

Oil and gas developers and producers spent an estimated \$900,835 drilling 12 wells in the county last year, with 37.6 percent of that figure lost in six dry holes. The total drilling yielded one oil

Economy Of County Pecos East Side Boosted by Oil, Gas Boat Ramp Closed For Re-Building

Boaters who struggle to launch their vessles from the old Highway 90 ramp on the east side of the Pecos River in Amistad Recreation Area will find their task considerably easier within four to six months.



Report of BOB KRUEGER U.S. Representative

THE SANDERSON TIMES

One of the most vexing economic problems facing our nation is the combination of inflation with recession. Among the many explanations of this problem, I'd like to offer my perspective.

When this country was founded, settlers moved into an area, cleared it, planted and grew crops, and then moved on to new locations when the land was ruined. Toward the end of the century, our abundant lands began to play out, and we turned increasingly to technology to allow the continued improvement in our standard of living. By the time World War II, our extraordinary industrial capacity and our unified labor force allowed us to create and mobilize an immensely powerful force, and to emerge from the war undisputedly, the world's industrial and economic leader.

Since that time, however, the output per person in the U. S.A., which had for a number of years greatly excelled that of any other country, has begun to decline. The reason, I believe, is that we have put too much into immediate consumption and not enough into planned investment and capital formation -- the ingredients for a healthy economy for the next generation. The early settlers knew that they could not consume all of their corn at the table; they had to have seed corn in order to plant for future years. The need is no different today.

During the great depression, we stimulated the economy by stimulating consumption; an econmic theory urged by Keynes. But any economic theory has its limits, and we need to recognize that simply stimulating consumption is not enough to deal with the needs of future generations.

One reason that we have combined inflation and recession (especially unemployment) is that our plant capacity is not sufficient to absorb our full work force. If enough capital is not invested in the future, then our productivity does not rise as fast as it should, and shortages occur. We now see shortages in areas auch as steel, energy, mining, and many sectors of manufacturing. The American government, by consistently overspending (our government has run deficits in 14 of the last 15 years), has dried up our capital markets and has discouraged investment for fuure generations. Japan currently invests twice as much as does the United States, and its gross national product grows at twice the rate of ours. Further, the growth in productivity of the Japanese worker has been three times as great as that of the American worker in the past 13 years. Merely stimulating consumption will do nothing for long-term economic growth unless a significant portion of spending is directed toward increasing the productive capacity of the nation. If there is a moral for us in our experience of combined inflation and recession, it is that we must give attention 's seed corn as well as table com. We cannot simply live or today and for ourselves ithout thinking of the needs of our own future and that of our children. Not only must the government cease spending more than it takes in, but it should follow tax policies that encourage thrift, discipline, and hope, all values at immigrants who settled inis country cherished very dearly. Our pending shortages of natural resources such as oil, iron, aluminum, copper, mean that we must continue to invest in improved technology in order to pay for the natural resources which we will have to import. If we confront this task openly,



Boys' dress - Shirts with tails must be tucked in; shirts must be buttoned to within one button of the throat; boys, 5th grade and above must not wear white undergarments as shirts.

Girls' Dress - No halter tops: no see-through blouses or midriffs; girls will be allowed to wear tank tops but from the 5th grade up they must wear a shirt or blouse over the tank top. Blouse or shirt over tank top may be worn outside of pants or skirt; girls must wear undergarments.

All students must wear shoes and socks or sandals.

Drop In Lambs, Sheep on Feed

The number of sheep and lambs on feed in Texas as of July 1 was down two per cent from a year ago, Agriculture Commissioner John C. White has announced.

Following the pattern of previous years, there was a significant drop in the number of animals going into drylot feed operations between March 1 and July 1. This drop is the result of better grazing conditions and reduced demands for sheep and lambs.

The 1975 drop was 26%, from 170,000 in March to 126,000 on July 1. This compares with a 48% decrease in 1974 when the totals fell from 240,000 to 129,000.

Marketings of fed sheep during March through June were 26% below last year. Figures dropped from 219,000 in 1974 to 162,000 this year.

Current marketing intentions for the next three months call for 48,000 head to be placed on feed in July, 47,000 in August, and 31,000 in Septem. ber. However, final figures could be substantially higher because additional lambs will be placed on feed early in the period and marketed later in the period.

New Warranty Laws for Fiber

Consumers can look forward to more explicit warranties from fiber manufacturers who offer warranty programs on their products, Claudia Mitzel. consumer information - clothing and textiles specialist, reported this week.

The new law, effective July 4, 1975, does not make warranties mandatory. It does set standards that manufacturers must follow if they offer warranties, the specialist with the Texas Agricultural Extension Service Jaid.

"For the consumer, clothing warranties are an excellent way of insuring a high standard of materials and workmanship. Warranties are found on many types of clothing and some household furnishings.

"If durability is important to the consumer, he should look for those items which carry warranties."

The specialist noted that one major provision of the new law is to distinguish between "limited" and "full" warranties. A full warranty will cover all aspects of fiber, fabric and apparel performances, whereas a limited warranty will not.

"Another requirement the law will effect is the use of the word "guarantee". This word will no longer appear by itself on any hangtags or advertisements. But it may be used if accompanied by the word 'warranty'

"The tags will carry a mandatory printed warning stating protect your warranty, keep the tax and your sales slip'."

The specialist said that setting up procedures and regula-tions for this new law will take about a year.



White is waging a kind of crusade to alert Texas officials and news media representatives what to expect and trying to rally lastditch opposition.

The act, White emphasizes, would mean far more than federallymonitored voter registration and election procedures.

It would also require that every change in state voting laws, all legislative and local boundary line redistricting and even municipal annexations affecting voting precinct makeup would have to be approved by the U.S. attorney general.

White says Texas has done everything called for in the federal bill to protect voting rights — including passage of a law requiring bilingual ballots and registration materials.

However, the state still would be brought under the act, due to a retroactive provision. That section applies the law to states where fewer than 50 per cent of voting-age adults were registered in 1972 or voted in the last presidential election.

White insists there is no substantial evidence of voting rights violations in Texas, and that applying punitive provisions of the act to the state is an injustice, "a fraud and an insult."

The first impeachment action in 44 years was launched in the House--against 229th District Judge O. P. Carrillo of Duval County.

A select committee unanimously approved a resolution containing 11 articles of impeachment. The House will recovene August 4 at 10 a.m. to consider the resolution. If it, or any similar version, is approved, the Senate will be called into session within about a month to sit in trial of Carrillo.

Courts Speak

Third Court of Civil Appeals held big corporations cannot decrease their franchise tax debt to the state by manipulation of subsidiaries. The case is expected to mean \$24.4 million in additional state revenue. Texaco Inc. brought the action for return of taxes paid under protest.

Texas prosecutors were told by the Court of Criminal Appeals they cannot make a big issue when an accused person refuses to testify during trial. The Court ordered reversal of a life sentence given a Waco man for rape.

Wire Taps Checked

The Criminal Justice Division of the governor's office plans a check of city police and county sheriffs to see they aren't doing illegal electronic surveillance with equipment purchased with federal funds channeled through CJD.

A total of 28 grants have been received to buy \$100,000 worth of equipment.

Audits followed an inquiry from the U. S. Law Enforcement Assistance Administration.

A state appropriations bill rider prohibits use of any appropriated funds, including federal money, to buy wire-tapping devices.

The Department of Public Safety has some equipment used in electronic surveillance of organized crime, but funds to buy it did not come through CJD. DPS spokesmen said the Department does not make a policy of tapping telephone lines. where Mr. Harkins will do post-doctorate research in social psychology.

One of the most vexing economic problems facing our nation is the combination of inflation with recession. Among the many explanations of this problem, I'd like to offer my perspective.

When this country was founded, settlers moved into an area, cleared it, planted and grew crops, and then moved on to new locations when the land was ruined. Toward the end of the century, our abundant lands began to play out, and we turned increasingly to technology to allow the continued improvement in our standard of living. By the time World War II, our extraordinary industrial capacity and our unified labor force allowed us to create and mobilize an immensely powerful force, and to emerge from the war undisputedly, the world's industrial and economic leader.

Since that time, however, the output per person in the U. S.A., which had for a number of years greatly excelled that of any other country, has begun to decline. The reason, 1 believe, is that we have put too much into immediate consumption and not enough into planned investment and capital formation -- the ingredients for a healthy economy for the next generation. The early settlers knew that they could not consume all of their corn at the table; they had to have seed corn in order to plant for future years. The need is no different today.

During the great depression, we stimulated the economy by stimulating consumption; an econmic theory urged by Keynes. But any economic theory has its limits, and we need to recognize that simply stimulating consumption is not enough to deal with the needs of future generations.

One reason that we have combined inflation and recession (especially unemployment) is that our plant capacity is not sufficient to absorb our full work force. If enough capital is not invested in the future, then our productivity does not rise as fast as it should, and shortages occur. We now see shortages in areas uch as steel, energy, mining, and many sectors of manufacturing. The American government, by consistently overspending (our government has run deficits in 14 of the last 15 years), has dried up our capital markets and has discouraged investment for fuure generations. Japan currently invests tarice as much as does the United States, and its gross national product grows at twice the rate of ours. Further, the growth in productivity of the Japanese worker has been three times as great as that of the American worker in the past 13 years. Merely stimulating consumption will do nothing for long-term economic growth unless a significant portion of spending is directed toward increasing the productive capacity of the nation. If there is a moral for us in our experience of combined inflation and recession, it is that we must give attention 's seed corn as well as table corn. We cannot simply live or today and for ourselves ithout thinking of the needs of our own future and that of our children. Not only must the government cease spending more than it takes in, but it should follow tax policies that encourage thrift, discipline, and hope, all values at immigrants who settled inis country cherished very dearly. Our pending shortages of natural resources such as oil, iron, aluminum, copper, mean that we must continue to invest in improved technology in order to pay for the natural resources which we will have to import. If we confront this task openly,



The House Interior Committee today (July 15) defeated H.R. 3510, The Land Use and Resource Conservation Act of 1975, by a vote of 23 to 19, with one absention.

Drop In Lambs, Sheep on Feed

The number of sheep and lambs on feed in Texas as of July 1 was down two per cent from a year ago, Agriculture Commissioner John C. White has announced.

Following the pattern of previous years, there was a significant drop in the number of animals going into drylot feed operations between March 1 and July 1. This drop is the result of better grazing conditions and reduced demands for sheep and lambs.

The 1975 drop was 26%, from 170,000 in March to 126,000 on July 1. This compares with a 48% decrease in 1974 when the totals fell from 240,000 to 129,000.

Marketings of fed sheep during March through June were 26% below last year. Figures dropped from 219,000 in 1974 to 162,000 this year.

Current marketing intentions for the next three months call for 48,000 head to be placed on feed in July, 47,000 in August, and 31,000 in September. However, final figures could be substantially higher because additional lambs will be placed on feed early in the period and marketed later in the period.

New Warranty Laws for Fiber

Consumers can look forward to more explicit warranties from fiber manufacturers who offer warranty programs on their products, Claudia Mitzel, consumer information - clothing and textiles specialist, reported this week.

The new law, effective July 4, 1975, does not make warranties mandatory. It does set standards that manufacturers must follow if they offer warranties, the specialist with the Texas Agricultural Extension Service said.

"For the consumer, clothing warranties are an excellent way of insuring a high standard of materials and workmanship. Warranties are found on many types of clothing and some household furnishings.

"If durability is important to the consumer, he should look for those items which carry warranties."

The specialist noted that one major provision of the new law is to distinguish between "limited" and "full" warranties. A full warranty will cover all aspects of fiber, fabric and apparel performances, whereas a limited warranty will not.

"Another requirement the law will effect is the use of the word "guarantee". This word will no longer appear by itself on any hangtags or advertisements. But it may be used if accompanied by the word 'warranty'.

"The tags will carry a mandatory printed warning stating 'protect your warranty, keep the tax and your sales slip'."

The specialist said that setting up procedures and regulations for this new law will take about a year.



White is waging a kind of crusade to alert Texas officials and news media representatives what to expect and trying to rally lastditch opposition.

The act, White emphasizes, would mean far more than federallymonitored voter registration and election procedures

It would also require that every change in state voting laws, all legislative and local boundary line redistricting and even municipal annexations affecting voting precinct makeup would have to be approved by the U.S. attorney general.

White says Texas has done everything called for in the federal bill to protect voting rights - including passage of a law requiring bilingual ballots and registration materials.

However, the state still would be brought under the act, due to a retroactive provision. That section applies the law to states where fewer than 50 per cent of voting-age adults were registered in 1972 or voted in the last presidential election

White insists there is no substantial evidence of voting rights violations in Texas, and that applying punitive provisions of the act to the state is an injustice, "a fraud and an insult."


Short Snorts


