Now all of us know that money doesn't matter nearly so much as good health and good friends -- and I sincerely mean that -- but money is a nice thing to have around when the bills come in, and it's pretty nice to have anyway so long as we don't worship the dollar. (Remember the finance com-

pany ads on television a few years ago where this guy said, "All the happiness in the world won't buy you any money"??) Anyway, the Kiplinger people, who publish the Washington Letter, Changing Times, and some other economic publications, said in a Jan. 21 letter:

"The boom of the 60s--the biggest on record -- will be followed in the late 70s by a new and perhaps even bigger boom. And with it, more inflation."

They go on to say that al-though the short-range prosects don't appear too boomy (that's my word, not theirs), they are predicting a new boom and more inflation in the years ust ahead. They point out that in 1935 during the depression they predicted inflation ahead, and in 1946 renounced the wide-ly-held view that a severe postwar depression was inevitable.







Clymer warns that late corn plantings are especially subject to severe attack by second generation borers at a criof the plants. He suggests planting as early as possible with early - maturing varieties to # minimize crop damage. In the Panhandle and other colder areas, double disking or plowing corn stubble exposes the borers to drying and freezing temperatures and allowsalmost complete overwinter kill, if wind erosion is a problem, the entomologist suggests listing the soil, which also prepares it for good retention of any winter rainfall. If no cultural practices are used in the fall or winter, the larvae will overwinter in the stalks below ground level. Later on, farmers can usually gain some control by deep plowing in the spring to bury the lavvae so the mature moths cannot emerge. Some control can be obtained by deep plowing prior to planting. In-season control is limited to application of chemicals, which must be critically timed because the larvae are safe after they bore into the stalk. Clymer adds that insecticidal control on moderate infestations has not been economical in the tests.



NON-CHEMICAL PEST CONTROL SOUGHT

Cultural control, a fancyname for preventing insect damage without using chemicals, has been found to be the best method of controlling the southwestern corn borer in West Texas.

Information from two years of result demonstrations by the Texas Agricultural Extension Service has shown that various cultural practices have out performed insecticides in controlling the small borers, which hit many American corn producers square in the pocket-

book each year. "In our tests, we found that very little yield increase was obtained through chemical control," reports Dr. Bill Clymer, area entomologist at A marillo,

For the past two seasons, he has worked with county agricultural agents and farmers trying various practices to stop the insect, which can infest 100 cent of the plants in a corn field ano completely prevent grain production.

"Damage is causes by young lants being killed or dwarby borer activity in the stalk," Clymer says, "yield is reduced by extensive tunnelling and tunnelling and

TAXPAYERS ASK IRS

Q) I want to deduct the interest I paid on my department store charge account , purchases, but all my statements show are the "finance charges." Is there any way I can figure out the interest?

A) The amount of the finance charges which constitutes interest can be deducted. Interest has been defined as money paid for the use of money. However, 'if the interest cannot be ascertained, a deduction for the lesser of six percent of the average unpaid monthly balance of your charge account or the total finance charge allocable to the year may be taken.
