WE NOTICE that The Levelland Sun -News runs a column written by a "Certified Master Graphoanalyst', which sounds like someone who studies the inner workings of record players, or possibly someone who finds hidden meanings in pictures. Actually the author is a handwriting expert, one who can tell something of a person's character by his or her handwriting.

I don't doubt for a minute that such persons can accurately figure out a lot of things about most persons from their handwriting, because they have tested these traits of handwriting thoroughly and know that in most cases they apply. But I doubt that they apply in every case, and I also figure they read so much into some handwriting that its possible they could be entirely wrong.

For example, I read years ago that if you let the lines at the end of your words point downward, this is a sign of low moral character, untrustworthiness and possibly some other undesirable character traits. So I immediately started making sure all my words ended with the lines turing up so everyone who knew anything about analyzing handwriting would think I was a nice fellow. Unfortunately for my reputation, most people didn't seem to know much about the science.

I don't know much about it, either, but I have noticed that most people can't write very plainly. Women, of course, write better than men, probably because men don't consider it all that important to have neat handwriting. Neat script could be a drawback to some people, especially doctors. One of the rules of the American Medical Assn. is that no doctor will be permitted to practice if his handwriting can be read by the average citizen. If you know a doctor who writes neatly, beware - he probably is an impostor.

I remember a segment in the old "Get Smart" series on TV, in which all the top code experts in the free world had worked for months on a captured coded message from the enemy spy group. After they finally admitted defeat, Maxwell Smart went out with the paper for a few minutes, then came back and in and told them what it said. The chief asked Smart how in the world he managed to figure out such an incomprehensible note, and Smart said it was simple - he just took it to his pharmacist.

When I was teaching English to college freshmen (I done my best, but some of them never did learn to talk good) I had a couple of students whose handwriting was totally indecipherable. I suspected they wrote this way on purpose so I couldn't catch all the misspelled words. Finally I suggested the students type their outside papers if they had access to a typewriter. The only trouble with this idea was that some of the typing was harder to read than the handwriting.

The cotton section of the Agriculture and Consumer Protection Act of 1973. which became effective this year, offers far less benefits to participating farmers than did the previous program. And county ASCS personnel across the High Plains fear that some farmers may fail to recognize the improtance of "Signing up" this year.

The concern stems from an abnormally slow sign-up pace this year. Walter Wells, Lubbock County ASCS Of-

fice Manager, reported on June 28 that only about onefourth of Lubbock County farmers had signed to participate in the 1974 program. In previous years the percentage signed up two weeks before the July 15 deadline has been from 50 to 65 percent, he says.

This year's program authorizes disaster payments of about 12, 7¢ per pound times. the farm's established yield if planting is prevented by drought or if crops are lost to hail or other adverse weather. And the same payment may be made on the difference between a
