



# **Highlights From** County H. D. **Agent's Office**

by Mabel Ann Manley The time to plant fall gardens as rolled around. The gardener that plans to plant fall potatoes will find these tips useful. Cover the seed potatoes with gunny sacks and straw and keep them moist until they sprout. Open the ridge that the potatoes are to be planted in late in the evening, just after sundown, is best. Plant the potatoes early in the morning while the ground is cool. Fall potatoes should be planted deep-

er than spring potatoes. Now is the time to plant pole beans, turnips, tender green, and mustard. Fall radishes can be planted about the fifteenth. Leaf lettuce can be planted about the same time. If fall carrots are planted, cover the seed bed with a board to keep the moisture in and help bring the delicate young plants up. When the plants have come through the round remove the boards late in the afternoon and give the bed a gentle but generous sprinkling. The water should be turned on the young plants until the ground is thoroughly soaked. Four-H Club girls in Cochran


LEHMAN COMMON SCHOOL DISTRICT NO. 5 ORDER OF ELECTION TO CONSOLIDATE

SCHOOL DISTRICTS STATE OF TEXAS COUNTY OF COCHRAN

WHEREAS, on the 6th day of August, 1948, a petition was presented to me for an election to be held in the Lehman Common School District No. 5 of this County on the question of determining whether or not a majority of the legally qualified voters of said district desire that Lehman Com-

mon School District No. 5 of Cochran County, shall be consoli dated with Whiteface Independent School District of Cochran County for school purposes; and IT APPEARING that Cochran rtnc County contains a population of 3,735 according to the last United

States Census; and



AUSTIN-Sixty Texans died as the result of appendicitis during the first five months of 1948, ac cording to figures released by the Texas State Department of Health.

"This figure does not appear large compared to the deaths from cancer, tuberculosis and heart disease", Dr. Geo. W. Cox, State Health Officer said, "but with the knowledge that these sixty Texans died needlessly, the figure is tragically high.

More than anything else, Dr. Cox said he would attribute fatal. ity in appendicitis to the complacent attitude of the people concerning the disease. It is not put in its "proper perspective Too often, the Health Officer said people have the vain hope that the prolonged pain in their stom cautioned that the stomach ache which lasts more than three o four hours should be considered

Appendicitis killed 60,000 peo ple in the United States and Canada last year. Dr. Cox said He warned that young adults are especially susceptible to attacks and that appendicitis is a leading cause of death among children and adolescents.

"Operative techniques have been improved to the extent that an unruptured appendix can be removed with great safety," Dr Cox said. "It is therefore apparen that the negligence in appendi citis rests with the patient who fails to seek prompt medical at tention.

He said it was imperative that the patient lie quiet until the doctor comes as moving about disturbs the inflamed parts. He strongly urged against taking laxatives in cases of suspected appendicitis.

H. J. R. No. 7 HOUSE JOINT RESOLUTION proposing an Amendment to Article IV, of the Constitution of the State of Texas, by adding a new Section to be known as Sec-tion 3a, so as to provide for succession to the office of Governor in the event the Governor-elect dies, or becomes disabled, or fails to qualify, before taking his onth of office as Governor; and providing for the issuance of the necessary proclamation and publication by the Governor. BE IT RESOLVED BY THE LEGISLA-TURE OF THE STATE OF TEXAS: Section 1. That Article IV of the Con-stitution of the State of Texas, be and the same is hereby amended, by adding another Section 3a, to read as fol-lows: "Saction 5a. If at the time the Legisla-

If, at the time the Legisla-ture shall canvass the election returns for the offices of Governor and Lieutenant Governor, the person receiving the highest number of votes for the office of Governor, as declared by the Speaker, has died, then the person having the highest number of votes for the office of Lieutenant Governor shall act as Governor until after the next general election. It is further provided that in the event the person with the high-est number of votes for the office of Gov-ernor, as declared by the Speaker, shall become disabled, or fail to qualify, then the Lieutenant Governor shall act as Gov-ernor, as declared by the Speaker, shall become disabled, or fail to qualify, then the Lieutenant Governor shall act as Gov-ernor until a person has qualified for the office of Governor, or until after the next general election. Any succession to the Governorship not otherwise provided for in this Constitution, may be provided for in this Constitution, and shall, during the entire term to which he may success, bu under all the restrictions and inhibitions imposed in this Constitution on the Governor." Sec. 2. The foregoing Constitutional Amendment shall be submitted to a vote of the qualified voters of this State at a General Election to be held throughout this State on the date provided by law in the month of November, A. D. 1948, at which election all ballots shall have printed thereon: "FOR the Constitutional Amendment monthis for a succession in,"

the month of Norman shall have printed which election all ballots shall have printed "FOR the Constitutional Amendment providing for gubernatorial succession in the event the Governor-elect dies, or be-comes disabled, before qualifying and for such succession in other contingencies." "AGAINST the Constitutional Amend-ment providing for gubernatorial succes-ior becomes disabled, before qualifying and for such succession in other contingencies." "Each voter at such election shall mark out one of such clauses on the ballot, leav-ing the clause expressing his vote on the proposed amendment. Sec. 3. The Governor of the State of Texas shall issue the necessary proclama-tion for said election and shall have the sume published as required by the Consti-tution and Laws of this State.


