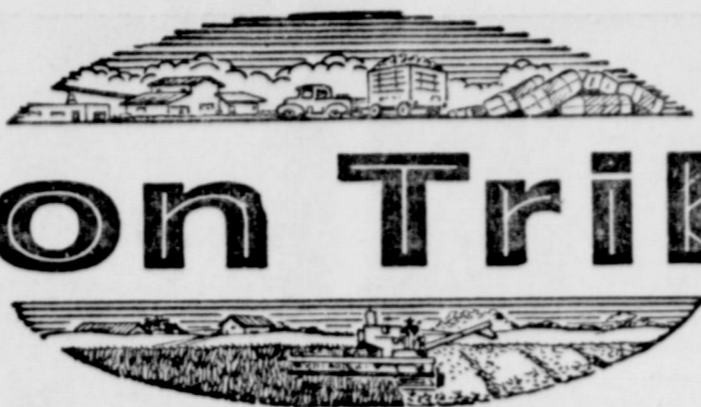

Chamber to hold one-day membership drive



An intensive one-day membership drive was outlined by directors of the Morton Area Chamber of Commerce during their regular meeting Monday evening in the Chamber office. The drive will be held Wednesday, Dec. 11, beginning with an 8:30 a.m. kick-off meeting in the Chamber offices.

Directors will meet at 5 p.m. Monday, Dec. 12, to make final plans for the drive.

Prospective members, both business and individual, will be assigned to small teams of directors and Chamber members to assure that all prospects are contacted during the one-day effort to widen support for the Chamber.

A brochure is being prepared which will list all Chamber accomplishments during 1966, plans for 1967 activities and a budget plan for the coming year.

Plans also were outlined for a unique Fourth of July celebration in Morton next year. Incoming president Rusty Reeder told directors of plans to hold the First International Championships for utility pole climbers and stickmen.

Drawing enthusiastic response was his proposal to hold a two-day contest for all high-pole climbers and workers. Included in the tentative program are six contests. These contests will be supplemented by other activities on the holiday.

Tabled until January was a bill for \$18.12 to pay for new lights and repair on the community Christmas decorations. Other bills were approved for payment.

Mrs. Truman Doss was named head of a newly-formed greater committee to welcome new residents to the community.

President George Hargrove read a letter from the West Texas Chamber of Commerce, seeking information of a local Women's Activities Committee and a representative of the local Chamber to the WTCC women's activities committee. Manager Leon Kessler was instructed to review the need and scope of such a committee and report at the next meeting.

Public housing, Urban Renewal clarified

The public housing story, which appeared in last week's issue, has a few points which were not stated, including the cost of the programs included and the programs.

Programs were discussed at the meeting, including Urban Renewal and Public Housing. The Urban Renewal program is undertaken, a referendum is required. No referendum is required, unless petitioned, for public housing.

Urban Renewal, which was discussed and will not be acted upon until the work on the courthouse is finished, can include: city beautification, flood control, air pollution, etc. This program costs the city 25 per cent of the bill, which is credited by projects in the city, school and county projects within the city limits. In some instances, the project would cost the city a cent.

Public Housing costs the city 25 per cent and involves the building of housing.

Post Office offers suggestions for mailing Christmas packages

Airmail cards and parcels should be mailed to Servicemen overseas no later than December 10 to assure before Christmas delivery. Don't forget to use ZIP Codes on all your Christmas mail . . . in both the address and the return address . . . only you can put ZIP into your postal system.

All gifts should be packed in sturdy boxes . . . Cardboard boxes should be wrapped in heavy paper and tied with strong cord. Don't let any gifts rattle around in your Christmas mail packages. Sufficient cushioning is important to give the box strength. There may be a set of encyclopedias shipped in the box on top of yours.

Each package you mail should include a slip showing the person receiving your Christmas gift and listing the contents. In case outer wrapping of package comes loose your gift will still be delivered. In addition to articles normally prohibited in the mails, matches and lighter fluid may not be mailed overseas to military addresses. Make sure your addresses are

written or printed clearly and that they are complete. Don't let your mail end up in the Dead Letter Office because your handwriting can't be read.

Gift parcels to distant States should be mailed by early December, and those for local delivery by December 15. Don't forget that under normal conditions there is no delivery of cards and letters on Christmas Day other than Special Delivery.

Greeting cards with a five-cent stamp may be sealed and contain written messages. They are given priority in delivery and forwarding. Remember to mark all mail for which you have paid special charges with the type of handling it should get (Airmail, Special Delivery, Special Handling, etc.)

BALLOTS

Referendum ballots must be postmarked by December 9

Friday, Dec. 9, is the final day to vote in the mail-out cotton referendum concerning the proposed research and promotion act which, if passed, would impose a charge of \$1 per bale on cotton producers.

The ballots, which were mailed out Dec. 2, must be postmarked not later than Dec. 9.

The act is set up to "enable cotton growers to establish, finance and carryout a coordinated program of research and promotion to improve the competitive position and to expand markets for cotton."

Passage requires two-thirds vote or majority vote of producers who also produce two-thirds of the cotton represented in the vote.

If the producers approve the order in the referendum, the order will be issued by the Secretary of Agriculture and it is planned that the \$1 per bale assessment will start at the beginning of the growing

season for the 1967 crop. A complete copy of the order has been published in the Federal Register and may be obtained at the ASCS county office.

Any producer who does not care to support the research and promotion program may obtain a refund of assessments paid by making written application to the Cotton Board. A producer will be given a period of at least 90 days after payment of the assessment to apply for a refund. The refund will be made within 60 days after demand. Information on refunds to individual producers will be treated as confidential.

The research order will be administered by a Cotton Board composed of representatives of cotton producers. Members of the Cotton Board and their alternates will be selected by the Secretary of Agriculture.

The Board will enter into contracts for research and promotion,

Faulty Indian offense loses

Morton has won five basketball games this year and lost two. The Indians absorbed their second loss at the hands of the rugged Plains Cowboys in the spacious Cowboy gym Tuesday night, 38-54.

That was the second time the Cowboys have given the Indians a lesson in aggressive basketball and the only difference was in the slight point spread as the Cowboys won the initial encounter 36-55.

Morton led only once, on an opening basket by Donnie Harvey. And a sparkling rally late in the second period and early in the third narrowed what had been as much as 11 points difference to just one. With 6:02 left in the third quarter, Morton trailed 25-26.

But the Cowboys scored almost at will after that as the Indians

showed a reluctance to drive past midcourt or pass the ball away from a three-on-one press.

After Harvey's opening basket, Plains exploded as Calvin Smith dumped in 12 points and Billy Taylor added four for a comfortable 16-6 edge after one period.

Harvey managed to add a free throw, as did Freddy Thomas and Byron Willis hit a field goal to account for Morton's points.

Morton began to gain a little in the second period as Willis and Harvey hit baskets, while Plains countered with two free throws and a field goal.

As Plains committed its fifth team foul, Morton pulled up. Thomas hit two free throws but two players missed the first charity toss on bonus situations. Smith countered with a goal to make it 22-12.

Rodney Hobson came off the bench and canned a free throw and Lorenzo Green added one from the free throw line.

Harvey hit a long shot and Hobson made a three-point play on a field goal and a free throw, as Morton trailed 19-22 with 13 seconds left in the first half.

But Smith made it a five-point difference as he hit two free throws. That gave the Cowboys a 24-19 margin.

Dick Vanlandingham opened the second half with a field goal and Plains made two free throws. Then the Morton fans saw hope as Moore hit a basket and Thomas made two free throws in just 43 seconds. That left Morton trailing 23-26 with 6:02 left in the third period.

Thomas fouled out with 5:36 left

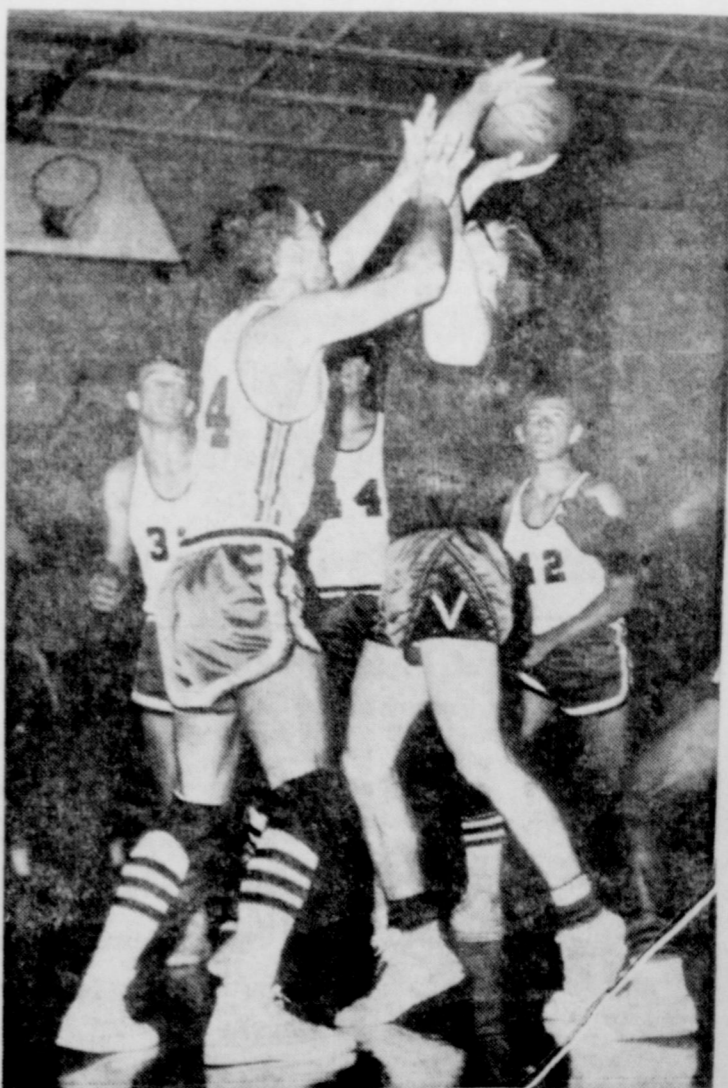

About the only memorable thing in that stretch was that Calvin Smith missed a free throw, the only one in nine attempts during the game.

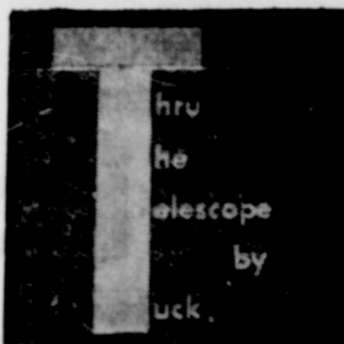

Calvin Smith dominated the scoring with 28 points on ten field goals and eight free throws. And he spent considerable time on the bench in the second half. Harvey and Willis had eight each for Morton.

The Morton B team made it seven in a row in the first game, as they downed Plains 42-26. They led 13-6, 23-6 and 29-20 at the stops. Rusty Rowden topped the scoring with 11 points, while Kennedy had 10 for Plains.

provided such majority produced more than 50 percent of the cotton during the representative period designated for the referendum.

In November Democratic Congressman W. R. (Bob) Poage of Waco said he thought the attitude of Congress on future cotton programs would be profoundly affected by the decision of farmers on the dollar-a-bale research and promotion program.

He said, "If farmers show by their votes (on the referendum) that they are ready to give up on cotton, I think the Congress will be ready to give up too."

"As things now stand," Poage said, "under the emergency four-year program in effect — the government has gone just about the last mile in making cotton competitive in price, in the domestic as well as the foreign market."

He noted that payments to protect the cotton farmer's income, most price competition and reduce the surplus are substantial. He noted that a typical farmer who diverted the maximum 35 percent of his allotted acres in 1966 received over \$70 per bale produced in direct government payment.

UNTIL CHRISTMAS on the outside of a Christmas package that goes through the mails. If a letter is enclosed it must be noted outside the package and first-class postage should be paid for the letter, in addition to the parcel post rate.

During the week just before Christmas long distance gifts and greeting should be sent by air-mail to assure on time delivery. You can help the post office by separating greeting cards into local and out-of-town bundles.

Check the return addresses of the people who send you gifts and greeting cards and add their ZIP Codes to your mailing list. Zip Code your responses to them for better mail service.

Special Christmas hours are in effect at the post office. They are Monday-Friday 9:00 a.m. to 5:30 p.m., Saturday 9:00 a.m. to 12:00 p.m.

Using the new Christmas stamp as postage for your greeting cards assures first-class service and decorates the envelopes too.

This time of the year there are quite a few temporary postal employees delivering mail. You can help them by making sure your address number is not covered so they can easily identify your building.

of low cost housing. Urban Renewal, when it involves large scale slum clearance, is almost impossible to undertake without Public Housing, provided there is not suitable housing for the families that would be displaced in the slum clearance. This displacement and subsequent necessary relocation would necessitate Public Housing.

All of these measures have only been discussed by the City Council and no action has been taken except for the publication of the intention of the City of Morton to enter into a cooperative agreement with the Housing Authority of Morton. This notice is necessary if Morton is to have Public Housing, which in turn will probably be necessary before Morton can have an Urban Renewal program of slum clearance.

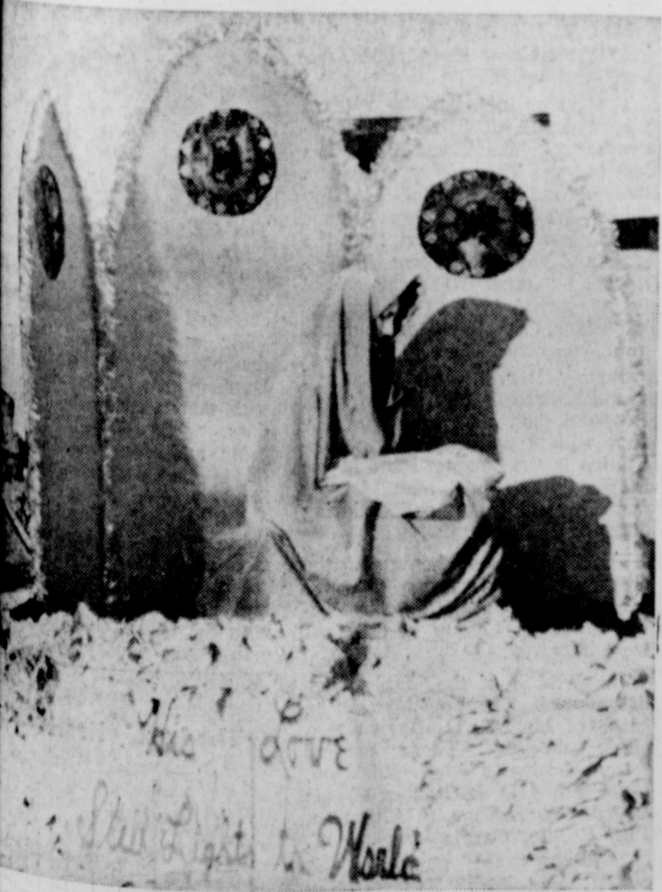
