## BROWNFIELD MAN WORLD'S CHAMPION ROPER

Two weeks ago we told the readers of the Herald that Milton Good had gone to Louisiana State Fair at Shreveport to take atry with the best ropers to be assembled, and we are glad to report that he won near one-half of the money and lowered a world's record while there.

The other contestants that got 2nd and third place were, Fred Beeson, of Arkansas City, Kans., and Bert Weir, of Monument, N. M.. The time on roping and tying single steers was as follow is now given, but is based on tying four in the four days of the fair. Will state that the best time heretofore known for tying 4 steers was 100 seconds: Milt tied 4 in 94 seconds: Fred Beeson tied his four in 121 2-5 seconds, and Bert Weir tied his 4 steers in 121 3-5 seconds, being just 1-5 second behind Fred.

Milton said he had a fine time at the fair, but it was hard to make those Louisiana folks believe he was just an ordinary cowman and did not belong to some show outfit.

Just to guy Milt a little, we asked him if he found any branch water while down in the pineywoods, and then we found why he is almost a perfect specimen of manhood, and is possessed of such a steady nerve.

## BROWNFIELD CITIZENS HOLD MASS MEETING

As per a call issued Tuesday afternoon, about forty or fifty of the citizens of the town meet in the District Court room to discuss plans for incorporating the town, in the face of the fact that that matter was decided by a big majority vote last Friday, and to make nomination of officers to serve for the first year, who are to be elected in the next ten days or two weeks.

Judge R. L. Graves called the meeting to order, and was elected Chairman; A. J. Stricklin was made Sec. The object of the meeting was then stated by the chair, and discussion was called for. It seeming to be the will of the meeting that the business of the evening be entered into, nominations were in order for Mayor.

Motion was made and seconded to nominate Fred Smith for that place and the motion carried. He asked that the motion be withdrawn for reasons stated, which was done, and Judge Geo. W. Neill was then nominated in his place.

Motion then prevailed to nominate five aldermen, and it was decided to nominate ten, and five receiving the highest vote could serve, and the following men were nominated for that place: Earl G. Alexander, Jno. B. King, J. L. Randal, I. C. Burgess, H. H. Copeland, Tom May, A. M. Brownfield, E. T. Powell and A. E. Graham.

The nomination for City Marshall was then gone into, and the following citizens were nominated for that place: B. W. Stinson, E. Brown and A. M. McBurnett.

Good talks on the subject were made by Judges Graves and Neill.

The meeting then went into the work of organizing the local unit of the West Texas Chamber of Commerce.

This organization will mean much to the business life of Brownfield, and everyone who has the good of the town at heart should get in.

What's the Matter With Texas

A circular issued by the government, Sept., 25th, shows that a wide range of prices are being paid for cotton and cotton seed in the different cotton states. The price in North Carolina is \$60 per ton for seed and 34.6 per pound for cotton. In Texas they are paying \$26.10 for seed and 28.8 for cotton. It is hard to reconcile this difference on a fair and just basis. Texas is placed on record as paying less for cotton and seed than any other State in the cotton region, and if the figures quoted in the circular are absolutely correct we are placed in a very unenviable position. Farmers are strongly urged by J. W. Neill, Director of the Institutes in Texas, to hold their cotton for 48 cents, middling basis, and to demand \$50 per ton for seed.—Ralls Banner.



### BAPTIST TO EXPEND MILLIONS.

Dallas—Approximately \$2,000,000.00 will be expended by the Baptist of Texas during the year 1920 on buildings which are now under construction or which have recently been completed at the various institutions for higher education fostered by the denomination in this State. This is by far the greatest building program ever undertaken by Texas Baptist in one year, and it is possibly the largest ever undertaken by a single denomination in any state in the South in the same length of time.

This extensive program has been made possible through the recent 75 million campaign which was carried to success by Southern Baptist. A campaign is now on in Texas known as the 75 million Cash Round-Up Campaign looking toward the collection of the remainder of the pledges due this year. One-fifth of the 16 million pledged by Texas in the 75 Million Campaign will be due by November. Approximately \$2,000,000.00 has already been collected.

The money which is being expended on building this year has been allotted as follows: Baylor College for Women, Belton, \$480,000; Baylor University, Waco, \$350,000; Southwestern Baptist Theological Seminary, Fort Worth, \$350,000; Howard Payne College, Brownwood, \$312,000; Simmons College, Abilene, \$175,000; An allotment for \$750,000 has been made to the Dallas Greater Medical Center, \$375,000 of which is to be used in the erection of a dispensary building, providing added quarters for the training of physicians and nurses.

An additional fund of \$170,000 has been provided which is being used in assisting congregations to build churches at various points over the State which are considered strategic and needy.

### GAME LAWS FAILURES

In some states, for a dollar or two, the state issues licenses which in effect permit the hunter to overrun the farmer's lands. In such states the farmer first drives the game birds away if he can. He is glad if rats, owls and other varmin will do it for him.

In other states the farmer posts his land against hunters, but often that fails him. Under our present game laws, which are absolutely dismal failures so far as perpetuating game is concerned, the farmer can't kill the game on his farm and sell it for food, nor breed it for food purposes. Think of that in this civilized age; prohibition against the production of food.

The fatal point is that the state assumes ownership of game. And this assumption is causing our game to gradually disappear.

Wake up! Fill our woods and fields and wild places again with pheasants, grouse, quail and prairie chickens.

Make the land owner the owner of the game on it. Permit him and his family to trap, breed and raise the birds as he raises poultry, and let him freely sell them as food. Today vermin and winter storms kill more birds than all the hunters. The farmer, finding game birds highly profitable, will destroy the vermin and feed the birds in winter when it is necessary. In a few years, protected birds that are at liberty will fly off and multiply in every corner of the land. —Iowa Park Herald.
