

Area Swelters Under Heat Wave

High Mark Is Set

The area has been sweltering under the worst heat wave on record during the past two weeks, with a steady diet of 100-degree-plus temperatures, and no prospects of rain in sight.

The city's all-time record high was established on Sunday, June 24, when the mercury climbed to 108 degrees. The National Weather Service at Lubbock was unable to furnish the exact details due to personnel being on vacation, but longtime weather observer A.L. (Jake) Outland said he could not recall a reading as high as Sundays in the time he has lived in Friona. All-time records were established at both Amarillo and Lubbock that day when those cities topped out at a balmy 110 degrees. Thursday's reading made it five days in a row over the 100-degree mark in Friona. Eleven days in June have registered 100 or above; 19 days have topped out at 95 degrees or more, and 25 days have been above 90. Only .06 inches of moisture has been received during the month, and that situation is now critical for farming operations.

nation won by the blood of those patriots who felt that such freedoms were worth fighting for. They used the "Star Spangled Banner" as a symbol of these freedoms, as have the members of the U.S. Armed Services ever since then.

The real issue behind the burning of the flag is the desecration of American morality and the eventual destruction of the American spirit. Freedom of expression should not be used as a tool to justify offensive public behavior.

Who are these people who burn flags? I personally don't know any and doubt that I would like them very much if I ever came across one. They are probably the same sort of people who vandalize the grave stones of other people's deceased relatives, who shoot animals out of season, and who litter mall parking lots with their baby's dirty diapers. If they don't have any pride in themselves, of course they are not going to have any pride in their surroundings, in other people's feelings, or in the sacred symbols of the country in which they live.

I would like to meet one such person sometime and ask him or her some questions, such as: What was your homelife like? Do you love your parents? Do you believe in God? Were you ever a member of Cub Scouts or Brownies? and, Where were you when your first grade teacher was teaching the Pledge of Allegiance to the rest of your class? I do agree that the desecration of American values cannot be solved by Congress or in the courts. Morality is the responsibility of every citizen. Unfortunately, there are an awfully lot of irresponsible and immoral folks roaming around in this free country. Fifty years ago in Colorado, there was an incident when a man was tarred and feathered for giving the Nazi salute to the U.S. flag. Perhaps there is a simpler solution. If you should happen to exercise your "freedom of expression" on the Statue of Liberty, or the Washington Monument, or the Vietnam Memorial or even on a stalactite in Carlsbad Cavern, you would probably get carted off to the pokey and expected to pay a large fine or be incarcerated for a period of time. So why not designate the nation's flag as a national monument whenever or wherever it is displayed in public, whether it be hanging on a flag pole, or worn as a lapel pin on a person's clothing. The Preservation of American Antiquities Act passed in 1906 under President Theodore Roosevelt gives the president authorization to set aside national monuments without the approval of Congress or the Supreme Court. Employees of the Department of Interior take care of national monuments. Any person in that capacity could see to the issuing of citations and fines against anyone found desecrating the nation's flag if it were a national monument. This would include all National Park Rangers, Land Resources Management, Water Resource workers, Historic Preservation Council, and all Fish and Wildlife Game Wardens, among others. This is not any more far-fetched than declaring that the burning of the flag is "freedom of violation. expression" as granted by the First Amendment to the Constitution. If you feel that the idea of making the flag into a national monument has some merit, then please write enforcing the ordinance to its to President Bush, or clip out this fullest extent, Goodwin added. column and send it to him. Pursuant to the settlement, while not admitting liability, Southwestern Bell, the other local exchange telephone companies in Texas, and AT&T Communications of the Southwest, Inc. have agreed to pay refunds to those WATS/800 customers who paid overtime charges attributable to the rounding practices for intrastate WATS/800 services at any time between September, 1976, and February, 1987. The refunds will be based upon either the actual or estimated amount of overtime charges attributable to such rounding practices. An exact refund will be determined for customers able to produce copies of their WATS/800 service bills. For customers who do not have copies of their WATS/800 service bills to establish actual overtime charges paid, an average refund of \$4.53 to \$5.95 per WATS/800 service line per month will be applied. All claims will be subject to verification. The refunds will also include interest at the rate of 7.80% per annum.

Fireworks Injuries Involve Children

fireworks-related eye injuries 1-800-221-3004. happened to children, warns the Texas Society to Prevent Blindness.

Fireworks injuries of all kinds soared 10 percent in 1988, up to a new total of 10,200. Eye injuries in particular tend to be severe. In one study, 40 percent of the reported cases caused permanent eye damage, visual disability or destruction of the eye.

Consumer Product Safety Commission statistics show that in 1988, 45.6 percent of fireworks eye injuries requiring hospital emergency room treatment struck children 5-14 years old. This is a sharp increase from the year before, when the same group accounted for 32.9 percent nationwide. Even very young children were injured. Last year 7.6 percent of fireworks-related eye injuries occurred to tots under the age of 5, up from 6.1 percent from 1987. Most injuries result from mishandling fireworks. Accidents occur when they are held in the hand, when attempts are made to relight apparent duds or when bending directly over fireworks to ignite them. While a number of states have banned the private use of fireworks, most still permit Class C devices to be used. This category includes pieces that contain no more than 50 mg of black powder. Bottle rockets, roman candles and sparklers are common examples. Together these have caused the overwhelming majority of serious injuries to the eyes. The Texas Society to Prevent Blindness warns against the private use of fireworks. Unfortunately, the range of state laws and illicit market make fireworks readily available. If you are going to use fireworks, the following safety rules are recommended: *Check local laws regarding use of fireworks. It may be illegal to use fireworks within the city limits, or within the county you live. *Never allow children to use fireworks. Even sparklers are dangerous. *Fireworks should only be used outdoors in a clear area away from homes, buildings and combustible materials. *Be sure others are out of range before lighting fireworks. Many firework injuries occur to innocent bystanders. *Never handle or attempt to relight a firework that does not go off. Keep water nearby for emergencies and for dousing malfunctioning fireworks. Drench thoroughly before discarding the dud firework. *Never ignite fireworks in a container. Glass and metal containers can easily shatter. The Legal List Is Alive and Well

In 1937 the U.S. District Court in the District of Columbia, with the guidance of Standard & Poor's Legal List criteria are alive and Corp., established a Legal List of investments suitable for trust funds.

At first the list consisted primarily of ultra-conservative, public-utility debt obligations. However, an astute attorney, Bernard J. Nees, was able to find certain railroad bonds that met the restrictive criteria while yielding more than 10 percent and selling for less than 50 cents on the dollar. It was a matter of finding bargains without sacrificing quality. In 1947 the same U.S. District Court revised Rule 23 to allow up to 40 percent of an estate or trust to be invested in equities from a new and expanded Legal List. Nees, who continued to use the list when representing his clients, believed the strict criteria, now reasonably expanded, could be successfully applied to professional management of a mutual fund. In 1952 he joined one of the nation's oldest and mostresearch respected and management companies to offer, for the first time, shares of a unique fund. By 1973 the lessons of the Great Depression were remembered only in history books. Many trustees and fiduciaries appealed to the courts to abolish the Legal List, thereby removing the harsh restrictions and allowing greater flexibility in an effort to become more competitive in managing money. Ultimately, Rule 23 was repealed and replaced by the "Prudent Man" rule, which holds fiduciaries and trustees responsibile to act with "care, skill, prudence, and diligence." It may well be a good idea,
