WHAT OUR FARMERS ARE DOING

A FEW RANDOM NOTES OF AGRI-CULTURAL INTEREST.

Wihout Exception There Are Expressions of Confidence That This Will Be Good Crop Year.

On the farmers of Hale county much depends; to state the matter more concisely and effectively, it all depends.

When the farmer is prosperous the wheels of industry hum with songs of gladsome gain, and everybody is an optimist and glad they are alive.

But let the farmers fail-well, it's considerably different. Pessimism is at a premium and everybody has a grouch.

Hale county is destined to have excellent crops this year. The last two seasons have been usually dry, and even with that difficulty there was no great shortage of feed stuffs raised. and last season, although uncommonly unfavorable for agricultural production. Hale county captured 14 ribbons for premium products displayed at the Dalas Fair.

In addition to the large acreage of broom-corn, he is preparing to plant 100 acres to flax and 100 acres to barley. He will also plant extensively to maize, kaffir and millet. Mr. Heard has the reputation of being a very successful farmer, who farms along advanced lines, and his confidence in this country and the possibilities it offers along agricultural lines will prove of great benefit to others. He has made a success of broom-corn cultivation here, and sees no reason why it should not be more extensively cultivated, as he thinks the crop particularly adapted to the soil and climatic conditions here.

640 Acres Ready.

H. E. McCabe informed a Herald representative that he has 640 acres plowed and thoroughly prepared for a seed bed and was just waiting for the proper time to plant. Mr. McCabe is of the opinion that this will be a bountiful crop year, and he has great faith in the productive qualities of Hale county soil.

Four Hogs \$135.

"Hale county is the best hog country I ever saw," said G. B. Simmons, a farmer who lives a few miles north of Plainview. "They can be raised here cheaper than in the best hog ranges of the East, and they make better meat, larger and healthier hogs. I recently slaughtered three shoats,

just eight months and three weeks old, that dressed, respectively, 260, 265 and 274 pounds. These pigs had never been penned, but allowed to run at large in a big pasture and provide for themselves until a short time before slaughtering." News that after the line is completed to Seymour he would be in a position to announce the three different routes to the Plains country which are under consideration. This step will be taken before deciding upon a definite route, which is interesting the residents in the Plains country. The line has been graded to Seymour and the rails have been put down to a point within fifteen miles of that place.

Our Citizens in Dallas.

E. Dowden, president of the Commercial Club of Plainview, Texas, and J. E. Lancaster, a business man of Plainview, were in Dallas yesterday conferring with President J. J. Jermyn and Vice President Ben B. Cain. of the Gulf, Texas & Western Railroad, regarding an extension of that line to the Plains country. Plainview vants the road in order to have closer connection with North Texas and to add to its importance as a railroad center.

The town now has the line of the Santa Fe which was recently built from Amarillo to Lubbock, and a branch is being built from Plainview to Floydada, in Floyd county. Mr. Dowden states that a direct line to Dallas will save 150 miles, as the present route' is via Canyon City and Amarillo to Fort Worth and then to Dallas. He stated that the Gulf, Texas & Western Railroad has built about fifty miles of line from Jacksboro west, and Plainview is anxious to have the road extended to their city. Mr. Dowden claims that more hogs were shipped out of Hale county last year than any other Texas county ..

President Jermyn, of the Gulf, Texas & Western, is in Texas to remain about a month, and it is believed that he will consider the advisability of continuing the road to some point in the Plains country in the near future.-Dallas News.



Indeed, in one sense, city-planning offers greater inducements to the small towns and to the large towns just budding into cityhood than it does to such places as Dallas and Houston. For the smaller places it is far less costly, and can be done by them much more completely, for the simple reason, of course, that there is not so much ugliness to destroy as a preliminary step. There is a vast deal of ugliness in Dallas, and in every city of its class in Texas. There are blocks twice and even thrice as long as they ought to be, with a consequent dangerous crowding of streets. There is a lack of open spaces in the midst of the city, with the result that thousands have no means of wholesome recreation, no access to free and unincumbered air; while for their children the streets are their only playgrounds, beset as they are with physical and moral perils. Life in this environment, under these conditions, is not a highly attractive boon. There is nothing in it to exalt men's minds, to uplift the spirit; but there is much in it to generate discontent, pessimism, despair-to make living a routine, sodden existence. He is wofully lacking in understanding who imagines that these conditions are without a real and sensible influence on the physical, intellectual and moral life of a city. Under these handicaps the latent power there is in society to uplift itself can accomplish very little, if anything.

"And what is the cause of this condition in Dallas and in every other Texas city of its class? Fundamentally, it is the failure of those who ruled twenty years ago to consider future needs, much less to make any provision to meet them. Their negligence may have been due to their inability to foresee the growth of those cities, or it may have been due to that spirit, happily passing away, which made men regard the growth of a city merely as a chance to make money. Whatever may have been the cause of their negligence, the consequences of it are abundant, unmistakable-and pitiful. IN SNOWSLIDE

who will furnish a brilliant array of IDAHO DISASTER DEALS DEATH AND DESTRUCTION.

> Small Town Buried Under Fifty Feet of Earth and Snow-Rescue Party Saves Lives.

> Spokane, Wash., Feb. 28.-Twentyfour are known to be dead as the result of the snowslides yesterday and to-day in the mining district of Northern Idaho.

> To the eighteen known to have pershed in the snowslides at Mace and Burke, Idaho, last night and this morning are added three more who died in a similar disaster about noon yesterday, when the camp of the Carbonate Hill Mining Company, at Mullan, Idaho, was destroyed. Two more were killed at Dorsey, Idaho, late this afternoon.

The fight against time and cold at Mace and at Burke has been waged bravely by the little army of men who hope to find under the ruins in the ravine some who have escaped death.

Work of Rescuers.

The rescuers have dug frantically for many hours. Every available able-bodied man has been pressed into service, old men and boys joining the rescue forces. Mace is situated on the creek bed and the mountains rise high on either side of the town. The main body of the avalanche. which started from the top of the Custer Mountains, passed beyond the town, and, striking the opposite slope with terrific force, rushed up to the opposite mountain side. 
