## SCOUTS PREPARE FOR 10 DAY CAMP

Local Boys to Go to Buffalo Trail Camp on Concho, Near Sterling City, August 12.

### LIONS CLUB PLANS DINNER

Boys Will Be Guests at Colorado—Work and Play in Daily Program of Fun at Camp.

Preparations are completed for the annual camp of the Buffalo Trail Council, Boy Scouts of America which will be held ten days beginning August 12, on the Concho River near Sterling City. The Buffalo Trail Council is made up of Scout troops in cities in Nolan, Fisher, Mitchell and Scurry Counties and over 100 Scouts and Scout leaders from these counties are expected at the camp.

Over 25 Scouts are expected to attend and are eagerly looking forward to the date when the Scouts will pack up their blankets, mess kits and haversacks and set out for ten days of fun and outdoor education.

The Scouts will leave Sweetwater early Saturday morning, August 12, and will be joined by troops from other cities at Colorado. It has been announced that the Lions Club of Colorado will entertain the Scouts at noon Saturday at Colorado with a big feed, after which the trip to Sterling City will be continued.

According to Scout Executive Barcus, the camp will be prepared in advance of the arrival of the Troops and all will be in readiness when they arrive. Barcus is executive for the four counties, and with Scoutmasters and assistant Scoutmasters will be in charge of the camp and training program during the ten days.

The Scouts will enjoy all phases of camp life while on the Concho and will have every opportunity to study the Scout tests, merit badge tests and outdoor life during their stay. Among the outstanding features of each day's program while in camp will be five-one-hour study periods each day when each period will be devoted to the study of Scout tests, nature study, first aid, signaling, fire building and cooking, scout pace, woodcraft and other phases of Scouting. Each study period will be in charge of an efficient Scoutmaster or assistant.

## CONFESS THEFT

Boys Said to Have Admitted Stealing Car—Believed Guilty of Stealing in Paris and Abilene

Officers are expected to arrive Monday night to take over Warren and Milton, two boys arrested here last Thursday with an alleged stolen car, and return the pair to Durant, Okla., according to Chief of Police Johnson. After Durant authorities notified Johnson that the car was stolen from that city, the boys confessed to the robbery, it is stated. ## MRS FERGUSON LEADS BY 5,137

Texas Election Bureau Figures Give Her Substantial Lead Over Lynch Davidson Monday

237 COUNTIES COMPLETE

Ferguson, 145,441; Davidson, 140,204; Robertson 191,820—Account For 698,778 Votes

DALLAS, TEXAS, Aug. 4.—Texas Election Bureau figures from 251 of 252 counties, 237 complete, at 11 a. m. showed Miriam Ferguson leading Lynch Davidson 5,237 votes in the race to oppose Felix D. Robertson for the gubernatorial nomination in the Democratic primary run-off August 23.

The total vote accounted for 698,778 out of an estimated total of 700,000 ballots; Barton 29,254; Burkett 21,633; Collins 25,081; Lynch Davidson 140,204; Whit Davidson 124,050; Dixon 4,226; Ferguson 145,441; Pope 17,069; Robertson 191,820.

## ONE PLANE LOST IN WORLD FLIGHT

Lt. Wade on Deck of U. S. S. Richmond, Hears Tow Rope Break Leaving Plane in Ocean

### ENGINE TROUBLE SUNDAY

Wade and Mechanic Rescued After Forced Down—Smith and Nelson Await Wade in Iceland

ABOARD THE U. S. S. RICHMOND, off Iceland, Aug. 4.—The Boston U. S. Army 'round the world flight plane piloted from Santa Monica three fourths of the way 'round the world by Lt. Leigh Wade, was abandoned near Sumbae Light off the island of Syceros, where it was forced down by engine trouble Sunday.

The Richmond flagship of the convoy, was to bring the wrecked plane to land, having rescued Wade and his mechanic. The tow line parted and the plane was abandoned.

Standing on the deck of the Richmond as the crack cruiser proceeded cautiously through the white caps to Iceland, where Lts. Nelson and Smith were waiting, Lt. Wade suffered the supreme disappointment of the American sky expedition when the sharp snap of the rope signalled the end of his plane.

The Boston was left to her fate in the heavy seas, and the Richmond picked up speed toward Iceland.

## LABOR PREPARES CALLES IS ILL

Plan Most Extensive Campaign For La Follette in History of American Federation

ATLANTIC CITY, Aug. 4.—A huge political organization with 3,000 campaign committees, hundreds of speakers, and 3,000,000 active workers will sweep the nation in behalf of La Follette's candidacy for president.

This unprecedented offensive was decided upon by the executive council of the American Federation of Labor in a session devoted to arranging complete details of the political organization.

Samuel Gompers will be in active control of the movement, which is believed will be the biggest political attempt ever made by labor.

DETROIT, Mich., Aug. 4.—Patrolman Ashworth was killed by four bandits who held up a branch of the Continental Bank today and escaped with \$24,000. Patrolman Hale was slightly wounded.

The four men drove up in a touring car and one remained at the wheel while the other three entered the bank. Seeing the patrolman approaching, they opened fire, scooped up all the cash in sight, and fled.

OKLAHOMA CITY, Okla., Aug. 4.—Efforts to align all the units of the Ku Klux Klan in Oklahoma behind E. B. Howard, Tulsa, former Congressman, in the race against former Governor Jack Walton for the United States Senate have failed, it is the opinion here.

A decisive victory for Walton over the Klan appeared imminent with the report that W. R. Sampson, Muskogee Cyclops, had refused to heed the request made by N. C. Jewett, Grand Dragon, that all K. K. K. units in the state support Howard in tomorrow's state Democratic Primary.

Jewett admitted a break with the Muskogee Cyclops.

## LABOR PREPARES CALLES IS ILL

President-Elect of Mexico Refused To Be Interviewed In Houston—Is Enroute To England

HOUSTON, Tex., Aug. 4.—General Elias Calles, who claims to be the president-elect of Mexico, was too ill to be interviewed when he passed through Houston today enroute to New York.

Calles is on his way to Europe, where he hopes to perfect arrangements for British recognition, and possibly arrange a new Mexican loan.

He declared he was "too ill to be interviewed" when asked what effect the murder of Mrs. Rosalie Evans, British subject, in the state of Pueblo might have.

## GERMANS LEAVE FOR CONFERENCE

Delegates To Allied Reparations Session Expected in London Tuesday—Hope For Settlement

CONFER WITH HUGHES

Marx and Sressemann, German Leaders, in Session With U. S. Secretary—London Optimistic

BERLIN, Germany, Aug. 4.—German delegates to the Allied Reparations Conference in London which has agreed on the application of the Dawes plan for reparations settlement left for the British capital at 11 a. m.

The delegates were headed by Chancellor Marx and Foreign Minister Stressemann, who had a long talk with Hughes, American Secretary of State, here Sunday. Hope that settlement of the entire post-war situation may be near ran high as officials bade the delegates good bye.

LONDON, ENG., Aug. 4.—Great Britain today believed a final settlement of the tangled reparations question which has kept all Europe in anxiety near as the Allied Reparations Conference resumed sessions.

The first session met as word was received that the German delegates had left Berlin for London. They are expected here tomorrow, and will probably confer with Prime Minister McDonald and other leaders of the conference at once.

## CRIME PARTNERS FIRST IN CARDS

Cheating at Bridge First Partnership of Leopold and Loeb, Alienist Testifies

### LOEB STARTED YOUNG

Got Pleasure From Theft When Nine Years Old—"Childish Compact" Is Unprintable

CHICAGO, Ill., Aug. 4.—Cheating at bridge was the start of the criminal partnership of Leopold and Loeb, Dr. William Healy, noted psychiatrist of Boston testified today at the judicial hearing of the millionaire youth held for the murder of Robert Franks.

They were not very successful in their bridge partnership, the doctor said. Another delinquency in which Leopold and Loeb took part was heavy drinking, he declared.

As for young Loeb, his criminal tendencies began long before he met Leopold, Dr. Healy said. When he was only nine, he took up the practice of stealing whatever he could lay his hands on. He crawled through windows of neighboring homes and stole such things as expensive vases, things that he could not use, merely for the satisfaction of being able to get away with it.

Loeb, Healy said, received from his association with Leopold some one who could help him carry out his criminal imaginings and ideas. He stated that Leopold's association was the direct of his "childish compact."

State's Attorney Crowe jumped to his feet with the demand that Healy tell the nature of the compact. "I shall be glad to tell it in chambers," Healy replied, looking at Chief Justice Caverly, indicating that the story was unprintable.

## FOUND OUT PESTS

Kansas Citizens Get Exercise And Rout Beetles.

McPHERSON, KAN., August 4.—"Pounding out" blister beetles is one of the favorite sports of McPherson citizens these days.

The blister beetle has descended in "armies" on the gardens here. The poison sprays commonly used in killing off insect pests, seemingly have no effect on this particular type, so the "pounding out" process is being used. This is done by pounding on the ground with a wide board on one side of an infested patch. The beetles seem to dislike the sound and they travel away from it, and if the pounding is continued long enough the entire "army" can be routed.

**VOLUNTEERS**

Nearly every available automobile on the streets of Sweetwater was put into service Sunday night, to answer a fire alarm in the city lake park, where a brush pile was burning peacefully enough. Some of them did remarkably well, getting in the way of the fire trucks and violating enough traffic rules to form the basis for some splendid smash-ups. **POLITICS**

According to statistics the total vote polled in the County primary in July was 3,074. Of this number 1,036 were polled by women and 2,038 by men. All of which would seem to indicate that all women don't use the vote now that they have it. Men are not above criticism on that score either, for that matter. If all persons who were entitled to vote, and took the same interest in proceedings

that the political bosses do, politics would be much above its present low ebb.

**SHOCK FOR BOSTON**

Staid old Boston is due for a shock this fall when Mary V. King, candidate for Mayor of the city, announces her platform.

The campaign that Miss King expects to wage would shock nearly any city, according to the issues with which she is prepared to cut loose. And if she is not elected, it will not be for lack of a platform, for if ever a candidate had a platform, Miss King has.

She is against prohibition, says that women should not be allowed to wear long hair, should smoke any time and anywhere men smoke, is against political speeches, for easy divorcees and hard marriage, and backs good roads, good health, and morals.

Prohibition, the woman candidate for Mayor says, is reactionary, impossible, and conducive of law violation. She believes in bobbed hair because it is efficient. Long hair, Miss King says, is unsanitary, hot on the head, and calls for hairpins, tormentors that have destroyed women's concentration abilities for ages.

If elected, Miss King will see that women employes of the city bob their hair, "merely for efficiency." In the meantime, Boston is wondering, and waiting, and preparing for a shock.

**WASHINGTON**

Figures completed for the year ending July 1 show that Washington, capital city of the "most advanced nation on earth," is close to the top of the list in per capita arrests made for violations of law.

Washington is the seat of America's law making power, center of educational and social culture, and has in its population a higher percentage of college folks and a lower percentage of illiteracy than any similarly large city. It also had last year an average of almost one arrest per family, on the basis of five persons to a family.

Automobiles and booze are at the root of the increasing number of arrests and crimes in the capital, analysis shows. The superintendent of

the Washington police says that Washington isn't growing more lawless, but that the police are becoming more vigilant.

OPEN MIND COLUMN  
IS WOMAN SUFFRAGE A FAILURE

After a struggle lasting for 30 or 40 years women were granted full suffrage in the United States in 1918, of course it had to be granted them by the male qualified voters of the country. Many voters were persuaded to vote for it by its advocates, but did so with much doubt as to any benefit coming to the government or to them.

In Nolan county in 1918 when women voted without paying poll tax there was a total of 2207 votes cast at the July Primary, 1047 or nearly half of them women. After that year it became necessary for them to pay a poll tax, same as men do, in order to vote. The result has been that the number of women voters in proportion to men has steadily declined, so that in the July Primary just past, out of a total vote of 3074 only 1006 of them were women or less than a third, instead of one half. In other words only one half of the women exercised the "sacred right of suffrage" talked so much about prior to 1918.

Is it possible that the small sum of money required to pay poll tax is the reason, or is it a lack of interest in

government?

Or is like that a child crying for a toy, seen for the first time, soon tires of it and throws it away.

So far it is practically certain that the women vote has had no real effect in determining any question or electing anybody, as 9 out of ten of them vote as do their husbands or fathers.

It seems to me that as we have woman suffrage, probably never to be taken away from them, the women clubs could do no greater service to the country than to strive to get the women to take the same or equal interest in government, as do the men. To think for themselves. The girls have the same opportunity at school to learn the science of government. Why can't they apply it?
