Great Plains Ag Credit, a rural financing cooperative, has sent its customers checks for their share of the lender's record net income from 2011.

Sharing earnings in the form of a patronage refund is one of the ways that the cooperative lender provides its services at a low cost to its customers, who are also its owners. At the end of 2011, Great Plains Ag Credit's Board of Directors declared a record patronage of \$4.96 million. Of that, \$3.22 million was distributed in cash in mid-March, and the remainder has been set aside for payment to stockholders at a later time.

Comptroller announces business tax amnesty

Texas Comptroller Susan Combs has announced the opportunity for businesses to clear up their tax records without any penalty. The state's Fresh Start tax amnesty period is set for June 12 through August 17, 2012.

"The amnesty is a chance for businesses to set their tax records straight and save money by not having to pay penalty and interest on tax reports they had failed to file," Combs said. "During the two-month amnesty businesses can file those missing reports and pay the overdue taxes, or amend and pay previous reports in which they had incorrectly stated a lower amount than was due."

The tax amnesty covers taxes and fees that

were originally due before April 1, 2012. The amnesty does not apply to underpaid tax returns (tax that was reported but not paid) or filing periods that businesses have in audit.

The Fresh Start amnesty applies to sales tax, franchise tax and other state or local taxes or fees administered by the Comptroller's office, except Public Utility Commission gross receipts assessments.

A similar tax amnesty was held in summer 2007 and brought in approximately \$100 million in unpaid taxes.

In a recent "Cogitations" column I asked if anyone knew where the Bek's Place recreation hall was located when it was sold in 1936. Librarian Darla Bracken and Melba Smiley provided the answer. It was in a two-story building located on Main St. where Allan Haile's Chieftain storage is now located. Bek's Place was purchased by Ralph and Melba Miller The pool hall was downstairs. It was later purchased by Billy and Carl Fairchild who lived upstairs.

Later on, the building was divided and moved. The Fairchilds moved the upstairs part and lived in the residence for many years. The lower building was moved over on Washington St. The current building was built later and also served as a pool hall.

Here is news from Uncle John White in a January 1938 Friona Star.

I just took off time enough Saturday night to attend the closing games of the basketball tournament held here at the High School Gymnasium and witness the four games played that night. The stadium, both the upper and lower sections,

was crowded with spectators, all of whom seemed to thoroughly enjoy the games.

The Friona teams, the Chiefs and the Squaws, were engaged in but two of the four games played that night, in which the Chiefs won over Farwell Steers, and the Squaws lost to the Dimmitt girls, but it was a mighty close game all the way through until the last few minutes when the visiting girls scored with two or three goals in rapid succession. They all played well and hard.

But in addition to the great amount of amusement I received from these games, one of the things that impressed me most favorably was the really sportsman spirit that was manifested by all the players. For, whether winning or losing there seemed not to be the slightest desire on the part of any member of any team to bully, bulldoze, or cheat their opponents, and everything went off peacefully and in the best of humor.

Now that is what I call real sportsmanship and that kind of sportsmanship is a mighty good foundation for good citizenship and if the coaches and teachers in our local and neighboring schools are

teaching and cultivating that kind of a spirit in their school sports, they are truly deserving of the backing and commendations of the patrons of these same schools, and my hat is off to them one and all.

Last Saturday night a car belonging to Chester Vaughn, living west of Friona, was being driven down main Street by a son of Mr. Vaughn who was accompanied by another young man, when the car collided with the rear of a truck that was parked on the side of the street in front of the J.W. Parr residence.

The collision apparently broke the gas line, according to reports and the spilling of the gas seemed to break into a flame at once, and the occupants barely escaped from the flames. The car was completely destroyed by the fire.

The young man riding with Mr. Vaughn is reported to have received some severe cuts about his face from the force of the collision, but no serious injuries were sustained by either of the young men.

S. Michell, City Fire Chief, got out with the fire truck and assisted in extinguishing the fire.

Eating healthier just got easier BY SHANA FLEMING March is National Nutrition Month. We are also experiencing

warmer weather, so it is a good time to focus on eating healthier. A great way to do this is to increase the amount of fruits and vegetables that you eat. The Academy of Nutrition and Diabetes recommends that you make half of your plate at each meal be fruits and vegetables. There are several ways to do this:

- Make a smoothie for breakfast and add fresh or frozen fruit, or add fresh fruit to your cereal.

- Eat crunchy vegetables with low-fat dressing instead of chips with your sandwich.

- Add fresh or frozen vegetables to soups, pasta, omelets, pizza, sandwiches, meat loaf or lasagna.


- Keep fresh fruit out and easily to grab. Place fruit in a bowl on a counter or the table where family members can easily grab it. Try washing and taking grapes off of the stem to make them a "fast food".

- Make afternoon snacks a fruit or vegetable choice. Try a dip option like whole wheat pita wedges in hummus, baked tortilla chips in salsa, strawberries or apple slices in low-fat yogurt, or graham crackers in applesauce.

Another way to eat healthier is to cook at home. By cooking at home, we are able to control what we put into our dishes. We all have those days that we just aren't sure what to make. There are two tools that will help you on those nights. One is a blog. You may follow the blog that every Tuesday posts a tried and true recipe. The blog is called Deep in the Heart of Texas and is written by Texas AgriLife Extension Family and Consumer Agents. The address to the blog is http://extensiondeepintheheartoftexas.blogspot.com/.

The second tool that will help you with ideas is a newsletter written by Texas AgriLife Extension Agent Shana Fleming. The newsletter will be sent to you in an email once a week with a link to a video demonstration of a new healthy recipe. This is a great tool for those nights you are not sure what to cook, for individuals just learning to cook, or even for college students. Using these tools and finding ways to add fruits and vegetables will make eating healthier easier for everyone.

The bride's cake was five-tiered, each tier a different flavor, decorated with sugar gum paste flowers that matched the wedding colors, guava and lapis.


The groom's chocolate cake was golf-themed, decorated with cake golf balls, with the bride driving the groom in a golf cart.

Don't get hit with a penalty! "Render" your taxable property by April 15th.

A "rendition" is a report to the appraisal district that lists all the taxable property you owned or controlled on January 1st of this year.

Who must file a rendition?

You must file a rendition if you own tangible personal property that is used to produce income - such as the inventory and equipment used by a business. If you render late, don't render or file an incomplete or false rendition, a 10% to 50% penalty may be imposed.

Are there any advantages to you?

The advantages of filing a rendition are:

- · You give your opinion of your property's value. The appraisal district must notify you in writing of any value to the appraisal review board.
- · You record your correct mailing address so your tax bills will go to the right address. If your bill is mailed to the wrong address, the law still holds you responsible for paying your taxes on time or paying extra charges for late payments.
- You can also file a "report of decreased value" to notify the appraisal district of significant depreciation of the value of your property in 2009. The district will look at your property before assigning a value in 2010.

What's the deadline?

The last day for filing 2011 renditions is April 15. You can get an automatic extension to May 15 if you ask for it in writing on or before the April 15 deadline. The chief appraiser may grant an additional 15 days after May 15 for an owner who shows good cause in writing. Where do you file?

APPLICATION AND PRELIMINARY DECISION. Cargill Meat Solutions Corporation, P.O. Box 579, Friona, Texas 79035, which operates the Cargill Meat Solutions, a beef packing plant, and rendering facility, has applied to the Texas Commission on Environmental Quality (TCEQ) for a renewal of TCEQ Permit No. WQooo1350000, which authorizes the disposal of process wastewater, utility wastewater and domestic wastewater not to exceed a total flow of 71.3 million gallons for any 30 day period from the facility to the playa lake and an application rate not to exceed 2.8 acre-feet per acre per year via irrigation on a combine area of 2,865 acres of various crops; and the disposal of brine and pickling wastewater at a daily average flow not to exceed 21,000 gallons per day via evaporation. This permit will not authorize a discharge of pollutants into water in the State. TCEQ received this application on June 3, 2005.

The facility is located immediately south of U.S. Highway 60 and the Santa Fe Railroad, approximately 3.3 miles southwest of the City of Friona, Parmer County, Texas 79035. The disposal areas are located on various tracts of land with approximately 10 miles south of the facility. The facility and disposal areas are located in the drainage area of Frio Draw, which flows into Tierra Blanca Creek, and thence to Upper Prairie Dog Town Fork Red River in Segment No.

0229 of the Red River Basin.

The TCEQ Executive Director has completed the technical review of the application and prepared a draft permit. The draft permit, if approved, would establish the conditions under which the facility must operate. The Executive Director has made a preliminary decision that this permit, if issued, meets all statutory and regulatory requirements. The permit application, Executive Director's preliminary decision, and draft permit are available for viewing and copying at the Friona City Hall, 623 Main Street, Friona, Texas. PUBLIC COMMENT/ PUBLIC MEETING. You may submit Public comments or at the new bullpen at the Chieftain ballpark. The request a public meeting about this application. The purpose of a public meeting is to provide the opportunity to submit comments or to ask questions about the application. TCEQ holds a public meeting if the Executive Director determines that there is a significant degree of public interest in the application or if requested by a local legislator. A public meeting is not a contested case hearing.

OPPORTUNITY FOR A CONTESTED CASE HEARING. After the deadline for submitting public comments, the Executive Director will consider the comments and prepare a response to all relevant and material, or significant public comments. Unless the application is directly referred for a contested case hearing, the response to comments will be mailed to everyone who submitted public comments and to those persons who are on the mailing list for this application. If comments are received, the mailing will also provide instructions for requesting a contested case hearing or reconsideration of the Executive Director's decision. A contested case hearing is a legal proceeding similar to a civil trial in a state district court.

TO REQUEST A CONTESTED CASE HEARING, YOU MUST INCLUDE THE FOLLOWING ITEMS IN YOUR REQUEST: your name; address; phone number; applicant's name and permit number; the location and distance of your property/activities relative to the facility; a specific description of how you would be adversely affected by the facility in a way not common to the general public; and the statement "[I/we] request a contested case hearing." If the request for contested case hearing is filed on behalf of a group or association, the request

must designate the group's representative for receiving future correspondence; identify an individual member of the group who would be adversely affected by the proposed facility or activity; provide the information discussed above regarding the affected member's location and distance from the facility or activity; explain how and why the member would be affected; and explain how the interests the group seeks to protect are germane to the group's purpose.

Following the close of all applicable comment and request periods, the Executive Director will forward the application and any requests for reconsideration or for a contested case hearing to the TCEQ Commissioners for their consideration at a scheduled Commission meeting.

The Commission will only grant a contested case hearing on disputed issues of fact that are relevant and material to the Commission's decision on the application. Further, the Commission will only grant a hearing on issues that were raised in timely filed comments that were not subsequently withdrawn. TCEQ may act on an application to renew a permit for discharge of wastewater without providing an opportunity for a contested case hearing if certain criteria are met.

EXECUTIVE DIRECTOR ACTION. The Executive Director may issue final approval of the application unless a timely contested case hearing request or request for reconsideration is filed. If a timely hearing request or request for reconsideration is filed, the Executive Director will not issue final approval of the permit and will forward the application and request to the TCEQ Commissioners for their consideration at a scheduled Commission meeting.

MAILING LIST. If you submit public comments, a request for a contested case hearing or a reconsideration of the Executive Director's decision, you will be added to the mailing list for this specific application to receive future public notices mailed by the Office of the Chief Clerk. In addition, you may request to be placed on: (1) the permanent mailing list for a specific applicant name and permit number; and/or (2) the mailing list for a specific county. If you wish to be placed on the permanent and/or the county mailing list, clearly specify which list(s) and send your request to TCEQ Office of the Chief Clerk at the address below.






