STATUE COST \$50,000

Represents Washington in Uniform as He Appeared at Valley Forge By Associated Press.

NEW YORK, June 9. - A heroic equestrian statue of George Washington will be unveiled next Saturday at the Brooklyn terminal of the New Williamsburg bridge, and formally presented to the city of Brooklyn by James F. Howe. City officials, members of military organizations and government representatives from Washington will be present at the cere-

Washington is represented in continental uniform and as he appeared at Valley Forge.

The statue was cast in eight pieces and is said to have cost \$50,000. It is eighteen feet high, weighs seven and a half tons, and will be mounted on a granite pedestal, eighteen feet high.

# PROTEST MADE ON FIRE LIMIT

C. J. Swasey Writes Letter to Mayor and Council

Making the assertion that the action of the city council in extending the fire limits of Fort Worth so as to include his property, a block bounded by the following streets: El Paso street on the north, Lake street on the west, Henderson or Huffman street, as the same was formerly known, on the east and Rio Grande avenue and the Texas and Pacific Company right of way on the south, "arises either from some silly mistake or some personal motive" and that "its consummation is not only ridiculous, but outrageous or malicious," C. J. Swasey, in a communication addressed to the mayor and aldermen of Fort Worth, asks that body "why this was done."

According to city ordinance, no buildings may be erected within the fire limits of the city unless they are constructed of brick or stone and the roofs of such structures must be of fire-proof material. This is probably the prime reason for the straight "kick" registered by Mr. Swasey against the action of the last meeting of the city council in extending the fire limits of Fort Worth so as to include the property of Mr. Swasey.

Mr. Swasey's Letter

The communication in full is as fol-FORT WORTH, Texas, June 7, 1906. -To the Honorable Mayor and City Council, Fort Worth, Texas-Gentlemen: I noticed in the issue of The Fort Worth Telegram of last Tuesday that the city council of Fort Worth. upon recommendation of the fire committee, had placed block 10, Texas and Pacific addition, within the fire limits. As I am the owner of that block, I should like to know why this was done. The property is 400 feet by 365 feet, some three or four acres, and vacant; it has never been leased in part or in whole: it has never, in a single instance, been offered for sale in lots or lot; a price of \$20,000 was asked for the entire property to June 1, 1906; after that, \$25,000 is the minimum price. An offer of \$16,000 to \$18,000, all cash (yes, two or three such offers) have been promptly declined, and this for the whole parcel of land. I take it, that some one is evidently desirous of reducing its value, or that the fire committee has been informed that a permit was out to build some small wooden buildings on the property (some eight or ten in number). If they have been so informed, it is most certainly a mistake, and a permit, without any authority from me. It is either a fraud or a mistake—and the action taken to put this property within the fire limits, as I hear it has been done, arises either from silly mistake or some personal motives, and its consummation is not only ridiculous, but outrageous or malicious, and, as a citizen of this town. I deserve better treatment and, in fact, so would anybody else.

than this from the common council-"I am charitable enough to believe that it is simply a huge mistake, but when the facts are noticed that at the very time your body was in session these buildings were erected and occupied on some property some short distance away, near the viaduct on Eighth avenue, it looks like that, although you were unaware of it, some sand must have been blown into your eyes, blinding you to the real state of affairs; but, in any event, you shall not put me in the disgraceful attitude of even attempting to be a party to the scheme of creating a public nuisance upon my own property-while the wrong is being continued under your very eyes. It is simply the big joke of the season or else a scheme is being worked, and if such is the case, I desire you to understand that, as a citizen and property holder of the city of Fort Worth, I do not lend my approval of it. **EIGHT DIE FROM EXTREME HEAT** 

Hot Weather Causes Much Suffering in Chicago

By Associated Press. CHICAGO, June 9 .- Although yesterday was appreciably cooler than the preceding day, the neat was given as were several prostrations.

The temperature reached a maximum of 81 degrees, and there was a rainfall of .11 of an inch. The wind attained a contributing cause to eight deaths reported in Chicago. In addition there a velocity of forty miles an hour from the southwest.

The cumulative effect of the three days of warm weather was the chief element in the deaths. With little children this effect was most marked.

### BUILD ICE PLANT

First Packing Company of Indian Territory Established at Tulsa Special to The Telegram.

TULSA, I. T., June 9.-After a delay of several days work was resumed yesterday on the large building of the Tulsa Ice and Packing Company at First and Denver streets. This building will be 210x96 feet, with an addition to the rear. In some places it will be two stories, but for the most part will be but one story high. It will be equipped with the latest appliances for packing purposes and the manufacture

The packing department at the start will have a daily killing capacity of 100 hogs and twenty-five beeves, which vill be increased as business demands. This will be the first packing and ice plant of any considerable proportions in Indian Territory.

### REBUILD BRIDGE

Cotton Belt Will Move Structure Across Brazos 175 Feet Special to The Telegram.

WACO, Texas, June 9.-The Cotton Belt raffroad will not only rebuild its bridge over the Brazos river, but will move the east end of the bridge 175 feet further south and the west end thirty feet south. This will throw the bridge diagonally across the river, but will serve to do away with a double curve which the road has had to encounter on the east side of the Brazos and which has proved annoying. A new and strong bridge will be built. The Missouri, Kansas and Texas is also rebuilding its bridge over the Brazos and making it stronger.

### FRISCO RETURNS CASH Money Market Made Easy and Opera-

tors Seize Opportunity By Associated Press. NEW YORK, June 9.-The large return of cash from San Francisco to New York has caused an easier market in Wall street and professional operators in stocks have availed themselves of the supply of funds to embark on considerable commitments on the long side of the market. No large general demand for stocks has been attracted yet by the spotty advancing tendency

The advance in foreign exchange following the easing of money and the large fall requirements before the money market keep alive some degree of solicitude on that subject. Confidence in the promise of harvests is not impaired in Wall street by the strength of commodity markets and the general trade and industrial outlook is relied upon to produce an ultimate public demand for stocks on which to realize speculative profits.

# **NEW FIRE ENGINE 'S GIVEN TRYOUT**

Throws Water Higher Than Any Building in Town

The new fire engine ordered by the city council during the month of March for the use of the new fire station now in progress of erection in the Eighth ward, on the south side of the city, arrived in Fort Worth Friday afternoon and was given preliminary tryout at the Central fire station Friday night. The engine, as was told exclusively to The Telegram Friday afternoon, is size No. 2 and is strictly a metropolitan machine in every respect At the tryout Friday night the steamer was connected up and a stream of water more than one hundred feet high was kept in play for half an hour. According to the statement made Saturday, the engine gives perfect satisfaction in every respect. It will be kept in commission at the central station until the final completion of the Eighth ward station, which will be probably several weeks.

# TAX COLLECTIONS **CAUSE TROUBLE**

State Finds Many Errors in County Reports

AUSTIN, June 9 .- The comptroller's department is experiencing considerable difficulty with some of the reports received from the county tax collectors of the tax collections for last year. Chief Rabbi at Tangier Writes to Ambassador White, Expressing Gratitude

C., June 9.-One of the strongest institutions given by Secretary Root to the representatives of America at the Algeciras conference related to the protection of Jews in Morocco and the procurement for them of equal privileges guaranteed by the signatory nations. Through Mr. White's efforts such provisions were inserted in the treaty which concluded he conference. The following acknowledgment has

been received from the chief rabbi of Morocco:

Thanks America "TANGIER, April 23, 1906 .- Your Excellency: With a deep sense of gratitude it is my pleasant duty to express to you my warmest thanks for your intervention in the name of your government at the sitting of the Algeciras conference April 20, in favor of the Jews of Morocco. As representative of the leading Jewish community in Morocco, I am sure I am faithfully interpreting the sentiments of every one of my co-religionists in this country by requesting you to be good enough to convey to President Roosevelt and the American government the expression of our grateful feelings for their noble and generous intervention

n our behalf. "I pray God will send his blessings to the liberal American nation, champion of justice and supporter of the weak and oppressed. May she have unending prosperity and be always great as the van guard of nations for the welfare of humanity. I have the honor to be, sir, your most humble and obedient servant.

Sing Sing Inmates Receive Reward for Good Conduct

"The convicts in Sing Sing and other prisons throughout the state will have honor marks attached to their clothing as a reward for good conduct. The new rule, which was instituted by Superintendent C. V. Collins, went into effect June 1. For each year of good behavior a prisoner will receive an honor bar, to be worn on his coat sleeves between the shoulder and elbow, and at the end of five years those bars will be replaced by a star. Should a man be unfortunate enough to lose his bars on account of a serious infraction of the rules, he may win others by subsequent good conduct.

Privileges Extended Numerous privileges are extended to

the honor men. Those wearing bars may write a letter every two weeks and may purchase articles every month. # 3,000 LIVES LOST FROM BAD MEAT

So Says General Miles, Speaking of Recent Disclosures

DENVER, Col., June 9.-General Nelson A. Miles was in Colorado this week. He delivered the principal address at the commercement exercises of the state university at Boulder. In an interview Gèneral Miles said he believed the beef trust the worst of the trusts, that it regulated the price that should be paid for the cattle, and fixed the price for the consumer. He said that he thought packers who sent out impure meat should be sent to the penitentiary.

Death in Bad Meat

General Miles, referring to military matters, said there was no question in his mind that fully 3,000 soldiers lost their lives in the Spanish-American war because of the impure meat they were compelled to eat. This meat, he said, was put up by the same packers now in the limelight. He said he had seen man after man under him grow thin and pale and finally die because of the awful meat that was given them, furnished by the beef trust. He claims that the meat sent to American soldiers had been originally prepared for Chinese and Japanese soldiers, and that it was merely meat pulp with the essence and strength extracted. General Miles declined to comment on the Neill-Reynolds report.

Terrell, representative in the Twentyninth legislature and author of the Terrell election law, gave out the following today, in which he comes out for Judge Bell for governor and tells some interesting things about the administration of Governor Lanham, and roasts some of the opponents of Judge

"Though I will never again be a candidate for public office, my interest in the prosperity of Texas is undiminished, and as a private citizen I propose to state some strange features in the present contest for governor.

"When public affairs are never discussed except by candidates for office, and who remain silent until they want an office, it is time for people to begin to think for themselves. The apathy of the people over the pending canvass is alarming. This is a danger signal; for at such times political adventurers can ply their trade and make false issues to deceive the masses of the people. This indifference to public affairs is the natural result of universal prosperity and of the fact that we have practically but one political party in Texas.

"There are now four candidates if the race for governor. Certain news. papers and some of the candidates are training their guns on Bell and charging that he is the friend of Governor Lannam, that his success would be a continuance of Lanham's policy, and that Bell is the candidate of corporations. So the effort is made to defeat Bell by trying to make Lanham odious. Plain people who are honest will now inquire: 'What has Governor Lanham done to deserve cen-

Lanham's Record As Governo

"The last democratic state convention by a unanimous and rising vote indorsed the administration of Governor Lanham as 'wise and patriotic.' Since that time he has urged by his messages to the legislature, and personally to its members, that they should carry out all the demands of the democratic party as expressed in its platform, and especially to stop free passes on railroads and the practice of nepotism. His policy is precisely what it was during his first term. The legislature failed and refused to observe the demands of party that elected them, and, in doing this, disregarded the urgent appeals of the governor, and yet we find newspapers assailing the administration of Lanham as weak. Is this fair? Why not be honest and tell the people that the failure of the legislature to pass laws demanded by those who elected them must be charged to the legislature and not to the governor. The people are not deceived; they know that the governor cannot make laws, and if there was weakness in not carrying out the popular demands, it was not in the governor, but in the lawmaking department of the administra-

Danger Ahead

"The people must choose more carefully their members of the legislature. Our last legislature was an able body, but it did not carry out the demands of the people. If we neglect much longer to hold legislators responsible for neglecting platform demands, some of these days there will be a ground swell of popular resentment that will sweep the democratic party from

"A few papers opposed to Bell have charged Governor Lanham with practicing nepotism. Such a charge is ridiculous. He appointed his son as confidential secretary, and he did right, for he appointed no other kinsman, and in that there was no nepotism. Lanham and the Election Law

"Other journals find fault with his, failure to recommend a blanket count in nominating conventions at the special session. The legislature had months to de that in the regular session, and refused to do it. They then asked the governor to reconvene them for one special purpose and he did it. It was known to all that the senate was opposed to a blanket count in nominating conventions, and this opposition has destroyed half the benefits of the election law, but Governor Lanham could not prevent it. # SAN ANTONIO PENS **ARE UNSANITARY**

Proprietors of Six Slaughter Houses Arrested

Special to The Telegram. SAN ANTONIO, Texas, June 9.- As of this city yesterday afternoon by the board of health warrants will be issued citing the proprietors of six of the slaughter pens to appear in the corporation court Monday and show cause for having maintained a nuisance. The investigation of the menibers of the board of health showed that the killing of cattle and hogs was done in an unsanitary manner.

Four slaughter pens were visited and in each instance conditions were found to be fully as bad as described by the inspectors who made the investigation several days ago. In the inspection party were Drs. H. D. Barnitz, S. Burg, E. H. Hertleier, T. H. Muegg, secretary of the board of health, and Inspectors Backmann and Miller. The board of health is in favor of abolishing the pens altogether and suggesting that the owners of different pens make a combination so they can afford to keep their places clean. It is the intention of the board to

keep on arresting the offenders of the nuisances if the nuisances are not The inspectors discovered evidence which may lead to condemning some of the meat of animals slaughtered shortly before the visit made by the

board. An inspection was made of the two packing houses. They were found to be in a fairly sanitary condition and there is no complaint to make against

MEDICAL COLLEGE GET HIGH HONOR

Given Degree in Denver

FT. WORTH MAN TO

Professor N. B. Heller, professor of mathematics at Fort Worth University, left Friday night for Denver, where he will be the recipient of notable honor at the annual commencement exercises of the University of Denver, which begin Sunday. Next Wednesday is commencement day and on that occasion the degree of doctor of philosophy will be conferred on Professor Heller. This is the highest degree conferred by American universities and represents a large amount of work on the part of the one who receives it. Professor Heller's thesis is written on the subject of "Orbits" and discusses the results of work done by him at the observatory in Denver.

Answers Were Perfect He was highly complimented by Dr. Howe, head of the department of astronomy at the university, for the scholarly way in which the subject was treated and his thesis was returned to him without correction. In the written examination which he was required to pass, his answers, covering forty closely written pages, were marked perfect.

Professor Heller is a graduate of the University of Pennsylvania, receiving the degree of B. S. in C. E. at that institution. He later won a scholarship in Clark University and after being in school there one year was elected to a fellowship in the University of Chicago. He was at this institution four quarters and left to take a position in the department of mathematics at Drexel Institute, Philadelphia. He attended the University of Denver two summers and there completed the residence work for the doctor's degree, which he will receive next week.

This degree is conferred only upon the completion of at least three years of resident graduate work in a recognized university. The department of astronomy at Denver is one of the best in the United States and the observatory is provided with splendid equipment. Dr. Howe is a recognized authority on astronomy.



## CAMPAIGN OF COL. CAMPBELL

Colonel Thomas M. Campbell, the sage of Palestine, who is conceded to be the second man in the race for governor of Texas, is making an active campaign and raising a great deal of political sand in different portions of the state in his crusade against corporations in general and the railroads in particular. And while Colonel Campbell is raising this sand some of the newspapers have been making a little inquiry as to the genial colonel's record during the time he was a railroad magnate. The Houston Chron-

Colonel Campbell made a speech at Smithville the other night, and, according to the Times, if what the colonel said, as reported therein, is true, this glorious state of Texas is in a terrible predicament. The liberty of every citizen is restrained, his freedom is visionary, and the commonwealth, as a whole, is resting on a thin wave of perdition. What a nice morsel this is for the stranger, and they are here by the hundreds, to swallow. On the top of it the colonel proposes to lead a downtrodden people and a citizenship that is wholly without intellecaccording to his notion, along a primrose path and into an atmosphere of "more holier than thou" contraption. Is it any wonder that most people

shudder and shrink away from such talk. Surely, he has forgotten about the days when he was the star lobbyist in the legislative halls of this great state, and labored with might and main to throttle the will of the people as expressed by a legislative assembly If there ever was a time when the wel fare of the people of this magnificent commonwealth dangled in the balance it was when Colonel Campbell was at the head of the railroad lobby at the state house, and did everything within his power to deliver the state into the hands of the corporations, especially making the state subservient to the whims of the Goulds in general, and the International and Great Northern railroad in particular. Here is what Colonel Campbell had to say at Smith-

ville, as reported in the Times:

"While here, as everywhere, organzed corporate power is seeking to fasten its iron hold upon the people's government, while the trusts are forgng their merciless shackles upon the industry and energies of the patriotic people of the commonwealth and stifling individual efforts, while their unconscionable and unscrupulous ally machine politics, is plotting and planning for a government of the corporations, for the corporations and by the corporations, still there are indications that the sleeping giant, the people's power, is again astir. The whole people of Texas are again manifesting disposition to take an active and firm hand in public affairs that pres-

ent evil tendencies may be checked. "My fellow citizens, in the face of these conditions we are told by that part of the press dominated by the corporations and those in league with the special privilege class and corporate lawbreakers, that there are no ssues of commanding importance in this campaign. Indeed, many well meaning people have listened to that siren song until they believe, and are saying that there are no questions of now calling for settlement in this country. If you point out the evils lurking in the way of good government and suggest a remedy, you are stigmatized as the patron of an ancient prejudice and as a demagogue.

Leaving out any discussion of Colonel Campbell's railroad record, which has now become a matter of ancient history, The Telegram thinks the distinguished gentleman should be propTexas is not reduced to the desperate straits where his campaign argument places the state. Corporate greed and rapacity is a fearful thing when it is in full bloom and the people are compelled to submit to its dictation. But such conditions do not prevail at this time in Texas. It may be true that there is a disposition on the part of large combinations to bear down with oppressive force upon the people, but if the people submit to such a procedure they have only themselves to blame for the burdens that have been placed upon their shoulders.

The Telegram believes there is ample law already existing in Texas to put every combination that may be existing in the state entirely out of business, and if there is any oppression of the people the fault lies with officers who are charged with the proper enforcement of the law. Instead of lending encouragement to a gubernatorial aspirant who seeks to incite the passions of the multitude against every form of corporate investment in Texas, the duty of Texas people is obvious. They should satisfy themselves that the conditions complained of are reasonably true, and when satisfied on that score further

procedure is simple. The remedy lies in the election of officers who will enforce the existing laws, and the governor has no more to do with that feature of the situation than an ordinary citizen. The attorney general, the district attorney, the county attorney and the gentlemen upon the bench are the ones who are charged with the enforcement of the law in Texas, and they are the ones who should be looked after in the state campaign. The governor can recommend matter for legislative action, but he is not the ex-

ment of the majesty of the law. Colonel Campbell is an honest man and a good citizen, but he is letting his desire for gubernatorial honors overcome his usual sound discretion. He is setting up a bogey man for political purposes and is engaged in a crusade that must inevitably injure

never escape from corrupt machine politics in nominating state officers until the power to swap and sell out is taken away from convention delegates. To prevent this I tried in vain during two sessions to secure a second primary election between the two foremost candidates if neither of them had a majority of the popular vote, and I failed. How is it now, with the field full of candidates? The votes of the people it is true are first counted, but when the weakest man after each ballot is withdrawn, what becomes of his votes? The delegates vote them as they please. This is the harvest of the corruptionist, who will be on hand, and then delegates and not the people will nominate a governor. Governor Lanham is not responsible for this, for the friends of clean elections have always had his full sympathy and co-operation. Governor Lanham, like myself, is fast approaching the sunset of life, and is entitled to fair play in this canvass. The attacks on him are inspired by methods so transparent that a child should see it. Those who are urging the defeat of Bell charge that his elec. tion would result in a continuance of Governor Lanham's policy, and they seek to hurt Bell by breaking bark over Lanham's head.

"We should not forget that a majority of the last legislature voted against carrying out the platform demand. Their combined influence is great, and their constituents must either censure them or the governor. There is also a little army of disappointed men who wanted official appointments and feel hurt. It then was and still is the most comprehensive railroad commission law in the United States, and now if the state cannot control the roads under these vast powers of the commission, what folly to elect a governor on an anti-railway corporation issue.

"There was a time, nearly thirty years ago, when I tried in the senate to protect the cause of individualism against the extension of corporate power, and had little help. My prediction that if we suffered the corporations to peddle in the daily avocations of life they would end by combining and fix prices of all things for the people was not heeded. Now the trusts are upon us. Charley Bell sustained me then and is now assailed as a candidate of the corporations. How unjust and

# Wafers NINTH STREET TO BE PAVED

Completion of Work Soon Appears Assured

WORK ALREADY BEGUN

Proposed Improvement Will Extend From Rusk Street to the City Hall

There is a strong probability now that the paving of Ninth street, from Rusk to the city hall, will be one of the next paving jobs undertaken. 
