

Had His Money on Deposit

Kowalski's relatives assert that he was innocent of any knowledge as to the mismanagement of the bank by President Stensland. When the bank failed Kowalski had \$700 of his own money on deposit in the institution and his immediate relatives nearly \$50,000. Had the teller known of Stensland's defalcations, they assert, he would at least have notified his es and would have taken his

The region over which the heavy rain

extended is not great in area, not reaching much out of Tarrant county to the west, but covering the territory north as far as Sherman and Paris. At Snerman the precipitation was heavier than here, being 3.52 inches, while here t was but 2,86 inches at 7 o'clock. Paris had 1.92 and there was a lighter rain at Weatherford. Dallas had .74 of an inch.

The damage done by the storm in Fort Worth falls most heavily on the telephone companies and the laboring people, who had to lay off a day as a result of the rain. The Southwestern Telephone and Telegraph company suffered to the amount of 250 phones out of order. Two of their cables were put out of commission entirely and another injured. The Fort Worth Telephone company had a number of instruments out, but the number could not be accurately learned.


River Rises Rapidly

The Trinity river rose rapidly during the morning and at 11 o'clock the water was running about three feet over the old dam, the rise having been four or five feet at the waterworks. At the suspension bridge west of the court house the water was leaving the river banks at 1 o'clock and still rising. However, unless there be further heavy rain, no serious overflow is anticipated. The official at the city waterworks station reported that his rain gauge had received 3.25 inches of water at 7 o'clock this morning, showing that the rainfall was much more on the river bottom than on the higher level in the

city. Rainfall Over Three Inches

The rain which fell at Fort Worth and vicinity Saturday morning was one of the heaviest of the year, almost

three inches having fallen up to 7 o'clock in the morning, and fully .60 more by noon. The total precipitation during August previous to this rain was .40 inch, making the total for the month to date nearly equal to the rainfall in August, 1896, which was 4.78 inches, and the greatest in the eleven years during which the station of the weather bureau has been maintained in Fort Worth. The rain is far in excess of the greatest previous precipitation for any twenty-four hours in

LAWTON, Okla., Aug. 11.-Southwest Oklahoma and Northwest Texas were again flooded with a fierce downpour of rain last night. The report from all towns give accounts of deluges

in the low districts and rapid rising of streams and extensive damage to crops. An ugly cloud giving evidence of a cyclone, appeared in the southwest early yesterday evening and reports of extensive damage reached here from Frederick today. The reports are not confirmed, owing to the poor condition of telephone and telegraph wires.

Water is running over the railroad tracks south and west of here. Washouts and consequent detention of trains are reported from Ryan and Comanche, I. T., on the main line of the Rock Island, Small bridges are washed out all over the southwest country.

Trains Go Slow


Railroad tracks throughout Southwest Oklahoma are in a dangerous condition since the recent heavy rains. All trains are running at reduced speed and the regular schedules are temporarily abandoned. No serious wrecks have been reported. Wednesday evening the engine and water tank attached to the southbound Enid and Waurika train were derailed on account of soft track two miles north of Apache. The Chattanooga train that runs over the same line, going south

of the wreck, received the mail, baggage and passengers and made the run to Waurika instead of the regular train. Water is running over portions of the Waurika and Chattanooga lines.

Rain Injures Crops

Special to The Telegram. TULSA, I. T., Aug. 11.-Six days of continuous rain have done great injury to this section of the country. Everywhere comes reports of injury to crops, especially to cotton. All rivers and smaller streams are swollen and over their banks and lands adjacent are inundated with many feet of water. Railroad traffic is retarded. The Frisco, Katy and Midland Valley have suffered washouts and all trains on these roads have been delayed from

one to five hours the last two days. Business in the city is feeling the effect of the wet weather and merchants and others report "nothing doing."



Thus far the Associated Press has only been able to obtain meager details of the affair, from which it appears the grand duke was personally reviewing the maneuvers and putting the troops through blank firing practice, when he was suddenly startled by a wasp-like hiss of bullets about his head, but fortunately neither himself nor his horse were touched.

At the command they ceased firing immediately, the soldiers from the regiment from which the bullets came marched back to quarters and an investigation began in hope of ascertaining from the barrels of the rifles which soldiers fired ball cartridges.

May Have Been Accident

Several arrests are understood to have been made. One of the grand duke's aide de camp, who, however, was not personally present, advanced to the Associated Press the theory that possibly the bullets were fired by accident, but he considered it beyond doubt there was a plot on hand and a number of guardsmen who deliberately planned to take the grand duke's life, under cover of the general blank cartridge firing.

"It is not more an accident," said the aide de camp, "than the firing of a charge of grape from a saluting battery at the Winter Palace on the occasion of blessing the waters of Neva by the emperor a year and a half ago." The bold attempt on the grand duke's life caused an immediate change in the plans of the emperor, who arranged to go to Krasnoye Selo today and spend a week with the soldiers of his imperial guards.

Affair Kept from Press

It was learned that the troops were in extended order and engaged in volley firing when the "accident" occurred, rendering it difficult to determine the regiment from which the bullet, came. The grand duke was surrounded by officers and aides-de-camp off on one side, out of the line of fire. The affair created a deep impression in military circles and is the one topic of conversation in the clubs, but the attempt on the grand duke's life is not generally known here, no word on the subject having been published in the



Jones County Man Proposes Use of Auditorium

S. M. Young is a Jones county man who resides at or near Abbie, and is engaged in stock farming.

"I have been over to Dallas attending the Farmers' Union and am on my way back to my home. Everything seemed to move along smoothly in the union.

"I can only repeat what all Jones county men will tell you, that is, crops, cattle and grass were never better and the people are, or ought to be, in a satisfactory frame of mind, if they ever expect to be.

"You Fort Worth people certainly are pushers, and this push you have gotten now will, I am sure, push your city up to the top of the heap as far as cities go. The auditorium and stock show will be a big thing and if you will only fix it so that the Farmers' Union and other large bodies which have annual meetings somewhere, could have a place in which to meet, it will help the whole country and, when any of we farmers want first class breeding hog, sheep or jack, all we will have to do is to come down to the show, look at what is on exhibition and then hunt up the owner and get what we want from his herd at his home. The wives could come along too and hunt up an old speckled hen or dominicker and a setting of fine eggs. In fact, there does not seem to me to be any end to the influence for good that this business will not bring into play."



Member Tells of the Farmers' Union at Dallas

Colonel John W. Childress, who now makes his home in Taylor county, posting his mail at Abilene, was here Friday, on his way from Dallas, where he had been in attendance on the Farmers' Union meeting. The colonel is a former resident of Cooke county, where he resided for some time in the early fifties, and is a brother-in-law to Coloned Joe Gunter, a well known stockman.

"Everything looks all right with us in the Farmers' Union," said he, "and we had a pleasant meeting, which was something like the old-time experience meetings of the Methodist church, where everybody told what had hap. pened in their communities since the last meeting. The members felt very much upholden at the success the organization has had so far, and came away hoping for the best to continue in the future.

"As to conditions in our county, why they could not be in much better fix. You never saw such crops of every kind and cattle are as good as anyone ought to want them. May Disappoint Negroes







DOWIE'S ZION \$299,980 AS FEE Former Prosperous Community Laura Biggar, Former Actress, Now Impoverished Sued for Bill

The state of the s

CHICAGO, Ill., Aug. 11 .- Twelve months ago the thriving population of Zion City was pouring thousands upon thousands of dollars into the coffers of John Alexander Dowie. Now John C. Hately, the receiver appointed by the government, has issued an appeal for a relief fund to stay the hunger of Dowie's old followers. Where a community of 5,500 tithe-paying people dwelt in prosperity a year ago, there are now a scant 3,000 persons menaced by want. They are unemployed, their land is valueless and their children are underfed and half clothed.

This is the story of the downfall of a city that was built on the self-made and self-administered religion of "Dr." Dowle, "the healer."

Pitiable conditions are found among the people. It was found that a majority of workingmen who live in Zion City now make their living in neigh-boring towns. Time was when laborers from Waukegan, Kenosha and other towns within a radius of twenty miles found employment within the growing city; when men even went from Chicago and secured work there at profitable wages.

Now in Kenosha and Waukegan can be found men of good families with homes in Zion City earning a bare living for themselves and those at home by working on new roads. Among these common laborers are those who once held positions as bank clerks, traveling men and aids to Dowie in his magnificent Mexican scheme.

Decline of Employment

In the general administration offices of Zion City last year there was employment at good wages for sixty-five clerks. Today there are fourteen on the first floor of the building and these are not certain that their labor will be repaid.

In the bank a year ago there were eight clerks. While they are away building roads a single small boy sits in the bank office to warn stragglers who may try to get in that the bank is closed. In the land investment department, where there were twenty-six clerks, there are left only three and the telephone force has been reduced from four to one.

Conditions at the hospice furnish added proof of the decline. The visitor to Zion City used to find the dining room filled and every room tenanted. To one who dropped in today there was presented no spectacle of booming business; just twenty-six discouraged men and women were seated about the dining room at luncheon. Some of these were invalids, who, as one of the half-alive waiters expressed it, could not leave the hospice. Others were officers in the once pros-

It is this man who is reputed to be the father of Miss Biggar's son Willis.


Her most sensational role was when she essayed the character of Iris, the model in the famous disrobing scene in "The Clemenceau Case." For moons she was the rage of the gayer portion of New York theatergoers. Laura Biggar was possessed of some talent and ability. This, coupled with great magnetism and beauty, decided Charles H. Hoyt to cast her as the vivacious widow in "A Trip to Chinatown." She made a great hit in this part and toured the country. Burt Haverly, a well known minstrel, was playing the part of O'Day in this company, and they were married.

Miss Biggar first met Henry M. Bennett at the Duquesne theater in Pittsburg. It was a trifle more than five years ago that fate merged the life lines of the aged millionaire and the dashing actress. He was fascinated by her manifold







FINAL RESULT AT DALLAS

Alderman Bill Shaw of Dallas, best known to fame however as Farmer Shaw, has been a firm and consistent supporter of Judge Bell for governor since the beginning of the campaign, and thus summarizes the situation:

"If Bell be fourth in the race, his vote, when he is dropped, will be pretis evenly divided among the other three, with the chances that Brooks will get more of them than either of the other candidates. On the second ballot, whether Colquitt or Brooks is dropped, Campbell, it seems to me, because of evident alignments, would have the necessary majority.

"If, however, Brooks is the first candidate dropped, a very large mafority of that vote would naturally, It seems to me, go to Bell and insure Mr. Colquitt as the drop-out on the second ballot, leaving the race between Campbell and Bell, and I think this would nominate Bell

"However, while I have been for Bell on the sole ground that he is in every sense the best equipped man in the race, still we will have a pretty good governor no matter which candidate lands. Of course, I'd like to see Bell climb to first place when all the returns are in, but if he gets to second place he is a sure winner. I think, and If he only stays at third, with the small margin as to votes now in still remaining, he has a mighty fine showing. With Bell in fourth place, Campbell, it seems to me, has a cinch, although his vote is less than 33 1-3 per cent of the total vote."

Farmer Shaw needs to revise his estimates. In the first place, Judge Bell is not fourth in the race and will not reach that level. The fourth seat in the gubernatorial procession has been reserved for Judge M. M. Brooks, the water wagon candidate for governor, who was favored by the extreme prohibitionists and Senator Joseph Weldon Bailey for first place. The third seat is occupied by Oscar Branch Colquitt, who was treated so badly by Brooks in Kaufman county. Judge Bell is occupying the second seat and is preparing to take possession of the front seat, which has been pre-empted by a gentleman from East Texas.

Brooks will be the first man dropped and Colquitt will be the next sacrifice. There will be a split in the vote of each man as his name is dropped, for the politicians have the situation well in hand and will prolong the agony as long as possible. Then will come the final fight between Bell and Campbell, which will result in the tri-

umphant nomination of Bell. The fact that Judge Bell has second place ought to cause the Farmer to issue an immediate revision. There has apparently been a very determined effort to keep him out of his rightful position as long as possible, but the official figures cannot be juggled with. When the vote of all the counties has been counted and officially prorated it will be found that The Telegram has been correct from the very beginning that Judge Bell had sec.
