

# LIGHT THROWN ON **KAISER'S ACTIONS**

France Aroused Over Revelations About Bismarck

By Associated Press. PARIS, Oct. 13 .- The revelations resulting from the publication in German of the late Chancellor Von Hohelohe's "Recollections," continue to make a great stir in France on account of the sidelights thrown on the German policy toward this republic, and today in connection with the centennial tomorrow of the battle of Jena, which opened the gates of Berlin to the victorious French army, newspapers here are filled with articles on the subject. The general verdict is that Emperor William's action in dismissing Prince Bismarck for counseling infidelity to Germany's ally, Austria, was highly honorable to the emperor, but nevertheless entailed grave conse-

#### Kaiser More in Light

quences.

The Republique Francais points out that Bismarck's object was to repair the bad effects of his policy at the Berlin congress by insisting on a renewal of the secret "reinsurance" agreement with Russia, previously existing despite the Austrian alliance. Emperor William, the paper adds, threw Russia into the arms of France, thus becoming responsible for the diplomatic situation of which he now complains, and which he vainly attempted to modify by his bold stroke of policy at Tangier.

Under this act of the legislature railways are requested to provide suitable and separate toilet rooms for male and female patrons within or in connection with their depots or passenger stations, and a penalty of \$100 a week is imposed against any railroad falling, neglecting or refusing to comply with the act.

The penalty prescribed by the act has been -construed differently by a number of trial courts and the validity of the law was assailed, among other grounds, because it being a pena law, must be strictly construed, and since the penalty named in the law is indefinite, it is contended that the law is inoperative and void for uncertainty. Other grounds are being urged on the appeal, among which are that all doubts of construction must be resolved in favor of the defendant; and since there is such an ambiguity in the act under review as to leave reasonable doubt of its meaning, the penalty cannot be inflicted.

most disastrons fires in the history of Bryan occurred last night from 10 to 12 o'clock. The compress was totally destroyed and with it from 1,500 to 2,000 bales of cotton, with seven or eight freight cars leaded with cotton that stood on adjacent tracks. A large cotton warehouse near by

was narrowly saved and some fifty bales of cotton on the outside that could not be gotter into the building were burned.

The fire was said to have been caused by a spark from a passing locomotive. In just a few minutes the entire building and the hundreds of baies of cotton were a mass of flames.

There were several locomotives in the yards of the Houston & Texas Central and International & Great Northern railroads and they acted promptly and saved a number of cars by pulling them out of danger. Fourteen cars were burned, but only seven were loaded with cotton. The firemen had great difficulty in saving a number of nearby buildings. The stock of the compress company

amounted to \$28,500 and the entire plant was valued at \$40,000. The total loss will reach in the neighborhood of \$125,000.

The compress was entirely destroyed by fire once before about seven years

# AGE SHOWS IN PAVING

Many Depressions on Main Street Alone

# **REPAIRS NEEDED**

Traction Company Is Doing Its Part-Will Be Acted On by City Council

The condition of the brick paving on Main street has caused some comment more with reference to the condition of the pavement immediately adjacent to the street car tracks of the Northern Texas Traction Company, tho there are other places where the pavement has worn to some extent.

From the court house to the Texas and Pacific station adjoining the street car tracks there are depressions in many places so deep that narrow tired vehicles may catch in the depressions and against the rails.

On the part of Main street beginning at Seventh street and extending southward the street car company has begun the repairs of that part of the street; in fact, relaying the entire space for which it is liable, that is to say, the space between the tracks and for eighteen inches on each side

The company has been delayed by an inability to get the bricks necessary for the work of relaying or repairing, where the latter will suffice.

There are other places in the pavement of Main street which are not in perfect condition and a careful examnation of all of that work shows the following defects:
