Mrs. Ava Childers, city secretary, stated Monday of this week that Doyle Burchfield filed for a place on the city ballot as a candidate for mayor and F. C. (Slim) Newton filed as a candidate for alderman.

With the deadline for filing passed, the ballot will carry the names of two candidates for mayor and four candidates for the two aldermen places.

Scott Field Gains 2 Producers; Five Rigs Drilling In Area

With five rigs drilling in the new Scott Field, nine miles west of town, prospects for a real oil boom in the area continue to become better with the passing of each week.

Two new wells were brought in last week and according to reliable sources they are the best yet discovered. Woodson Producing Co. brought in one on the Naomi Heysler tract and another flowing well has been completed on the Adelia Scott tract.

Five Wildcats Stated

Spotted as a 1,950-foot rotary wildcat 10 miles southwest of Cross Plains was Melvin Ochs No. 1 Fred Cutbirth. Location is 330 feet from the south and east lines of N. B. Johnson Survey.

Allen Dykes, et al. of Abilene No. 1 H. W. Ross is slated as a wildcat five miles northeast of Clyde. Having a proposed depth of 1,700 feet with rotary, it is located 330 feet from the north and west lines of the southeast quarter in the southwest quarter of Section 85, BBB&C Survey.

The fifth wildcat is Rogers & Thomas of Waco No. 1 J. S. Bentley, located two miles southeast of Eula. Location is 2,110 feet from the north and 750 feet from the west lines of Section 19, BBB&C Survey. It is slated for 1,999 feet with rotary.

Editor's note: The Bayou Philosopher on his Johnson grass farm on the Bayou must have gotten the wrong number the last time he was in town to use the telephone, his letter this week indicates.

I was reading in a copy of a newspaper which my wife had lined a bucket with to keep the eggs from breakin she was takin to town, some people thought radio would put the newspapers out of business, then they decided television would, but I've got my first time to see anybody try to line an egg bucket with a radio or a television set, at any rate, I was out here reading this newspaper and tryin to stay warm on the south side of the barn durin the recent cold snap and an article attracted my attention.

It was about telephones in Japan. According to it, up to now the public telephones in Japan have been on an honor system, after you get through usin one you're supposed to drop a coin in the slot, instead of before, which just goes to show how backward the Orientals are, because the telephone company found out most people, after they got through talkin, didn't figure the conversation was worth a nickel, and left nothing.

However, I sort of like some aspects of the system. Under our system here in the United States, you pay a nickel at a public telephone before you get to talk to your party, and while this is fine for the telephone company and maybe all right with the person

Slated for 1,900 feet with rotary, it will be 500 feet from the west and 7,440 feet from the south lines of Thomas H. Brown Survey 215.

In the Scott, Cross Plains Sand Field ten miles west of Cross Plains, R. W. Brown of Abilene will drill the No. 1-B Naomi Heysler.

Drillsite is 2,310 feet from the east and north lines of William Scurlock Survey 211. Depth will be 1,900 feet with combination tools.

C. L. Wann, et al. of Abilene No. 11 E. W. Arledge, regular field project three miles east of Cross Cut in N. B. Mitchell Survey, has been completed as a producer.

It flowed 33.64 barrels of 43 gravity oil in 23 hours, pumping from open hole at 1,293-1,315 feet. Top of pay was 1,292 feet.

J. C. Kattlesen of Dallas No. 3 W. P. Thomas has been staked as a Cross Cut Field project a quarter of a mile south of Cross Cut.

Slated for 1,400 feet with rotary, it will be 3,100 feet from the south and 3,125 feet from the west lines of William Travis Survey 143.

Three and a half miles northeast of Cross Cut, John Stoker, et al. of Healdton, Okla., potential the No. 3 Hickman as a regular field producer. It is in F. M. Kinsey Survey.

No. 3 Hickman pumped 25 barrels of 38 gravity oil in 24 hours from 72 perforations at 1,279-1,300 feet. Casing was set at 1,613 feet and total depth was 1,320.

Branded Enterprises of Abilene have staked the No. V-18-C Westerman as a regular field project two and a half miles east of Cross Cut.

It will be 300 feet from the south and east lines of Section 150, Block 5 N. B. Mitchell Survey.

RE-STATEMENT: As the tempo of congressional activity increases, I would like to state again my idea of the proper role of the Democratic minority in this Congress. It is the right and responsibility of the majority to present a legislative program. It is the right and responsibility of the minority to point out the weak and the strong points of this program. Both opposition and support must be based on principle—not on partisanship.

FARM PROGRAM: This means that in considering farm legislation, for example, now the subject of committee hearings in both Senate and House, we must work for a program which will protect our farm economy without being unfair to other groups in our national life.

I oppose the sliding scale price support system—not for the sake of opposition, but because I know farmers already are in trouble and I don't want to see them pushed farther down the economic ladder. We can't get away from the record of history, which shows that the lower farm prices go—the higher farm surpluses rise.

TAXES: This concept of the minority's rightful role means that in considering tax reduction, to take another example, our purpose—during this period of "economic readjustment"—should be to seek the fairest means by which to increase consumer purchasing power.

That is why I favor increasing the personal income tax exemption. A \$200 per year increase would mean an annual saving of about \$160 for a married man with two children. Every family would have proportionately that much more money to spend for goods.

TREATY POWERS: Debate and voting on the Bricker Amendment was almost wholly along non-partisan lines. The amendment reported by the Senate Judiciary Committee never came to the floor for a vote. After voting for several provisions designed to close the constitutional loophole with respect to treaty-making powers, I urged Senator George to introduce a substitute amendment that would attain the basic objectives of Bricker Amendment supporters.

He did so. His amendment was supported by Senator Bricker and others among the sponsors of the original amendment. We lost by just one vote.

Nevertheless, a valuable purpose has been served. Americans have been alerted to the need for action to protect the constitutional rights of the States and of the people generally. The issue will be with us again, and I predict that some such measure as proposed will finally be enacted.

FOR TEXAS: I believe Texans generally feel, as I do, that all of us are Americans before we are members of any political party. As your Senator, I want to act in the best interests of Texas and of America. I have no higher ambition.

The celebration included publication of Bantam Books, New York, of his book, "Our American Government." . . . Texas State Society honored me with a second term as president . . . Several East Texans appeared before Senate Appropriations Committee on behalf of Ferrell's Bridge Dam and Reservoir, near Jefferson. I accompanied them and made a statement urging an appropriation to keep this vital project moving along . . . Joe T. Steadham and W. H. Winchester of Austin and John G. Carr of Cleburne were welcome visitors. They were here in the interests of the Railroad Brotherhoods . . . I was glad to see State Senator Rogers Kelley of Edinburg . . . I went with Dallas citizens to the Veterans Administration to protest against proposed transfer of Dallas District VA office to Denver . . . Let me hear from you.







"As It Looks From Here"

Washington, D. C.—The Congress has passed and sent to the President the measure which will allow farmers and ranchers to legally employ Mexican Nationals to work on farms and ranches and gather crops. Otherwise, Mexicans coming across the border would have done so illegally and be subject to deportation.

We were voting on this proposition at the time the shooting occurred in the House of Representatives. Of course, everyone has read about the incident or heard it on the radio.

To put it mildly, it was pretty exciting. The amazing thing about it all is that out of the twenty-four shots known to have been fired, only five members of the Congress were hit. The worst part about it was that there was nothing to do but hope you were missed. As it happened, I was sitting just about in the center of the House Chamber and there was no escape.

The day following the shooting incident, the Governor of Puerto Rico, Luis Munoz Marin, and his wife flew to Washington from San Juan to express their regret and to visit the wounded.

It so happened that my wife, Ruth, was going to the home of Mrs. McGregor, wife of the Republican Congressman from Ohio, for luncheon on Wednesday of this week. Mrs. Clifford Davis of Tennessee, whose husband was one of the victims of the shooting, is a close friend of Ruth's, and she also was attending the luncheon. Since Mrs. Munoz Marin was to call on Mrs. Davis shortly before noon, it was suggested that the Governor's wife come along to the luncheon. Following lunch, Ruth and Mrs. Davis brought Mrs. Marin back to her hotel and had opportunity to know her better.

The situation in Puerto Rico, because of this small terrorist band, makes it necessary that the Governor and his wife remain under guard at all times. They were registered at the hotel here in Washington under an assumed name.

Guar Is Good Cash Crop As Well As Soil Builder, SCS States

Now is the time to begin preparation for planting of guar. Seed should be secured soon along with an inoculant for inoculating the seed.

Guar should be planted in May or the early part of June about cotton planting time. Spaced in normal width rows, guar is a good soil improving crop. Five to six pounds of seed should be planted per acre.

Guar can be used as a cash crop by combining the seed. In addition to this, guar may also be used as a green manure crop by plowing up and leaving on or near the surface when the plants are in full bloom.

Since cotton, wheat, and peanut acreages have been restricted this year, many farmers are asking about soil improving crops for these diverted acres. Guar will fit into our cropping system extremely well. In average years guar will produce from four hundred to six hundred pounds of seed per acre.

Crops succeeding guar have shown decided increases over crops not following guar.

Guar seed can be obtained locally.

West Texas Utilities To Sell \$6,000,000 In Its Preferred Stock

Abilene—Price Campbell, president of West Texas Utilities Company, announced here today that the Company is filing an application with the Securities and Exchange Commission for the sale and exchange through competitive bidding of investment bankers and brokers \$6,000,000 in its preferred stock.

At the present time, the company and own 62 percent of all the out-ferred stock which pays \$6 per share. This is considered out of line with present day hire capital, so the stock will be called or exchanged in accordance with its provisions of \$110 per share or for the equivalent in face value of lower interest bearing stock plus some cash to those who desire to exchange.

Campbell advised that he may name a number of brokerage or investment firms in Texas to join with the successful bidder. It is hoped

that the successful bidder will be a Texas firm as he desire to retain in West Texas the present high ratio of stock ownership.

Sixty-five percent of the present preferred stockholders live in Texas and own 62 percent of all the outstanding preferred stock.

Of the funds received from the sale of this new preferred stock, about \$5,000,000 will be used in the exchange and expense of calling the old preferred stock. The remainder of about \$1,000,000 is to be used in the Company's construction program for this year.

Details of the new stock issue and exchange offer will be made available to the individual stockholders and the public in the near future.


