## CROSS CUT CEMETERY

SETTLEMENT BEGAN IN THIS AREA OF BROWN COUNTY AFTER THE CIVIL WAR WHEN SEVERAL FAMILIES FROM SOUTHERN STATES MOVED HERE. THEY FORMED A COMMUNITY, INITIALLY KNOWN AS CROSS CUT. IT BECAME CROSS CUT IN 1879 WHEN AN ERROR WAS MADE ON A POST OFFICE APPLICATION.

CAROLINE PENTECOST ELSBERRY WAS THE FIRST PERSON BURIED IN THIS COMMUNITY CEMETERY IN JULY 1877. THE TWO-ACRE PLOT OF LAND DEDICATED AS A GRAVEYARD IS BELIEVED TO HAVE BEEN DONATED BY MARK AND SARAH PENTECOST.

OIL WAS DISCOVERED IN 1923 IN THE CROSS CUT SAND FORMATION. THE SMALL TOWN QUICKLY SWELLED TO ACCOMMODATE THE INCREASE IN POPULATION AND SEVERAL NEW BUSINESSES WERE ADDED. BY 1940 THE POPULATION OF THE TOWN WAS EXCEEDED BY THE NUMBER OF BURIALS IN THE CEMETERY. IN 1954 THE CROSS CUT SCHOOL CONSOLIDATED WITH CROSS PLAINS SCHOOLS, AND THE TOWN DECLINED THEREAFTER. ONLY A FEW BUILDINGS AND THE CEMETERY REMAIN.

AMONG THOSE BURIED HERE ARE EARLY SETTLERS AND THEIR DESCENDANTS, AND VETERANS OF CONFLICTS FROM THE CIVIL WAR THROUGH THE VIETNAM WAR. A CEMETERY ASSOCIATION WAS FORMED IN 1976, AND A PERPETUAL CARE TRUST WAS ESTABLISHED. THE SITE CONTINUES TO SERVE THE AREA.

## CROSS CUT CEMETERY HISTORICAL MARKER

## CROSS CUT CEMETERY HISTORICAL MARKER DEDICATED

At 10:00 a.m., Sunday, July 20, 1997, a new historical marker was dedicated seven miles south of Cross Plains on Highway 279. The marker, approved by the Texas State Historical Commission earlier this year, stands beside the new entrance to the Cross Cut Cemetery and commemorates the centennial year of the little cemetery's existence.

The dedication ceremony was presided over by Roy Stambaugh of Cross Cut, current President of the Cross Cut Cemetery Association Board of Directors. More than two hundred former Cross Cut citizens and their descendants endured the July heat and watched as Mr. Stambaugh and fellow members of the association board officially unveiled the marker. Board members are: O.B. and Blanch Byrd and Scott Byrd of Cross Cut, Annie Mae Wright of Cross Plains, Charles and Charlie Mae Kizer and Oneta Hubbard of Brownwood, and Peggy Chambers of Abilene.

Following the unveiling, a wreath was set at the base of the marker by John Elsberry of Cushing, great-great-grandson of Mrs. Caroline Pentecost Elsberry; the first person to be buried in the cemetery on July 10, 1877. The placement of the wreath was followed by a historical address given by Ferrell Newton of Eastland, grandson of early pioneers Jim and Jane Newton. The ceremony concluded with a prayer given by Clois Clark of Graham, 86 years young and son of John and Judie Clark, also early pioneers of Cross Cut.

The event was covered by CBS affiliate, KTAB out of Abilene and aired on that station's 10:00 p.m. news. The Cross Cut Cemetery Association wishes to express its sincerest gratitude to Mr. Joel Fox and KTAB for the coverage.

Immediately following the dedication ceremony, attendees retired to the welcome air conditioning of the Cross Plains Community Center for the annual Cross Cut Reunion where they enjoyed purchasing souvenirs and bidding on silent auction items donated to the beautification project. The Board wishes to thank everyone who donated items for this event. The proceeds from both the sale of souvenirs and the auction came to \$924.10, less miscellaneous expense of \$83, for a total net of \$841.10, which will cover the balance deficit for the cemetery entrance and purchase a plaque to be attached to the brick entrance.

## Texas FFA Members Walk Away with Half a Million Dollars in Scholarships

Justin C. Richey was awarded a four-year, \$10,000 Houston Livestock Show and Rodeo FFA scholarship on Thursday, July 10, in ceremonies at the FFA State Convention in Amarillo.

Justin, the son of Roy and Karen Richey, was one of 50 recipients honored in the festivities. Justin graduated first in his class from Cross Plains High School. He plans on majoring in agricultural services and development at Tarleton State University.

Richey has played an active role in his FFA chapter. He has participated in the Houston Livestock Show and Rodeo and San Antonio Livestock Exposition. He received the Star Greenhand award and earned his Lone Star FFA degree. During the past year he has served as vice president of his local chapter and treasurer of the district FFA.

Justin's FFA team participation includes involvement with the senior

parliamentary procedure team and the dairy cattle judging team. He also has chaired and participated on several FFA committee activities.

Recipients of the FFA scholarship were selected by members of the Texas Education Agency. The selected students all demonstrated academic excellence and strong leadership skills throughout their high school careers. All Houston Livestock Show and Rodeo FFA scholarship recipients must pursue a degree in agriculture or life sciences at a Texas college or university.

In his speech to the students, Jim Bloodworth, president of the Houston Livestock Show and Rodeo, stated that the Show takes great pride in its financial contributions to the Texas FFA program. Since the scholarship program began in 1957, it has provided scholarships to more than 1,000 FFA members, representing a commitment exceeding \$8 million dollars.

These 50 scholarships were funded through net proceeds from the 1996 Houston Livestock Show and Rodeo and are only a part of the Show's annual education commitment. The FFA scholarships, combined with another 182 \$10,000 awards, 36 \$5,000 awards, 100 \$3,000 awards and 21 \$2,500 awards, as well as various other contributions to Texas colleges and universities, bring the Show's 1997-98 educational commitment to \$4,382,500.

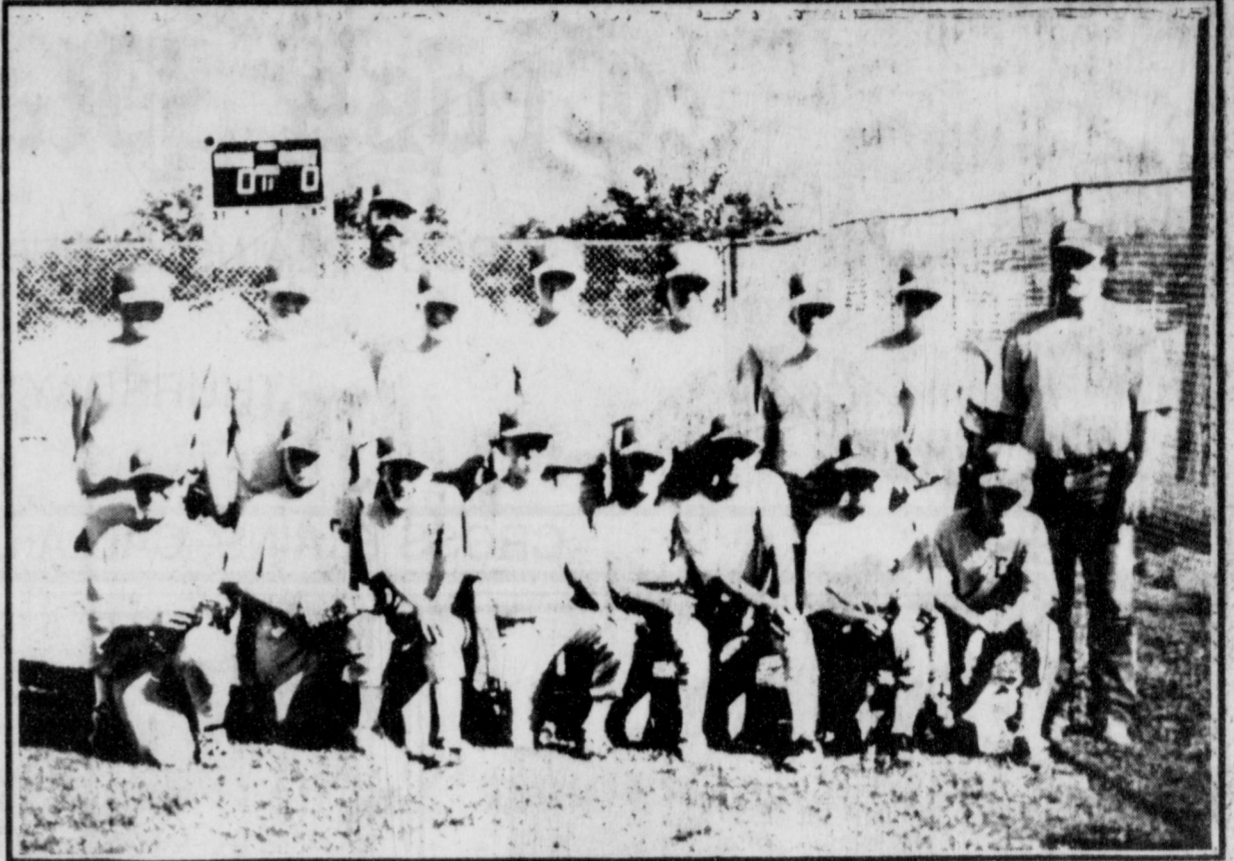

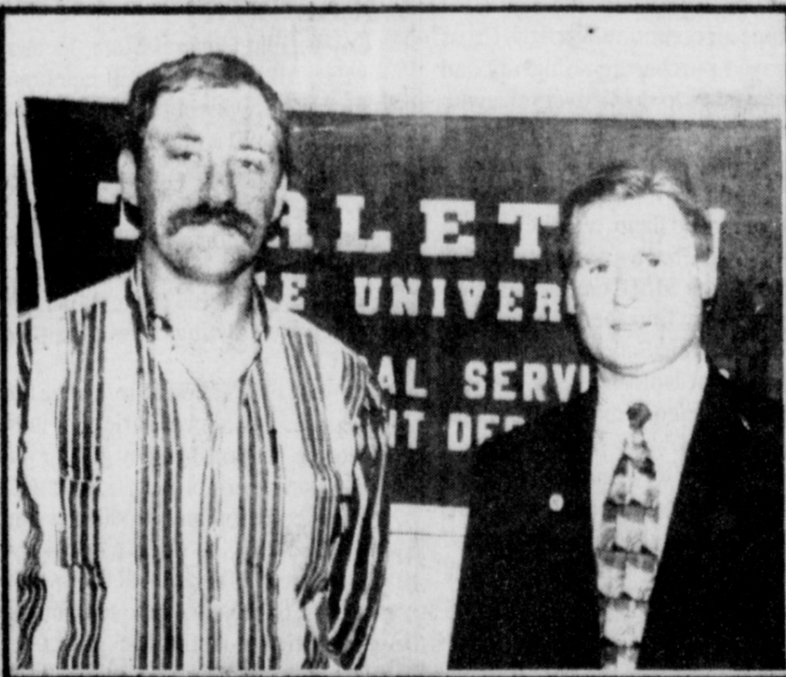

# Clips, Quips & Comments

"This N That and Other Chit-Chat"  
The Cross Plains Garden Club held its last meeting in May. Our meeting will resume in September with a newly elected slate of officers. The members are anticipating an outstanding year ahead. Meanwhile, many of us have been busy with gardening and yard work, pruning, fertilizing, watering etc. Flower gardens abound with luscious fragrant blossoms. We have been enjoying radishes and lettuce from our vegetable garden. We have already harvested, dried, and ground or pulverized a variety of herbs and stored them away in sealed glass jars. The first ones we've done are sage, fennel, mint, dill, parsley, marjoram, cinnamon basil, and thyme. I estimate that we save at least \$50 to \$60 per year at the grocery store just on spices alone. We do that by growing, harvesting, drying and grinding our own herbs into spices. We also save on lettuce, radishes, and fennel for celery substitution. This year I put in several herbs that I had not had before. They are really doing well with all this rain. Most of the herbs we have already harvested are almost ready to be gathered again. Among those not yet harvested are sorrel, chocolate mint, two different varieties of parsley, pineapple sage, lemon balm, lavender, tarragon, rosemary, bush dill, and two more batches of thyme all of which are new plants put in early this spring. Besides the herbs already dried and

stored away this summer, I still have several to harvest and store that were planted one to three years ago. Among those are oregano, onion chives, garlic chives, one rosemary plant, cress, peppermint and the horseradish and cilantro given to us last year by Rolan Jones. We planted some burpless cucumbers but they seem kind of slow-growing so far. The branches of the fennel can be picked from time to time and used in salads, stews and stirfry, which we do in place of celery. The bulb of the fennel plant is also edible, they are very good cooked until tender and finished up with a cream sauce, and salted and peppered to taste, (similar to creamed leeks.) We had extremely good luck last year with our parsnips. We plan to plant some more again this year. Next year I plan to put in more lavender and hopefully more basil. All of our basil plants did not come in this year. Moving on, I would like to thank Mattie Faye Wilson's third grade class for the beautiful personal notes they made and wrote for me near the end of the school year. They were just precious! I also wish to thank them for the beautiful basket of flowers they made for me. I'm still enjoying them. I was their volunteer during the school year and very much enjoyed working with them. A true privilege. Enjoy the rest of your summer. We'll all probably be seeing each other; all out working in our yards. "C" "U"

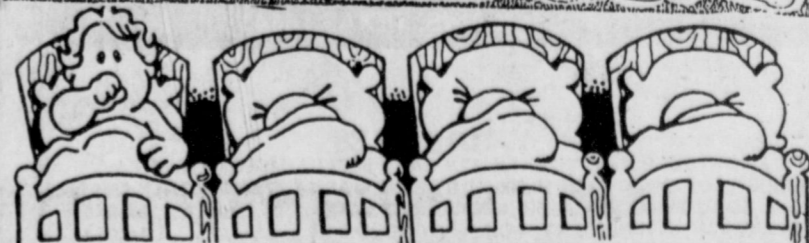

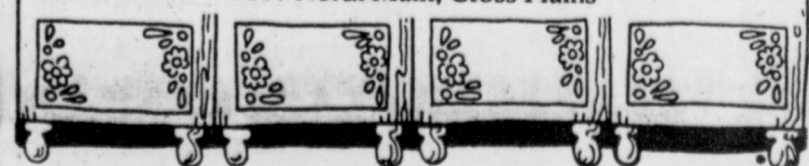

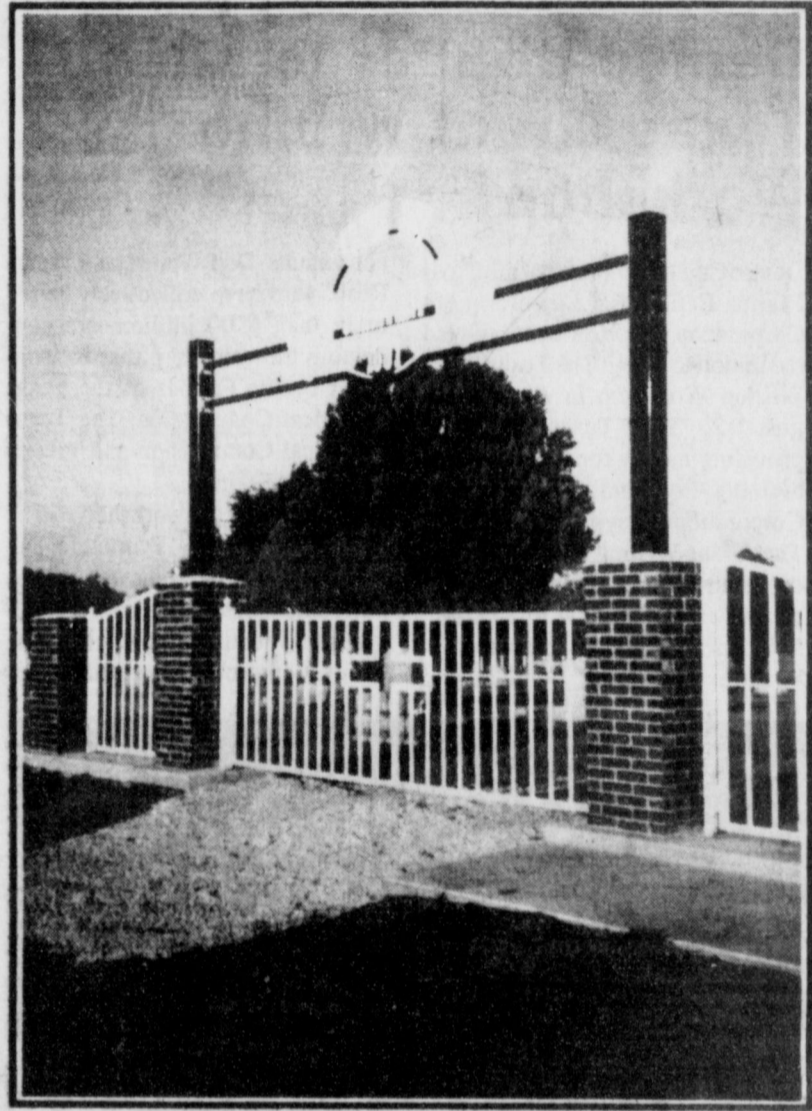
