

Callahan Co. Commissioners Addressed Issues From Hiring Part-time Help to Moving **Funds to CD's At Meeting**

BAIRD-Callahan County Commissioners met in regular session Monday, February 8 in the Commissioners Court Room. County Judge Roger Corn called the meeting to order with these officials present; Commissioners, Charlie Grider, Precinct 4, Tommy Holland, Precinct 3, Bryan Farmer, Precinct 2, Harold Hicks, Precinct 1, County Clerk Jeannie Bohannon, and County Treasurer Dianne Alexander.

-The minutes of the previous meeting were approved and Judge Corn mentioned that the Auditors Report had not been approved during the last meeting.

-Resolutions to support legislation that would aid counties with Capital Murder Trials and improve the County Road Systems was approved after a motion by Grider and seconded by Corn.

-A resolution to support the **Texas Association of Counties Loss** Control Classes was approved. Motion by Farmer and seconded by Holland.

-A request by the District Clerk for hiring part time help was discussed.

Corn recommended hiring a part time employee to work in the district clerk's office Monday, Tuesday, and 1/2 of Thursday.

Corn said that Rhonda Vestal had been hired to help part time in several offices, but more help was needed because both the Justice of the Peace Office and District Clerk's Office needed help on Mon-

"No," agreed Burns, "Sharon needs help with the child-support on Mondays and Tuesdays.

"I don't know anything about that," said Holland, "I just know what we decided and it was said that if the office (district clerk's) was computerized it would be a one person job".

"Wrong," said District Clerk Sharon Owens, "I never said that". Farmer said, "Also when we did this in October, we sat right here and asked three times, if there were any questions and nothing was said"

There was some discussion over whether Owens was present at the October meeting.

"We called everybody up here that time (for the October meeting)," said Farmer, "newly elected and elected officials. "We had the whole bunch here," Farmer said.

"I wasn't here that day," said Owens, "but once I got into the office and saw the work load, then I saw there needs to be someone there on Monday and Tuesday". "The computer sits there idle be cause no-one has time to work it," she added.

"Do you think you could find somebody to work Monday and Tuesday," said Grider.

"I sure could," said Owens, "If I could have her all day, it would be wonderful and would give her time to work child support in the mornings and the computer in the afternoon"

Both Burns and Owens said that their busiest times are Monday and Tuesday.

"Rhonda's trying to work both offices now and she just can't do all

No burn bans have been enacted in 1999 in Callahan County as conditions have not reached a dangerous level yet.

County officials request that anyone planning to burn to please Call local authorities before lighting a controlled burn. Many hours are wasted by Fire Departments each year when they respond to "Controlled Burns" that haven't been reported as such.

To report a "Controlled Burn" in Callahan County call the Sheriff's Office in Baird at 854-1444 and give them the location (county road or highway address, and nearest intersection), property owner, person to contact with a phone number, and time the burn will take place.

Texas Natural Resource Conservation Commission rulings, that took effect in September of 1998, give specific guidelines on all outdoor burning. Some excerpts from these regulations are as follows:



County Clerk Attended Educational Conference in Jan.



The Greek word from which "worship" is translated in the New Testament means an act of homage or reverence," literally "to kiss toward." The only recipient of worship is as an angel directed the aging apostle John: "Worship God." (Revelation 19:10; 22:9)

Actions wherein we worship God may be thought of as "acts" or "avenues." In last week's Breakthru I noted some New Testament guidelines in regard to scriptural "avenues" of corporate worship -- studying God's word, praying and partaking of the Lord's supper. In regard to the Lord's Supper, the first day of the week, Sunday, is the New Testament example and pattern for this time of "proclaiming the Lord's death till He comes. "(Acts 20:7; I Corinthians 11:26)

Paul also told Christians at Corinth: "On the first day of every week, each one of you should set aside a sum of money in keeping with his income, saving it up, so that when I come no collections will have to be made." 
Primary Grades Share Joint Venture in Learning

CONTROLLED BURNS

All burning must be outside the corporate limits of a town except where the town has enacted ordinances allowing such burning. (No Call shan County Cities have app:oved such an ordinance.)

Burning shall only be allowed when weather conditions are such that smoke will not cause adverse effect to any public road, water way, or off site structure or residence.

Burning can begin no earlier than one hour after sunrise and will be completed by no later than one hour before sunset. The fire shall be attended by a responsible party at all times during the active burn phase. All residential fires and or smoldering objects must be extinguished if the smoke has the potential to create a nuisance or traffic hazard condition. (There are no allowable controlled burns after dark.)

Burning is not allowed when winds are predicted to be less than 6 miles per hour or greater than 23

CITY COUNCIL

The council approved the sale of the building by the EDC if the final details could be worked out. Motion by Ray Womack and seconded by James Nichols.





count for Records Management Fees for the County Clerk's Office was discussed.

It was explained that in the past the funds had been carried in the general fund and is supposed to have its own account. The money can only be used for records management and preservation and not for any daily expenses.

There was some discussion with County Clerk Bohannon about developing a budget for records preservation and she was asked to present the commissioners with some figures at a later time.

It was the very defiant opinion of the commissioners that the county's voters considered Precincts having C.D.'s very undesirable and declined to follow the recommendations.

Dianne told commissioners that she was considering putting some of the county's general funds in C.D.'s. Commissioners gave her the O.K. to do that.

-Farmer said he and Hicks had attended the Clyde City Council meeting where the FM 604 overpass was approved.

"About all they did was have a question and answer period," said Farmer, "and the City Council voted to build it (the overpass)".

"The only thing I said during the meeting," Farmer said, "if they expected the county to pay for anything before they voted, they need take it to the (commissioners) court". "They opted not to do that," he said, "and I guess basically they are going to fund the whole thing"

Corn said, "Then it came out in the paper that the county will have to buy right-of-way".

Hicks and Farmer both agreed that nothing was mentioned, at the council meeting, about the county having to buy anything.






