Former supt. ousted

Former Haskell superintendent James Kemp was fired last month as superintendent of the Royal Independent School district.

The Houston Chronicle reported that Kemp was reportedly under pressure from declining morale in the district and the fallout from an unauthorized strip-search of students.

The Chronicle said it was an acrimonious ending to Kemp's five years at the helm of the 1,200-student district west of Houston. After nearly three hours in closed session, the school board on Jan. 24 voted unanimously to oust him from the \$62,800-a-year position.

Kemp was effectively barred from returning to the district campuses. He will continue to receive his salary until the expiration of his contract in June.

Kemp became Royal superintendent in 1989, going there from Haskell.

Associates said he was under mounting pressure from parents and the district staff for several problems, ranging from declining student test scores to escalating disciplinary problems.

Parental opposition was galvanized in the aftermath of an Oct. 7 strip-search of girls in a beginning high school Spanish class. An assistant principal and a school nurse conducted a futile search for \$41 reported missing from a student's purse.

Letters of apology were issued to the students, and the two staff members were disciplined. Kemp avoided blame for the incident, but his critics said it reflected the growing problems with his leadership.

Other protests from parents came over the delays in the start of courses in the Gifted and Talented program and honors courses.

Kemp said there had been problems in recruiting instructors for those programs.

Kemp was superintendent in Haskell from 1985 to 1989.

Early voting for primaries now open

Early voting for the March 8 Democratic and Republican primaries opened Wednesday.

Registered voters may vote by personal appearance at the County Clerk's office through March 4.

Voters also may vote by mail by requesting applications from the County Clerk. Deadline for making application for mail voting is March 1.

County Clerk Rhonda Moeller said those requesting mail ballots need to designate their party preference when making application, in order for her office to know which ballot to send.

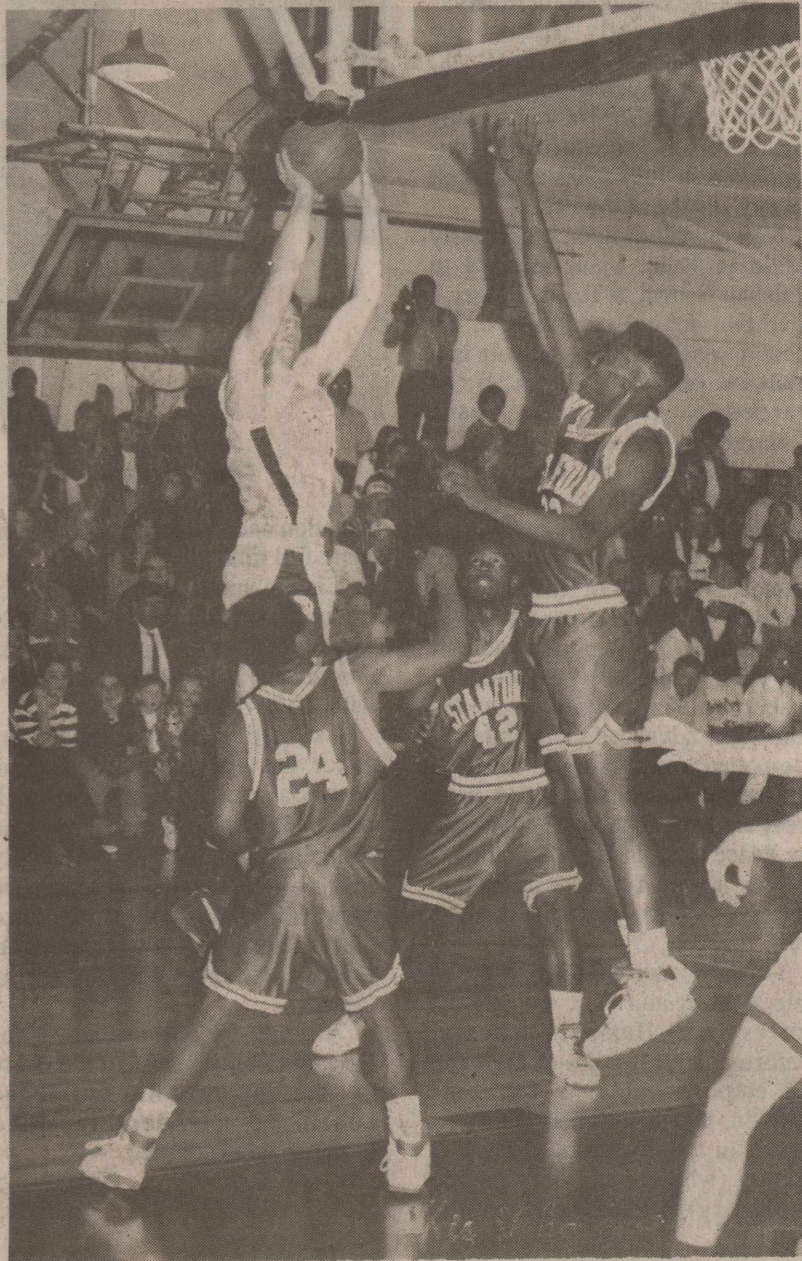

Although more than a hundred men were on the scene within a few minutes time, it was impossible to do anything toward saving the building, the fire having gained too much headway.

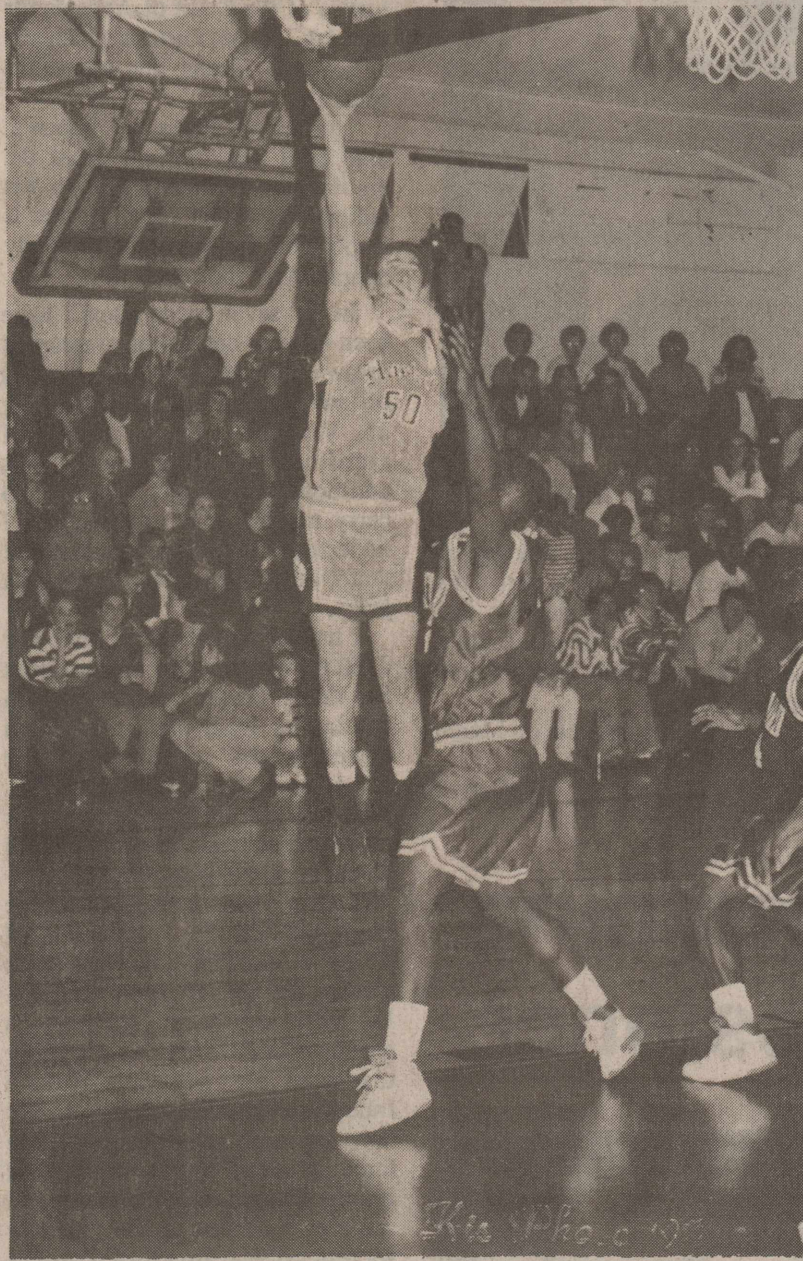
A good many books were gotten out of some of the rooms, and most of the seats and desks were saved out of the rooms on the lower floor.

Indians win 2-A championship, meet Dublin in bi-district playoff

The Haskell Indians were crowned champions of district 7-2A Tuesday night as they defeated Anson, 63-40, while Stamford was losing to Rotan, 69-66.

Going into Tuesday's contests, the final district games, Stamford and Haskell were tied for the lead. When everything was over, Haskell's record stood at 6-1 in the district's second round of play, while Stamford fell to 5-2.

Haskell now moves into the playoffs with a bi-district contest against Dublin, runnerup of district 8-2A. The bi-district game is tentatively set for Friday, Feb. 25, in Abilene.

Coach Mark Coffman said he is seeking a practice game for the Indians prior to bi-district. He hopes to line up an opponent for a

game on Monday or Tuesday.

Stamford, which tied the Indians for first place in the first half of the district season, also advances to the playoffs as the runnerup team in district 7-2A.

Tuesday's win over Anson, their 13th victory in the last 15 games, boosted the Indians' season record to 22-8.

The Indians made quick work of the Tigers at Anson, jumping to a 16-6 first-period lead, and continuing to outscore the Tigers in every quarter.

Jonathan Tatum paced the Indian attack by scoring 17 points. Also in double figures was Casey Coleman with 10 points.

The Indians had suffered their only loss in the second half of district play Friday night when

Stamford came from behind to take a 65-55 decision.

Haskell led 28-24 at halftime, but the Bulldogs forged ahead, 43-41 in the third quarter and then outscored the Indians 22-14 in the final period.

Cody Cooley scored 20 points, Brian Brzozowski had 15 and Tatum added 11.

On Tuesday of last week, the Indians defeated Hamlin, 81-77, as Brzozowski scored 26 points, Mart

Guess pitched in 24 and Casey Coleman added 14.

The Indians shot to a 26-13 lead in the first period and led 45-37 at halftime.

The Haskell Maidens ended their season Friday night when they lost to Stamford, 51-36, giving them a 15-13 record for the year and a 3-4 mark in the district's second half.

Last Tuesday, the Maidens defeated Hamlin, 48-31.

Waitress returns \$400 she found

A Coleman woman is back in possession of \$400 in cash she lost Feb. 5 in a Haskell restaurant, thanks to the honesty of a waitress and the restaurant owner.

Annie Herrera, a waitress at Rodriguez Inn, found the money, enclosed in a bank envelope, on the floor of the restaurant. She turned it over to Sam Rodriguez, owner, who said he felt that someone would be looking for it.

It turned out that the money belonged to Patty Miller, who realized she had lost the envelope after she returned to her home in Coleman.

Ms. Miller called Frances Lane at Lane Felker where she had been shopping earlier in the day and asked if anyone had found the envelope. When Mrs. Lane told her no one had reported finding the envelope, Ms. Miller said she had gone to eat at Rodriguez Inn. Mrs. Lane said she would contact the restaurant. The restaurant was closed so Mrs. Lane was unable to call until Tuesday.

She said Rodriguez told her a waitress had found the money and he was holding it. Mrs. Lane called the Coleman woman who drove to Haskell and picked up the money.

Taxes continue downward

Haskell's sales tax rebate took another drop this week when the City received its check from the state comptroller.

This month's check, representing taxes collected on December sales, was in the amount of \$28,502.96, representing a 6.16-percent decrease from the \$30,376.94 received for the same period last year.

Coupled with the \$13,441.95 received last month, the City has now received \$41,944.91 for the first two months of 1994. For the same period last year, the amount was \$45,618.74.

All other Haskell County cities received rebate checks this month. Rule got \$3,143.14, Rochester \$2,345.53, Weinert \$719.98 and O'Brien \$525.09.

Haskell has a 1.5-percent city sales tax rate. All other county cities have 1-percent rates.

City to close landfill

The City of Haskell will close its landfill as of April 8.

After months of maneuvers to keep the facility open, the City Council has decided that the cost of continued operation of the landfill is prohibitive.

Sam Watson, city administrator, said the city is not certain how it will handle its garbage after the closing. It will likely be sent to Abilene, either in the city's own vehicles or by a contractor.

Watson said the city is hauling some garbage to Abilene on a "trial run" basis. "We want to see how it works," he said.

Also affected by the closing are several area cities which have contracted with Haskell to handle their garbage. The cities have been notified that the last day of operation for the Haskell landfill will be April 8.

5 Haskell men leave on mission

Five Haskell men left Wednesday morning on a humanitarian mission to Richmond, Mo.

There, they will help repair the home of a family of five which was severely damaged in last year's devastating flood. The family has not been able to live in the home since the flood.

In the group were Tom Hairgrove, Kenny Watson, Ken Lane, Bob Baker and David Davis.

The local group is part of the Volunteers in Missions of the Methodist Church.

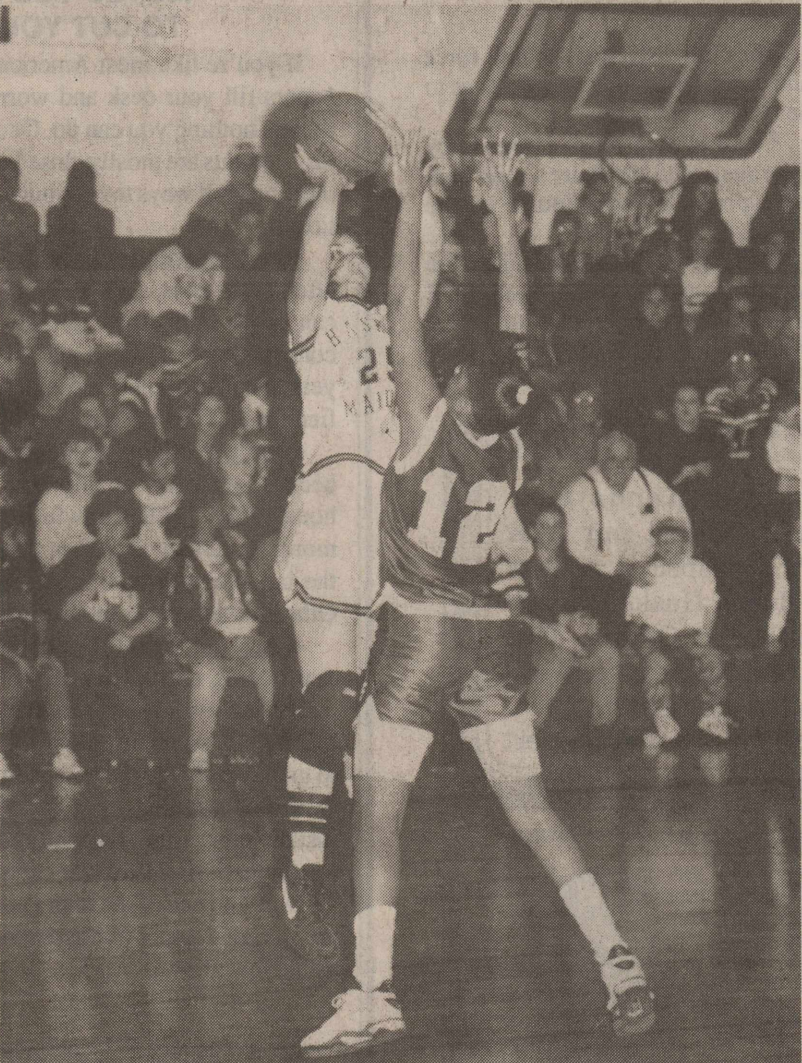
The men will return Sunday.

Adams candidate for commissioner

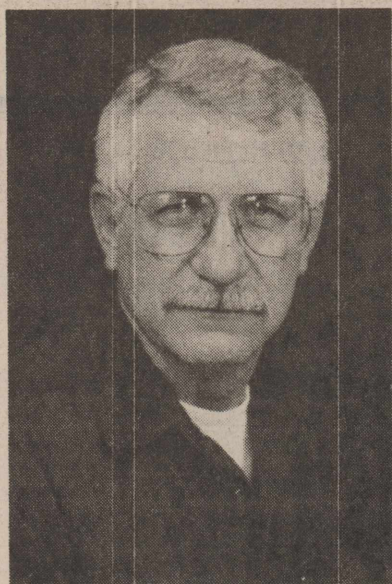
E. L. (Elmer) Adams is a candidate for County Commissioner, Precinct 2, subject to the Democratic party primary.

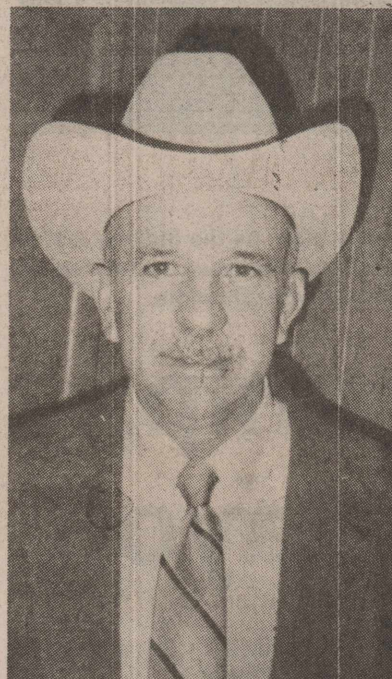

Heart disease No. 1 killer of Hispanics

If you're Hispanic, there's a good chance you'll die from the same killer of most Americans.

Heart and blood vessel diseases, the leading killer among Hispanics, caused 32 percent of all Hispanic deaths in the United States in 1988, the latest year for detailed statistics. The diseases caused 37.1 percent of the deaths of Hispanic women and 28.1 percent of the deaths of Hispanic men.

That's almost double the number killed by all forms of cancer.

But it's likely that many heart disease and stroke deaths can be prevented. Learn—and do something about—the major risk factors for coronary heart disease (heart attack) that can be changed. They are cigarette/tobacco smoke, high blood cholesterol, high blood pressure and physical inactivity.

Smoking statistics are staggering. Of the total U.S. population, 28.4 percent of the men and 22.8 percent of women smoke cigarettes. In comparison:

•43.9 percent of Mexican-American men and 24.2 percent of Mexican-American women smoke,

•41.9 percent of Puerto Rican men and 33.5 percent of Puerto Rican women smoke, and

•45.1 percent of Cuban-American men and 23.9 percent of Cuban-American women smoke.

A blood cholesterol level of less than 200 milligrams per deciliter (mg/dl) is considered desirable. A blood cholesterol level of 200 to 239 mg/dl is "borderline high" and can confer twice the risk of heart attack compared with people whose cholesterol level is below 200 mg/dl.

Anything above 240 mg/dl is considered high and the risk of heart attack is greater still. As many as 18.3 percent of Mexican-Americans, 17.7 percent of Puerto Ricans and 18.6 percent of Cuban-Americans have blood cholesterol levels of 240 mg/dl or higher. Statistics for high blood pressure and physical inactivity are not yet available. However, the American Heart Association says that obesity, which also contributes to heart disease, is prevalent among Hispanics.

To fight heart disease, talk to your doctor about the risk factors you can change. You can also contact your local American Heart Association or call 1-800-242-8721.

MOVES YOU CAN STILL MAKE TO CUT YOUR 1993 TAX BILL

If you're like most Americans, this is the time of year when tax papers fill your desk and worries fill your mind. With 1993 over, there's nothing you can do. Or is there? Once the year has ended, the tax accounts are mostly closed, allowing little room to maneuver. Yet there are still ways to cut your 1993 tax bill. Consider these possibilities:

•**Look for statutory exceptions.** The law permits some adjustments after a year ends, such as for an IRA contribution. Eligible taxpayers can invest until April 15. Self-employed taxpayers may benefit by contributing to a Keogh plan, if the plan existed at the end of the prior year. No plan? Some may still benefit by establishing a SEP (Simplified Employee Pension), permitted even after the year ends.

•**Don't overlook deductions.** Many taxpayers miss deductions because of the law's complexity. One common oversight involves the home office, still a lawful deduction for many. Points paid for mortgage refinancing often get mishandled, too. Some taxpayers miss the tax-exempt status of savings bonds used to pay for education. Others overlook tax credits that they are entitled to take.

•**Check different filing options and elections.** If you're single with dependents, check your eligibility for filing as head of household.

Review with your accountant any elections that might cut your tax bill or defer payment of taxes. One election available this year applies to taxpayers hit by the new, retroactive 36% and 39.6% tax rates. The extra tax resulting from the higher tax rates can be paid in three installments, free of penalty and interest charges. It's an election every qualifying taxpayer should consider.

Don't be one of the many taxpayers who needlessly overpay their taxes. Call if you'd like assistance in keeping your tax liability as low as the law allows.

First let me express my appreciation to each of you for allowing me the privilege of serving you as County Judge these past years. Your assistance and support have been invaluable and is appreciated very much.

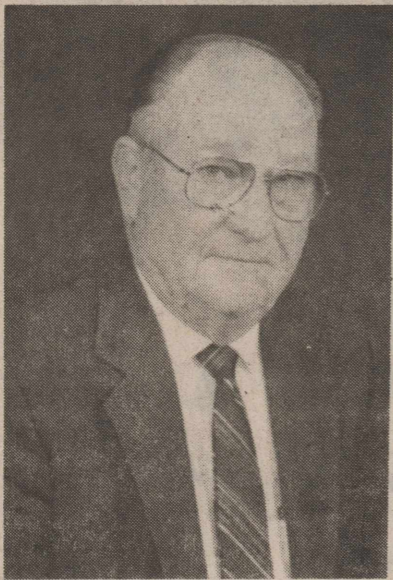

I have met these requirements and have been certified by the Secretary of the Texas Supreme Court to take the state bar examination should I ever choose to do so. As you can see, the duties of County Judge are varied and many and sometimes complicated and difficult.

Most of you have known me for many years. I am a native of Haskell County, have served my country and fellow citizens in various capacities to the best of my ability. Billyjo and I have been married for forty-six years and have reared two sons and a daughter. I am engaged in farming on a small scale and am very fortunate in having an

Greenbugs on increase in county

Greenbugs are aphids that suck plant juices and inject toxins into small grain plants.

These aphids are pale green, approximately 1/16 inch long, with characteristic dark green stripes on the back.

Greenbugs develop in large numbers under favorable conditions and may cause economic losses. They reproduce rapidly at temperatures between 55 and 95 degrees. Natural enemies, however, reproduce slowly when temperatures are below 65 degrees. Thus, in cool weather the greenbug may increase to enormous numbers while its natural enemies multiply slowly. The average temperature must be below 20 degrees for at least a week to kill 99 percent of the greenbugs.

The population also must be without protection from snow cover. During the winter, infested fields may have yellowed spots preceding the appearance of small, deadened areas. Later, greenbugs in these spots may increase and spread throughout the field.

Greenbugs cause more damage when small grain crops suffer from deficient moisture during a mild winter and a cool spring. Damage may be confused with moisture stress and/or nitrogen deficiency or foot rot.

While walking diagonally across the field, make a minimum of five random counts per 20 acres of field area, each consisting of one linear foot of row. Greenbugs can be counted on small plants. On larger plants, slap the plants against the ground to jar greenbugs loose for counting. If greenbugs are numerous, estimate the number present. Make counts during the warmest part of the day when greenbugs are most likely to be exposed on the above-ground part of the plant. During periods of cool, dry weather, greenbugs may congregate in loose soil at the base of plants, making detection and chemical control difficult.

The need for applying insecticide depends on the number of greenbugs present, size and vigor of plants, temperature, time of year, moisture conditions, state of growth and effectiveness of parasites and predators. Irrigated small grains can withstand larger greenbug populations than dryland small grains without yield loss.

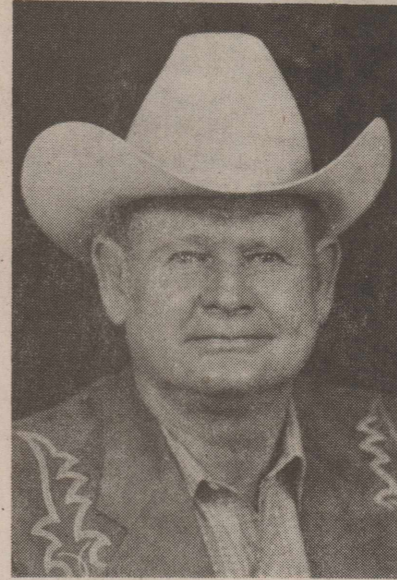

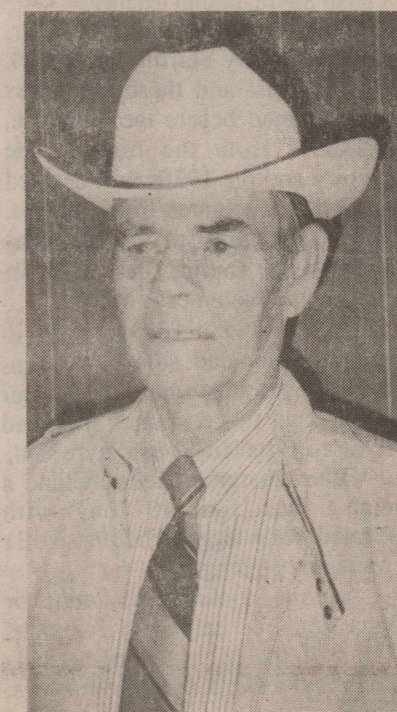



Other costume needs include a man's suit size 40 long with pleated, wide-legged trousers size 31 waist and 36 length.

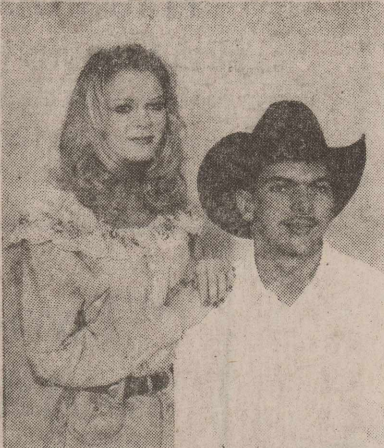

Editor: The Haskell Fire Department would like to pass along a word of safety and precaution to all parents.

Fire safety and pre-planning are essential for surviving a fire in your home. Children become confused in a fire very quickly. Take time to teach the whole family how to escape in case of a fire in your home.

Your house is familiar with lights on or in daylight, but when it is full of smoke it is like a new maze.

Here are a few basic rules to go by in planning escape route:

1. Stay low. Get down on the floor and crawl out, because heat and dangerous gases rise to the ceiling and settle downward.
2. Have a pre-set escape route and also an alternate route just in case. Practice these routes a few times with blindfolds on to get accustomed to "feeling" your way out.
3. Have a designated meeting place once you get outside. Pick a place away from your house, such as a neighbor or a spot across the street. Teach kids to go to this place and wait for their parents instead of wandering around looking for their family.

These are just a few basic rules to use to insure the safety of your family. A life is a terrible loss, but a child is an even more difficult loss.

We hope you never have a fire in your home, but if you do, being prepared is the first step to survival.

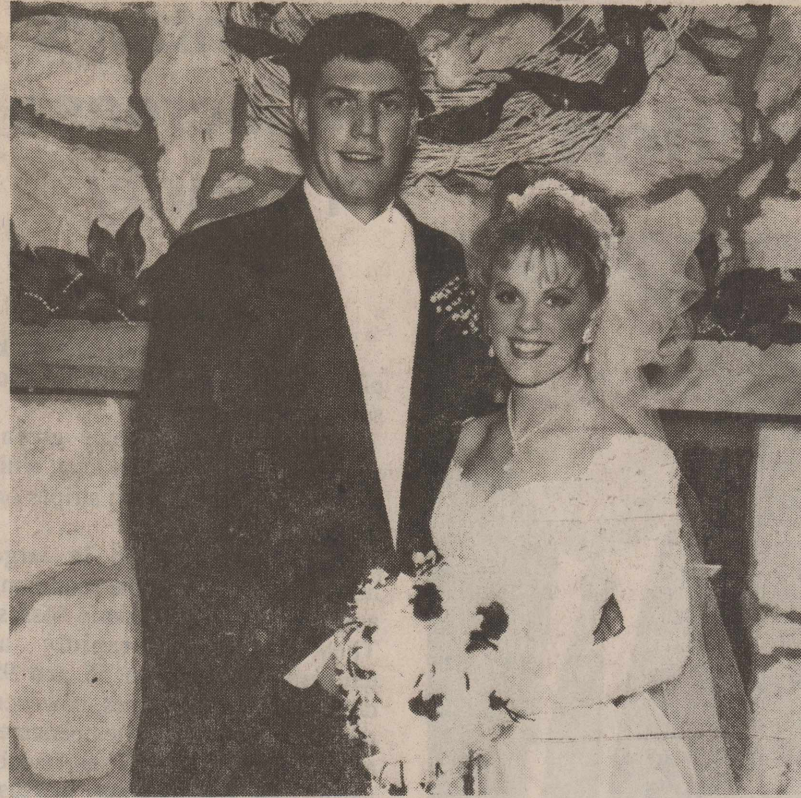

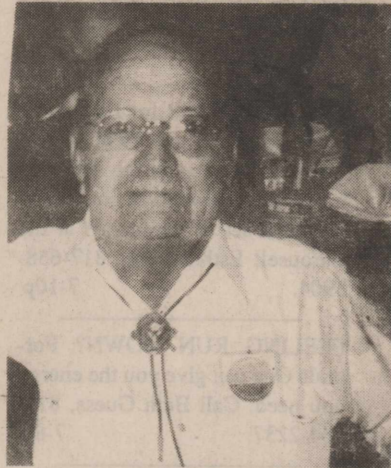

Even if the disaster loss was not large enough to qualify for disaster overpayment, it may mean eligibility for some advance deficiency overpayment forgiveness.

Final deficiency payments will not be calculated until early March, but it is almost certain, given current prices, that the final will be less than the advance. To be eligible for forgiveness of any overpayment, the producer must request disaster aid at the local ASCS office.

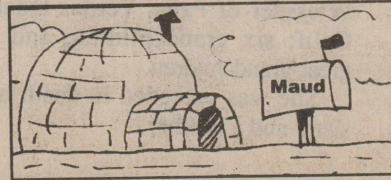

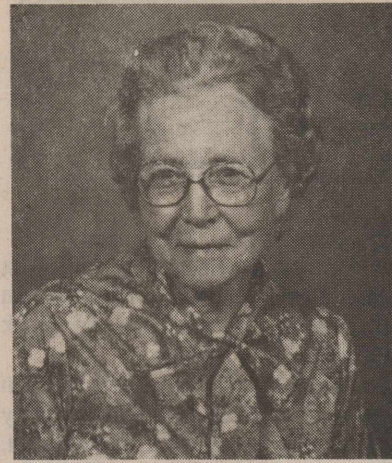

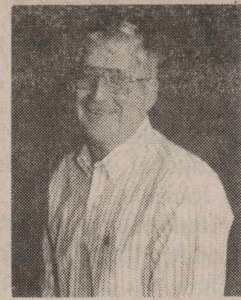

Lower Cholesterol Carefully: Further research on the benefits of lowering cholesterol show that attempts to go below "normal" levels (160 to 200mg/dL) may be more harmful than helpful. Those whose cholesterol levels exceed normal should try to lower them, but initial treatment should be at least a 6-month trial of diet and exercise. If that is not effective, then niacin should be tried because it is the only anticholesterol medical treatment that has been shown to save lives.
