Indians win their way into regional

The Haskell Indians won their way into the Region 1-2A basketball tournament Tuesday night with a 68-56 victory over the Wall Hawks in an area playoff game in Abilene.

For the second consecutive year, and the fifth time since 1988, the Indians have reached the regional and the right to compete for a berth in next week's state tournament in Austin.

A torrid first half, highlighted by the pin-point "bombing" of 3point ace Mart Guess, powered the Indians to their win over Wall. They shot to a 22-15 first-period lead and then stretched it to 41-26 by halftime as Guess scored 14 points, including four 3pointers.

The Indians continued their hot pace in the third quarter,

building a 21-point margin late in the period, which ended with them on top, 54-35.

But Wall fought back in the final period, going on a 15-2 run to narrow the gap to 6 points, 56-50, midway through the quarter. With 3:31 to go, Brian Brzozowski took a pass from Guess and put it through the hoop, and then sank a free throw to complete a 3-point play and put the Indians out front, 59-50. From that point, the Indians had things pretty much their own way.

Brzozowski was the team's leading scorer, getting 21 points on the strength of 7 field goals and 7 of 10 free throws. Guess wound up with 19 points, 15 of them coming on his five 3pointers.

Shannon Meeks and Casey Coleman each scored 7 points, while Robert Huff and Jonathan Tatum each had 5.

The Indians advanced to the area playoff with a 61-53 win over the Dublin Lions in Abilene Friday night.

Cody Cooley canned back-to-back 3-pointers to open the fourth quarter and propel the Indians to victory. Cooley's shooting sparked a 14-3 run as the Indians pulled away.

Cooley's 16 points led the Indian scorers and Coleman was right behind with 14. Brzozowski scored 12 points, half of them in the first quarter before he got in foul trouble. Guess scored 10.

The Indians led 34-28 at halftime, but Dublin had tied the score at 43-43 by the end of the third period.

Indians **play Friday** in regional

Haskell will play Shallowater Friday night in a first-round Region I-2A game in Moody Coliseum at Abilene Christian University.

As of Wednesday morning, it was not known whether the Indian game would be played at 6 p.m. or 8 p.m.

Shallowater advanced to the regional with a 77-70 win over Panhandle in an area game Tuesday night.

The other half Friday's regional twinbill will pit the Stamford Bulldogs against Clarendon. Stamford advanced with a 64-58 victory over Anthony in an area playoff Tuesday, while Clarendon was winning over Hale Center, 63-49.

Winners of Friday's games will meet Saturday afternoon for the regional championship and the right to represent the region in next week's state tournament in Austin.

Four contested races in Democratic primary

Spirited races for County Judge, two County Commissioner seats and a Justice of the Peace will be climaxed next Tuesday (March 8) when Haskell County voters go to the polls to vote in the Democratic primary election.

Those are the four local offices for which more than one candidate has filed.

Voters will cast ballots from 7 a.m. to 7 p.m. at 10 voting precincts in Haskell County, four in Haskell and one each in Rule, Rochester, O'Brien, Weinert, Paint Creek and Sagerton.

County Judge candidates include J. M. (Stick) Raughton, Giles M. Kemp, Jerrell (Judo) Johnson and incumbent B. O. Roberson.

Contested commissioner races include the one in Precinct 2 where the candidates are James R. (Jimmy) Hannsz, incumbent Ronnie Chapman and E. L. (Elmer) Adams.

The other contested commissioner race is in Precinct 4 and the candidates are Don Hisey

Jim Mattox, Richard Fisher and Evelyn K. Lantz, are seeking the Democratic nomination for U.S. Senator. In the governor's race, Governor Ann W. Richards is opposed in the primary by Gary Espinosa.

There also are contested races for Railroad Commissioner, three Supreme Court seats and two criminal appeals court judges.

High candidacy fuels GOP interest

The candidacy of Haskell's Doyle High for the State Senate is the top local attraction in a rare local Republican primary in Haskell next Tuesday.

Voting will be from 7 a.m. to 7 p.m. in the First National Bank. High, local businessman and pharmacist, is opposed by Tom Haywood of Wichita Falls for the District 30 Senate seat now held by Democrat Steve Carriker, who is unopposed in the Democratic primary. The High-Haywood





Paint Creek's Will Duniven received honorable mention as a defensive lineman.





Deadline near for sign up

"If you don't have Part B of Medicare and you want it, you have until the end of March to sign up," says Glyn Hammons, Social Security district manager in Abilene.

Every year, the government offers a three-month enrollment period---Jan 1-March 31---during which people who turned down or previously dropped the Part B coverage can sign up for it. "If you enroll during this period,

your coverage will begin July 1,' Hammons aid, "and you'll probably pay a slightly higher monthly premium."

The current cost for Part B coverage is \$41.10 per month, but most delayed enrollees pay a 10percent surcharge for each year they could have been enrolled but weren't.

Part B coverage, also called "medical insurance," helps pay for doctors' care, outpatient hospital visits and other medical services. People are offered the option of signing up for Part B at the same time they are automatically enrolled in Medicare's Part A program. Part A helps pay for inpatient hospital care and certain other services.

Hammons said people who want to sign up for Part B should call the Abilene Social Security office or call Social Security's toll-free number 1-800-772-1213.

Loose dogs in violation of city code

Police Chief Tom Bassett reminded citizens this week that it is illegal for dog owners to allow their dogs to run at large.

Article II of Section 3-21 of the Haskell Code states:

"It shall be unlawful for any person to permit any dog to run at large within the limits of the city. It shall be the duty of each owner or keeper of a dog in the limits of the city to have such dog on a leash or in the care and custody of some responsible person when the animal leaves or is allowed to leave the property of such owner or keeper."

The code further states that it is the duty of the police chief, or any city employee working under his supervision, to impound loose dogs.

Bassett said the police department has had a number of complaints concerning loose dogs and he is calling on citizens to cooperate.



IGA chief calls health plan threat to small businesses

The Independent Grocers Alliance (IGA), the nation's largest voluntary supermarket network with more than 2,500 independently owned supermarkets in 49 states, has stepped out against President Clinton's health care plan, saying it discriminates against small business owners and would ultimately increase the prices consumers pay for groceries.

"President Clinton's proposal may well be the single most destructive piece of anti-small business legislation that I've ever seen," said IGA Chairman and CEO Thomas S. Haggai at a Feb. 17 press conference.

"Based on IGA's Hometown Proud philosophy, we agree with the administration that all citizens should have access to health care, but the plan unfairly places a disproportionate amount of the funding responsibility with small business owners," Haggai said.

Under the Clinton Health Security Act, unionized and large companies with more than 5,000 employees are allowed to continue to provide health insurance under their current plans. However, small business owners would be forced to enter regional governmentcontrolled programs---regardless of how successful, effective or efficient their plans have been, Haggai said.

The administration's proposal also stipulates that employers would be required to pay 80 percent of coverage for employees and their dependents. Haggai said that since more than 95 percent of the business community is composed of small employers, the President's plan would cost small business owners nearly \$29 billion in new expenditures, according to a study.

The IGA chairman said that independent and family owned supermarkets make up more than half of all grocery retail outlets in the country. "Since net profit for supermarkets is already less than one cent per dollar of sales, the Clinton health plan would compel

these independent retailers to pass the new costs on to consumers in the form of higher prices," Haggai said.

"We are shocked at the proposal's inequity," he added. "The President's plan seems to be out of character for him because when he was attorney general for the state of Arkansas, we spoke at the same convention where he sharply criticized legislation that was detrimental to small business. He has always presented himself as a friend to the small business owner, but now his own proposal threatens entrepreneurs by requiring them to enter government alliances steeped in excess costs."

The IGA Benefit Trust currently provides health coverage benefits for more than 37,000 supermarket





Usually patients need to use the light box for 30 minutes each day, and it should be used under a doctor's supervision.







TAX PLANNING

EMPLOYING HOUSEHOLD WORKERS CREATES TAX LIABILITY

Though Congress talked a good deal about changing the tax rules affecting domestic workers, there still has been no change in the requirements that got so many politicians in hot water last year.

If you employ household workers, you should be aware of the tax requirements governing their wages. If you pay \$50 or more per quarter to anyone for performing services in your home, you are required to pay FICA (social security and Medicare) taxes of 15.3% on the wages. You should require the worker to pay half the taxes (7.65%), but if you don't withhold the employee's share from his or her wages, you are still responsible for the total 15.3%. You may also be liable for other payroll taxes, such as federal and state unemployment tax.

If the services are not provided at your home or if the provider is an independent contractor, you are not considered an employer and are not subject to these requirements. If you engage an agency or service who provides workers to perform services for you (and the agency hires, fires, and pays the workers), it is generally the agency's responsibility to take care of payroll taxes.

Some household workers resist any tax withholding or reporting to the IRS because they want their take-home pay to be higher. However, when the worker applies for unemployment or social security benefits, your failure to comply with the law may come to light. You could be held responsible for back taxes, plus interest and penalties.

Congress may get around to dealing with this issue in 1994, but there's no guarantee. In the meantime, if you need details on the requirements or assistance with the tax filings, please contact our office.


