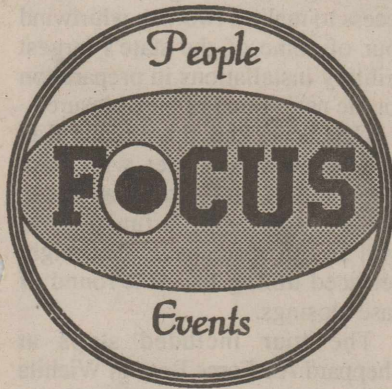

## Child Welfare Board members recognized for long service

In recognition of 10 years of service on the Haskell County Child Welfare Board, Mary Martin and Sue Miller were honored Sunday with a reception at the Haskell National Bank community building.

Mrs. Martin and Mrs. Miller have recently resigned from the board.

Hosting the reception were current board members: Molly Cannon, Suzanne McGuire, Pam Mathis, Christy Gannaway, Julie Kretschmer, Julian Estrada, Monique Morgan and Tom Long.

Because of their service, each was presented with a commendation plaque signed by Texas Department of Protective and Regulatory Services regional director Mark Marsh and current board members. CPS supervisor Linda Haynes of Haskell presented the plaques and gave a brief history of the board, board projects, and Mrs. Miller's and Mrs. Martin's involvement.

Boards are authorized by state legislation. Boards are established through a contract between a county commissioners' court and TDPRS. The contract establishing the Haskell County Child Welfare Board was signed May 1, 1984. The

Commissioner's Court was comprised of County Judge John McDermott, and commissioners C. E. Tidwell, Ronnie Chapman, Ray Perry and Bud Tumbow.

Board membership was decided by Commissioners' Court with each commissioner selecting two persons from their respective precincts. The board began with nine members with Mrs. Martin and Mrs. Miller original appointees.

A board orientation was held June 12, 1984. The organization meeting was held July 16, 1984. Officers included Mrs. Martin as secretary and Mrs. Miller as treasurer. These were the positions held by these two women until their resignations from the board.

What is the purpose of the Haskell County Child Welfare Board?

The board has the responsibility of making the public aware of what child abuse and neglect is and how to report abuse and neglect. The board helps inform children there is help available if they are being abused or neglected.

They have worked toward the prevention of child abuse and neglect. Raising funds for needy

children in the county has been a major focus of the board. The board, like other boards, serves as a liaison with DPRS and makes suggestions of needed policy changes. They also inform legislators of their views of pending legislation affecting children and families.

The Haskell board has been and still is committed to helping children and families. Each year they sponsor programs in April to promote Child Abuse Prevention Awareness Month. This year, flyers were placed in grocery bags, and book marks were handed out in county schools.

Over the years, pencils with the Hotline number, Spiderman comics about abuse, and other printed child abuse materials have been given to school age children. Programs are given and articles have appeared in the newspaper. Information booths were always set up at the County Fair. Children's needs have been met through the board purchasing clothes, school supplies, camping supplies, groceries, diapers and Christmas gifts. Medical and dental care and medication expenses have been taken care of by the board. The Department of Health CDC program liaisons with the board to help pay for transportation, lodging and meals in regard to out-of-town medical appointments.

Since the Haskell board was established with no funding from the county, it has had to rely on donations and funds raisers. Their first fund raiser was a "Car Bash" at the September 1985 County Fair. That year also began the traditional

## More streets to receive seal-coating

The number of streets to get seal coating will be expanded by about 25 percent, due to a lower-than-expected bid.

The City Council at its meeting Monday night accepted a bid from Lipham Construction Co. of Aspermont for 59 cents per square yard to seal coat the streets.

Originally, the city had planned approximately 40,000 square yards of treatment. But because of the low bid, another 10,000 square yards will be added to the project.

Scheduled for seal coating are the following streets:

- Avenue A from North 14th to South 2nd Streets,
- North 14th Street from Avenue E to Avenue A,
- South 7th Street from Avenue E to Avenue M (cemetery road),
- Two blocks on South 2nd Street and two blocks on South 4th Street near the elementary school, and
- Avenue D from South 1st Street to the park.

City administrator Sam Watson said the other streets to be added have not been determined.

The city also discussed next year's budget and set the first hearing for Aug. 23. Watson said he does not expect any major changes from this year's budget.

Mayor Ken Lane announced that the Economic Development Board has elected Bobby Hobgood president. Greg Melton is vice president and Randy Hise was elected secretary-treasurer. Other directors are David Jim Strickland and Bill Stewart. Members of a sub-committee are Fred Hernandez, Bob Baker, Abe Turner and Johnny Wheatley.

Watson told the Council he has filed an application for an arid-exemption for the city landfill with the Texas Natural Resources Board. If granted, the City will consider the cost-effectiveness of re-opening the landfill.

Council members discussed the possibility of seeking a state grant to upgrade water lines in the east

part of the city and possibly in the business district.

The Council also agreed to raise the price it is paying the Department of Public Safety for a police car. The price was raised from \$4,075 to \$4,800 after the DPS learned the automobile was a 1990 model, instead of a 1989 model.

Traditional cap and gown and tux and drape pictures will be taken. Also, students may want to bring western clothes, casual and/or church clothes for the other picture areas.

The \$25 deposit is not required if only the yearbook (tux and drape) picture is taken.

## School to end for 50 students

More than 50 area students will complete summer school this week at the Haskell and Munday campuses.

The summer school, sponsored by Haskell CISD and funded by a JTPA grant of over \$80,000, offers area students a chance to earn high school credits in English, math, science or reading, as well learning citizenship and employability skills.

Students attend classes in the mornings and work for non-profit agencies in the afternoons. Students from Rochester, Aspermont and Haskell have participated on the Haskell campus. Those from Benjamin, Knox City and Munday attend school at the Munday campus.

Students work sites include the City of Haskell, Haskell Memorial Hospital, Haskell County Extension office, the Experienced Citizens Center, Department of Public Health, the Haskell Agriculture Stabilization and Conservation office, Haskell Soil Conservation Service and Rochester, Aspermont and Haskell schools.

"This program helps you get organized, gives responsibility and supplies good references," said Malinda DeLaSantos of Haskell, a

student.

In addition to classroom and work experience, the program included vocational and cultural enrichment activities. Students have toured the Paint Creek power plant, the Environmental Recovery/Recycling Center at Stamford, the Texas A&M Vegetable Research Center at Munday, the Grace Cultural Center in Abilene, Buffalo Gap Historic Center, Dyess Air Force Base and Texas State Technical College.

A new component of the grant this year is the reading program. High school students in this program attend reading class in the morning and tutor elementary students in the afternoon. "I think the older students have had a positive influence on the elementary students they teach," said Janna Brendle, reading coordinator.

"This program requires the cooperative efforts of personnel from the West Central Texas Council of Governments, the non-profit agencies and the schools involved," said Billie McKeever, program director. "By working together, we are able to offer this program to help students develop the skills they need to become productive members of society."

**DID YOU KNOW?**

**TUBERCULOSIS HAS BECOME THE COMEBACK PLAGUE**

When did the incidence of TB begin to rise?  
 Until the middle of this century, tuberculosis was a common and often fatal illness. Between 1953 and 1984, the disease decreased an average of 5 percent a year and the Center for Disease Control published the goal of eliminating the disease in the United States (less than one case per million people) by the year 2010. However, from 1985 to 1992, more than 51,000 new cases were reported, an increase of 20 percent and a clear indication that the disease is not retreating.

**Why is the disease increasing now?**  
 Three major factors contributing to the increase of tuberculosis in our society are:

1. The increased number of immunodeficient people at risk for infection. The higher incidence of AIDS and of other immune-system suppression is associated with this rise.
2. Increased immigration from countries with high tuberculosis levels continues to introduce new exposure into the country.
3. Poverty, homelessness, substance abuse, and lack of medical care have always contributed to the success of tuberculosis in invading and thriving in a society.

**How is tuberculosis transmitted?**  
 TB is transmitted when an individual infected with the Mycobacterium tuberculosis germ coughs, sneezes, talks, or shouts, and a fine spray of droplets containing the germ is expelled into the air and is inhaled by an uninfected person. Tuberculosis cannot be transmitted by sharing food, drink, or eating utensils with someone who has tuberculosis.

**What steps are being taken to control tuberculosis?**  
 The increased incidence of tuberculosis in many Texas counties prompted a study by the state Tuberculosis Elimination Division that has identified high-risk counties. Women, Infants, and Children clinics in these counties have begun to provide TB skin testing along with the routine childhood immunizations. Employers have been urged by the Occupational Safety and Health Administration to redouble screening and protection programs for health workers. Early detection and prompt treatment remain the primary weapon in the fight against TB, and we find that we still have rounds to fight.

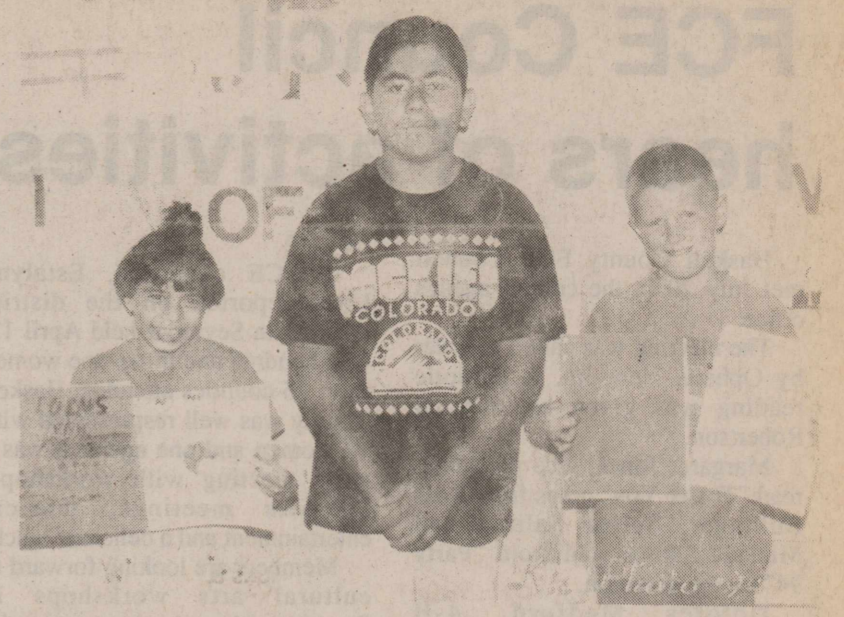

Mary Martin and Sue Miller will truly be missed on the board, so it was only fitting they be recognized for their service.

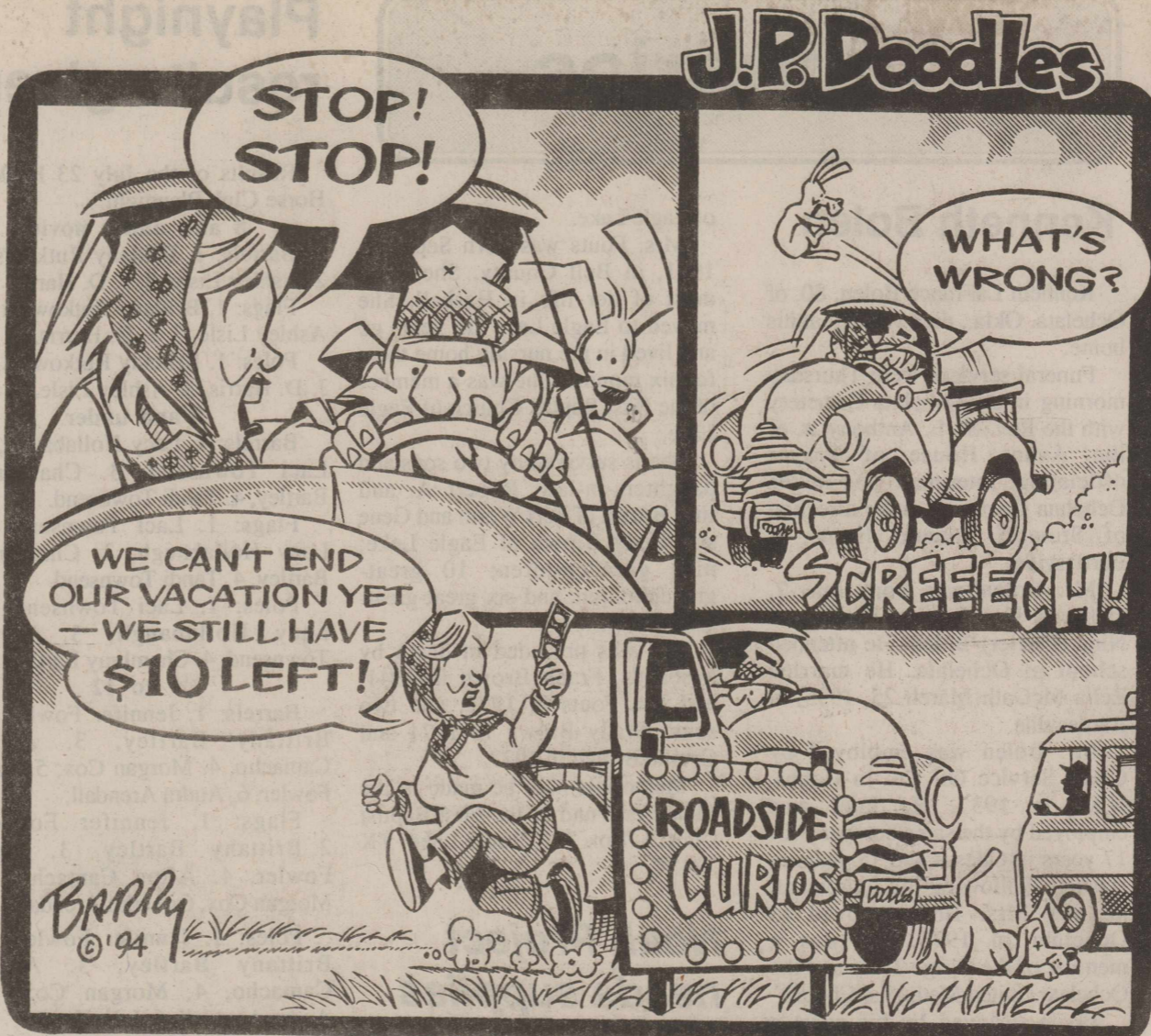

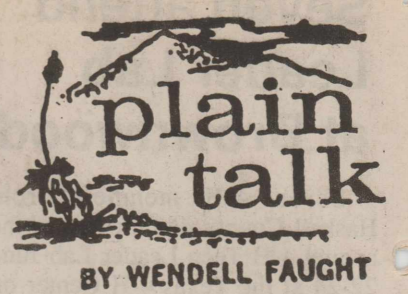

There are two things everyone agrees on.

They are underpaid and they are overcharged.

"I'm sorry, Your Honor," said the woman to the judge, "I can't serve on this jury since I am against capital punishment."

"Maybe you don't understand," the judge said. "This is a civil suit brought by a wife to recover \$5,000 of her money spent by her husband on gambling and other women."

"Oh," said the woman, "I could be wrong about capital punishment."

A Burkburnett convenience store has become the 200th Texas business to sell more than \$1 million in lottery tickets.

Not surprisingly, the latest member of the "Million-Dollar Club" is a store near a border of another state---in this case Oklahoma.

The undisputed leader in lottery ticket sales is Hester Oil Co. in Seminole, just a stone's throw from the New Mexico state line. As of July 16, the Seminole store had sold \$6,711,556 in lottery tickets.

Second place belongs to a store known as Town and Country, in the border town of McAllen, where sales had reached \$4,807,33 as of July 16.

Four other Texas cities have businesses which have sold more than \$3 million and all of them are near borders of other states or Mexico: Hughes Auto Parts in Farwell (New Mexico), Hamiter's Chevron in Waskom (Louisiana), Jackie's Exxon in Seminole (New Mexico) and United Drive In in Mission (Mexico).

A Stop N Go store in Dallas is in sixth place with sales just under \$3 million, but after that come stores in four more towns on or near state lines, Texarkana, Farwell (again), Orange and Gainesville.

Although the businesses located in border cities have a natural advantage, part of their success has to be attributed to creativity.

Hester Oil in Seminole has a drive-through window to sell tickets to buyers who are in a hurry, and has installed a 20-foot "scratching counter" for customers who prefer to take their time.

Town and Country in McAllen offers a new pickup truck to any customer who hits the Lotto jackpot, and so far has bought two new trucks for its customers.

"A weak dollar wreaked havoc on the Texas Stock Index in June," State Comptroller John Sharp said. "The Index fell for the fourth time in five months, dropping by 10.8 points to 158."

But the comptroller said there's a bright spot in the latest Index. The finance, insurance and real estate sector reflects Texas' thriving real estate market, she said.

## Selective Service reduces force

The Selective Service System, the federal agency that maintains draft registration records and remains prepared to draft men for military service in a crisis, is cutting its size and streamlining operations.

The agency will close its regional headquarters offices in San Francisco, Dallas and Philadelphia, and consolidate operations at offices in Denver, Chicago and Atlanta by Aug. 1.

This will result in a more than 40-percent reduction of full-time personnel in the regions.
