#### DO YOU WANT TO BE SAVED?

Only one time, in the entire Bible, is the question asked. "What must I do to be saved?" (Acts 16:30). In the next verse (Acts 16:31) the question is answered,

"Believe on the Lord Jesus Christ, and thou shalt be saved, and thy house."

Remember:

Hell's Hot Life's Short Death's Sure Eternity's Long

and, "There Ain't No Exits In Hell." NO MAN KNOWS, HOW SOON IT IS TOO LATE

'Thou shalt not take the Name of the Lord thy God in vain; for the Lord will not hold him guiltless that taketh His Name in Exodus 20:7

Any way that you use God's Name, the Lord's Name, Jesus' Name, other than in a Holy manner, is taking His Name in

"For God so loved the world, that He gave His only begotten Son, that whosoever believeth in Him should not perish, but have everlasting life." John 3:16

Acts 2:21 and Romans 10:13 indicate that, "whosever shall call up the name of the Lord shall be saved." In the next verse, Romans 10:14 it says, "How then shall they call on him in whom they have not believed?" Believing precedes calling upon The name of the Lord. Jesus Himself said in John 14:6 "I am the way, the truth, and the life: no man cometh unto the Father, but by me." God reaffirms this truth in I Timothy 2:5 saying "For there is one God, and one mediator between God and men, the man Christ Jesus." When someone says "repeat this prayer after me to be saved" it is making people feel like they have to "do" something to be saved, other than believing. If someone is asked to say a prayer to be saved, the person who says the prayer is still on his way to hell, after repeating the prayer, if he hasn't believed in his heart. Nowhere in the Bible is it found that a person has to pray a prayer to be saved. God does not hear a prayer unless you go to God in the name of Jesus Christ. The Only Mediator between God and man. Jesus Christ is not your Mediator unless he is your Lord and Savior. So according to God, the steps are, first, you believe in Jesus Christ as your Lord and Savior. By believing as Acts 16:31 indicates, you are saved! Acts 16:30, 31 is the only time in the Bible where the question is asked, "what must I do to be saved?" God answering through Paul said, "Believe on the Lord Jesus Christ, and thou shalt be saved." By being saved, Jesus Christ is your Lord, Savior, and Mediator between God and yourself. Now you can pray to God, because you have the Mediator, Jesus Christ.

I believe that when a person "prays" to God, without being saved, his prayer goes no higher than the ceiling, and God probably says, "Who do you think you are, to think that you can come to Me, without coming to Me in the only possible way that I have set out in My Word? For you come to Me, through My Only Begotten Son, Jesus Christ, the One and Only Mediator between you and Me." You don't just pull Jesus Christ out of the air, and say today I want You to get me to God, be my go-between for God! It doesn't work that way. Jesus Christ is either your Lord and Savior, making Him your Mediator, or, if Jesus Christ is not your Lord and Savior, He is not your Mediator. I believe it is very important to stress that you are saved by believing only. John 3:16, probably the most quoted verse in the Bible, says that, "whosoever believeth in him should not perish, but have everlasting life." Again, this passage clearly prescribes believing, not repeating a prayer. In John 3:4, Nicodemus asks Jesus, "How can a man be born when he is old? Can he enter the second time into his mother's womb, and be born?" He was asking this in regard to Jesus' statement in John 3:3, that a man eds to be born again. Jesus' answer in John 3:5 and following is "Except a man be born of water and of the Spirit, he cannot enter into the kingdom of God." Nowhere does Jesus say, pray to be saved, it is always believe.

Years ago, I heard Dr. Donald Grey Barnhouse say "I'm deeply offended when I hear a prayer that does not end with the idea that God must be approached only through the Name and the Being of the Lord Jesus Christ." Ephesians 1:13 says "In whom (Christ) ye also trusted, after that ye heard the word of truth, the gospel of your salvation: in whom also after that ye believed, ye were sealed with that Holy Spirit of promise." Romans 10:9 tells us "That if thou shalt confess with thy mouth the Lord Jesus, and shalt believe in thine heart that God hath raised him from the dead, thou shalt be saved. <sup>10</sup>For with the heart man <u>believeth</u> (first) unto righteousness; and with the mouth confession (next) is made unto salvation." How many people have gone to hell or are going to hell by putting their trust in the ungodly "pray the sinners prayer" or "repeat this prayer after me," instead of believing John 3:36: "He that believeth on the Son hath everlasting life: and he that believeth not the Son shall not see life; but the wrath of God abideth on him.'

Luke 23:39-43 tells us "And on of the malefactors which were hanged railed on him, saying, If thou be Christ, save thyself and us.40But the other answering rebuked him, saying, Dost not thou fear God, seeing thou art in the same condemnation? 41And we indeed justly; for we receive the due reward of our deeds: but this man hath done nothing amiss. 42 And he said unto Jesus, Lord, remember me when thou comest into thy kingdom. 43 And Jesus said unto him, Verily I say unto thee, Today shalt thou be with me in paradise." In these verses in Luke, we see that a man was saved by believing only. The malefactor did not, and was not instructed by Jesus, to pray, to receive salvation. He said unto Jesus, "Lord, remember me when thou comest into thy kingdom. 43 And Jesus said unto him, Verily I say unto thee, today shalt thou be with me in paradise." You don't fool Jesus. Jesus knew that this man believed in Him; that his man believed that this Jesus that he was talking with was the Lord, The Messiah, the Only Begotten Son of God, the Savior, and in believing, the man was saved. Now if you think that you have to pray first, repeat first, or anything first, before believing, why did Jesus tell him "today thou shalt be with Me in paradise?" OR if there is a need to do for anything to go long with believing, why didn't Jesus tell him what that was? Jesus doesn't make mistakes! God's Word, and it be true. Just leave His Word alone, and do what God said, **believe**. Psalm 119:89" "For ever, O LORD, they word is settled in heaven." Revelations 22:18,19: 18 For I testify unto every man that heareth the words of the prophecy of this book, If any man shall add unto these things, God shall add unto him the plagues that are written in this book: 19 And if any man shall take away from the words of the book of this prophecy, God shall take away his part out of the book of life, and out of the holy city, and from the things which are written in this book." Take your Bible and check the references that we contained herein-nothing added to and nothing taken away; and then you hear "the plan of salvation" from anyone, get your Bible out and see if it is God speaking or "someone's" idea. I can't see "ten steps" to salvation, I can see only one step: believe. The malefactor on the cross had but one step, and he took it. You, I, we all have "one step," believe. Please take it, and believe in the Lord Jesus Christ for your salvation.



## **Haskell Home Health Agency**

Dear Misty,

In one of your earlier columns you said a patient must be homebound in order for medicare to pay for home care. What do you mean by homebound?

> Sincerely, Janet Wilson

Dear Janet.

The patient experiences a normal inability to leave the home and, consequently, leaving their home would require a considerable and taxing effort. If a patient in fact leaves the home, the patient may nevertheless be considered homebound if the absences from the home are short and infrequent. Generally speaking, a beneficiary will be considered homebound if he has a condition due to an illness or injury which restricts his ability to leave his place of residence except with the aid of supportive devices such as crutches, canes, a wheelchair or walker.

Also, the law requires that a physician certify in all cases that the patient is confined to his home. If you still have questions, check with your physician or a Haskell Home Health nurse.

Thanks for the question.

#### Home insurance rates show slow decline

AUSTIN-In spite of reform legislation passed during the last session, two consumer groups-Texas Watch and AARP Texas-are not happy with insurance rates in the state.

The average Texas homeowner pays \$1,390 in premiums, a 4 percent decrease from 2003. But the new legislation was expected to drop rates by 12 to 18 percent.

The groups said last week that Texans have overpaid some \$287 million in premiums just since last August, based on an analysis of data from the Texas Department of Insurance. But Jerry Johns, a spokesman for the Southwestern Insurance Information Service, disagreed with the consumer groups' figure.

Johns said rates have stabilized in Texas and should begin dropping once more loss information is available. The process may take three years, he said.

Based on the new legislation, last year the Department of Insurance ordered Texas' largest insurers to roll back their premiums.

State Farm and Farmers took the matter to court and the litigation still has not been resolved. Twenty-seven other companies settled with the state, but the amount of their rollback was reduced as part of the settlement.

Loss ratios were only 58 percent last year compared with 108 percent in 2002 and 118 percent in 2001, a trend the Insurance Council of Texas said will be good news for consumers "in the long run."

The Department of Insurance also says it still sees an overall improvement in the rate situation.

"We're past the mold crisis that drove up the dramatic increases in the homeowners market," said department spokesman Jim Hurley. "We've turned a huge corner."

#### No fountain of youth...

Texans are getting younger, but no one has discovered a fountain of youth. The state's just getting more residents under 18.

New data show that the state grew by 350,000 people under 18 from 2000 to 2003, more than Florida or California, the nation's other two states in the top tier of young population growth.

"This shows how young Texas is becoming," state demographer Steve Murdock said. The trend, he continued, means that "demand for educational services will be particularly acute in the years ahead."

The new data also has Texas at 22.1 million population, an increase of 913,000 adults since 2000. Only California, with 35.5 million, has more residents.

#### \$1.4 million decision...

A Henderson County District Court issued a \$1.4 million judgment against Maria Elena Garza, whom Texas Attorney General Greg Abbott sued last year for operating a widespread scheme that defrauded hundreds of immigrants in and around Dallas.

By posing as an immigration officer, Garza persuaded hundreds of immigrants to pay her hefty fees, often in excess of \$1,000, to process work visas, permanent residency status or citizenship forms. No work was actually performed.

Garza operated primarily from a bingo hall in Seven Points, southeast of Dallas.

In February, she was convicted in federal court on charges of mail fraud and impersonation of a U.S. immigration officer. At her sentencing hearing on May 18 she faces up to 68 years in prison.

"Application for loans under this emergency designation will be accepted until Oct. 12, 2004, but farmers should apply as soon as possible. Delays in applying could create backlogs in processing, with possible delays into the new farming season," Larry P. McDaniel said.

The FSA office in Haskell is open from 8:00 a.m. to 4:30 p.m., Monday through Friday.

## Gov. requests USDA help for Haskell Co.

Governor Rick Perry has formally requested assistance from the U.S. Department of Agriculture (USDA) for four Texas counties dealing with severe weather conditions. The requests include assistance for damage as a result of the continuing drought, since July 7, 2003, in Lee County and severe storms in Baylor, Hopkins and Haskell Counties.

"Farmers and ranchers in these counties have suffered considerable economic and physical losses because of weather events beyond their control," Perry said. "These losses exceed the state, local and private sector assistance capabilities, and we are asking the federal government to assist these counties."

Perry has asked the USDA to designate the affected counties as disaster areas and make assistance available through the Federal

Emergency Loans Program. The counties have been asked to file a Damage Assessment Report with the USDA.

USDA emergency loans in counties declared as disaster areas help cover both production and physical losses, including the restoration or replacement of essential property, reorganization of a farming operation and refinancing of certain debts. The loan limit is up to 80 percent of actual loss, with a maximum indebtedness of \$500,000.

The weather system producing severe storms on Mar. 4, caused damage in Haskell County due to hail, high winds, lightning and a
