State elections office sets up voter fraud hotline

AUSTIN-A funny e-mail making the rounds purports to be the electronic voting system for a large Southern state that played a critical role in the 2000 presidential election.

When a recipient opens the attachment, a short animation shows a citizen's efforts to vote for one of the two mainstream presidential candidates. When the person clicks on their candidate's name, nothing happens. After a few more clicks, the user gets a message saying, "Are you sure of your selection?" A few clicks later nets the prompt: "Are you, really REALLY sure?"

In the end, after several more bytes of high tech political humor, a message pops up thanking the voter for casting his vote for the other candidate, not his.

Humor's one thing, reality's another. The Secretary of State's office, which oversees enforcement of the Texas Election Code, announced an anti-voter fraud effort with the beginning of early voting last week.

"To anyone who might be considering engaging in any sort of voter intimidation or voter fraud," Secretary of State Geoffrey Connor said in a written statement, "our message is simple and clear: Don't mess with Texas voters; don't mess with Texas votes."

Toward that end, Connor's office has set up a toll free number (800) 252-VOTE, for anyone encountering voter fraud or any other violations of election law.

In addition to the government effort, several civil rights and minority groups have organized their own anti-fraud effort. Their toll free number is (866) OUR-VOTE.


Late benefit payments net penalties...







Local man part of Coast Guard drug seizures

Former Haskell resident, Petty Officer 2nd Class Gavino Ortiz, son of Robert and Linda Ortiz of Haskell, was part of a crew from the U.S. Coast Guard cutter Gallatin making a 4,000-pound cocaine bust, Oct. 2 in the Colombian basin, and detaining four suspects from a go-fast

According to the office of Public Affairs of the U.S. Coast Guard Seventh District, the bust was the first one of the new fiscal year, which began Oct. 1, and follows a record shattering year in fiscal year 2004 with more than 240,000 pounds of cocaine seized in the Eastern Pacific and Caribbean.

The 40-foot drug-smuggling boat was spotted by the Gallatin's Sting Ray helicopter crew in international waters at about 4:45 p.m. As soon as the crew aboard the boat knew they had been spotted, they began throwing bales overboard, and a chase began.

When multiple visual and verbal warnings to stop were ignored, the Sting Ray helicopter was given permission to fire warning shots and disabling fire, and safely disabled three outboard engines on the go-fast vessel.

A boarding team from Gallatin was deployed in its pursuit boat. Once on the scene, they attempted to establish the nationality of the vessel, but the suspected smugglers would not provide one. As a result, the vessel was determined to be stateless and subject to U.S. jurisdiction. A boarding began and the four men were eventually taken into Coast Guard custody.

The crew from the Gallatin recovered 68 of the bales dumped by the smugglers. Each bale tested positive for cocaine.

Capt. Michael Parks, of the Gallatin, said "This drug bust was a success due to the professionalism and effective team work between

suspicious go-fast vessel had been

Gallatin, its high speed boat crew, its deployed armed helicopter crew and the Operation Centers of the Joint Interagency Task Force South in Key West, and the Seventh Coast Guard District in Miami." Following that case, when the Seventh District Command Center received notification Oct. 8, that a

located in the Caribbean Colombian Basin, the Gallatin was diverted along with its armed helicopter from Jacksonville, Florida.

After stopping the vessel with disabling gunfire, a law enforcement team from the Gallatin boarded the disabled boat, and discovered suspicious bales on board that later tested positive for cocaine. Finding no indicators of nationality, the boat was determined to be subject to U.S. jurisdiction. The four people and 58 bales of cocaine, weighing

approximately 3,880 pounds were brought on board the Gallatin.

The smuggling vessel was taking on water and was destroyed by the Gallatin's crew as a danger to navigation. The drugs and detainees were transported to Drug Enforcement Administration

Coast Guard Cutter Gallatin, on which Petty Officer 2nd Class Gavino Ortiz serves, is a 378-foot High Endurance Cutter homeported in Charleston, South Carolina.
