### Calendar Wildfire proclamation

In a proclamation issued Dec. 30, Haskell County Judge David Davis declared a state of disaster for Haskell County, which has resulted from the potential threat of wildfires due to drought and adverse weather conditions.

The purpose of the order is the mitigation of the public safety hazard posed by wildfires during the current drought conditions by curtailing the use of all combustible materials.

Pursuant to the Texas Disaster Act of 1975, relating to Emergency Management, the following regulations will take effect immediately, and will remain in effect until the state of disaster is terminated:

1. The use of combustible materials in an outdoor environment by any person is prohibited.

2. Combustible materials specifically include, but are not limited to, fireworks, camp fires, welding and any other pyrotechnic material, which in the manner or means of its use could result in a wildfire.

In accordance with the local government code, a person who knowingly or intentionally violates this order commits a Class C misdemeanor, punishable by a fine of up to \$500.00.

# Fire destroys downtown business


Haskell's business district Dec. 31 when a fire call went out for Ave. D, located on the east side of Shirley and Don Welch of Weinert. suffered a blow Saturday evening, local floral shop, Conner Floral at 12 the square. The business is owned by

attempt to limit the fire to the one business. Firefighters continued into the night keeping vigil on hot spots and occasional flare ups. Other businesses along the east side of the street were affected by smoke damage.



Upon arrival firemen assessed the building with its already blackened glass windows and determined that the interior was severely damaged preventing an interior attack. Upon entering the building they could see that the fire was located between the ceiling line and below the roof causing the roof and fire to drop inside the business. Safety reasons moved the attack into the defensive mode with firemen concentrating on putting out the fire and preventing the spread of the flames to adjoining businesses and buildings. All of the contents of the floral shop were a total loss

Circle C Decorating, CellularOne and Boggs and Johnson Furniture Store, all businesses to the south of Conner's, suffered some smoke damage; along with vacant buildings on the north side of the fire. No other businesses or buildings were damaged by the fire.


Four departments responded to a mutual aid call from Haskell firemen. Munday Stamford, and Throckmorton sent men and equipment; Weinert sent men; and Anson responded with their Community Emergency Response Team (CERT) to provide a rest and eating area for the men.





#### **Governor calls National Guard** to fight wild fires

AUSTIN - Drought overlaid with unusually warm weather and gusting winds combined into perfect conditions for wild fires in the closing weeks of 2005.

Wild fires mainly hit tens of thousands of acres of dry grass and brush in north, central and east Texas. Windborn fires jumped roads, caused at least four deaths and burned hundreds of homes.

Gov. Rick Perry ordered the Texas Army National Guard to assist local firefighters and requested air tankers and helicopters from the U.S. Forest Service.

Burn bans were in effect in more than half of the state's 254 counties. "We are working hard from both

the ground and the air to protect Texans and their homes and property," Perry said after touring wild-fire stricken scenes.

Senators to study tax situation The Legislature must meet in a special session this spring to reengineer the state's broken tax system before a court-ordered deadline of June 1.

Texans who want to share their ideas on how to fix the state tax system now have a choice of senators to contact.

Lt. Gov. David Dewhurst, who presides over the Senate, recently formed the Senate Select Committee on Education Reform and Public School Finance to study tax issues and recommend legislation that: (1) satisfies the Texas Supreme Court ruling that the current property tax system violates the state constitution; (2) improves public schools; and (3) reduces school property taxes.

Dewhurst named Sen. Florence Shapiro, R-Plano, chair of the committee and member Sens. Kip Averitt, R-McGregor; Kim Brimer, R-Fort Worth; Robert Duncan, R-Lubbock; Juan "Chuy" Hinojosa, D-McAllen; Eddie Lucio, D-Brownsville; Steve Ogden, R-Bryan; Royce West, D-Dallas; Tommy Williams, R-The Woodlands.

In November, Gov. Perry formed the 23-member Texas Tax Reform Commission comprised of nonlegislators and headed by former state Comptroller John Sharp, a Democrat. The commission's focus, as its name suggests, is tax reform.

But Dewhurst's committee will have a broader focus. He encouraged the committee to "continue work on a public school finance plan that puts additional resources into public school classrooms, tied to greater accountability and performance, cuts property taxes and closes business tax loopholes.

Furthermore, the opinion said, a district attorney may not require a justice of the peace to deny organ or tissue removal.

SBC, the company formerly known as Southwestern Bell, was one of seven "Baby Bells" born in 1982 when a federal court forced the breakup of AT&T into regional telephone companies.

With the acquisition and name change, San Antonio-based AT&T becomes the largest phone company in the nation.

#### Jurors to be paid more

A law that goes into effect with the new year compensates members of grand juries and petit juries much more for their civic service.

Jurors who serve all or part of a single day will still get a \$6 check, but jurors who serve two or more days, or a fraction of a day after the first day of service, will get \$40 per day.

New Year's Resolution: Pay Your Child Support

This is a time of year when many of us assess our past and plan for the future. By paying child support, you are setting a good example for your children and helping to secure their future.

Thank you to those parents who paid their child support in full and on time during 2005. Your faithfulness will provide endless benefits to your children. Parents who regularly pay their child support demonstrate that they are concerned for their children's welfare.

It is common knowledge that child support payments cover a child's basic needs, such as food, shelter and clothing. However, the benefits extend beyond the financial security that each payment provides. Research shows that children of parents who pay their child support have fewer behavior problems, make better grades, and stay in school longer than children who do not receive regular support.

Parents who pay child support are also more likely to "be there' emotionally for their children and take an active role in their upbringing. To help parents collect child support, my office accepts application from mothers, fathers and other individuals who request our services. Parents who receive financial assistance through the Health and Human Services Commission automatically receive child support services.






