Payne shared the wide receiver honor with Danny Bingham of Reagan County who snared the All-District spot back in late November. Payne took kicker spot again as he had done the year before but had to settle for honorable mention at wide receiver.

"I think the coaches (who made the All-District selections) may have looked more at years of experience than this season's performance. With the writers choosing the All-West Texas Team, I probably had more of an opportunity.

## Filing for county offices ended

Monday at 6 p.m. with 20 political hopefuls having places on the March 8 Democratic Primary ballot.

Kathryn Mayfield, B. W. Stewart and Jess Marley are asking election to the office of judge. That position has yet to be filled since the resignation of Judge. A. O. Fields which was effective Dec. 31. Although Fields' resignation was accepted by commissioners' court and he is no longer on the county payroll, he is required to serve until commissioners appoint a replacement.

The offices of county attorney and tax assessor/collector are the only uncontested races on the Super Tuesday ballot. Incumbent Tom Cameron filed for attorney and Tom Stokes is asking re-election to his tax assessor post.

Running for sheriff are Jim Wilson, Aldo Gonzales and Manuel Hartnett. Sheriff Billy Mills will not seek re-election to the position he has held since January of 1957.

Three candidates will be on the ballot for constable. They are Rick Hunnicutt, Raymond "Bear" Borrego and incumbent Gene Williams. In the Pct. 1 commissioner's race, incumbent Sostenes DeHoyos, Cruz "Coy" Tambunga and Richard Berry are asking to be elected.

Six candidates have filed for the Pct. 3 commissioner's job held by Jack Williams since January of 1969. On the ballot will be Jim Marks, Beth Boyd, Rex Fenton, C. E. Light, Glenn "Pop" Wheeler and Jim House.

Democratic Party chairman Steve Kenley released the final list of local candidates Monday night.

## Fire department has busy year

Ozona volunteer firemen handled 134 calls during 1987 according to the end of the year report. Of these, 119 incidents were in county and 15 out of county.

Grass fires accounted for 68 of the calls with structure fires being the next most frequent at 20. There were 14 responses to vehicle fires.

Nine oil field related calls were listed, and seven investigations were made in other instances where there was no fire.

Standby for motor vehicle accident calls numbered six, and department members did five washdowns.

Twice the volunteers were called to assist other agencies where there was no fire.

False alarms, rescue calls and use of the jaws of life were listed as one call each.

During the last week of the year, volunteers responded to an 8:15 p.m. call to a grass fire at Cherry and Mulberry Streets on Dec. 23. Two trucks and six men went to the scene where they used 200 gallons of water.

was out on Dec. 25 when volunteers arrived. Three trucks and nine men raced to answer the 9:47 call.

Volunteers were part of an effort to find a lost hunter on the Mike Clayton Ranch Dec. 26. Twelve from the fire department responded to the 5:52 p.m. call.

Dec. 30 was a busy day for volunteers. Their first call was at 10:22 a.m. to the county dump ground east of the cemetery. Two trucks and six men made the call which required 250 gallons of water.

A call received at 10:23 a.m. took firemen to a grass fire three miles. north on TX Hwy. 163. The fire on the east side of the road required 100 gallons of water. One truck and three firefighters made the call.

At 11:25 a.m. a truck with three firefighters went on a four hour trip to assist the Eldorado fire department. A total of 2,250 gallons of water was used.

## Sharp execution date to be set

A hearing to set the date of execution for convicted murderer Michael Eugene Sharp will be held in Ozona Jan. 11. Sharp was convicted in 1983 by a Crockett County jury of capital murder in the June 11, 1982 stabbing death of Brenda Kay Broadway near Kermit.

The charges grew from the kidnapping of Mrs. Broadway and her two daughters from a Kermit car wash. Mrs. Broadway and her daughter, Christie, were killed after the three were abducted and driven to a remote spot near the Ector-Winkler county line. The older daughter, Selena Elms, managed to escape and was the key witness for the prosecution. The trial was moved to Ozona on a change of venue.

sentence of life in prison in November of 1982 in Lubbock for the murder of eight-year-old Christie Elms.

When sentence was pronounced on Sharp for the killing of Mrs. Broadway by presiding 109th District Judge James H. Clack of Andrews, Sharp maintained his innocence.

Glen Williamson, court appointed defense attorney from Santa Fe, NM also maintained his client's innocence at the time of sentencing.

Sheriff Billy Mills will fly to Huntsville to bring Sharp back for the 11 a.m. hearing. Sharp has been incarcerated on Death Row at the Texas Department of Corrections Ellis Unit 12 miles northeast of Huntsville.


## TASCO burglarized

The OTASCO store in the Village Shopping Center was burglarized Friday night some time after owner Ray Henderson closed at 6 p.m. The break-in was discovered Saturday morning when Henderson arrived to open for business.

Six handguns valued at about \$1,100 were taken from a glass case. Entry to the building was through a front window which was broken with a rock. Glass was also broken in the gun case.

Several handguns were taken from the case, but two were dropped in the store.

"This makes the fourth time I have broken into," said Henderson. The burglary remains under investigation by Crockett County Sheriff's Department personnel.


He is a past president of Ozona Chamber of Commerce and of Lions Club


"I have worked with the public for the last 20 years, and I feel like this experience will help me in decision making in regard to the county," Berry said.

AUSTIN-Seven wecks away from the Super Tuesday primary, Texas Democrats remained split bchind seven candidates while Texas Republicans drew together.

Governor Bill Clements endorsed Vice President George Bush for president and both stressed the importance of carrying the state.

Meanwhile, Texas Democratic Party chairman Bob Slagle drew fire from the Galveston County party committeeman and his state representative over Slagle's controversial endorsement of U.S. Sen. Albert Gore of Tennessce.

Clements remained neutral publicly for several weeks but his endorsement was expected since his wife Rita co-chairs Bush's Texas campaign.

The announcement was made at the Houstonian Hotel which is Bush's legal residence in Texas. The residency has been targeted by Texas Democrats who say Bush, a former Texas Congressman who was born out-of-state, is not a real

Texan anymore. **Slagle Called Unfair** 

The two Galveston County Democrats said Slagle was unfair in using state party resources to campaign for Gore but not the other six Democratic presidential contenders.

Committeeman Richard Kilpatrick, who is also county treasurer rapped Slagle for using state party staff, postage machines and telephones to help only Gore.

Slagle had sent a statewide mailout which bore a disclaimer, and Slagle said he personally paid for everything, even staff time.

But Kilpatrick, joined by LaMarque state Rep. Lloyd Criss, said he plans to question, at the next executive meeting, whether it's right for the state party staff to work for only one candidate, privately paid or not.

Meanwhile, Comptroller Bob Bullock's spokesman said complaint calls have skyrocketed since the new sales tax law went into effect this fall.


A recent comptroller's report said the state's economic base is shifting away from oil and that stable oil prices are needed before rising oil prices.

## T.C.'s Bookie Turf

Late last night and the night before, Tommyknockers, Tommyknockers, knocking at the door. I want to go out, don't know if I can, 'cause I'm so afraid of the Tommyknocker man.

No more than a simple poem, a child's nursery ryhme. Yet, the slight chill it depicts will come to life as a full haunting nightmare in the pages of Stephen King's latest, The Tommyknockers.

It begins innocently enough with Roberta Anderson, a novelist of better-than-average selling westerns. As she and her dog, Peter, trek in the woods behind her rural homestead near the town of Haven, she trips over her fate.

Jutting out of the rain-moistened ground is three or so inches of solid metal; metal that when first touched, holds a faint vibration; metal that slowly eats away at her conscience and invades her sleep in the form of green-lit nightmares.

She digs. As she removes more and more dirt, she uncovers more of the strange metal which gradually swells from the intial three inches and she realizes the object buried in the ground is more than a sunken Model T; it's a space ship.

Enter Jim gardener; a dying poet who earns his meager living off summer reading tours. A constant premonition keeps telling him that his friend and ex-lover, (Roberta) Anderson is in trouble.

After certain problems of his own. including a near-suicide drunken black out, Gardener arrives at Anderson's house and almost overlooks her, considering she weighs thirty pounds less and suffers from complete exhaustion.

And Gardener discovers batteries. Anderson's electric source is no longer Central Maine Power. Her water heater runs off a dozen Dcell batteries which produce a blinding, green light. She has a new, improved typewriter that transmits thoughts to paper and produces a novel in three days.

Aided with "New and Improved" (as Gardener comes to describe the resulting changes from the exposed space ship), Gardener joins Anderson indigging up something that has been hidden in the earth for over two million years.

In the second part of the book,

of teeth, that is. Slowly, the people are "becoming" Tommyknockers.

One or two stand out like sore thumbs to the Havenites. Gardener is one. Due to a skiing accident of long ago, he carries a steel plate in his hand and evidently it shields him from Haven's atmospheric mutations and the people's mind probing.

In the long run, this will make the difference. Gardener knows that once the interior of the ship has been reached, his death will follow.

Thus, Gardener sets out to right wrongs: save an innocent boy's life and get rid of the ship. Easier said than done.

As the New Tommyknockers close in. Gardener alone must decide the world's fate (since no outsiders seem to make it into haven without being poisoned from the air and/or struck down by a mechanical sentry guard; A Coke machine for example).

King provides a fast and steady pace that quickly tingles the spine. Not often has King been able to mesh both good, constructive writing and haunting suspense. But here the combination comes together and though the end may seem more like that of Star Wars than typical Kingish twitch, the book may just be King's best on account of continual flow and message.

He leaves you with more than an imaginary beast to contemplate. He points out in his foreword that the Tommyknockers are real.

Please don't forget to lock the door.
