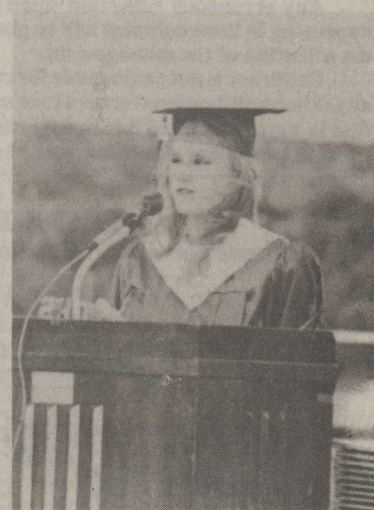

## Ozona Site Of 1993 World Championship Goat Roping

Ozona Chamber of Commerce will host the 1993 World Championship Goat Roping on June 25 and 26 at Crockett County Fairgrounds. The Texas Goat Roping Association series finals promises two days of excitement including a match roping during the Friday evening performance between defending world champion goat roper Johnny Bownds and defending match roping champion Glyn Hutto.

Buckles will be given to all series winners, event winners and world champions at the finals. There will also be a reserve world champion junior buckle.

A saddle will be given to the open world champion goat roper and series winners in the senior 50 and over and junior divisions. There is \$3,000 added money in the open world championship, \$1,000 in the junior world cham-

ampionship and \$250 in all jackpot roping events.

Besides goat roping and goat tying at the finals and the match roping, each performance will have a goat sacking event for kids 12 and under and a boot scramble for those 8 and under. Trophies will be given to the first four places each night.

A goat ropers ball featuring Ray Wylie Hubbard will be held Friday

night starting at 9 p.m. The Friday night performance will start at 7 p.m. to allow for the dance. Saturday night's performance is scheduled for 8 p.m.

The Texas Goat Roping Association sponsors series roping held within an approximate 200 mile radius of San Angelo, the home of the association office. The non-profit organization benefits the West Texas Boys Ranch and West Texas Rehabilitation Center.

## Discrimination Bill Dies In Committee

A bill approved by the Texas Senate which would have made discrimination illegal at athletic clubs in communities of 5,000 population or less, died last week in the State Affairs Committee. S.B. 1463 was filed by Sen. Eddie Lucio of Brownsville after an identical bill, House Bill 801, filed by Rep. Pete Gallego of Alpine bogged

down in a sub-committee of the State Affairs Committee.

The bills resulted from a meeting the legislators had with County Attorney Orlando DeHoyos while they were in Ozona last fall on a campaign trip.

In addition to prohibiting discrimination in the use of equipment or facilities at athletic or swim clubs in

counties with a population of 5,000 or less, the bill was designed to affect clubs with more than 100 members or those that receive more than \$75,000 in annual dues.

Under the provisions of the bill, violators could be charged with a Class B misdemeanor which is punishable by a maximum of six months in jail

and a \$1,500 fine and could also be subject to a civil lawsuit.

Legislation passed unanimously by the House and Senate which would prevent school teams from practicing at athletic clubs where discrimination is allowed was signed by Gov. Ann Richards on May 22.

Originally designed to prohibit discriminatory membership criteria for private clubs in rural areas and prevent high school teams from practicing at clubs that refuse membership to minorities, H.B. 800 passed with only the portion concerning high schools practicing.

## Mrs. Gutierrez Retires From School System

Juanita Gutierrez, library aide at Ozona Intermediate School, retired last week after 15 years in the school system.

Mrs. Gutierrez began working as the Spanish teacher for third and fourth grades. Five years later, when the state removed the Spanish instruction re-

quirement, she was assigned as an intermediate school aide for five years. After two years as a special ed aide in high school, Mrs. Gutierrez became the library aide at OIS, a position she has held for three years. All aide positions involve more than the basic assignment, Mrs. Gutierrez said. While a library aide, she also worked the cafeteria count and did other things as needed.

Mrs. Gutierrez plans to concentrate on remodeling the house once she retires. Her husband, Hector, retired several months ago.

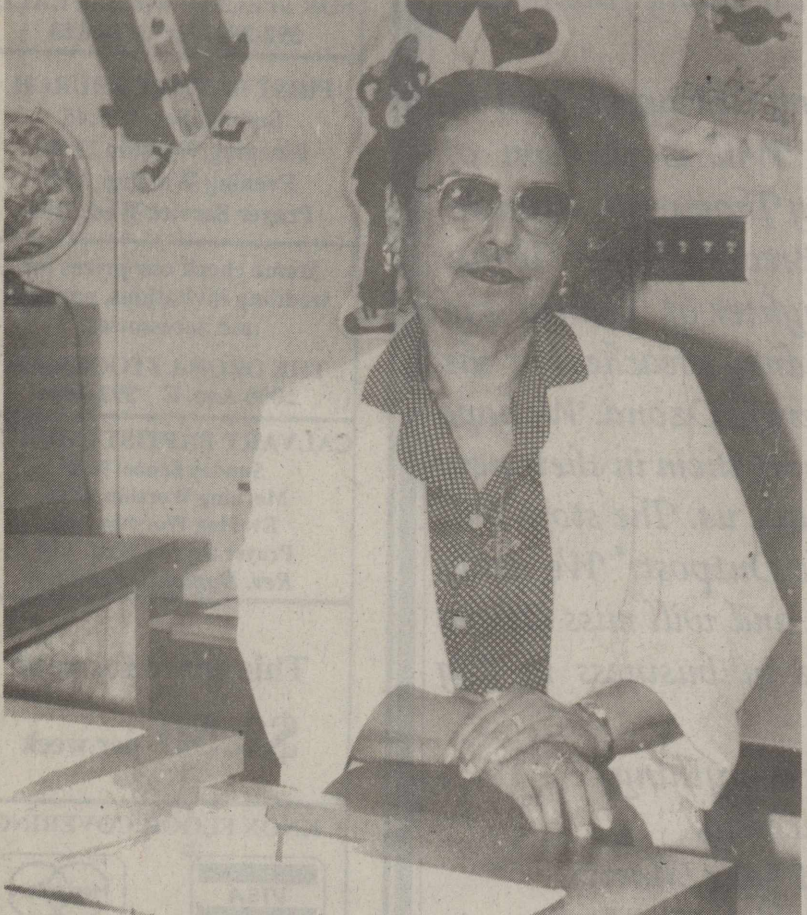

Juanita and Hector Gutierrez are the parents of three sons and grand-children to two boys and two girls.

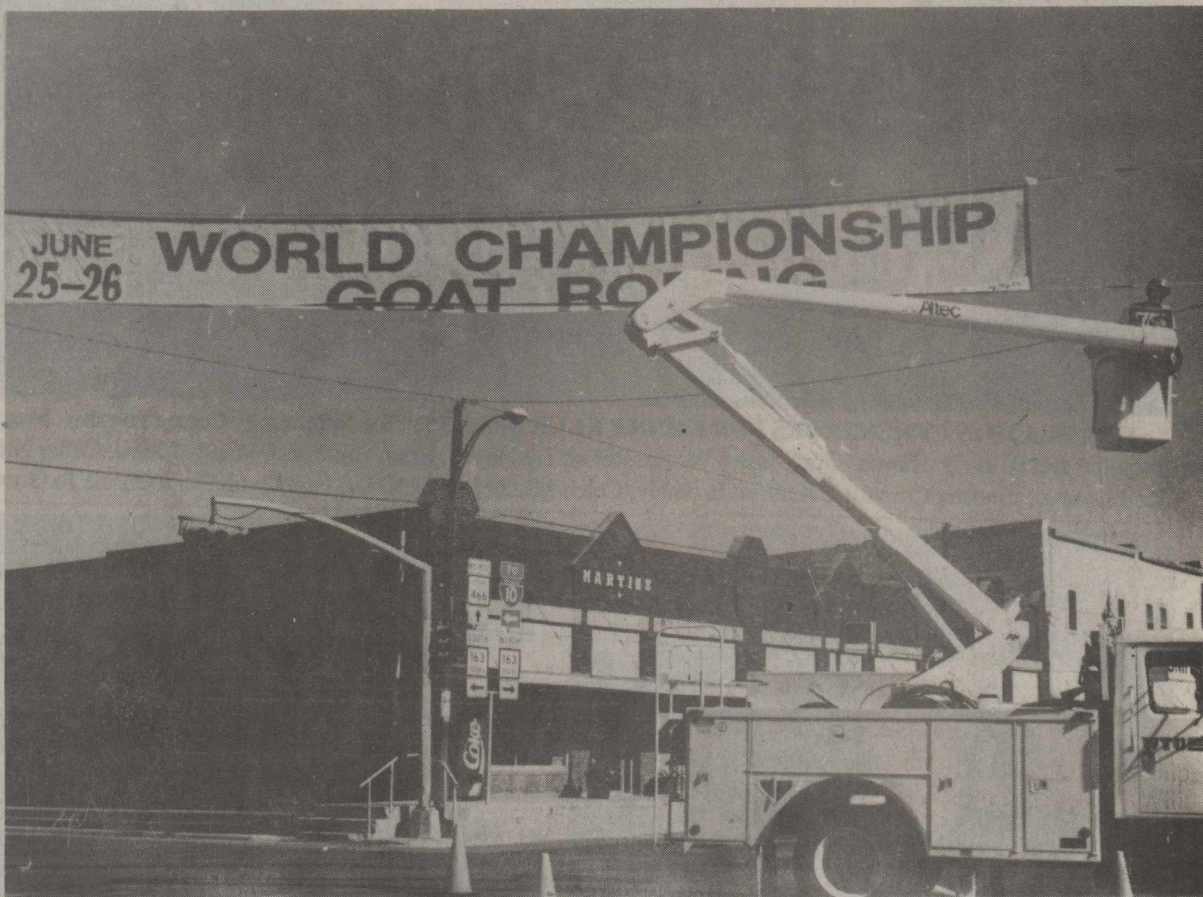

Heriberto lives in Carthage, NY, where he is a security guard.



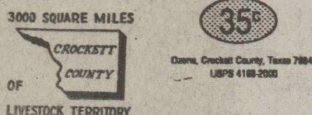

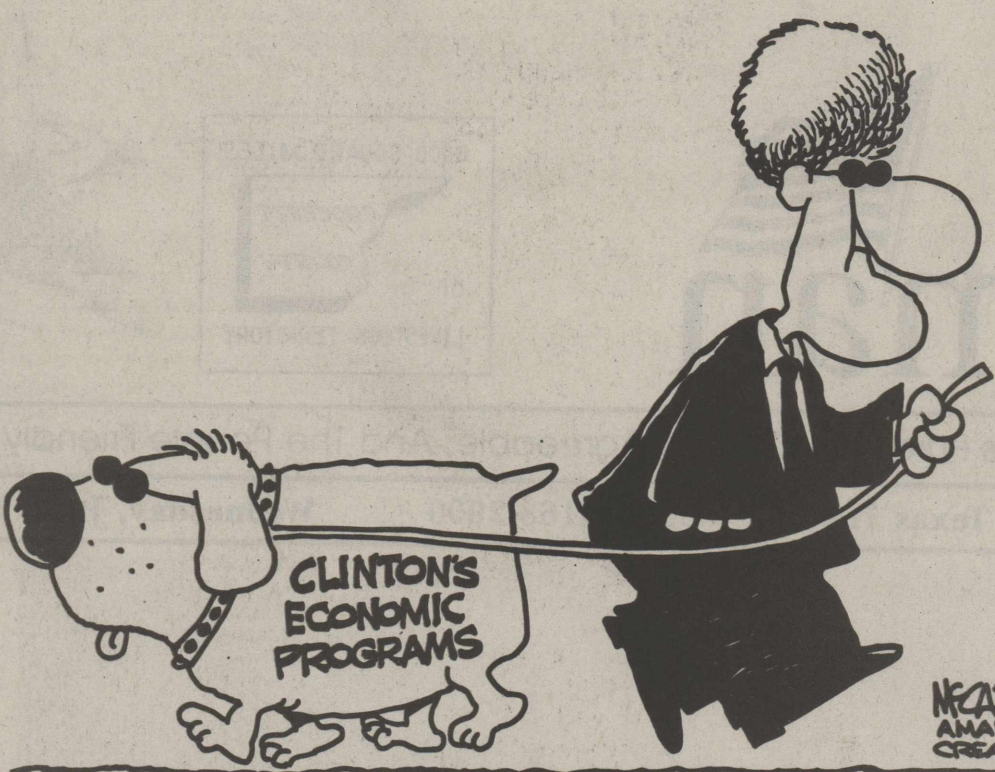

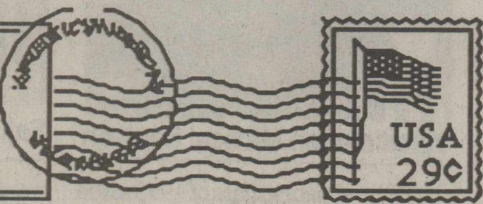

Dear Scotty and Linda:

I think we have begun to see the objective of our County Attorney (and his sponsors) all too clearly...the taking of private property by a government that knows better than you how you should run your life. It became quite clear in his last letter. He spoke of the county owning the golf course and making FAIR compensation for its taking. (I wonder how many Eastern European nations heard that same chant before being unified into that great communal whole that has since fallen into utter run?) How might the county club be taken...it certainly isn't going to be sold to the county. What would the commissioners do, vote to take it and then by gunpoint, go get it? What is FAIR compensation and how would the county pay for it? The county can barely make the yearly budget as it is. Would Orlando want to cut his \$30,000.00 per year salary to a figure more in line with what he does for the county, say about \$1,000.00 per month? He would still continue to have a private practice in an office and with a secretary paid for by the county. Would the Commissioners want to cut their own salary? How about the County Judge, the District and County Clerk, The District Judge, etc. etc.? Should I have even asked the ques-

tion? (As an aside, I just received the Fiscal Year 1993 Probation Office budget...would you believe \$413,033.79? Astonishing! I'll have a bit more to say about that at a later time.)

The taking of private property by governmental decree, an objective which appears to be obvious from his letter, is quite unconstitutional and the use of racism as a basis is a sham and does a disservice to all those people of good will who are trying to overcome the problems begat by generations of inequality. The real objective, then, is the acquisition of power...It's a power game so it would be best for everybody to understand the game and its rules. It makes enemies where none existed. It creates animosity where no animosity existed except in the mind of those radical elements that are bent on taking power by any means. It uses people of good will and turns them into bearers of ill will. It leaves in its wake social and economic chaos, a condition which is much more easily taken advantage of by the power seekers. There are no rules.

This is the agenda about which I spoke in my last letter...the unspoken agenda. It IS shameful!

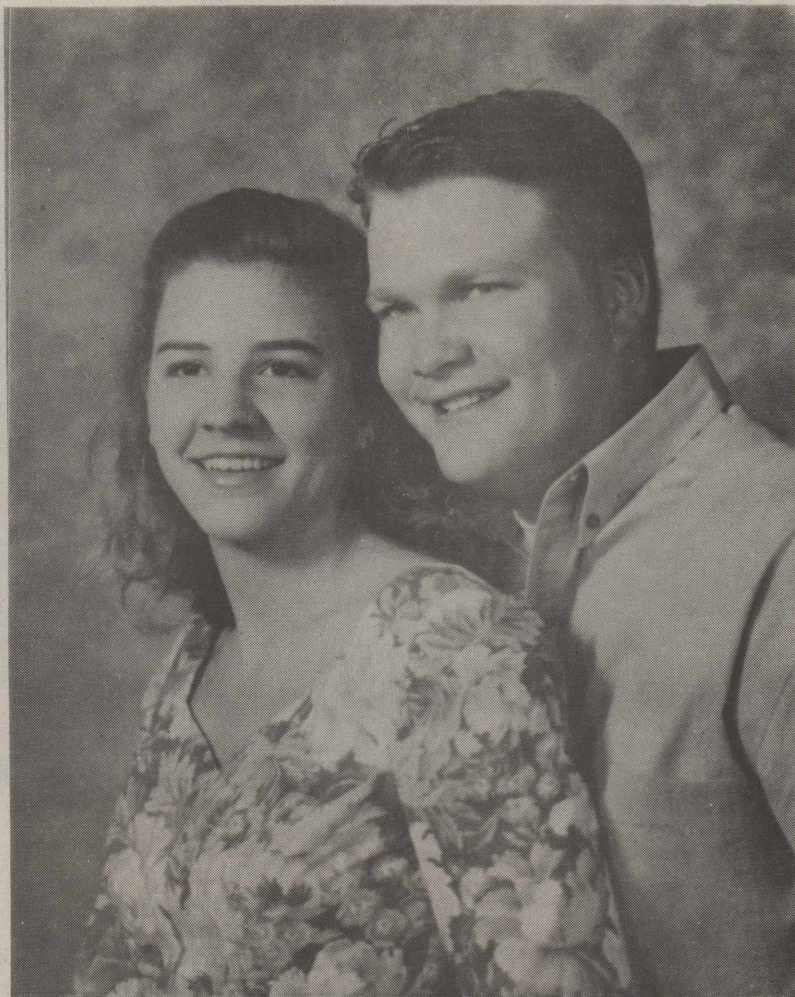

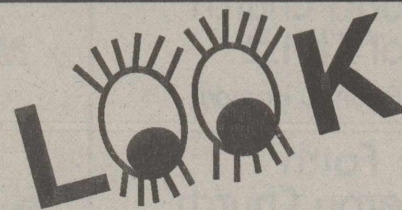

He was born Oct. 21, 1920, in San Saba County. He was a rancher and a member of the Methodist Church.

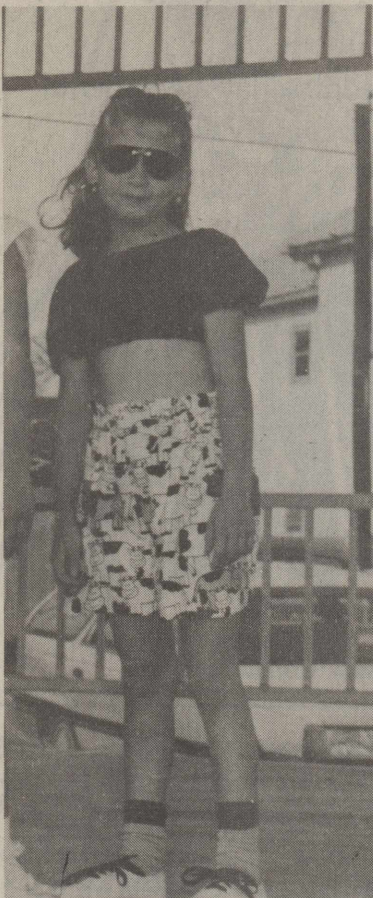

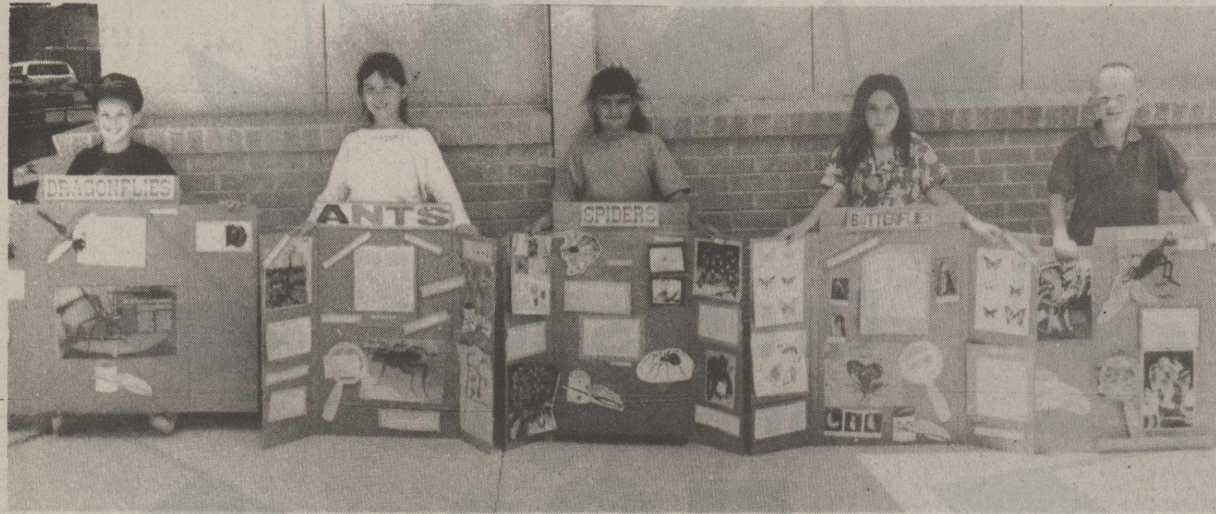

## School Personnel Sessom Graduates Ask For Salary Increase From OHS

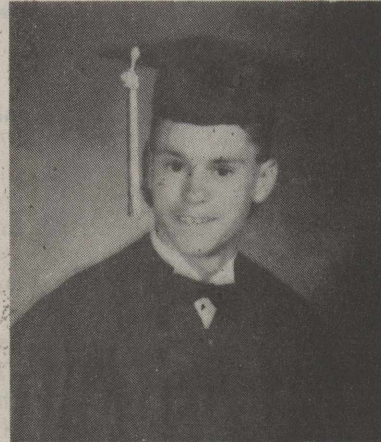
Members of the Ozona School Board, meeting in regular session on Tuesday, May 11, heard requests for consideration of various issues from four separate individuals or groups during the open forum section of the May meeting.

Speaking on behalf of a large group of school para-professional personnel who appeared before the members, Carol Yeager presented the school board with an information packet of material which also listed some concerns of the group. The concerns included: (1) a possible reconstruction of the present salary schedule to be equal to other public schools in the area; (2) consideration of such factors as how their responsibilities and actual job duties have changed recently due to rapid and increased complexity of school programs; and, (3) the concern that inequities occur in the present salary schedule when other job criteria are taken into consideration in addition to para-professional longevity and previous experience.

Included in the packet was the present salary schedule for para-professional staff, a listing of their present job descriptions and actual duties performed, and other items of information that can be used by the school board to determine if a need exists to update the job descriptions/salary schedules of the employees.

President Gary Buck Mitchell thanked the group for coming before the school board and said that the members would study the information packet that the group had presented.

David Porter, physical education teacher in Ozona Intermediate School, appeared before the board to request trustee consideration of the purchase of additional playground equipment at the school. Porter said, "There is a great need for playground equipment that will be used each day for play and/or physical education which will develop the upper-body strength of the students. This is an area of physical fitness that our students are lacking more than any other area. Only 34% of the students completed at least one pull-up on the physical fitness test. Only 26% could do more than one pull-up. In order to be in the 50th percentile ranking on

the physical fitness test, boys in the 9 through 12 years of age bracket must do at least 2 pull-ups, and the girls in the same age group must do at least 1 pull-up. Porter presented a proposal for the purchase of a 9-unit physical fitness course and equipment which would cost approximately \$2,600. A 12-unit course (\$4,650) and a 16-unit course (\$6,700) were also listed as alternates. The consensus of the board was to consider Mr. Porter's proposal during a 1993-94 school budget workshop that will be held this summer.

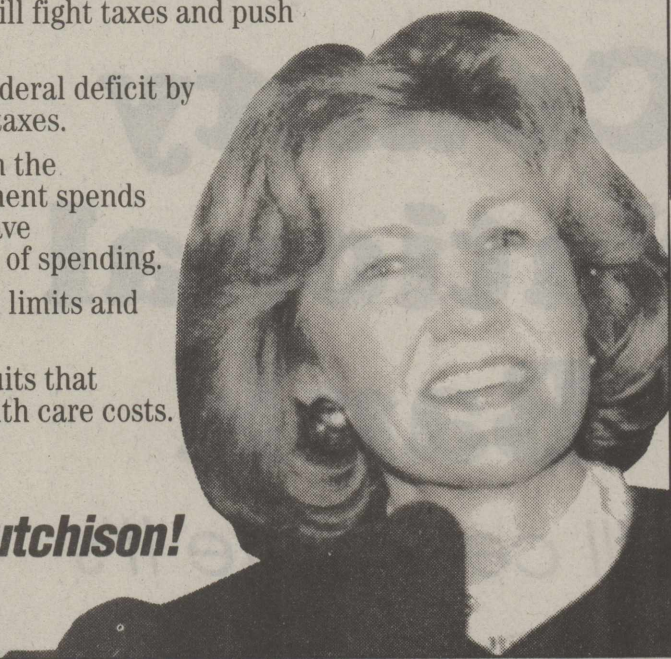

## Sales Tax Report Issued

The fourth quarter of 1992 state sales and use tax report issued May 17, 1993, shows Crockett County with 87 reporting retail outlets with gross sales of \$6,246,923, up 2.4% from 1991 sales of \$6,101,838. The 1991 sales were reported by 100 retail outlets.

Area counties and their 1992 fourth quarter results include: Crane, 72 outlets, \$5,376,794, no change; Irion, 34 outlets, \$921,457, up .8%; Reagan County, 61 outlets, \$6,392,751, up 8.5%; Schleicher, 44, \$2,113,019, down 17.5%; Sutton

County, 98 outlets, \$5,591,161, down 6.7%; Terrell County, 44 outlets, \$1,190,666, down 29.7%; Upton, 87 outlets, \$5,895,177, up 76.7%; Val Verde, 611 outlets, \$67,020,208, up 8.5%.

Schleicher and Irion Counties were the only two showing an increase in the number of businesses over the previous year.

Crockett County's report for all industries showed 144 reporting outlets in 1992 compared to 164 in 1991. Gross sales were \$11,828,459, up 16.1%.

Kelly Glaze, band director in Ozona High School, met with the board to request consideration of the purchase of a utility trailer that could be used to transport band equipment for area activities and contests. "At the present time", Glaze said, "the small trailer that the district purchased many years ago is inadequate because of limited storage space, and its condition has deteriorated to the point where it is becoming unsafe to pull."

Glaze also noted that the majority of the band's approximately \$111,000 of equipment (instruments and uniforms) had to be carried on school buses and were not adequately secure. "Only the largest band instruments can be carried in the small trailer," Glaze said. "A large trailer can be used not only by the band for all of its equipment but also by the district's vocational agricultural program and one-act play activity which requires many stage props."

Board discussion was centered around the possible purchase of a larger trailer for the district or a used U-Haul type van that would not have to be pulled by a vehicle. At the conclusion of the discussion, the members asked Mr. Glaze, Pete Maldonado (school bus maintenance supervisor), and Curtis Keith (school building maintenance supervisor) to make a study of this type of vehicle need and report back to them at the next regular meeting of the board.

Pete Maldonado met with the trustees to give a report on school bus transportation needs for next year. In his report Maldonado noted that during the 1992-93 school year the district's fleet of school buses had already traveled 186,472 miles, and while all of the buses were in good mechanical condition, twelve of the nineteen vehicles had mileage in excess of 77,000 miles. "The range goes from 77,402 miles to 155,358 miles on these buses", Maldonado said.

He also noted that several times this past winter when school bus routes were being run and when the football team and band left for a football game, the district had only one back-up bus to use in the event of a breakdown. "If the district had one bus in the shop for major repairs at this time, it might be an uncomfortable situation", he remarked.

Mr. Maldonado also reported that the vehicle used to transport food from the central cafeteria to other school campuses was in critical need of replacement. "In addition to the poor overall condition of this vehicle, it is inadequate in terms of transferring food items from the main cafeteria into the van and storing them for transferral to the various buildings."

After discussing these transportation needs, the trustees voted to purchase two 65 passenger activity buses and one panel truck to be used by the school cafeteria service. Although the two school buses will be ordered as soon as possible, the anticipated delivery date to receive the vehicles will be from six to nine

months because of the backlog of orders already pending from school districts across the state.

The members also approved the adoption of the district's 1993-94 school year calendar and accepted the resignation, effective at the end of this school year, of Kristy Smith (three-year old program teacher), Judith Greene (fourth grade teacher), and Bill Greene (high school counselor).

Gary Buck Mitchell was elected Board President, Wade Richardson was elected Board Vice-President, and Elliott Barrera was elected Board Secretary for the 1993-94 school year. Newly elected school board member Becky Childress was appointed as the board's delegate to the Texas Association of School Boards-Texas Association of School Administrators Annual Convention in Dallas, and Elliott Barrera was appointed as the board's alternate delegate. During the meeting, Mrs. Childress and George Ybarra were administered the oath of office by Superintendent Jim Payne. The school board's next meeting will be Tuesday, June 15, at 7:00 p.m.

## Sexual Abuse Happens In Small Towns Too

In a small town it is very easy to become over confident that our children are safe.

They are certainly a lot safer in a small town like Ozona than in a large city.

However, Ozona is not crime free, and children do get hurt even here.

I recently went through the case files of child sexual abuse cases in Ozona from 1982 through 1993. In that period of time there are nine cases to date on record.

There were five cases of Indecency With a Child, three cases of Aggravated Sexual Assault or Rape of a Child, and one case of Incest on record.

Parents, sexual assault of a child is usually done by someone that you know.

Either a father, stepfather, adopted father or grandfather, or uncle or cousin. Occasionally even a mother stepmother, adopted mother or grandmother or aunt become involved.

The American Humane Association estimated there were about twenty-one out of every ten thousand children, about 132,000 children who suffered sexual abuse in 1986. These are the last national figures I could find.

This number, I can personally assure you only taps the surface of this terrible problem.

As a victim of sexual abuse and incest, I can assure you a lot of these cases go unreported and unprosecuted.

Some are because the non-abusing parent doesn't want to believe the child.

Some are because the parent doesn't want to further traumatize the child by forcing them to tell their story to strangers and in court.

There are even some cases that the children never tell their parent or parents about because of fear or shame.

Parents, please teach your children to know the difference in love and the touching that's okay and sexual abuse and the kind of touching that is involved in that.

Let them know before they are

even ready for school. Give your child the ammunition to protect himself or herself from the most life destroying thing that could happen to them.

Tell your children that they can always come to you and that if someone touches them or hurts them it isn't their fault. Make sure to explain to them that this includes relatives. That no one who tries to touch them in a wrong way is right. They can tell you anything.

If, God forbid, that your child is molested or raped get that child medical help and psychiatric help as quickly as possible.

A lot of parents think that they are doing their children a favor by not filing charges against the guilty party. Let me assure you as a victim who never saw the guilty party punished, file charges. It is a large part of the healing process to know that the person who hurt you is being punished for it.

Afterwards that is about the best you can do for them other than give them lots of love and continue to assure the child that you do not blame them or think any less of them.

Prevention is even more important today than ever before with the AIDS virus and all.

Learn to watch for certain signs. If your child suddenly stops wanting to be alone with a relative or friend for no apparent reason, find out why.

If your child begins having nightmares that they've never had before and they won't explain them, suspect some type of problem.

If your child bleeds or you find blood on their underwear or their clothes sometimes end up on backwards or wrong side out after you've dressed them correctly.

These are all signs of a problem. In themselves any of these signs could be attributed to other problems, but they are also signs that appear in sexual assault or incest cases involving children.

If you are alert to the signs and you teach your children what to watch for, hopefully your child will not still be having flashbacks into hell when they are in their forties as I've had to.

## Texas Businesses Oppose BTU Tax

AUSTIN -- A host of Texas businesses and industries have joined a national coalition to oppose the Clinton administration's proposed BTU energy tax. The non-partisan organization, the American Energy Alliance, has become one of the fastest growing movements in legislative history, and now lists more than 1,200 members nationwide.

Railroad Commissioner Jim Nugent, who with fellow commissioners Mary Scott Nabers and Barry Williamson first sounded the alarm against the tax plan at a Capitol news conference, welcomed the outpouring of support.

"This unprecedented ground swell of opposition reflects a growing awareness that President Clinton's BTU tax plan means disaster for

Texas," Nugent said. "I applaud these businesses and industries for standing up against this ill-conceived proposal. And I hope others will join them to let our state's voice be heard in Washington."

Nugent and others have pointed out that the BTU tax would hit Texas doubly hard, since the state is one of the top consumers of energy as well as a leading producer of energy. At the same time, coal-producing states and states using oil for home heating will enjoy favored treatment under the proposed legislation.

"I urge Texans to contact their representatives in Congress and let them know that we are vigorously opposed to this unfair legislation," Nugent said.

## Social Security News

### Help For Low Income Medicare Beneficiaries

If you have a low income and few resources, your State may pay your Medicare premiums and some "out-of-pocket" Medicare expenses such as deductibles and coinsurance. This help is available through the Qualified Medicare Beneficiary program (QMB).

To qualify for this help, you must meet certain requirements:

\*\*\*You must be entitled to Medicare Part A.

\*\*\*Your monthly income in 1993 must be less than \$601 for one person or \$806 for a couple.

\*\*\*Your resources (resources are things you own) must not be more than \$4000 for one person or \$6000 for a family of two.

If you qualify, your State will pay for your Medicare Part A deductible (\$676 for each benefit period), your Medicare Part B deductible (\$100 each calendar year), your Medicare Part B monthly premium (\$36.60 per month) and the Medicare coinsurance.

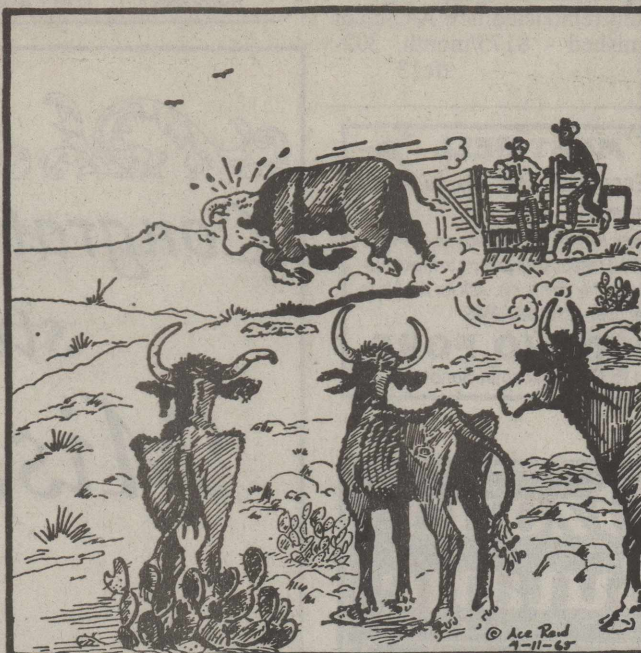

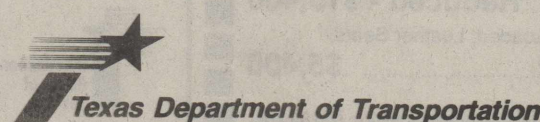
