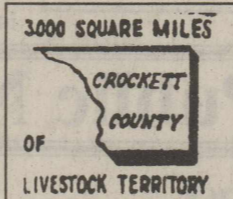

## Crawford wins NASCAR truck race

The air was thick with excitement as the Circle Bar Racing tractor trailer rig rolled into the truck stop last Wednesday. Tom Mitchell's #14 Circle Bar Ford F-150 truck was enroute to the NASCAR Craftsman Truck Series race at the Phoenix International Raceway on April 19.

Crew members Michael John Moore, William Lusk and Mark Meggitt were excited to present Mitchell with the victory trophy driver Rick Crawford won April 4 at the Metro-Dade Homestead Motorsports Complex in Homestead, Florida.

Crawford is hot off last year's Rookie of the Year runner-up status in the NASCAR Craftsman Truck Series. In the 1997 season, he placed 12th for the year with 3149 points, one top-5 finish and 10 top-10 finishes with total winnings of \$237,845 as well as being runner-up Rookie of the Year.

Owner Tom Mitchell said, "Rick did real, real good as a rookie, and is doing real good this year."

The season started off a little disappointing in January where Crawford had fuel pump problems at Walt Disney World Speedway. The next stop at Homestead, FL, brought a victory celebration. "There's some big guns in this series. To put up a little team from Ozona, TX, to compete with these guys says a lot for Tom Mitchell. It took us 28 races to pull off a win, but maybe number two's just around the corner," said Crawford. Adam, Crawford's 9 year-old son had a Little League victory that weekend. Upon his father's return home in Mobile, AL, Adam said, "It looks like them Crawford boys had a good day, Daddy."

Crawford's third start of the year in Phoenix this past weekend brought a fifth place finish. After his victory in Florida, Crawford's standings went up to seventh place with 256 points and

winnings of \$61,635. After the fifth place in Phoenix, Crawford climbed up to fifth place with 441 points and winnings of \$71,910.

The NASCAR Craftsman Truck Series is now in its fourth year. "The series has really gained in popularity" said Tom Mitchell. Daughter Lisa added "All of the races are televised." This past Sunday's race was on ESPN2, so was not available on cable to Ozona viewers. Immediate results of all races can be obtained on the internet at [www.nascar.com](http://www.nascar.com), as well as stats and schedules on all NASCAR events.

The fourth start of the year will be the "Craftsman 200" on Saturday, April 25, at the Portland Speedway. The race will be carried by TBS and will begin at 2:35. The May schedule includes: May 9 at the Evergreen Speedway on TBS, May 23 on TNN at the I-70 Speedway and May 30 at the Watkins Glen International on ESPN.

## School trustees hear report on proposed campus improvements

During their regular monthly meeting that was held on Tuesday, April 14, members of the Ozona School Board held a lengthy discussion with district architect Larry Harvey concerning renovation plan proposals for Ozona Middle School, Ozona Middle School Gymnasium and Davidson Gymnasium.

Mr. Harvey presented a list of facility renovations for the board to consider during the discussion on renovating these three buildings. The list for Ozona Middle School included: removal of 22 classroom heaters and installation of 22 roof-mounted new heating and air conditioning units; removal and replacement of school cafeteria heaters; updating and remodeling of restrooms; providing a new library for the school; providing a new area for band practice and walkways; renovating the existing administration area; repairing eleven classroom floors and making them level to the corridor floors; providing new paint on all existing interior and exterior painted surfaces; providing new carpet in corridors, all classrooms, and offices; providing a new fire and smoke detection alarm system; upgrading the present electrical system; replacing all existing exterior and interior doors with new hardware and locks; replacing evaporative coolers in the cafeteria with new air conditioning; installing a new standing seam metal roof system over the existing sloped roof; and, reducing the utility cost and improving the energy conservation of the building by installing additional insulation.

In regard to Ozona Middle School Gymnasium, facility improvements discussed included providing a new wood playing floor over the existing tartan artificial floor covering, relocating the boys' locker room to a new addition along the west end of the gym (freeing up space for additional seating), providing additional seating along the south side of the gym with storage below, renovating the existing girls coach's office, showers and toilets for new public accessible toilets, and relocating the girls coach's office, girls' showers and girls' toilets to the new west addition.

Facility improvements discussed in regard to the renovation of Davidson

Gymnasium for the purpose of making the gym Americans with Disabilities Act (ADA) handicapped accessible include the renovation of the existing storage room located at the east end of the gym for use as a public concession and viewing area. Access to this area would be provided by a new east accessible entrance and through new doors cut into the existing east wall of the gym. When completed, the gym floor would be visible from the east concession area, accessible seating would be provided for the handicapped, additional accessible public toilets would be provided, and an accessible route would be achieved into the public seating areas. Mr. Harvey told the trustees that renovating the east storage area for viewing would require that the existing scoreboard be relocated, and he suggested that the larger east scoreboard be relocated on the west side of the gym and the smaller west scoreboard be relocated on the east side of the gym.

Following discussion of renovations to these three buildings, the board asked Mr. Harvey to prepare a more accurate estimate of expenditures required and to bring these estimates to the next meeting of the board on Tuesday, May 19, at 7 p.m.

The trustees also approved raising the district's VISA credit card limit from \$10,000 to \$25,000. Supt. Larry Taylor explained that the present card limit is \$10,000 and that the period of time between the end of basketball season and full implementation of spring activities sometimes causes charges to go over this limit.

While all expenses are approved expenses, the limit needed to be raised to cover this overlapping period.

Also receiving approval was the 1998-99 Ozona Public Schools School Calendar and certification of election of unopposed trustee candidates Elliott Barrera (Dist. 1), Wade Richardson (Dist. 6) and Marcus Sims (Dist. 7) due to no opposition. An update to the school board's policy reference manual was also approved at first reading.

The board also accepted the resignation, effective at the end of this school year, of Fred Jones, eighth grade science teacher in Ozona Middle School. Mr. Jones will retire after teaching for 28 years in Ozona. In another personnel item, the trustees also approved extended sick leave for Jeannie Fuller, Rose Williams and Deborah Arrott in the event that they run out of regular sick leave before this school year is out. School board policy states that any employee who has exhausted all available state and/or local leave may be granted up to 20 equivalent workdays of extended leave for catastrophic illness or disability personally or in the immediate family. Extended leave shall be approved by the board upon the recommendation of the superintendent.

The meeting was adjourned following an affirmative vote by the members to approve a two percent 1998-99 school year salary increase for the district's maintenance director, assistant maintenance director, other maintenance employees, cafeteria manager and other cafeteria employees.

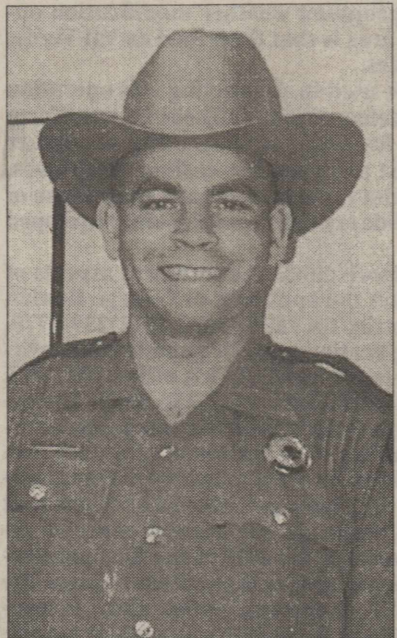

**NOTICE OF INTENTION TO CONDUCT WEATHER MODIFICATION OPERATIONS IN THE STATE OF TEXAS**

Date of the first of three weekly publications of this notice: April 8, 1998 in the Ozona Stockman.

1. Notice is given that the Texas Border Weather Modification Association, 232 West Strickland, Del Rio, TX 78840, has filed an application with the Texas Natural Resource Conservation Commission (TNRCC) for a State permit to conduct weather modification operations to change, or attempt to change, the natural development of clouds for the purpose, objective, period, and by the method summarized herein below. The Executive Director will issue this permit unless a written hearing request is filed within 30 days after the first newspaper publication of this notice.
2. The Texas Border Weather Modification Association submitted an application for a Texas weather modification license on March 23, 1998.
3. The purpose of the weather modification operation is to increase rainfall. The period of the permit is May 1, 1998 through April 30, 2002. The proposed cloud-seeding operation may be conducted at any time during that time period.
4. The proposed weather modification operation is to be conducted for and on behalf of the Texas Border Weather Modification Association, 232 West Strickland, Del Rio, TX 78840.
5. The proposed weather modification operation is to be carried out in both "Operational area" and a "target area" to cause the intended effects to occur only in the target area. The operational area is that area including Val Verde, Kinney, Maverick, and Terrell Counties, which is the target area; and those portions of the following counties within 30 miles of the outer boundary of the target area: Crockett, Sutton, Pecos, Edwards, Uvalde, Zavala, and Dimmit.
6. The area to be affected by the proposed weather modification operation is the target area. The target area is that described as Val Verde, Kinney, Maverick and Terrell Counties.
7. The methods and materials to be used in conducting this operation are summarized herein: A licensed meteorologist will select cumuliform clouds or other appropriate clouds for cloud seeding using a weather radar display, standard meteorologist analyses, forecasting techniques, surface weather observations, and pilot reports to initiate the release of the seeding particles, such as silver iodide crystals from airplanes equipped with flare racks and/or generators.
8. Persons interested in knowing more about the technical aspects of the proposed operation should contact the applicant or George Bomar, MC 158, TNRCC, P.O. Box 13087, Austin, TX 78711-3087, (512)239-0770.
9. Requests for hearing on this application must be submitted in writing during the 30-day notice period to the chief clerk's office, MC 105, TNRCC, P.O. Box 13807, Austin, TX 78711-3087, (512)239-3300. The petition must contain (1) the signature, full name, address and phone number of each person requesting the hearing, (2) a statement that each person is at least 18 years of age and resides, or owns property in the operational area; and, (3) a description of each person's interest and how that interest could be adversely affected. Requests for hearing must be received by the commission within 30 days of the date of the first publication of this notice. If at least 25 eligible persons make written request, the commission will hold a public hearing on the application prior to issuance of the permit. AUSTIN — University of Texas System officials see the decline in minority enrollment and they want to reverse the trend.

Last week, the *Austin American-Statesman* reported that UT officials and legal experts said they want to take steps to revive the case that made it illegal for the university to have a race-based admissions policy. The Hopwood case was brought by four white students who claimed they were denied admission to the UT School of Law in 1992 because of race.

UT officials recognize it likely will require another hearing in the U.S. Supreme Court, even though in 1996 the high court let stand a 5th Circuit Court of Appeals ruling that banned affirmative action. They also recognize that reviving the case may be a catalyst that results in a positive change for the nation.

"This is, no doubt, not just a major Texas issue — it's a major national issue," UT System Vice Chancellor and General Counsel Ray Farabee was quoted in the *American-Statesman*. "Sooner or later, it will need to be determined not just for Texas but for the rest of the states."

UT urged Attorney General Dan Morales to appeal. Morales, who represents the state of Texas in lawsuits, is expected to decide whether to go forward with an appeal this week. In deciding, he must consider the cost to the state for attorneys' fees and potential damages if Texas loses.

Proceeding is worth the risk, UT Systems Regent Patrick Oxford, a Houston lawyer, said. "I don't think it's risky at all to appeal. Under no circumstances can we be worse off than we are now."

Larry Faulkner, UT's new president, said that if the appeal goes forward, it could benefit the university.

**Insurers' Data Still Closed**

Auto insurers in Texas don't have to release information that could identify the practice known as "redlining."

In a case heard in Austin last week, State District Judge Paul Davis sided with auto insurers, deciding that the number of vehicles they cover and the rates they charge in each of the state's ZIP codes are

not open to the public.

The case was brought by Birny Birnbaum, an advocate for low-income consumers.

Birnbaum contended the information — which is filed quarterly with the Texas Department of Insurance — could show that insurance companies are illegally denying policies in areas where large numbers of minorities and low-income Texans reside.

Attorneys for State Farm successfully argued that the information is confidential under state law, and that releasing it would aid competitors.

**Low Turnout Explained**

Secretary of State Al Gonzales had this to say about the 3 percent turnout in Texas' runoff elections last week: "We have too many election dates."

For instance, Gonzales told *The Dallas Morning News*, 103 elections have been conducted in Dallas County in the past decade — an average of more than 10 elections per year.

He said that spreading out those voting opportunities over too many dates is costly to taxpayers and causes voter fatigue and confusion.

In the runoff, only 342,960 Texans — a mere 3 percent of Texas' 11 million registered voters — went to the polls.

My grandmother made the best candy and desserts around the holidays. Unfortunately, not all those recipes were written down, and now they are lost forever. My advice to those who enjoy someone else's desserts, get that person to write the recipe down now for you so you will have it in the future, when they aren't around. Life is just too short.

Cooking is one of my favorite hobbies. I collect all kinds of cookbooks. I enjoy cooking desserts and giving them away to my neighbors, friends and family members. I just start whipping up a dessert in the kitchen when I'm bored or when I would like to taste something sweet, like the dough, but being bored doesn't happen too often now that I have a 10-month-old baby girl, Megan Christine. I am now learning how to cook with one hand. Whatever I am cooking, I always give her a taste. That way maybe she won't be a picky eater when she gets older and can make her own choices.

It's very easy to cook for Roy. He likes everything fried, but he always eats everything that I fix even if it's not fried. His favorite meal is fried chicken, mashed potatoes and gravy. I also enjoy cooking big meals for my family on special occasions. My Lemony Cream Cheese Pound cake recipe was chosen to be in the 1996 Beta Sigma Phi Favorite Recipe Cookbook.

In high school, I was in 4-H cooking, and I won first place with my grandfather's guisada recipe along with homemade tortillas. I also won first with the Mexican casserole recipe.

### #1 Davee Chili

25 lbs. coarse ground deer meat  
5 lbs. coarse ground beef suet  
2 lbs. dried chili peppers (not hot).  
Equals 4 cups after de-seeded and coarsely ground.  
9 tsp. salt  
3 tsp. black pepper (heaping teaspoons)  
6 oz. chili powder  
6 large buttons garlic, fine diced and parched  
6 oz. ground comino  
Mix ground deer meat and beef suet in skillet and brown. Add all other ingredients to browned meat. Cover with water and simmer for three hours.

### Paw Paw's Guisada

2 lbs. of stew meat or round steak  
1 med. onion  
2 cans stewed tomatoes  
1 bell pepper  
2 ribs of celery  
2 tsp. comino  
1 tsp. oregano  
3 tsp. chili powder  
1 tsp. garlic salt or powder  
1 c. water  
Salt and pepper to taste

Cut the meat into bite size, then brown with onion. Add all the other ingredients and simmer 2 hours. Serve with tortillas.

### Tonya's Prize Winning Mexican Casserole

1 pkg. 12 corn tortillas  
1 1/2 lb. ground chuck  
1 can Ranch Style beans (16 oz.)  
1 med. onion, chopped  
1 lb. processed cheese food (sliced)  
1 can cream of chicken soup  
1 can (10 oz.) tomatoes with peppers  
Chili powder, salt, pepper and garlic to taste  
Grease large pan or dish. Line with tortillas, add beef which has been browned with onions and seasoned with chili powder, garlic salt and salt and pepper.

Add beans with juice. Lay sliced cheese on top. Cover with remaining tortillas. Top with mixture of tomatoes and chicken soup which has been heated. Cover with foil. Bake one hour at 325 degrees.

### Tonya's Lemony Cream Cheese Pound Cake

3 c. sugar  
1 1/4 c. butter or margarine, softened  
8 oz. cream cheese, softened  
1 T lemon juice  
1 T vanilla extract  
1 tsp. lemon extract  
1/2 tsp. orange extract  
1/4 tsp. nutmeg  
1/8 tsp. salt  
6 eggs  
3 c. cake flour  
Lemon Glaze  
Preheat the oven to 325 degrees.  
Cream the sugar, butter and cream cheese in a mixer bowl until light and fluffy. Stir in the lemon juice, vanilla, lemon extract, orange extract, nutmeg and salt. Add the eggs one at a time, beating well after each addition. Add the flour. Mix until smooth. Pour into a greased and floured 12-cup tube pan. Bake for 1 1/4 to 1 1/2 hours or until golden brown and the cake tests done. Cool in the pan for 10 minutes. Remove to a wire rack to cool completely. Spread the Lemon Glaze over the top, allowing the glaze to drizzle down the sides of the cake.

Lemon Glaze:  
1 c. confectioner's sugar  
1 to 2 T sugar  
1/4 tsp. lemon extract  
Combine the confectioner's sugar and sugar in a bowl. Add enough water to make a smooth glaze. Add the lemon extract; mix well.

### Tonya's Easy Maple Apple Bread

1/4 c. brown sugar  
1 T all-purpose flour  
1 tsp. cinnamon  
1 tsp. maple flavor  
1 large egg, beaten  
1/2 c. finely chopped apple  
1/4 c. chopped walnuts (optional)  
2 cans (8 oz. each) refrigerated crescent roll dough  
Icing:  
1/2 c. powdered sugar  
1 T milk  
1/2 tsp. vanilla extract  
Combine first 5 ingredients in a bowl; add apple and nuts; toss. Unroll dough and separate into 8 rectangles. Press perforations on dough firmly to seal. Spread on each rectangle with apple mixture. Roll up starting at narrow end. Place each roll lengthwise with seams toward center of loaf in greased 8 1/2-inch loaf pan, making 2 layers of 4 rolls each. Bake at 350 degrees for 20 minutes, cover pan with foil and bake 30 minutes longer, removing foil last 5 minutes. Cool in pan 5 minutes; remove and cool thoroughly. Combine icing ingredients; drizzle over loaf. Makes 12 slices.

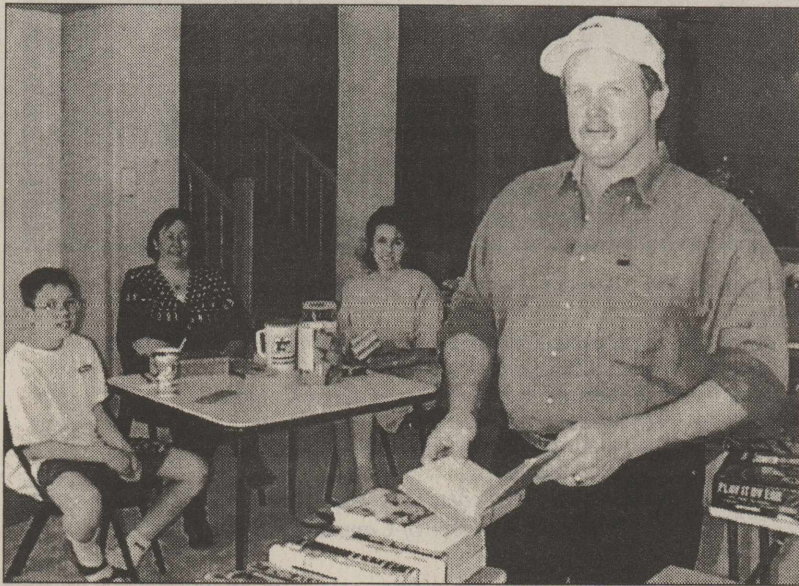
The care center residents had their exercise class Saturday morning, and they really enjoyed it. They were so tired, they had a full day of excitement.

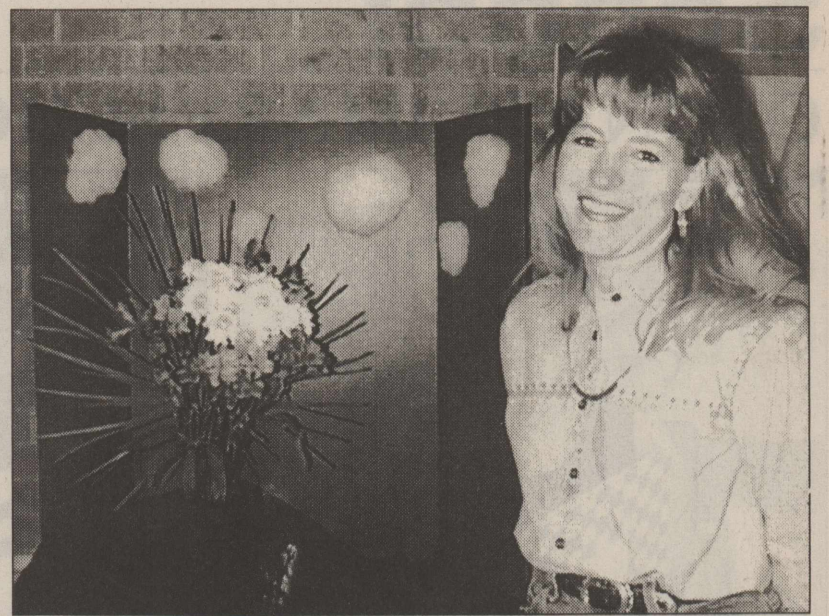

### Tijerina receives child care recognition

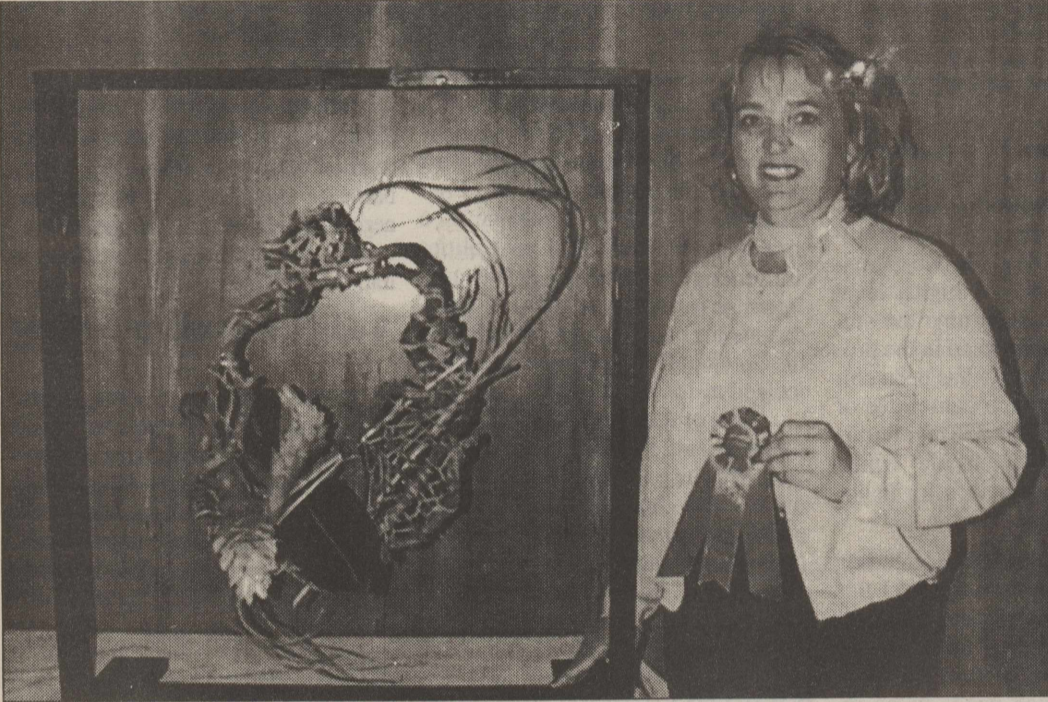

### Time to nominate GT students

The Crockett County Consolidated Common School District is now in the process of accepting nominations for its gifted and talented program for students with exceptional intellectual abilities.

According to Assistant Superintendent Ted Cotton, gifted/talented students are those who excel consistently or who show the potential to excel in any one or a combination of the following areas: general intellectual ability, specific subject matter aptitude, creative and productive thinking ability, leadership ability, ability in the visual and performing arts, and psychomotor ability.

"Students in the local program are identified and served in the area of general intellectual ability," Cotton said. "This area is defined as possessing superior intelligence with potential or demonstrated achievement in several fields of study and the ability to perform complex mental tasks. At the present time, the 48 students in our gifted and talented program are working on developing more higher-level thinking skills beyond what is normally required in the regular classroom. Gifted/talented education does not take the place of the regular classroom but supplements and provides time for students to use their thinking and reasoning skills to a greater degree."

Identification of gifted/talented students is very complex and comprehensive, consisting of two distinct steps: (1) nomination and screening and (2) selection. In the nomination and screening phase, a student may be nominated for the program by his/her

parent or guardian, by a teacher, by another person, or by scoring very high on a standardized achievement test. Once a student has been nominated, he/she will be given two nationally-developed tests of higher-level thinking skills to determine the student's potential to succeed in the program, and after all data has been collected on each child, a committee of professional educators will review this information and determine which additional students qualify for inclusion in the program.

"Anyone with a child attending grades kindergarten through 11 this year and wishing to nominate them for this program is asked to go by the principal's office and request a nomination form, which needs to be returned to the school by Friday, May 1. If you are unable to go by the school, please call, and we will see that you get one," Cotton said. Students who did not make the gifted/talented program last year may be nominated again if parents wish to do so.

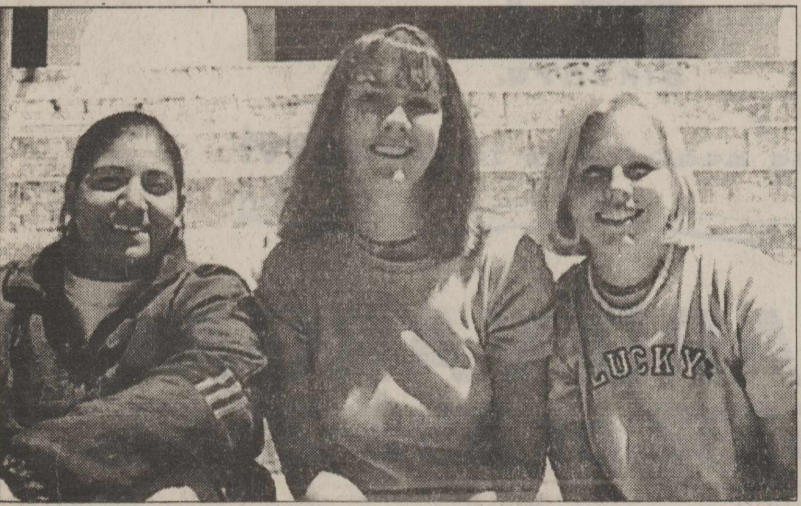

The purpose of the field day was to increase the awareness of our natural resources and educate the students to the need for proper management to sustain and improve these resources. Topics consisting of soils, water, range and wildlife were presented by professionals with the Natural Resources Conservation Service and Texas Parks and Wildlife Department.

Ivan and Janet Weir entertained the group with a sheep dog demonstration. They showed how these dogs are used to assist ranchers in their everyday ranching operations. The dogs, which are from Weir-Perry Kennels and trained by Ivan, put on a

show that all enjoyed.

Following this presentation, the students were treated to a hamburger lunch provided by the Crockett County National Bank. The meal was prepared and cooked by John L. Henderson, Susan Buchanan, Jim Skehan, Robin McNeely and Larry Williams.

Miles Dabovich, County Extension Agent, gave the students a presentation on sheep and goat production in Crockett County. Dennis Clark, manager of Emerald Underground Water Conservation District, talked about water monitoring and conservation.

A trip to Wool Growers Central Storage Co. capped off the day. Donnie Laughlin and Mike Edinburg explained to the students the processing of wool and mohair.

The Crockett Soil and Water Conservation District would like to thank the Ozona school officials for their continued support and all of the individuals who helped make the day a huge success.

## 1997 wool production up, mohair down

**AUSTIN** - Higher wool prices and more sheep and lambs shorn than a year ago led to an increase in wool production for 1997. Mohair production continued to decline in spite of slightly higher prices in 1997.

According to the annual report released by the Texas Agricultural Statistics Service, wool production totaled 10.95 million pounds during 1997, 11 percent above the previous year's total. This is the first year-to-year increase since 1992. Texas producers sheared 1.50 million sheep and

lambs during the year, 14 percent more than during 1996. The average fleece weight was 7.3 pounds compared with 7.5 pounds last year.

Total value of the state's wool production increased 40 percent from the previous year to \$11.61 million. Price per pound averaged \$1.06, up \$0.22 from the average for 1996.

Texas mohair production during 1997 totaled 6.38 million pounds, down 15 percent from a year ago and the least since 1918. Producers clipped 840,000 Angora goats and kids with an average clip weight of 7.6 pounds. The number of Angora goats and kids clipped declined 21 percent from the previous year, but the average clip weight was up 9 percent from 1996.

Value of the state's mohair production declined slightly to \$14.56 million. Price per pound averaged \$2.28, compared with the \$1.95 average a year earlier.

United States shorn wool production during 1997 was 53.9 million pounds, down 5 percent from a year earlier. Sheep and lambs shorn during 1997 totaled 7.03 million head, a decrease of 3 percent from 1996. Average fleece weight of shorn wool was 7.66 pounds per head in 1997 compared with 7.79 pounds in 1996.

The average price paid for wool sold in 1997 was \$0.84 per pound, for a total value of \$45.2 million, up 14 percent from \$39.7 million in 1996.

Mohair production in the four major producing states, Arizona, New Mexico, Oklahoma and Texas, during 1997 was 6.93 million pounds, down 14 percent from 1996. Goats and kids clipped, at 953,000 head, were 20 percent below 1996. Average weight per clip was 7.3 pounds, compared with 6.7 pounds a year earlier. Value of mohair production was \$15.6 million, up slightly from 1996.

## 4-H'ers participate in judging contests

On Saturday, April 18, Crockett County 4-H members participated in the wool and mohair judging contests and the range judging contest in Kerrville.

In the wool and mohair judging contests, the junior team of Allison Skehan, Victoria Miller and Grant Hodges placed first in mohair judging and second in wool judging to tie for first place overall. The tie was broken on the rail with Crockett County's junior team winning first high overall.

Allison Skehan placed as second

high individual in mohair judging, third high individual in wool judging and second high individual overall.

Participating on the senior team were: Dustin Shaffer, Bryan Skehan, Ashlee Worley and Katie Parker.

In the range judging contest, the Crockett County Junior Team placed second high overall. Junior team members were: Andrew Shaffer, Bryan Skehan and Allison Skehan. Jed Roane also participated as a senior individual.

## Weekly Drilling and Completion Report

Crockett County's Davidson Ranch Field gained a new producer when the No. 13 Perry GU "21" was completed nine and a half miles southwest of Ozona. Union Pacific Resources Corp. is the operator.

The developmental well flowed 1,038,000-CFD on a 1.25-in. choke and was rated at 1,487,000-CFD on absolute open flow. It was taken to an 8,400-ft. bottom with plugback to 8,243. The well will produce from 7,824 to 8,026 feet into the hole.

The same Fort Worth-based operator has filled for permit to drill a couple of developmental wells in Crockett County's Ozona Field. Designated the No. 14 Hoover "44" and No. 12 Hoover "49", the ventures are located 25.8 and 26.8 miles southwest of Ozona, respectively.

Location for the No. 14 well is a 640-acre lease in the T&STI Survey A-5394. The No. 12 is in a 784-acre lease in the T&STI Survey A-4194. The ventures are under permit for 8,000 feet of hole making.

Union Pacific gave up on its efforts to make a producer out of the No. 74 Couch "D", 10.6 miles southwest of Ozona in Crockett County's Southwest Ozona Field. Spudded on September 17, it probed to 1,961 feet total depth with no commercial prospects. Location was in the W. Brewer Survey A-4703.

Union Oil of California has posted first production figures for the No. 8 Wayne West Ranch "A", 29 miles south of Ozona in Crockett County's Massie Field. The new gasser flowed 1,377,000-CFD on a 1.25-in. choke and earned a 2,800,000-CFD evaluation on absolute open flow. Bottomed at 11,400 feet, it will produce from 11,025 to 11,392 feet into the hole.

Pioneer National Resources Co. of Midland has filed for permit to drill a couple of new pool wildcats near Crockett County's Ozona Field. 18.8 miles southwest of Ozona. They have been designated the No. 3 Robertson 5B and the No. 2 Robertson 5A.

Location is a 160-acre lease. The No. 3 well is in the TCRR Survey A-3924 while the No. 2 well is in the TCRR Survey A-3924. They are under authority for 6,900 feet of hole making.

Midland-based Sonat Exploration Co. has staked location for the No. 5 Baggett 11, about 11 miles southeast of Ozona in Crockett County's Baggett Field. Drillsite is a 640-acre lease in the GC&SF Survey A-2364. Canyon Formation will be the target at a depth of approximately 9,600 feet.
