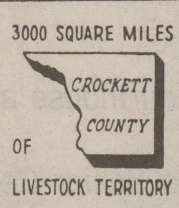

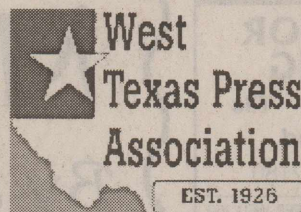

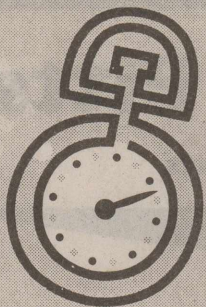

Ozona teams advance to Nov. 4 Regional Meet in Lubbock

Side by side, Roman Tambunga and Levi English ran through the hilly terrain of the Ozona Golf Course.

The two seniors, competing

in what would be their final district meet, waited until the last turn before breaking loose and turning their friendly run into a competitive race.

Tambunga and English led the Ozona Lions to the District 7-AA Championship Monday.

Tambunga would win the meet at 17 minutes, 38.6 seconds followed by English at 17:39.5.

"I relaxed and opened up my stride," Tambunga said.

"It felt awesome to run with him (Tambunga)," added English. "We both ran faster than if

we had run by ourselves."

Both Tambunga and English said the team will have to step up to do well at the Nov. 4 Regional Meet in Lubbock.

Sutton County jury sentences man to 60 years in prison

A Sutton County jury sentenced a man to 60 years in prison on Oct. 18 after a three-day trial.

Alfredo Murillo Chavez, also known as Freddy Chavez, was found guilty by the same jury, of seven men and five women, on Oct. 17 for burglary of a habitation committed in February 2006 at the Balch home on Edgemont Road in Sonora, according to a press release from the 112th District Attorney's office.

Burglary of a habitation is a second-degree felony with a punishment range of 2-20 years and a potential fine not to exceed \$10,000.

Because of the prior conviction, Chavez's punishment range was enhanced to a first-degree felony which carries a

SWEET REVENGE

Lions dominate Crane for win

CRANE - The Ozona Lions remembered losing to Crane in the first round of the 2005 playoffs as if it were yesterday.

As Friday's game unfolded, Crane apparently forgot what they needed to do to defeat the Lions again.

In what was hyped as the biggest game in District 7-AA, the Ozona Lions took control and defeated the Golden Cranes 32-6 in Crane.

"The defense had their best game of the year," said Coach Benny Granger.

Bad snaps followed the Cranes all night and the Lions defense took advantage of it picking up two safeties. The first came in the second quarter and the second came in the third quarter right after the Lions had scored their fourth and final touchdown.

The Lions defense held

Crane to only two first downs and 49 yards in total offense.

"That is very impressive," Granger said. "It covered up for the slow start that we had on offense. I think we may have been uptight at the beginning offensively, due to the fact that we were playing Crane. We had a few penalties and some dropped passes that killed our drives. Once we got rolling, things were

fine. The defense definitely carried us through."

Ozona would get their onslaught rolling in the second quarter, when Caleb Mitchel finally broke through running the ball 27 yards to Crane's 12-yard line. Mitchel would rush 12 times for 85 yards, and would catch one interception.

Board discusses security of middle school entrance

Safety on several levels was discussed during the Oct. 18 monthly meeting of the Crockett County CCSD Board of Trustees.

Superintendent Abe Gott said that members from the Region XV Educational Service Center recently conducted a safety audit on each campus.

While the results of the audit will take some time, Gott said an immediate step that needed to be taken was making visitors at the middle school more visible when they walk through front door.

One suggestion was to move the left side trophy case and construct an office out of the classroom behind it for the secretary, Sylvia Lara, which is near the front door, Gott said.

Middle School Principal Doug Guynes will then move into Lara's old office giving him more visibility into that hallway.

In order to construct this, a sixth grade teacher will have to

move and the sixth grade students would have to cross into the eighth grade hallway to get to the classroom.

Board member Dwight Childress said he was concerned about the sixth graders changing classes into the eighth grade hallway.

"I think we should separate the sixth grade wing. That school was built that way for a purpose," Childress said. "I think we should look at it."

Childress said he has received a lot of parental complaints and has referred those making the complaints to Guynes. Guynes said he has not received any complaints.

Guynes said teachers are in the hallway during class changes and security cameras are in the hallways. There are no other vacant rooms in the sixth grade hall.

"I've come up with a lot of different ideas, but none of them were feasible," Guynes said.

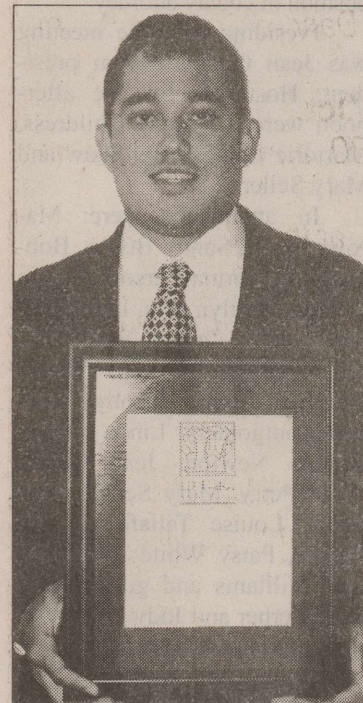

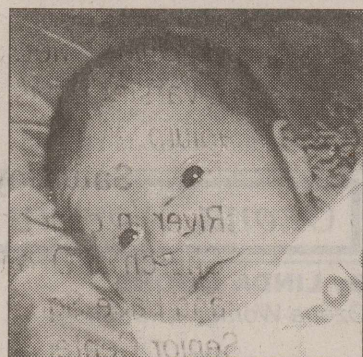
Galvan receives scholarship at A&M

Attention then turned to the finalization of projects. Work was done to prepare favors for the District VII Garden Club Convention to be held Nov. 10

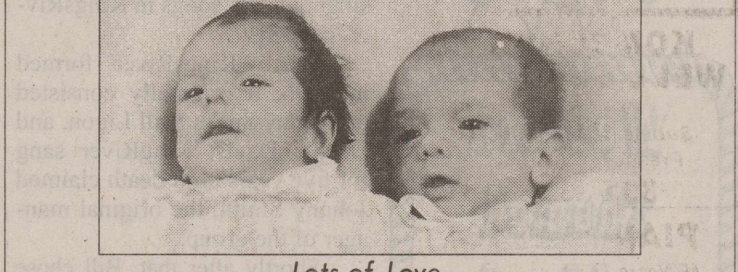

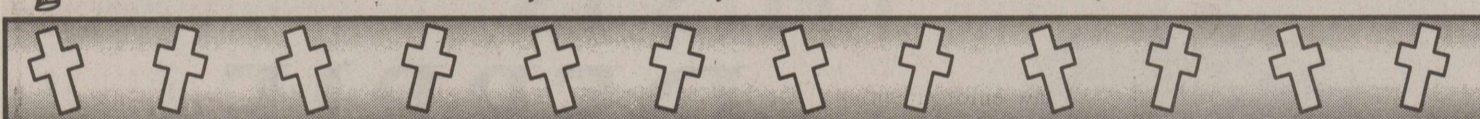

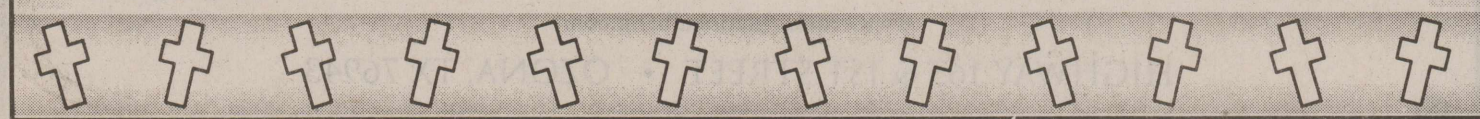

MUSEUM ARTIST PROFILE: MARY JO MASON

When entering the Wool and Mohair Room at the Crockett County Museum, it is hard to miss the colorful and scenic mural that covers the right wall above a wooden fence.

While Ozona artist Mary Jo Mason can't pinpoint exactly how long it took her to paint the mural of woolly sheep and angora goats on a West Texas landscape, she can remember having to redo the blue sky because it was first too dark.

"I had to start over," she said. "It's difficult to work on something this big."

Mason has been painting in both oils and watercolor since 1957 when she took an art course at the University of North Texas.

After receiving her bachelor's degree from the University of Texas at Austin in 1964, she waited seven years, when her son started first grade, to seriously begin studying art.

Some of the artists she has studied with include Wanda Johnson and Bud Biggs in Richardson. She has also studied with numerous artists and recently painted with a group at Cathy Lubke's studio in San

Angelo for seven years.

"I believe it is always best to paint what you know and what has meaning to you as an individual. Having grown up on a ranch in Crockett County, I enjoy painting the surroundings of West Texas," she said. "I believe in capturing the essence, the heart and soul of the subject matter that I choose to paint."

Mason's work is currently being shown at the J. Walker Gallery in San Angelo.

She also has shown her work at the Glass Door Gallery in

Richardson and at the Sonora Art Com Art Gallery in Sonora.

The most recent juried shows she has been in are the Southwest Watercolor Society, American Plains Artist Association and the San Angelo Art Club.

Her work also hangs in the offices and homes throughout Texas, as well as the Crockett County Museum.

"The excitement of paint mixing on paper and the incredible results never fails to inspire and delight," she said.

On the right side of the front entrance is a computer lab that is used by teachers for when they want students to do research or special assignments.

Technology Director Coty Tidwell said that in order to move the computer lab to the left side and then turn the lab into an office, the rough estimate cost would be around \$5,000 due to the moving of cable, electrical wiring and other equipment.

"We looked at a lot of different things," Gott said. "The best situation is to get someone up front and get the front door watched."

Gott said that there is a possibility with the "No Child Left Behind" bill that school districts may have to employ a police officer.

If so, then the new office in the middle school would have room to house an officer, Gott said.

Gott also said that deputies from the Crockett County Sheriff's Department have been making random patrols through each campus.

The board also looked at a presentation from Pfluger and Associates Architects about the possibility of getting a bond together for school improvements.

Kent Niemann, principal in charge of Pfluger and Associates, said that even in the newest middle schools, sixth, seventh and eighth grade students mix at one time or another throughout the day.

"The fact is all of the schools, at some time or another, they mix," he said. "As much as you would like to design to keep that mixing from happening, it's almost impossible to keep those kids from talking to one another."

Niemann and his partner John Williams looked at the en-

tranceway of the middle school and suggested building a counter, moving Lara out into the hallway between the office and library and install glass front doors.

Gott said they would have to get the fire marshal's approval since there would be a slight decrease in the hallway.

"That seems cheaper all the way around," Childress said.

During his presentation, Niemann said his company would conduct a feasibility study, which looks at each campus and reports what renovations and repairs would be feasible for the school district in their bond.

Niemann said it's also important to really get community members involved in the writing of the bond, along with having the school faculty, staff and students fill out surveys.

"You're the biggest business in town. What you (the school board) need to do is at least listen to all the people that are in your business," Niemann said. "You need to listen to the committee's recommendations. The district has to commit to sell this bond. If you haven't listened to the staff, the bond won't pass."

Niemann also said that the bond should address all the schools needs and prioritize them.

"When you go out and have a building assessment and go for a bond, lose trust public if you ignore obvious problems and if you don't have a picture of all the problems. You want to equally look at everything," he said.

Gott said it was important to have the feasibility study done before the bond committee meets in order to present this study to the community members.

"He'll (Niemann) give us an

assessment of the whole district. You really need several things for the committee to look at. It's a choice," Gott said.

Some of the board members said that getting the committee together was needed before hiring the architect for the feasibility study.

"We're trying to keep them (the committee) kind of focused and not having too much for them to digest because then you have the problem of them not wanting to do anything," Childress said.

Board Vice President Laurie Hale said it was important to do the study as the first step of their process.

"We need to get them to do this assessment so we all have something to look at and it's there when we start," she said.

The board then unanimously approved a motion to authorize the superintendent to go into contractual negotiations with Pfluger and Associates to do a facility needs study. The board will have to approve the final contract before the study is conducted.

The board then each voted on 14 names out of 24 possibilities for the bond committee. Gott said he would contact those who received the most votes and ask them if they would like to serve on the committee.

The board approved in a 4-3 vote to accept bids for the sale of school owned property (vacant lot) located in Lima Addition, Lot B1 Book 1, Monterey Street. Board members Jana Wilson, Carol Buie and Veronica Fierro voted against the motion.

The next scheduled regular board meeting will be at 6:30 p.m. Nov. 15 at the Administration Building on 797 Avenue D.

punishment range of 5-99 years or life and a potential fine not to exceed \$10,000, the release stated.

"Quick action by law enforcement officers led to the arrest of Chavez and a co-defendant within the hours of the crime. Additionally, officers recovered most of the stolen property on the same day," said District Attorney Laurie English, who prosecuted the case along with Steve Smith, assistant district attorney.

"This case is the best example I've seen of cooperation between local law enforcement agencies. From investigation through trial the Sonora Police Department, Sutton County Sheriff's Office, Sonora DPS Troopers and the local game warden worked together to solve the crime and then assisted the prosecution during trial to achieve this verdict."

Chavez was represented by Orlando De Hoyos and Thomas Williams.

Judge Royal Hart presided over the trial.

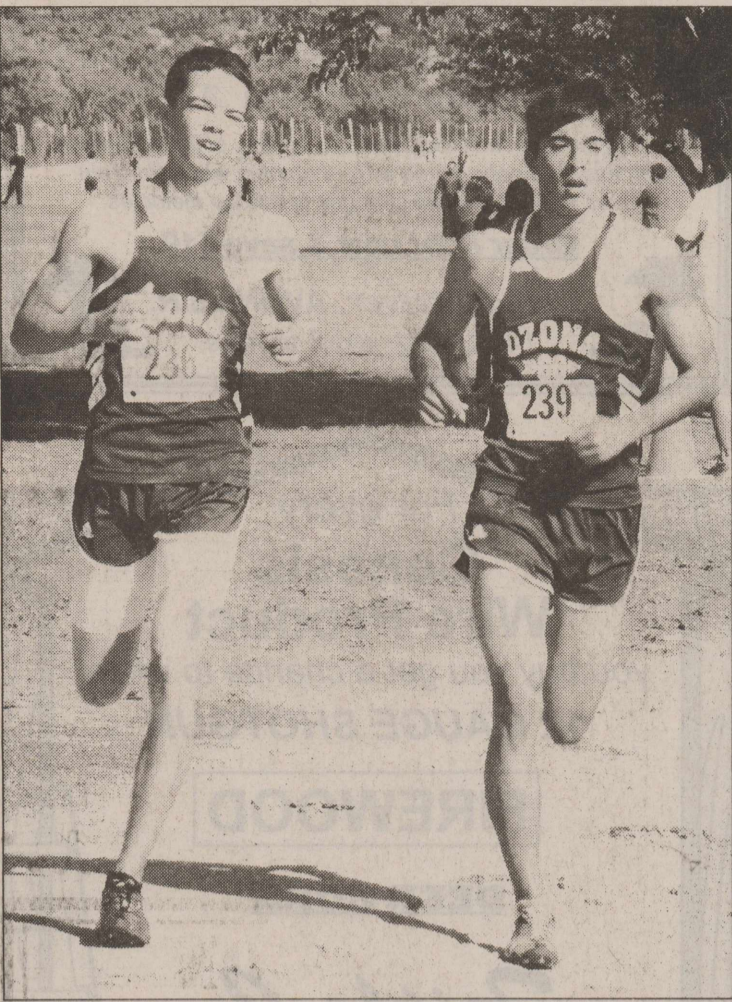

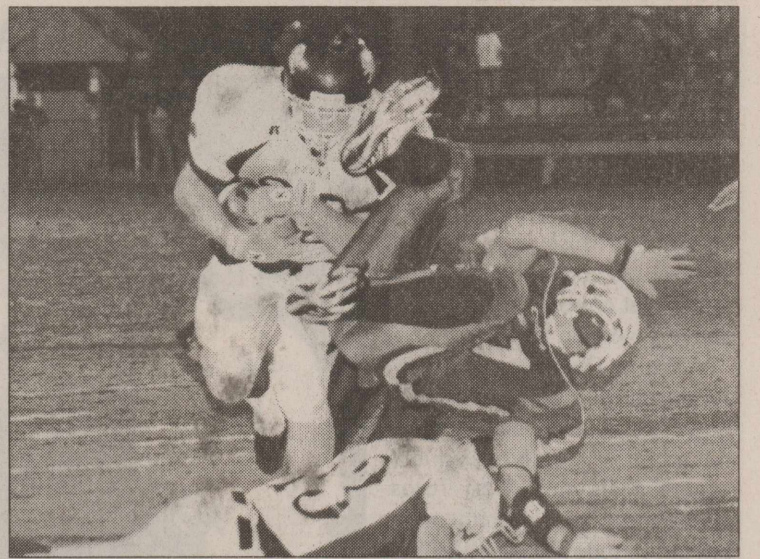

Candidates vie to grab your attention, your vote



AUSTIN — Little time separate today from election day (Tuesday, Nov. 7), so it wouldn't hurt to dig out that voter registration card and keep it where it's easy to find.

Many Texans, already settled on their favorite candidates, will choose to vote early. Dates for early voting: Oct. 23 to Nov. 3.

No newspaper is required to come out in favor of a candidate or slate of candidates, but some do. Like early voters, big city newspaper editorial boards have made up their collective minds and published endorsements.

The Dallas Morning News, the Austin American-Statesman and the San Antonio Express-News gave their nods to incumbent Republican Gov. Rick Perry.

The Houston Chronicle, Fort Worth Star-Telegram and Corpus Christi Caller-Times ran editorials standing with Houston Democrat Chris Bell.

Bell, Perry and independent candidate State Comptroller Carole Keeton Strayhorn all spoke to the NAACP in hopes of picking up more votes, from important constituencies. There was no such opportunity for entertainer Kinky Friedman of Medina, because of his documented use of the "h-word" in satiric or comedic routines.

Worth mentioning, Bell did something new in hopes of pointing the minds of more voters in his direction. In stump speeches and media appearances Bell suggested he is running against three Republicans, meaning Perry, Strayhorn and Friedman.

Strayhorn registered as an independent to get a spot on the ballot because the Republican convention predictably gave its blessing to the sitting governor.

Traditional party labels don't stick to independent Friedman, but his friendliness toward President and Mrs. George W. Bush give him a GOP-tinged aura.

Ad blitz hits as election nears

A new wave of campaign commercials lurched into living rooms in mid-October and will keep coming until election day or until the money runs out, whichever comes first.

Perry ads appeal to his base,

focusing on border security, jobs, power plants and his "trans-Texas" toll-road plan. Strayhorn's ads promise more pay for teachers, a real tax cut for property owners and better education for children. Bell's ads buoy Democrats and welcome disaffected voters to vote for him, calling for stronger fiscal responsibility and stressing the need for health and education improvements.

The way these commercials are stacked, it appears the heavily funded Perry, Bell and Strayhorn are engaged in a three-way donnybrook, and no one else is on the ballot.

But Friedman is out there, using his Web site and personal appearances to counter opponents' assertions that his plans for Texas are not as articulated and therefore don't carry as much weight as theirs.

Friedman laid out the planks of his platform, giving details of a state energy plan and most recently rolling out TexasCare, his plan to deliver health care to all Texans.

Governor must work with others

Of course, whoever ends up as governor will be, as Perry well knows, the chief executive of a "weak-governor state."

It's the lieutenant governor, who presides over the Senate, and the speaker of the House, who are the gatekeepers. Through them all legislative bills, the vehicles of change or status quo, must pass.

Lt. Gov. David Dewhurst and House Speaker Tom Craddick of Midland, both Republicans, possess the power to make or break the best ideas of reformers. The two are up for re-election and expected to continue in their capacities for another term. Dewhurst is on the statewide ballot and faces challengers Democrat Maria Luisa Alvarado, an Austin research analyst, and Libertarian Judy Baker of Houston. Craddick is running unopposed in his district.

But as speaker, he is subject to challenge. Every regular session of the Legislature, one state representative is elected speaker of the House by his or her peers.

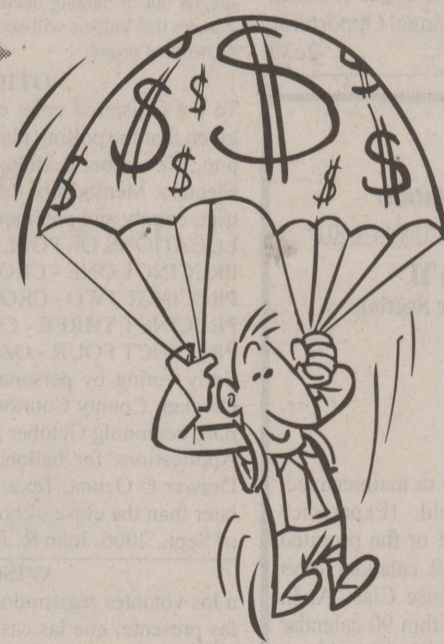
