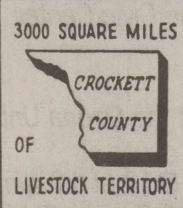

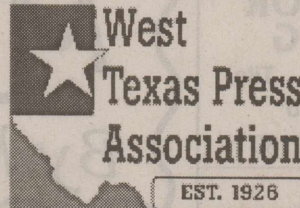

## Committee votes to build a new Ozona Primary School

In a majority vote, the School Facilities Committee decided to build a new primary school on the existing primary school site during a June 7 meeting.

The vote was 16-1 with Sally Roane voting the opposition.

"I do not think (the primary school) is a good site. It's not as secure as the intermediate school," Roane said. "I don't think a new school will get done in 18 months, and these are our most vulnerable kids that will be spread out all over town."

The new school would house pre-k through fifth grades, and would abandon the intermediate school.

Dan Pullen said even though adding classrooms to the intermediate school, to make it pre-k through fifth, would be more cost effective, the addition would be a "terribly crowded situation."

Frank Tambunga said the

primary school site is a bigger area to put more students.

Superintendent Abe Gott presented figures that he gathered from other school superintendents and architect firms.

In his data, an estimated figure of 40,000 square-feet was determined as the size of school the district would need for a new primary school. This amount did not include a new gym but included keeping the existing first grade classroom wing.

With an estimated \$130 per square-foot, the total cost is estimated at \$5.2 million. With the \$250,000 estimated for new windows in the Heritage Building, and \$300,000 for two new buses, the total cost for the district was estimated at around \$5.7 million.

Gott said the cost to demolish the existing primary school is estimated around \$450,000. The majority of the committee felt comfortable with peaking at \$7 million but no higher.

The board of trustees will now take the committee's recommendation and gather information from architects to get an exact figure. The latest the board can call for a bond for the November election is the first week of September.

Board President Dr. Marcus Sims said that committee members will still be involved on hearing the information.

"I know it's the public's money and we're not trying to waste it," Sims said.

Before the vote took place, Laurie Hale, board vice president, said that she was uncomfortable making a decision without hearing information on which site is the best. Hale said she wanted architects or engineers to look at both sites.

"I could make a better decision if I knew either place is great. Then I could go with what I feel," Hale said.

Wade Richardson said that the committee needs to figure

out a decision and put it out there for the board.

"We're sitting here trying to play architect. We're sitting here trying to see how small we can make it. We have to involve the architects in this," he said.

Tambunga said that school facilities have been at both sites a long time.

"We already know what works," he said. "We need to make a decision tonight and go on."

Sims and Gott said that the architects or engineers would present the pros and cons of each site, and that they would not tell the committee anything definite.

"I'm not going to learn anymore to change my mind," said Fred Van Shoubrouek.

Sandy Stokes said he commended the committee for coming together and working on this issue. He said he was amazed to see how many people cared about the education of the community.

"Right or wrong, at least we've tried," Stokes said.

## Skateboard park construction set to begin

Construction of the skateboard park is in the works.

The Crockett County Commissioners' Court approved a plan during their Monday meeting to get the park up and running.

The plan involves ramps and a pipe to be built at the old south swimming pool that is located by the Ozona Primary School.

A 6-foot chain-link fence will be built to keep skaters out of the deep end of the pool. Cost for the project will be around \$10,000.

"We've been messing with this for over five months now. It's time we start doing something with it," said County Judge Fred Deaton.

County Road Superintendent Eddie Moore said a set of steps would be left in case of injuries and people needing to walk down into the pool area.

## 'Riding the Orphan Train'

The townspeople would check their arms for strength, eyes for clarity and then make them open their mouths to look at their teeth.

This exercise in humility didn't always end badly. For the children who rode the orphan train, there were some happy endings.

During their multi-media presentations on Monday, Alison Moore and Phil Lancaster sang and recited the stories of some of the orphans that spent part of their childhood traveling on what was known as the orphan train.

"People were different then," said Hazen Armstrong, one of the survivors on the video documentary presentation. "You couldn't do a thing like that now."

From 1854-1929, more than 250,000 orphans and unwanted children of urban poor New York City were sent out on trains to western America.

Around 1,200 of the children stopped in Texas, with the last train stopping in Sulphur Springs, Texas in 1929.

The story of the orphan train is not one found in the history books, Moore said.

In fact, if it wasn't for the 1995 PBS documentary, most of these stories would have never been told.

"We never heard about this story until one of Alison's former students asked her about it," Lancaster said. "When we saw the PBS documentary, we never thought we would be in Ozona, Texas doing a program."

Lancaster and Moore have visited orphan train reunions and reenactments to gain research for their program.

The duo performed songs as pictures of some of the orphans, and the time period they lived in, scrolled across the screen.

Excerpts of survivors from the PBS documentary were shown, and Moore recited a short fictional story that she is currently working to make into a novel about the experience of the orphan train.

"These were the first foster children of our country," Moore said. "Fortunately, they were

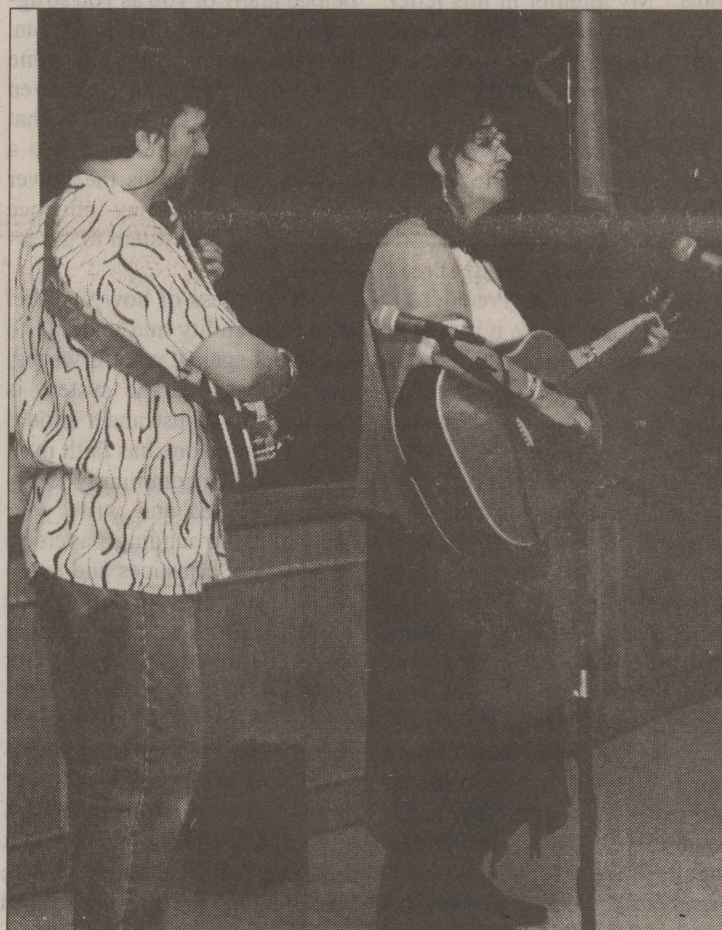

of the generation of if life gives you lemons, make lemonade. Some will admit they were very frightened."

In the late 1800s to the early 20th Century, a boom of European immigrants flooded New York City causing overcrowding.

Some buildings had around 10 people living in one room, Moore said. This was a time without government help.

It was also not uncommon to see three-year-olds working in match factories to help support their families, Moore said. "Some parents surrendered their children due to the poverty-stricken environment," Lancaster said.

Through private donations, the orphan train was started. The children were sent out west to help people on the farms.

In the land rush of Oklahoma, the more children a family had the more land they could get, Moore said.

When the trains would pull into a town, the children were lined up on a platform or a stage in a local meeting hall. The children were encouraged to perform

or sing to the prospective takers.

They were also poked and prodded as adults looked for good workers for farms or local businesses.

Children that were not chosen were loaded back onto the train and shuffled to the next town. All they owned was a suitcase with a change of clothes and possibly a Bible.

Brothers and sisters were often split up. Lancaster and Moore said many of the children spent their adult lives searching for their lost siblings.

Many also went back to New York to find birth certificates and records, which was difficult since the state of New York still has closed adoption records.

"Many of these children were not adopted. They were simply just taken on to the farms to be workers," Lancaster said. "We realize some of the situations didn't work out, but when it did it was wonderful."

Citizens of Crockett County got a glimpse of a future regional plan for housing in rural communities during a special meeting last week.

Members of the Regional Consortium for Economic Development and Business Support hosted the meeting and presented a housing model plan. The consortium covers 12 counties in the Concho Valley, including Crockett County.

The plan provided information from on how members of rural communities can come together and find resources to create affordable housing.

Citizens in Brady are currently working on this issue and have new housing being built. The housing is modular up to 1,200 square-feet, but is affordable in the \$60,000 to \$90,000 price range, said Wendy Ellis, vice president for the consortium.

working with people in Big Lake to get a local housing project started.

"The money is out there. You just have to work together. Don't automatically think you can't do it because you don't have the money," said Debbie Rockwell with the Big Lake Chamber of Commerce.

Ellis said the housing plan, which is currently under review, is part of a package the consortium hopes to put together for rural communities by the end of August.

The plan is a set of guidelines and resource materials to help communities jump start into home building projects, Ellis said.

Ellis also said the plan will match communities with similar needs.

Instead of buying land, one option was vacant lots or redeveloping land that has abandoned houses, Ellis said.

Ellis also said that citizens can check the appraisal and tax office for people who owe back taxes on property.

### Commissioner targeted, harassed

To the Citizens of Crockett County:

Many of you aren't aware of the "actual" events surrounding the arrest of my family members, particularly my father, Alfredo Tobar. My attempt in this letter is to inform you of how he and my family are being harassed for his interest in the county and its residents.

Let it be known that the latest article in published in the Ozona Stockman failed to mention that my father was questioning the chemicals being spread in his own precinct (Precinct 4). With terrorism today, it is important and a civil responsibility for all citizens to question what is being sprayed near your home, schools, and fields. The workers he approached at Precinct 4 did not know English and were unaware of what licenses they should carry in order to legally spray the chemicals. When asked if they had a license, they showed their Social Security cards because they were clueless of what was required to spray chemicals. Since he has been elected into a county position, he is considered and certified as an official to the county. He drove up in his personally owned vehicle, with his granddaughter, and present his commissioners' certification card - not a law enforcement badge.

I ask one question to the community -- How is it that one man and his family are constantly being targeted, harassed, and under extreme scrutiny? Anyone who knows my father knows that although outspoken, he is an honest man and would do anything to fight injustice regardless of who's affected. I would go as far as to say that he's probably helped many of you as you struggle with the injustice in Ozona. In 50 years this is the first time in his life that he's ever even been arrested. The irony is that it took him being elected into a position which holds the power to question or has any influence in changing the system to get arrested.

Regardless of how you feel about his ability and courage to speak out against what is wrong, it's obvious that the system is corrupt and unjust and I should expect that no one has faith in it.

I urge the community to become involved and write your local and surrounding papers to express any injustices and experiences you or your family has had with the local law enforcement. It's time to come together and request a thorough investigation of the local law enforcement. Also, before passing judgment and using gossip as your primary source of information on my father's case, remember that he has a family and they too are experiencing the injustice caused by this corruption and false accusations. Before speaking out against him, wait for the truth because it always comes out.

## Huntin' For A Hobby

My Doc said I'm getting to that age where I ought to consider slowing down. "Get a hobby," he said. "Something that will reduce your stress and give you satisfaction."

"I have a hobby," I replied. "I do leatherwork"

"Yes, I've seen your leatherwork. I was thinking of a more productive hobby," the Doc replied. "Something you might be good at and could take pride in."

There goes his hand-tooled leather fanny-pack for Christmas!

In looking for a more productive form of loafing, something to do while I'm not doing anything, I'm considering taking up either fishing or hunting, but it's not an easy decision. Do I want to smell like salmon eggs or deer urine? Do I want to gut a fish or dress a deer? Do I want to have my wife net my catch or have the dog retrieve it? Do I want to eat sushi or roadkill?

Admittedly, there are some similarities in the two hobbies. Both hunters and fishermen are covered in bug spray, get up early to get a head start on their prey, and both spend a fortune in Cabelas catalogs, tags and licenses.

I think I'd be good at either hobby. Anyone who has read my column for any length of time knows I'd be an excellent fisherman because I can exaggerate and tell lies. On the other hand, I'd also be a good hunter because I can cheat real good. The idea of using turkey callers, deer feeders, blinds, spotlights and decoys really appeals to the inner con-man in me. I also think I'd be especially effective at using natural scents to attract, or repel, game. Whatever the case may be.

I could use some exercise and I'd think that hunters are probably in better physical and fiscal shape than fishermen because they have to drag their game long distances. Or pay a guide to do it. I understand that some hunters only hunt from the front seat of their truck and that does sound relaxing, although sitting in a boat drinking beer all day without the chance of getting shot sounds a lot less stressful.

I'm leaning towards becoming a non-fishing fisherman in my retirement years and you'll probably never guess why. I'll give you a hint... surprise, surprise it has to do with my being a tightwad. In glancing through my Cabelas catalog it is obvious that hunters are big on two things: camo and ammo, and both of them seem terribly expensive. Now, I have never been much of a dresser, ask anyone who has ever seen me and they'll confirm that while some people in my position are dressed to the nines, I am mostly dressed to the twos. 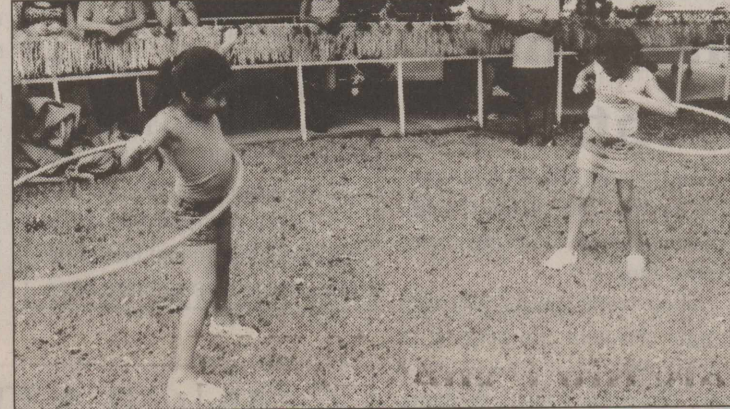
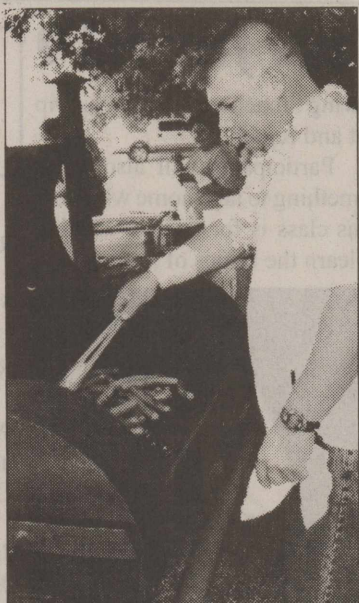

"More than one community is land locked like Ozona," said Shanon Biggerstaff, executive director for the Ozona Chamber of Commerce. "We can show landowners the need is there. All we can do is ask."

Examples of surveys for employers, residents and organizations and agencies were also presented. The consortium asked those who attended to submit pros and cons to the surveys by

July.

Each community would be responsible for getting and receiving the surveys in their respective towns, but the Concho Valley Workforce Development Board in San Angelo would compile the results.

Biggerstaff said the surveys should include questions about commuters and retirees, as well as other people in the community.

"Don't limit yourself to one industry or need in the community. Look beyond that and long-term," she said.

Ellis said the consortium will meet again in October, and will continue to look at tackling the big issues that exist in the region.

"I think we need to go forward with this," said Debbie Long about the housing plan. "This is an extremely big issue."

Also, no extra walls or slops would be added.

"This is a way of getting something open down there and getting starting. If you want to add more we can do that at a later date," Moore said.

The determining factor of when the park will open will be based on when the safety signs come in, Moore said.

The park will be open in daylight hours, with the hours set by the county depending on the time of year.

Signs also state that safety equipment is recommended but not required, and that the park is a "skate-at-your-own-risk" facility.

The park will not be for BMX bikes, but for skateboards and roller blades only.

The signs will also state that this is "an inherently dangerous

sport."

Commissioner Alfredo To-bar said that the bathrooms at the park site should not be reopened due to skaters possibly tearing them up.

"There is a lot of fun to be had with that swimming pool with a good ramp going down in it. I think it will be a good facility," Deaton said. "If someone wants to pick this up and work on it every year, there's room for improvement."

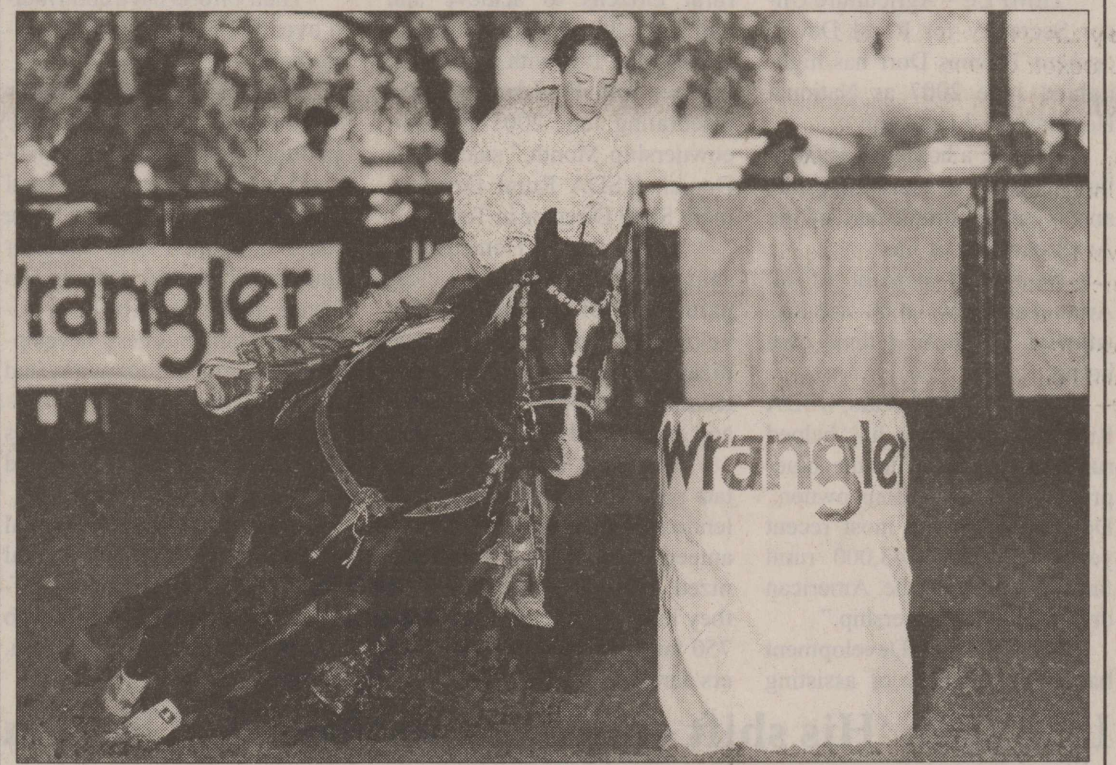

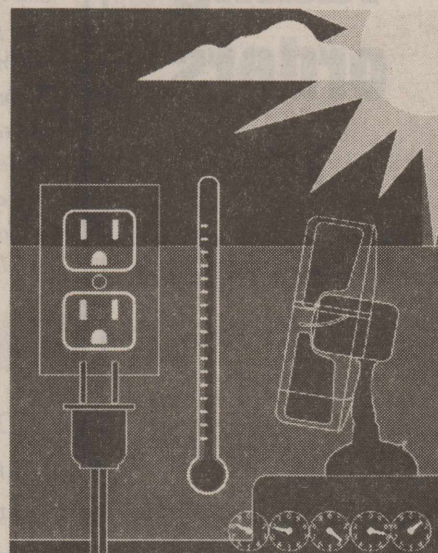

The wool team of Kraig Chandler, Lane White and Laura Stapper was second, with Laura being the third and Kraig being the fifth high individual.

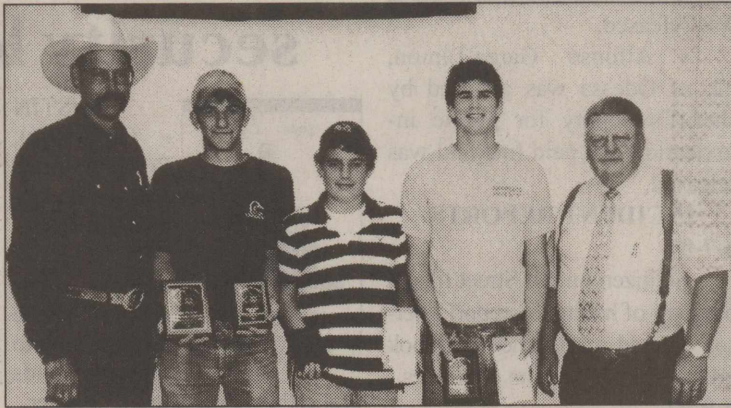
Our coaches, Carlon and Ann Stapper, even bought us all a meal for placing so well.

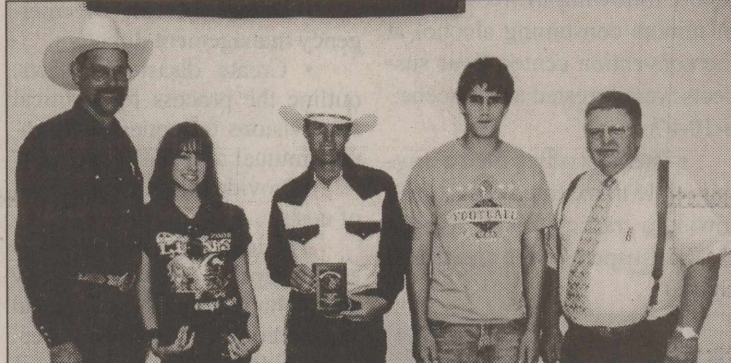
Each night we were there, we went to an assembly and a dance, which were fun.

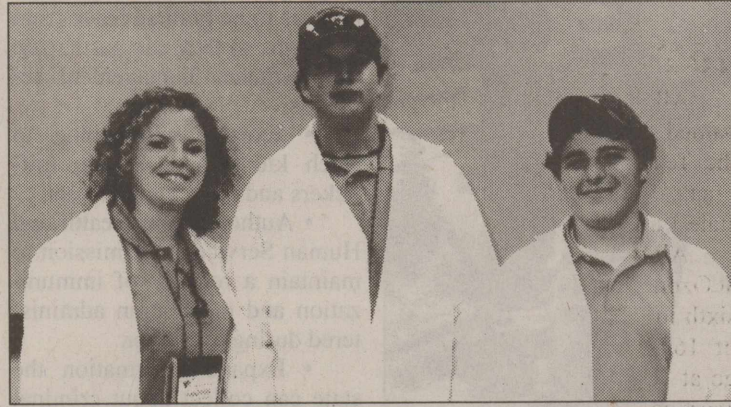
These tasks are not only for the 4-H kids who attended state, but for all 4-H'ers.

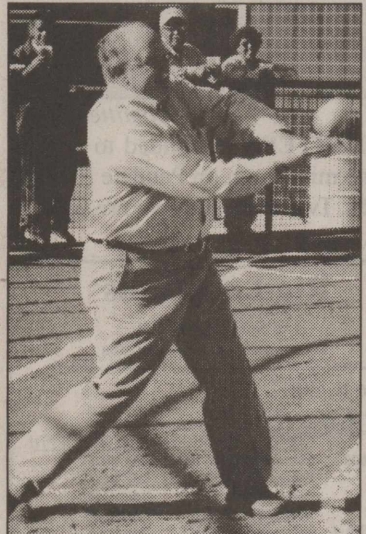

## Governor signs border security legislation

AUSTIN - Gov. Rick Perry signed SB 11 into law on June 6, creating a border security council to advise him on how to allocate funds along the Texas-Mexico border.

Perry will appoint all of the members of the council, and among its many duties, the council is to:

- Define the role of emergency management directors.
- Create disaster districts, outline the process for political subdivisions to request and provide mutual aid assistance.
- Provide for reimbursement of costs.

The legislation, which takes effect Sept. 1, was authored by Sen. John Carona, R-Dallas, and sponsored in the House by Rep. Frank Corte, R-San Antonio. SB 11 also does things such as:

- Allow up to 350 amateur radio operators who are state employees to be granted leave from their jobs so they can participate in emergency management activities.
- Expand wiretapping to catch kidnapers, human traffickers and money launderers.
- Authorize the Health and Human Services Commission to maintain a registry of immunization and medication administered during a disaster.
- Expand information the state can collect about criminal street gangs.

Perry lauded the bill, saying it "removes bureaucratic hurdles between seconds count and lives are in jeopardy."

"If a city has been hit by a wildfire, a chemical spill, a biological threat, or an act of terrorism, bureaucracy should not impede compassion," he said.

### BILL TARGETS FUNERAL DISRUPTERS

Gov. Perry on June 4 signed HB 1093 by Rep. Charlie Geren, R-Fort Worth.

Geren's bill, which took effect as soon as the governor signed it, makes it illegal to disrupt the funeral service of a fallen member of the U.S. military.

The bill increases the distance barrier for individuals picketing from 500 feet to 1,000 feet of a facility or cemetery being used for a funeral service, beginning one hour before the service and ending one hour af-

### SCHOOL FOOD STUDY TO BE DONE

The Texas Department of Agriculture wants to find out what schoolchildren are eating.

Agriculture Commissioner Todd Stapp appointed a committee of 12 people to conduct a study of school breakfast, lunch and afterschool snack programs.

The study, due before the next school term starts, should help to:

- Determine if there are barriers to participation in school meal programs.
- Identify changes in the nutritional policy that would increase student wellness, increase meal participation and decrease obesity.
- Examine availability of processed or prepackaged foods in meal programs and note the trans fat content of those foods.

### GOVERNOR SIGNS SMOG CONTROL BILL

Gov. Perry signed SB 12 into law on June 8, in support of the state's clean air incentive grant programs TERP (Texas Emissions Reduction Plan) and LIRAP (Low-Income Vehicle Repair Assistance, Retrofit, and Accelerated Vehicle Retirement Program).

SB 12 extends TERP to 2013 and raises the cap on amount of grant dollars allowed per ton of nitrogen oxide emission reduction from \$13,000 to \$15,000 per ton.

LIRAP, now tiered to allow vehicles up to two years old to qualify as replacement vehicles, also expands eligible participants to those who earn up to 300 percent of the federal poverty level.

### BILL TO ATTRACT TV, FILM JOBS

Gov. Perry signed HB 1934, the film incentive bill, a \$22 million package to help Texas attract jobs in television and film production.

The bill provides filmmakers with grants equal to 5 percent of what they spend in Texas. To qualify, they must spend at least \$1 million in Texas, shoot at least 80 percent of the project within state borders and hire at least 70 percent of actors, crew and extras in Texas.

The Texas Film Commission reports there were 32 film projects in the last four years that researched Texas for their production location but instead chose other states that offered incentives.

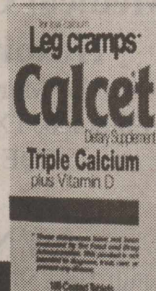

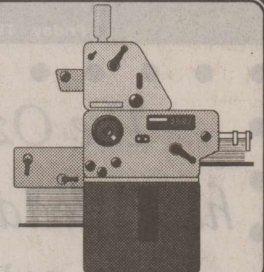
