Ozona honors, helps West

Ozona firefighters and citizens traveled to West, Texas to honor and help.

Blake Morrow, Joe Bradford and James Cassaro, with the Ozona Volunteer Fire Department, attended the memorial service held April 25 at Waco for the 12 West firefighters.

Ozona was one of thousands of emergency responders from across the nation to attend the service, along with President Barack Obama, Gov. Rick Perry, dignitaries from Austin and Washington, D.C. and West residents.

In the hours before the service, a solemn line of fire-trucks passed Baylor University's Ferrell Center. More than a mile long, the trucks and their crews came from small towns and large cities wanting to pay respects.

"This is an honor to do this for the fire department. I just hope, if we were to be in the same situation, people would do the same thing for us," Morrow said.

The explosion at the West Fertilizer Co. on April 17 claimed 15 lives. Those honored in the Ferrell Center were 10 volunteer emergency responders and the two men who helped them battle the blaze. Those two residents were deemed honorary firefighters.

"Today we honored the memories of 12 heroes, and

we will continue to do so tomorrow. I hope the families got to see the overwhelming support from as far as New York City, even Canada. I hope that all the responders and responders' family members realize that they belong to a family that massive," Cassaro said.

Cassaro is the grandson

of Ozona Fire Marshal Steve Kenley and a student at Cornerstone Christian School in San Angelo. Cornerstone Christian's Tennis Team competed in Waco and took donations to West.

"It's truly an honor to be able to represent the Ozona Fire Department and my school here at Waco today,"

said Cassaro. "The service was outstanding. I think the amount of fire personnel really showed how much of a family it is. I think that moved a lot of people, the president and first lady included."

Over the weekend, local residents Annie and Jason

Lady Lions Garcia, Moses headed to State Track Meet

Cynthia Garcia and McKenna Moses are headed to Austin.

The two Lady Lions punched their tickets to the State Track Meet Saturday after competing at the Region I-1A Track Meet in Levelland.

"I was very proud of the way the girls competed. They finished seventh out of all the schools in the region. This is definitely the best we've done in quite a while, and not losing much next year, we should do even better in the future," said Coach Erik Thormaehlen.

Garcia, a senior, placed first in the 400-meter run with a personal best time of 58.58 seconds. Moses, a freshman, was second in the pole vault at 9-feet, 6-inches.

The top two qualifiers in each event advanced to the state meet to be held May 10-11 in Austin.

"McKenna Moses became the first state qualifier since Vanessa Rodriguez in 2008. She did a great job of responding to the pressure and a crowded field. She will go into the state meet ranked

State Senate passes bills helping county roads, online voter registration

Bills that will aid in repairing damaged county roads and allow online voter registration passed the Texas Senate last week.

Both bills are authored by Sen. Carlos Uresti, D-San Antonio.

SB 1747, sent to the House on a vote of 30-1, would create County Energy Transportation Reinvestment Zones and establish criteria for counties to access funds for road maintenance and repair.

"Advancements in drilling technology have generated an unprecedented resurgence in oil and gas production, but it has come with a price," Uresti said. "Simply put, county roads weren't designed to handle the oil boom that Texas is enjoying."

The Texas Department of Transportation estimates that a county road used for

drilling just one oil and gas well will endure the equivalent of 8 million passenger vehicles.

In the Eagle Ford Shale region alone, 5,400 wells have been permitted by the Texas Railroad Commission.

According to a recent study by the University of Texas at San Antonio, a total of 24,000 wells can be expected in the region by 2022.

"It is clear that both short-term and long-term solutions are needed for this problem," Uresti said. "If we allow these roads to continue to deteriorate, we could kill the goose that lays the golden egg. The oil boom cannot be sustained if we don't give counties a

As a child, I was the very best at making fudge. My mother taught me all of this, but it was our neighbor, Mary Campbell who bragged the most. Had my parents been exposed to the ideas that Troy Dunn writes about, I very well could have become a millionaire making and selling fudge.

The second idea that could have made me rich was the use of a

backpack as a book bag. Again, my mother had taught me how to sew. Using that knowledge combined with a need to carry my books while riding my bicycle, I designed and sewed a book pack complete with my initials on it. If my parents had encouraged entrepreneurship, I

might be running my own factory producing Peggy's Packs.

The common thread in each of these examples is the "want." Give your children and grandchildren the "Gift of Want."

Dunn challenges us all to create an opportunity for our children to "figure out a way to pay for what they want." If we exercise restraint in giving them everything, encourage the opportunity to create a business, then we are teaching them to "learn to earn."

Allowance without responsibility attached, teaches children

to depend on us for their income.

Even the youngest child, five and under, can learn to earn. Once, I watched as my daughter stacked dimes on the corner of the kitchen cabinet. Each time she told her son to do a simple chore, she'd check to be sure it was done then the child was able to pick a dime off the stack.

For children ages six to 10 a simple lemonade stand can teach them to learn to earn. Personally, I never pass up a lemonade stand and I never pay more than asking price. Other tasks such as sweeping driveways for neighbors, pick-

ing up the neighbors' papers if they leave town or even taking care of pets can teach children about earning money.

Children from 11 to 14 will most likely have their own ideas for a business. They may create "spirit" items to sell to their school friends, tutor younger children, and learn to fix bicycles or water container plants for a family friend on vacation.

The older group of children age 15 to 18 will be ready to possibly launch a business. They no longer are satisfied with the simpler possibilities they had ear-

ly on in their history of business. They may learn how to copy VHS tapes over the DVDs for a fee.

Other entrepreneurs may create holiday wreaths or baskets or even detail cars.

We all need to be doing what we can to assure that the spirit of business ownership continues to prosper by encouraging children to "learn to earn."

Fortunately, Verizon was able to get the problem fixed by Friday evening, but during the few hours of this problem all three towns realized how dependent our society has become on phone and Internet service.

Emergency 9-1-1 calls had to be rerouted to Mertzson and Sonora. Businesses couldn't use their credit cards machines. Banks couldn't process debit cards or update accounts. Payroll couldn't be processed for some companies. Healthcare companies had to contact their clients with different numbers.

Fortunately, cell phones and those that used other companies besides Verizon were not affected, but the day made us all realize how we rely on technology.

At the Stockman office, I had planned on paying some of our monthly taxes, checking an invoice and placing an order for a customer. No phones, no Internet, none of that could be done.

The national and state government now requires sales tax and federal taxes to be paid online.

All of my other to-do list items, I normally could send a fax but not even fax lines were working.

Don't get me wrong, I love technology. It's great when it works. I love my iPhone connecting me to the world, my computer being able to allow me to visit with friends in another state and picking up the phone to talk to people from all over.

Technology has been going on since humans first formed a blade from a piece of flint, harnessed fire, or dragged a sharp stick across the ground to create a furrow for planting seeds.

It's also good to remember that electricity and water lines run on technology. Think of the people of West, Texas right now. Many of them are wishing technology was restored.

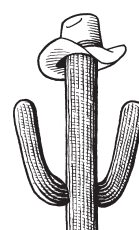

House passes voter assistance bill

AUSTIN — Legislation to amend the state elections law as to how much a person may assist others in voting was passed by the House on April 26.

Committee Substitute House Bill 148, authored by Rep. Cindy Burkett, R-Mesquite, received a final vote of 93-48, but not before lengthy and contentious debate on the House floor a day earlier.

Opponents of the bill, who were rebuffed in multiple attempts to amend the bill, warned that its passage likely would result in a federal court challenge under Section 5 of the U.S. Voting Rights Act of 1965, a part of the law that affects states showing a pattern of discriminatory behavior in election-related practices.

An official state analysis of CSHB 148, in short, asserts: "In certain localities, individuals receive compensation for harvesting mail-in ballots or

for going door to door collecting eligible ballots and posting them on behalf of voters. Such individuals are compensated on a per-ballot basis.

There currently is no limit on the number of times a person may act as a courier for mail-in ballots in a given election, and concerned parties contend that some mail-in ballot harvesters provide unlawful assistance or unlawful witness to voters and may even electioneer in the presence of an active ballot."

The bill would create misdemeanor offense for a person convicted of compensating an individual for assisting 10 or more voters in prohibited ways, and for engaging in other specific and prohibited voting-related actions.

Travis DA sentenced Travis County District Attorney Rosemary Lehmborg was

arrested for drunken driving on April 12 and is serving a 45-day sentence in the Travis County Jail.

Lehmborg's duties include heading the Public Integrity Unit, a statewide office that handles ethics complaints against elected officials.

On March 8, HB 3575 by Rep. Pat Fallon, R-Frisco, was filed, proposing to move the Public Integrity Unit out of Travis County's offices and into the Office of the Attorney General. The bill is scheduled for a House committee hearing on May 1.

TEXAS JOINS EPA CHALLENGE

Texas Attorney General Greg Abbott and attorneys general from 11 other states have filed a petition asking the U.S. Supreme Court to review the Obama Adminis-

tration's enforcement of environmental regulations under the Clean Air Act.

Petitioners claim the U.S. Environmental Protection Agency "ignored Congress' lawmaking role by rewriting federal laws through administrative rulemaking," Abbott's office stated in an April 22 news release.

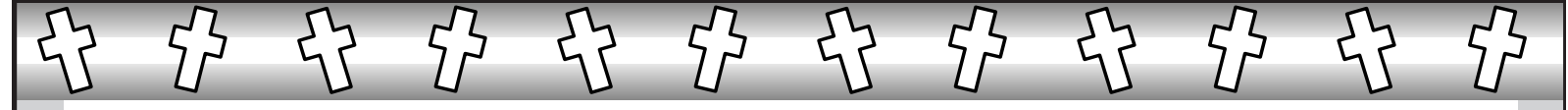

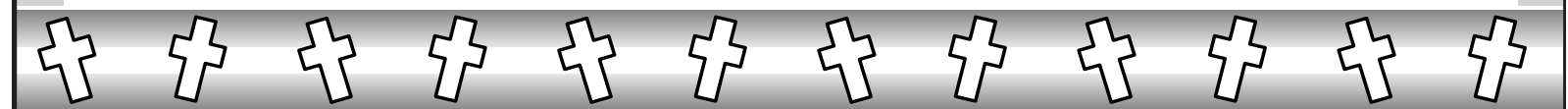

Luna, along with their sons Michael and Skylar, packed their vehicle with donations from Ozona and made the trip to West.

Annie Luna's sister, Traci Horecka lives in the Waco area and knew West Firefighter Kevin Sanders, who was killed in the explosion. Sanders, a big Superman fan, named his newborn son Reeve after actor Christopher Reeve. Reeve was born in January.

Friends and family, including Horecka, wore blue Superman shirts in his memory during the service.

"It was a very humbling experience," Annie Luna said. "It was also so heart-warming to see how many communities have pulled together to help this small town."

The Lunas took baby items, pet supplies, clothing, cleaning supplies and school supplies given by people in Ozona.

The explosion injured more than 200 people. It wreaked havoc on more than 350 homes, dozens of which still aren't safe enough for residents to return to. None of those hundreds of homes have water, and the people elsewhere in town who have water have been told not to drink it.

Annie Luna said they saw houses with large water tanks in the front lawn and signs on them stating "do not drink, toilet water only" and pallets of bottled water also on the lawns.

"Ozona thank you for the donations you so generously gave. We plan to go back soon too," Annie Luna said.

way to maintain these roads."

Under current law, counties are primarily responsible for the repair and maintenance of county roads.

Uresti said energy-producing counties deserve financial help for their roads because the entire state is benefiting from the upsurge in oil and gas production in the Eagle Ford Shale region and the Permian Basin.

SB 1747 would allow counties to create County Energy Transportation Reinvestment Zones — designated areas where county roads have been damaged by oil and gas production activity.

A county could apply for road repair funds based on its number of well completions, the number of weight tolerance permits, and the amount of severance taxes collected.

A county would also have to provide its county roads report for the past two years and contribute a match of up to 10 percent for each repair or maintenance project.

The bill was the result

of numerous meetings with county officials, the oil and gas industry, state transportation officials, and other stakeholders.

Senate Bill 315, sent to the House on a bipartisan vote of 22-9, would add voter registration to the increasing number of government services and functions available online, making it easier for Texans to participate in the political process.

"Voting is a fundamental right and a public duty in our democracy, yet many Texans don't participate in the electoral process," Uresti said. "Online voter registration will encourage more people to participate by making the registration process easier and more convenient."

Under the bill, eligible voters could register online if they possess a valid driver's license or identification card issued by the Department of Public Safety.

For those who do not have such documents, a website would provide a convenient way to register that minimizes typographical and transcription errors by submitting the voter's informa-

tion on a mail-in card.

Uresti said the measure would boost voter rolls, encourage young adults to get involved in the political process, and lead to greater turnout on Election Day.

Currently 12 states offer online paperless voter registration, two others are in the process of implementing laws to do so.

Arizona, the first state to offer online registration in 2002, experienced a 9.5 percent increase in the number of people signing up to vote in just the first two years. More than 70 percent of all voter registrations are now performed online in Arizona, according to the National Conference of State Legislatures.

Online registration also saves money. According to a 2010 report, "Online Voter Registration: Case Studies in Arizona and Washington," each paper registration costs 83 cents, compared to 3 cents for registering online.

"My bill simply acknowledges that we live in the electronic age," Uresti said. "It's time we brought the voter registration process into the 21st Century."

Abbott said the EPA's greenhouse gas regulations "were unlawfully created out of whole cloth and are a massive burden on states and businesses."
TIMOTHY COLE BILL PASSES
 HB 166 by Rep. Ruth Jones McClendon, D-San Antonio, was approved by the House on April 24. The legislation would establish the Timothy Cole Exoneration Review Commission to review and investigate cases in which an innocent person was convicted and then exonerated or released on writ of habeas corpus. The nine-member commission would review practices and procedures leading up to wrongful convictions and seek ways to minimize erroneous outcomes. The commission would not consider sentencing issues such as the death penalty and would not intervene in any pending cases, McClendon said.
 The bill honors the memory of Timothy Cole, a Texan who in 1999 died in prison, having served 13 years of a 25-year rape sentence before the legal system was satisfied that another individual had committed the crime. Cole received a posthumous pardon from Gov. Perry in 2010.

CROCKETT COUNTY PUBLIC NOTICE ORDER RESTRICTING OUTDOOR BURNING

The Commissioners' Court finds that circumstances present in all or part of the unincorporated area of the county create a public safety hazard that would be exacerbated by outdoor burning; and NOW, THEREFORE, IT IS HEREBY ORDERED by the Commissioners' Court of Crockett County, Texas, that outdoor burning is restricted in Crockett County for 30 days from the date of adoption of this Order, unless the restrictions are terminated earlier based on a determination made by the Texas Forest Service or this Court. This Order is adopted pursuant to Local Government Code 352.081, and other applicable statutes. This Order does NOT prohibit outdoor burning activities related to public health and safety that are authorized by the Texas Natural Resources Commission for: (1) firefighter training; (2) public utility, natural gas pipeline or mining operations; (3) planting or harvesting or agricultural crops; or (4) burns that are conducted by an approved Prescribed Burning Association, Natural Resource Conservation Service, the and/or Texas A&M Agricultural Experiment Station, or prescribed burn manager certified under Section 153.048, Natural Resources Code, and meet the standards of Section 153.047, Natural Resources Code.

All burns shall be reported to the Crockett County Sheriff's Office (325) 392-2661 and the Fire Chief (325) 392-2626 prior to commencing, together with the name of the landowner, location involved and expert to be on hand. This Order does NOT prohibit outdoor cooking in a properly contained area which is attended at all times. In accordance with the Local Government Code 352.081 (h), a violation of this Order is a Class C misdemeanor, punishable by a fine not to exceed \$500.
