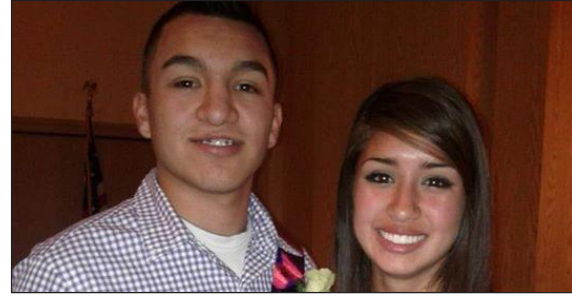

School Board hires new teachers

Superintendent applications narrowed to 13, next meeting Tuesday

After a two and half hour executive/closed session, the CCCSD School Board approved more new hires, contract renewals and resignations during their May 15 regular meeting.

The board unanimously approved one-year contracts as recommended by campus principals for the following position: Tiffany Esparza, technology integration specialist and coach; Eyrin Brook, diagnostician; Krystal Smith, OHS math; Greg Raymond, OHS biology teacher and coach; Mitch Key, OMS seventh grade science teacher and coach; Frankie Skinner, OMS sixth grade math teacher and coach; Vincent Del Vecchio, OMS Band Director; Erica Venegas, OES teacher; Sara Tandy, OES teacher and Briana Clark, OES teacher.

The board also unanimously approved resignations from Tye Moseley,

Kristine Robinson, Autumn Brown and Debra Kinnison, all effective at the end of the 2012-2013 school year.

SUPERINTENDENT SEARCH

Interim Superintendent Larry Taylor said members of the district site-base committee met on May 14 and narrowed down the 22 superintendent applications to 13. The district site-base committee is made up of teachers, administrators, school staff, parents and community members.

The board will hold a called meeting on Tuesday, May 28, to review superintendent candidate applications and develop interview questions. The meeting will be at 6:30 p.m. at the Administration Building.

At called meetings on June 3 and June 4, the school board will conduct the first round of superintendent interviews.

On June 11, the school board will hold another

called meeting and have a second round of interviews with two or three of the candidates. At this meeting, the board will name their Lone Finalist.

The state requires a 21-day waiting period after naming the Lone Finalist.

On July 3, a called board meeting is scheduled to negotiate the new superintendent's contract with the Lone Finalist. The search calendar has the new superintendent in place by July 8.

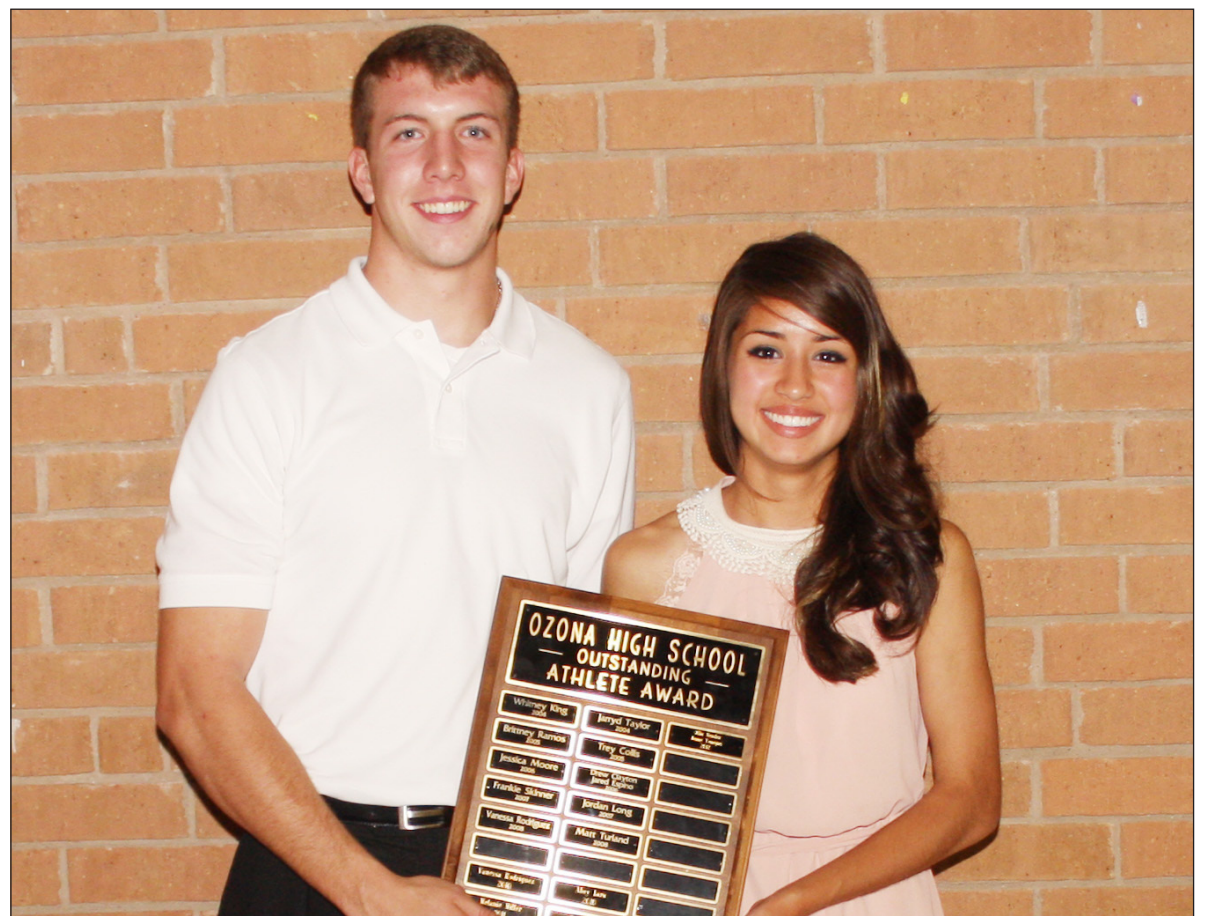

Still time in State Legislative session to help county roads

Now that House and Senate budget writers have tentatively agreed to fund \$2 billion for water projects — a top legislative priority — they must spend the precious little time remaining in the session to address another big ticket item: funding for state and county roads.

The Texas Department of Transportation needs an additional \$4 billion a year just to keep up with current levels of traffic congestion on state roads, and oil boom counties in South and West Texas need money to repair and maintain

battered county roads.

My top priority of the session has been to craft a solution for county roads. Numerous meetings with oil and gas industry representatives, TxDOT, county officials, and other stakeholders

resulted in SB 1747, which will create County Transportation Reinvestment Zones.

By establishing such zones, counties could use increased revenues from county property and sales taxes to repair and maintain roads that are disintegrating under the wheels of heavy oil patch trucks in the Eagle Ford Shale and Permian Basin regions.

Another source of funding would be provided in HB 1025, a supplemental appropriations bill that sets aside \$55 million for energy roads.

If they pass, SB 1747 and HB 1025 would be the only bills that would provide new sources of revenue for county roads, but together they are not enough to address all the counties' needs. The Legislature can do more, and there's still time to get something done.

House Energy Resources Chairman Jim Keffer, the House sponsor of SB 1747, said he is hopeful that \$500 million can be identified for county roads.

It is somewhat ironic that energy roads are being neglected in a legislative session that has

found extra money for water projects, public education, and other crucial programs — thanks in large part to the taxes paid by the energy industry.

James LeBas, a fiscal consultant who also works for the Texas Oil and Gas Association, recently told the Texas Tribune that oil and gas interests paid about \$12 billion in taxes in fiscal 2012, up from \$9.25 billion in 2011 and \$7.4 billion in 2010.

And the end of the boom is not in sight. Railroad Commission Chairman Barry Smitherman said earlier this year that

oil production in Texas could roughly double to 3 million barrels per day by 2020, which he called "OPEC-like numbers."

I've been repeating a simple mantra since the session began: Let's not kill the goose that laid the golden egg. That could happen if the state continues to neglect county roads, which serve as gateways to the oil patch. Fortunately, there is time left in the session to find more money for these roads.

The ever-changing memorial

Washington, D.C., is a city of memorials - impressive testaments to the men and women who have sacrificed for and shaped our country. Most of these monuments are complete. The National Law Enforcement Officers Memorial is unique - it is the only memorial in Washington, D.C. that will never be finished.

Unlike memorials created to honor other brave Americans who lost their lives serving their country, new names of fallen officers killed in the line of duty are added to the Law Enforcement Officers Memorial each year. During National Police Week, the colleagues, friends and families of these fallen officers visit the memorial to pay their respect to those who have fallen in the line of duty.

When it was dedicated in 1991, the names of more than 12,000 fallen officers were engraved on the walls of the memorial. Today, the names of nearly 20,000 are inscribed. During this year's ceremony, the names of 143 fallen officers were added.

A fellow West Texan, Deputy Sheriff Josh Mitchell from Reagan County, was on that list. Deputy Mitchell was shot and killed on August 1, 2012, in Big Lake, Texas, while answering a call. He was 25 years old. He is survived by his wife Jill, his parents, and his siblings. An entire community, indeed, an entire region, continues to mourn his loss.

Deputy Mitchell's spouse, Jill, his mother, Cindy, his sister, Bethany, and his parents-in-law, Jimmy and Linda, traveled to Washington for the memorial service. They were escorted by Reagan County Sheriff Jeff Garner and several officers from the Reagan County law enforcement community.

I was humbled to have the opportunity to meet Deputy Mitchell's family and his friends. However, no there are no words that can ease their pain.

The same week, thousands gathered yet again with heavy hearts to pay tribute to the men and women of Customs and Border Protection (CBP) who died in the line of duty.

In 2012, the CBP and our country lost five border patrol agents. Three of these agents lived in the 23rd

operations on July 6, 2012, from injuries sustained in an all-terrain vehicle accident. He was 29 years old. He left behind a wife and two children.

Agent James R. Dominguez of Uvalde was the third member of his family to serve in the U.S. Border Patrol. He lost his life on July 19, 2012 while assisting a stranded motorist. Still young at the age of 41, he is survived by his wife and four kids.

Agent David R. Delaney, assigned to the Big Bend sector, collapsed and died while patrolling on foot near Big Bend National Park on November 2, 2012. He too, was relatively young, only 44 years old. At his death he left behind a wife, two daughters, and a son.

Each day, every one of us sleeps peacefully knowing that if help is ever needed, help is but a phone call away. Dial 911. Within minutes, someone is there to help. The men and women who respond to these calls put their lives on the line each and every day. Some make the ultimate sacrifice.

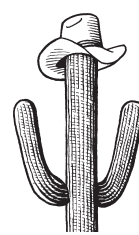
And, for their colleagues who mourn their loss - they too have a tough duty. Even in the face of adversity and loss, the men and women in law enforcement can never let their guard down. Their mission never stops. The danger never ends.

It may be too much to hope for that the Law Enforcement Memorial will someday be complete - no more names added. That day is still far off. In the meantime, every single day, let's thank the men and women in law enforcement who put their lives on the line to keep us safe.

And, let's keep the families of those lost consistently in our prayers. May our actions pay final tribute to theirs.

Final budget hurdles stand before lawmakers

AUSTIN — With 10 days to go until the end of the 140-day 83rd regular session of the Texas Legislature, a committee of House and Senate negotiators on May 17 agreed on a proposed state budget for fiscal years 2014 and 2015.

Next step is for the 150-member House and the 31-member Senate to accept or reject the work of the negotiators in votes expected to take place May 20 or 21. Pressure is on to get the budget bill to Gov. Rick Perry as soon as possible, while lawmakers carrying hundreds of other bills hope to squeeze as many as possible through the process in the last few days of the session.

Members of both parties in both houses worked furiously to replace as much as possible of the \$5.4 billion cut from public education in the 2011 legislative session as

part of an across-the-board budget-reducing plan.

The compromise before the Legislature now would increase education funding by about \$4 billion and take \$2 billion out of the state's Rainy Day Fund for water infrastructure improvements. Another \$400 million from the Rainy Day Fund would be added to transportation funding already in the base budget bill.

Complicating the picture is the fact that a two-thirds majority vote in both chambers is required to spend Rainy Day Funds.

DISCLOSURE BILL IS PASSED

On votes of 23-6 in the Senate and 95-52 in the House, the Legislature passed SB 346, the legislation that would require politically active non-profit organizations to disclose their donors to the public.

Under the bill authored by Sen. Kel Seliger, R-Amarillo, and sponsored in the House by Rep. Charlie Geren, R-Fort Worth, groups that spend more than \$25,000 a year on political activities would have to report contributions of more than \$1,000.

In passing the bill, Geren said donors have every right to give to political groups, but they should be willing to do so in the light of day, just like those who give directly to candidates.

HB 346 was forwarded to Gov. Perry's desk on May 14.

TEXAS FILES SUIT OVER SPILL

Attorney General Greg Abbott, acting on behalf of the State of Texas and several state agencies, on May 17 filed a lawsuit against BP America and a list of other

defendants for their roles in the April 2010 Deepwater Horizon offshore oil spill.

Filed in the Beaumont-based U.S. District Court - Eastern District of Texas, the lawsuit seeks natural resource damages, economic damages and civil penalties caused by the five-million-barrel spill.

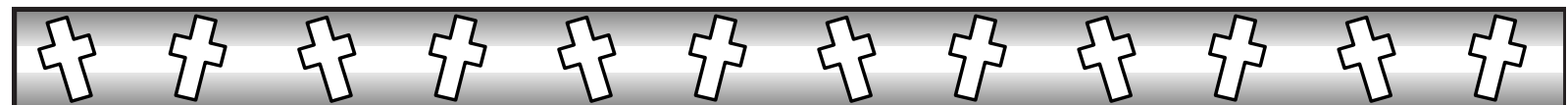

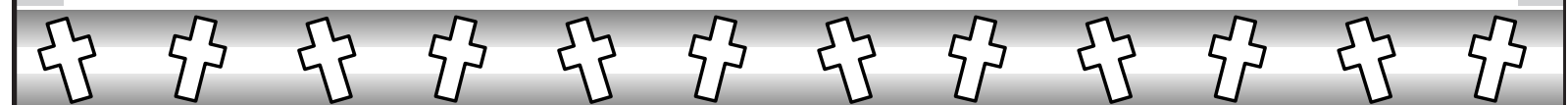

The study found that most Texas students started the last two years in larger classes, upgrades to technology, school buildings and basic maintenance have been deferred, decreased morale, reduced professional development, wage reductions and freezes and increased workloads for district employees, athletic programs, library services and summer school cut and an overwhelming number of districts cut student supports and interventions designed to reduce the achievement gap among diverse student populations.

The Texas Tribune reported on May 17 that the top House and Senate negotiators agreed to a two-year state budget that restores about \$4 billion of \$5.4 billion in cuts to public education made in 2011.

"Everybody in this room knows the greatest natural resource we have is our kids," Taylor said. "Financially, we're not good, we're not bad, we're just okay. As we work through the budget process in the next month or two, you will see what I'm talking about."

Taylor said since CCCSD is a Chapter 41 district, property-rich, and is required to send money to the state as recapture for property-poor districts; Ozona only keeps around 35 cents of every \$1 in the district's budget.

"We are helping people understand. Hopefully, it looks like they (the legislature) will put some money back in education," Taylor said.

OPEN FORUM

Lisa Broughten spoke in open forum/public comments and asked the board to reconsider the district's policy in allowing students to walk the stage at graduation, even though they haven't passed their TAKS test.

Broughten said her daughter has been ill this year causing her to miss school. Her

daughter found out last week that she did not pass her TAKS and will not be allowed to walk the stage at the May 31 graduation ceremony, according to the district's policy.

Broughten listed several area school districts that do allow students to participate or walk and the student is given a certificate of completion instead of a diploma.

Students who did not pass their TAKS tests will have another chance to take it in July.

Due to the item not being listed on the board agenda, board members could not comment or make a decision, according to the district's open forum/public comment policy.

OTHER ITEMS:

•District Spotlight - Special Olympics Highlights presented by Life Skills OES Teach-

er Whitney Brockman and presented the Texas Department Agriculture Validation Review where Food Services Manager Ludy Vargas and her staff were commended for serving healthy meals.

•Approved April 17 minutes, no amendments this month to the 2012-2013 Official Budget, extending the depository contract with Crockett National Bank and contracts with the Region XV Education Service Center for 2013-2014.

•The board also met with the district site-base committee on May 16 at the OHS Cafeteria for a district goal-setting workshop. No voting by the board took place at the meeting.

The board's next regular meeting will be 6:30 p.m. June 26 at the Administration Building. The meeting is open to the public.

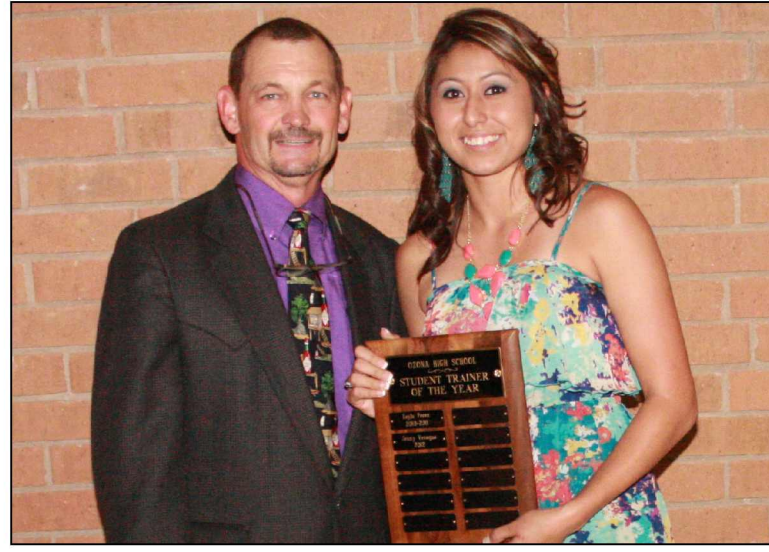

According to the Office of the Texas Attorney General, Texas is seeking civil penalties for every day of oil discharge and for every barrel of oil that was discharged; lost sales tax, state hotel occupancy tax and mixed beverage tax revenue; revenue lost from state park entrance, facility, activity and concession fees; and damages to natural resources, including wildlife and coastal ecosystems and habitats caused by the released oil and chemical dispersants.
