Midland woman killed in weekend accident had **Ozona** ties

The daughter of a former Ozona family was killed in a twovehicle crash



over the GRANGER weekend in Ector County.

Brittney Granger, 27, was pronounced dead at the scene at 7:15 p.m. Saturday, and was transported to the morgue at Medical Center Hospital in Odessa, according to the Department of Public Safety.

Granger was driving east on Interstate-20, 10 minutes west of Odessa, when her 2012 Ford F-150 pickup struck the back of a freight truck.

Ozona Athletic Director Edward Perez said he was anticipating Anthony after the UIL released its conference cutoff numbers in December, something it has never done in the past, in order to give schools a glimpse of where they might be placed.

"When the numbers came out we anticipated it because of geographic location. There are only so many schools out here," Perez said.

Anthony competed in Class 3A this year due to location and finished 1 -8 overall and 0-4 in district. Christoval was 8-2 overall and made a playoff appearance this year. They competed against Bronte, Eldorado, Menard, Irion County, Miles and TLC Academy this year.

OHS turned in an enroll-ment of 215 students. Class 2A has 204 schools overall.

Another change the UIL made this year was adding a fourth playoff team advancing from each district in team sport activities in conferences 2A and 3A. Ozona will now be part of that change.

"From the way I understand it, four teams make the playoffs," Perez said.

Also announced Monday was the new basketball districts. Ozona is in District 8-2A

with Christoval, Eldorado, Forsan, Iraan, McCamey, Irion County and Miles.

"Adding McCamey, Iraan and Forsan will just make the district more competitive in addition to the holdovers of Mertzon, Miles, Eldorado and Christoval," said OHS Lady Lions Coach David Tandy. "Another change will be heading east for the playoffs with the likes of Albany, Hamlin and Haskell in the first round."



Solar Plant planned for West Texas

It's not always sunny in West Texas, but when it is, it can be scorching.

An Arizona-based company is looking to tap those intense rays in the windy, oil-rich region as it plans a new solar power plant expected to rank among the biggest in Texas.

The firm, First Solar, will build and operate a 22-megawatt solar plant west of Fort Stockton in Pecos County, it announced Wednesday morning. First Solar will break ground on the Barilla Solar Project this week, the company said, with the plant expected to go online as early as June.

The project will sit on nearly 200 acres of land, enough to allow the company if successful — to add more capacity.

"This is an important step forward in our efforts to establish West Texas as a center for renewable energy," Pecos County Judge Joe Shuster said in a statement. "We are

not resting on our legacy of leadership in oil and gas. We welcome solar as the next new component in our portfolio of energy resources."

With the capacity to power about 2,000 homes, Barilla won't be the largest solar project in Texas. CPS Energy's Alamo project in San Antonio (41

megawatts, with the plans for additional plants that would total 400 megawatts) and Austin Energy's 30-megawatt Webberville facility have it beat.

Unique about the Barilla project, however, is that its developers are forging ahead without signing a power purchase agreement, which would

guarantee a buyer for its energy. Though First Solar may eventually ink such a deal, its representatives said they feel confident that their solar energy can compete by itself with other fuels on the open market.

Animal Control facility bid approved

A bid has been accepted for a new Animal Control Building.

During a Jan. 30 special meeting, the Crockett County Commissioners' Court accepted a bid of \$255,000 from Lopez Construction.

The county has \$173,876 from the 2013 budget for the project. The commissioners also approved a budget amendment of \$100,000 from the county emergency fund to cover the rest of the amount.

The building will be located next to the county's collection center, between Avenue I and 13th Street.

Road Supervisor Jeffrey Stuart said the Crockett County Water Control and Improvement District need to move a sewer line before his department can build a road to the building.

The commissioners told Stuart if the water department will not cooperate then they will request to have a joint meeting.

The commissioners also approved an order authorizing the creation of a County Energy Transportation Reinvestment Zone in order to apply for road funding from the Texas Department of Transportation. The funding is part of Senate Bill 1747 approved last year by the Texas Legislature.

Also approved were members of the County Energy Transportation Reinvestment Zone Advisory Board. They are Mario Mendoza, Melissa Perner, Bob Pearce, Greg Hopper and Ray Don Myers.

Last week, TxDOT extended the deadline to March 14 to receive application requests for the funding.

County Judge Fred Deaton said with the extension Crockett County may not receive as much funding as first thought due to more counties applying. Crockett County is requesting \$2.3 million.


What is a farm bill and why should I care?

What was expected to be the 2012 Farm Bill has been passed this week in the House and awaits action in the Senate.

A bitter political battle has pushed the bill all the way to 2014.

Farmers, who have a real stake in all this, would like for the rest of us to know why it's so important.

Opposition to farm legislation usually boils down to

What is a farm bill? It's a safety net, designed to keep farm families on the land.

It's those families who stand between us and a food supply that is mostly imported.

I hear from people all the time who complain about elements of farm legislation that haven't existed for decades.

In fact, in this bill, most of the complicated payment system has been eliminated. It's still complicated

enough, but most of what's left in terms of support for farmers is crop insurance. Crop insurance is a risky

business because agriculture itself is a gamble.

The government subsidizes crop insurance because farmers can't afford the premium otherwise.

However, in Texas, during the drought of 2011, we'd have lost most of our farmers.

and affordable because of the farm bill.

We need for the U.S. Senate to pass it and send it to President Obama for the promised signature. It's not just for farmers. It's for all of us.

President's annual address draws reactions

STATE CAPITAL HIGHLIGHTS By Ed Sterling Texas Press Association

AUSTIN — Gov. Rick Perry and Lt. Gov. David Dewhurst posted similar takes President Obama's annual state of the union address, televised live on Jan. 28.

Perry said, "... Texas has shown that the way to economic prosperity and significant job growth is through individual freedoms and the free market. Tonight, we saw a president with the same old agenda and no real idea on how to govern."

Dewhurst suggested the president "should take a page out of the playbook for the Texas Miracle and cut taxes, slash spending, and reduce the regulations that kill jobs."

In contrast, freshman U.S. Rep. Pete Gallego, D-Alpine, on Jan. 29 posted his reaction, referring to the president's speech "a call to action" that "requires us to take steps forward, and we must do so together. Though trust is lacking, our courage must

not fail us. If we fail today to grow the bipartisan momentum developed over recent weeks, we will miss a critical opportunity. To move the ball down the field, we all have to play on the same team. I will continue to play on the right team — America's team."

In other news, on Jan. 31, Perry reacted to the State Department's environmental impact study on the Keystone XL pipeline, a conduit being built to move petroleum-bearing tar sands from western Canada to terminals in Nederland, Texas, near Port Arthur.

"If, as the president said in his state of the union speech, he truly wants this to be a year of action, there would be no better way to kick it off than authorizing construction of this important project."

ENTITIES REACH AGREEMENT


The U.S. Environmental Protection Agency on Jan. 29 announced it had reached an agreement with the Texas Commission on Environmental Quality for approval of Texas' Flexible Permits Program for air pollution.

Under the federal Clean Air Act, the EPA was required to accept or reject Texas' air pollution rules within 18 months of the program's creation in 1994. The EPA, however, rejected the rules and disapproved the state's Flexible Permits Program in 2010, prompting Texas Attorney General Greg Abbott to file a legal challenge, asserting that the EPA failed to act within the allotted time period. In 2012, the U.S. Fifth Circuit Court of Appeals rejected the EPA's disapproval of the program. TCEQ Chairman Bryan W.

Shaw said the agreement,

while conditional, "provides a resolution to implement both the court's opinion and the necessary legal requirements for EPA approval." Shaw added that at a Feb. 12 meeting TCEQ commissioners would consider proposing rule amendments to gain the EPA's full approval later in 2014.

TEXAS AGRILIFE EXTENSION

COLLEGE STATION - Texas Agricultural Lifetime Leadership Program is seeking applicants for its new class, which will begin in July.

TALL is a two-year leadership development program managed by the Texas A&M AgriLife Extension Service. Applications for the newest class, Class XIV, are due March 15. Application forms are online at http:// tall.tamu.edu.

"Texas agriculture has a need for individuals who can lead our industry as it faces new and unique challenges. These individuals will provide the leadership, insight and direction to ensure agricultural viability for the future," said Dr. Jim Mazurkiewicz, AgriLife Extension leadership program director.

The program invests 455 hours of intensive training per person in seminars, speakers and domestic and international study trips over two years, Mazurkiewicz added. It is equivalent to the time spent obtaining a master's degree in agriculture.

The typical class size is about 25, and tuition is \$3,000.

"The goal of the program is to create a strong network within Texas agriculture by having representation from all agricultural industries and geographic regions," Mazurkiewicz said.

Participants include traditional crop producers, ranchers, bankers and attorneys, as well as those who work in lumber, food processing, agricultural corporations and horticultural industries, he said.




Draw Nigh to God

Gallego votes in favor of Farm Bill

U.S. Rep. Pete P. Gallego, D-Alpine, on Jan. 29 supported the 2014 Farm Bill.

The bill passed the U.S. House of Representative by a vote of 251 to 166. Gallego is a member of the House Agriculture Committee.

"This is a bill that should have been passed by the last Congress two years ago," Gallego said. "I am happy that common sense prevailed and that leadership came to a bipartisan, bicameral agreement on a bill so important to Texas."

The five-year bill, which preserves generous crop subsidies, heads to the Senate, where approval seems certain. The White House said President Barack Obama would sign it.

Texas Farm Bureau President Kenneth Dierschke said the bill was "truly a work of compromise."

"We believe the conference committee struck a good balance and made significant reforms, not only to farm programs but also to nutrition and other programs," Dierschke said.

The bill eliminates direct payments to farmers, but still encourages access to healthy

PETE GALLEGO foods for Supplemental Nutrition Assistance Program (SNAP) recipients.

The legislation also would continue to heavily subsidize major crops for the nation's farmers while eliminating some subsidies and shifting them toward more politically defensible insurance programs.

The bill ultimately would cut about 1 percent from the \$80 billion-a-year food stamp program. An earlier version of the legislation was defeated in the House last June after conservatives said the food stamp cuts were too modest and liberal Democrats said they were too deep. "The compromise cuts

the nutrition by only \$8.6 billion - returning \$31.4 billion to the program - and removes restrictive language that would have made it

more difficult for families to put food on the table.'







really is a good deal for a utility-scale project," Steve Krum, a spokesman for First Solar, said in an interview. "This can be part of the regular mix of generation," he added.

Texas, with its longstretching boundaries and ample solar radiation, leads the nation by far in solar energy potential. Much of that resource is in West Texas, which sees 75 percent more direct solar radiation than East Texas, according to the State Energy Conservation Office.


But the industry has struggled to get off the ground in the state. Solar energy makes up a miniscule fraction of Texas' energy portfolio, and compared with other states, Texas ranks just sixth in installed capacity, according to the National Renewable Energy Laboratory. That's largely because Texas officials have not implemented the same incentives

"It's an opportunity for us to do it in a more expedited way," Krum said.

But even more important, said Kathryn Arbeit, director of business development at First Solar, is Texas' rapid growth, which signals that the state will stay thirsty for power.

"Texas has the real need for electricity," she said.

As state officials wrangle over how to meet those needs. Arbeit said solar energy can help out — if just a bit, particularly on the hottest days, when Texans blast air conditioners. That's when solar energy, an intermittent fuel, ramps up.






