UIL STATE TRACK MEET

Moses gold, Rodriguez two silvers

AUSTIN — McKenna Moses was nervous as could be on the inside Friday at the UIL State Track and Field Championships.

But you would never know it thanks to the Ozona sophomore's calm demeanor on the outside, which included a bright smile that showed no signs of distress — except at one point during her pole vault competition.

Moses, who just nicked the bar on a 10-foot, 9-inch attempt, revealed a look of fear as she stood tall on the mat and watched the bar tumbling down toward her.

Did she clear the mark? The answer was yes.

"I knew I had hit it, and thought, 'Oh my gosh, please put the white flag up.' Then the official put it up and it made me so happy," said Moses, who won the gold medal with the clearance. "It's amazing because I really didn't expect gold. I would have been happy to medal."

Moses felt that "everything was on" throughout the pole vault competition, never feeling too overwhelmed until trying to clear the 11-foot mark — after already securing the gold.

When she accomplished the feat, Moses tried to ramp

Upton County jail agreement approved

The Crockett County Commissioners' Court approved an agreement with Upton County to house prisoners during Monday's regular meeting.

The intergovernmental agreement guarantees the Crockett County Sheriff's Office 15 beds at \$37.50 per day, per bed.

Sheriff Robert Rodriguez said he currently has 13 prisoners in Upton County, 2 in Sutton County and 3 in Mitchell County. Total housing cost for April was \$18,231.39.

Rodriguez said the agreement includes Upton County providing transportation to transport inmates.

"If they (Upton County) have space, then we can have more beds. It's not a fix, but it's a better band-aid that what we've got now," Rodriguez said.

Animal Control Officer Joe Jurado asked the commissioners if the area of 13th street, which is closed, be used as a yard for the new animal control facility.

The facility is currently being constructed at the county's collection center, across from Dollar General.

May is Military Appreciation Month, thank you to those who serve

May is Military Appreciation Month – a time to reflect on the sacrifice and commitment to public service made by those in uniform.

I've taught my son to say "thanks for your service and sacrifice" whenever he sees an individual in a military uniform. This support is deserved – and it reflects the incredible debt of gratitude we owe Soldiers, Sailors, Airmen, and Marines. It is so important that our nation treat the veterans of today's wars much better than how it treated veterans of the Vietnam War decades ago.

However, our leaders in Washington must do more. As a member of the House Armed Services Committee, I know that simply saying thank you is not nearly enough. One of my highest priorities is to fight the harmful effects of sequestration on our

nation's military. Sequestration is reducing funding for critical training hours and not meeting the equipment needs of our Soldiers, Sailors, Airmen, and Marines.

If our men and women in uniform go to battle with too few people, without enough training, or with equipment that doesn't give them the biggest advantage against an enemy, then there will be more casualties on the battlefield. Congress cannot allow this to happen. When it is possible to reduce risk, we must do so. Our service mem-

bers are our nation's sons and daughters, mothers and fathers, and sisters and brothers. They deserve committed, responsible leadership from those that represent them.

I've always been clear that the only part of politics I do not like is, well, the political part. I want to focus on finding the right policies regardless of whether an idea comes from a Democrat or a Republican. I support colleagues from either party when they are right, and I part company with them when they are wrong. I, too, want to reduce

federal spending. I cannot criticize other lawmakers for wanting to do the same thing. But smart policymaking – which seems uncommon in Congress – requires us to cut spending responsibly and thoughtfully; not slashing critical and non-critical programs equally. Smart policies from Congress will help ensure that our military has the critical resources it needs to accomplish its missions. That is the ultimate form of Military Appreciation Month from Washington, D.C. Merely saying, "thank you for your

service" is not enough from our nation's leaders.

The solution to sequestration – and thus the best way to truly support our men and women in uniform – is for Congress to come to a bipartisan agreement about our nation's budget and spending. Members of Congress must put patriotism above partisanship. And, we must demonstrate the same level of commitment to public service that our warfighters show every single day.

Death, neglect, broken promises at the VA

Today in America veterans are dying – not at the hands of a foreign enemy but through the neglect of the very country they served. Many of them put themselves in harm's way in foreign lands so we can live peaceful lives back home. They did so secure in the promise that America takes care of her veterans.

Sadly, that promise is being broken. The case of Navy veteran Thomas Breen is a sad reminder of this. In the weeks leading up to his death, Breen's family tried desperately to get him an appointment at the Phoenix VA Medical Center. It had been more than a month since he was rushed to the emergency room with serious symptoms of cancer. Sadly, Breen passed away on Nov. 30, 2013. A week later, the VA hospital called with his appointment time.

This is not an isolated case. According to a former VA doctor interviewed by CNN, no fewer than 40 veterans have died while waiting for appointments with the Phoenix VA. These tragedies are apparently the result of a scheme designed to give the appearance of providing speedy care, while covering up the fact that veterans were forced to wait months for appointments.

As if that weren't bad enough, high-level officials in the Phoenix VA system knew this was going on and did nothing about it. Actually, it gets worse: Not only did the Phoenix officials tolerate this scheme – they outright defended it. And the problem goes well beyond Phoenix. In Pittsburgh, for example, six patients at a VA hospital died and more than 20 others at the same hospital became sick after an outbreak of Legionnaires' disease due to contaminated water. As in Phoenix, patients at the Pittsburgh facility were kept in the dark about what was going on. Doctors and staff were aware of a potential contamination, but the veterans and their families were not informed.

This all unfolds against the backdrop of alarmingly high numbers of veteran suicides and a massive backlog of disability-compensation claims at the VA. As of April 26, there were

more than 596,000 claims pending nationwide, and a majority of those had been pending for more than 125 days. More than 51,000 of these claims are pending before just two VA regional offices – those in Houston and Waco.

To be clear, this isn't an excuse for the fatal mismanagement that occurred in Phoenix and Pittsburgh. Rather, it's an extended symptom of the VA's inability to uphold its commitment to veterans. Like many problems in government, the solution requires greater accountability and transparency. I've co-sponsored legislation that enhances both.

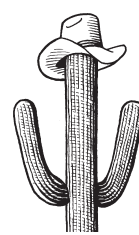
The Department of Veterans Affairs Management Accountability Act of 2014, introduced by Sen. Marco Rubio, empowers the secretary of veterans affairs to take swift action to remove senior officials within the department whose performance (or lack thereof) merits it. When such cases arise, the VA would be required to notify Congress – and, by extension, the American people. This would prevent the VA from using bureaucratic smoke and mirrors to conceal mismanagement.

With veterans' lives on the line, time is absolutely of the essence. The death of any veteran as a direct result of inadequate care – including inadequate mental health care – is inexcusable. And with Texas home to a very large military population, the matter is all the more pressing for our state.

America's obligation to her veterans isn't just a legal one; it's a moral one. Our men and women in uniform serve our country honorably. They do so based on a promise that when they come home, their country will be there to lend them a helping hand. They're upholding their end of the bargain; America needs to uphold hers.

If I wasn't in the beef business my second career choice would be that of a dairyman. I know that would mean no horses or brandings, and I'd have to wear those knee-high rubber boots that are forever springing a leak. And I'd still have to fix fence, just not as much of it.

I like dairying because in college I used to hang around the project dairy where a lot of my best friends were dairy majors and, I hate to admit this, but I really liked milking Holsteins. I know that dairy cows aren't the most intellectual animals in the barnyard but there are some advantages over beef cows: you can gather them by clanging a bucket, I'd never get bucked off again, and if I was a dairyman I'd always have access to that nirvana of the taste buds, chocolate milk.

Tried to sneak a barely-crippled cow by the guys at the saleyard but they wouldn't take her. I considered bribery but I haven't received my milk check yet and didn't have any money in my wallet. Tomorrow I have my yearly meeting with my banker and my stomach has been churning. (Pun intended.) I don't know if it's the banker, or the fact that Jose called and said he isn't coming back.

Wednesday- After the morning milking I took the banker to lunch and tried to get him drunk so he'd approve next year's operating loan. He kept talking about "his" cows, "his" land, "his" tractors and kept saying "our" assets had to be collateralized. Whatever that means. I sure wish he'd come milk "his" cows once in awhile. In the end he not only extended my loan, he urged me to expand because he said he can't foreclose on "my" cows because then he'd have to show a loss. The big difference between he and I is that the cow manure is on the outside of my boots.

Thursday- Got a letter from another

government agency who said they wanted to fine me \$75,000 per day because they found on my property an endangered microscopic insect eating an endangered invisible plant.

Friday- Went to bed flat worn out and realized I'd forgotten to eat today. The "Big Event" for the day was I got to buy a new front end loader because the old one finally went up in flames. Well, I didn't exactly get a new one, but I got a good deal on a 10 year old tractor that only cost \$100,000.

Decision upholds prayer in public meetings

AUSTIN — Governmental bodies' right to begin meetings with a prayer — so long as the prayer does not favor a particular religious denomination — was upheld by the U.S. Supreme Court in a 5-4 decision rendered May 5.

Texas Attorney General Greg Abbott reacted to the decision in Town of Greece, New York v. Galloway et al. "I am pleased that the U.S. Supreme Court has once again upheld the longstanding and constitutionally protected right of governmental bodies to begin their meetings with prayer," Abbott said.

Texas was one of 23 states that joined in a brief arguing against a circuit court of appeals decision declaring unconstitutional a New York local governmental body's tradition of opening its public meetings with a prayer.

SALES TAX REVENUE INCREASES

Comptroller Susan Combs on May 7 said state sales tax revenue in April was \$2.27 billion, up 5.6 percent compared to April 2013. Combs, who said this marks 49 consecutive months of growth in sales tax collections, will send cities, counties, transit systems and special purpose taxing districts their May local sales tax allocations totaling \$716 million, up 7.1 percent compared to May 2013.

In other news, Combs announced on April 29 the launch of an online database detailing public school construction costs since 2007.

The Texas Public Schools Construction database, found through the www.texastransparency.org, "will help Texans prepare to vote in the upcoming local bond elections, which feature a total of \$6.7 billion of proposed bond debt on the

ballot, 92 percent of which is proposed by local school boards," Combs' office said.

DROUGHT DISASTER CONTINUES

Gov. Rick Perry on May 9 renewed for 30 days the Emergency Disaster Proclamation he originally issued on July 5, 2011, certifying that exceptional drought conditions posed a threat of imminent disaster in specified counties in Texas.

The renewal, which means "all rules and regulations that may inhibit or prevent prompt response to this threat are suspended for the duration of the state of disaster," applies to 173 of the state's 254 counties.

HORSE PATROL UNIT STARTS

Texas Department of Public Safety on April 29 announced

the official start of a mounted horse patrol unit.

Cynthia Leon, chair of the Texas Public Safety Commission which oversees the DPS, said "Texas' majestic Capitol Complex draws more than one million guests each year, in addition to the thousands of state and civilian workers who report there

A history major from Ozona, Knox will intern May 19 through Aug. 8 in the Office of the Curator, where he will work in the Photography Division assisting in building a database of digital images as part of an ongoing effort to make photographs documenting events at the Supreme Court accessible to staff and researchers.

In addition to his work in the Photography Division, Knox will learn about the role and functions of the Supreme Court, its history and the architecture of its building.

He will also conduct tours and courtroom lectures and help document current decisions and events. Additionally, he will have opportunities to conduct research, visit national museums and monuments, and interact with professional historians and archivists, as well as court and political figures.

Dr. Shirley Eoff, Honors Program director, said, "This is a wonderful experience for Duncan to gain relevant

skills and experience in the fields of historical research and preservation while also experiencing the vast educational and cultural opportunities of our nation's capital. It is the type of opportunity that can open many doors."

Knox's travel and program costs are being funded through ASU's Alvin and Patricia New Honors Program Enhancement Fund, which was created in 2008 through an initial \$250,000 donation to the ASU Honors Program by former San Angelo Mayor Alvin New and his wife, Patricia, who are both ASU alumni.

Knox is a 2011 Ozona High School graduate and the son of Bobby Knox, of Ozona.



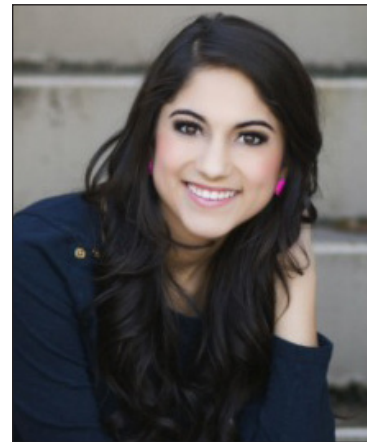

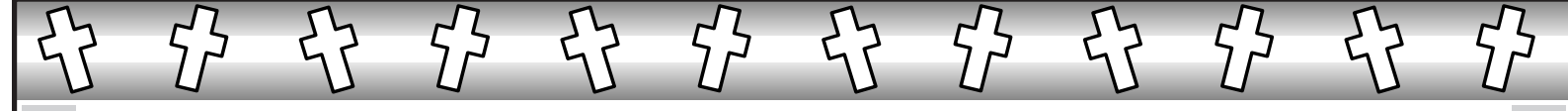

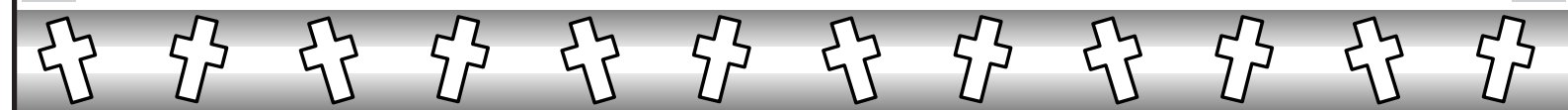

Juan (John) F. De Hoyos, age 65, passed away on Friday, May 9, 2014.

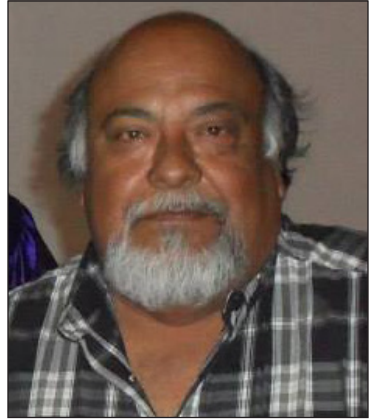

New interpretive trail blooms

Every couple of months Bob and Ruth Ann Perkins of Midland drive Interstate 10 to San Antonio to visit their son. The route takes them past Ozona and for the last several years, the couple noticed some work being done on a spot of land off of the 15th Street exit.

"The first thing I noticed was a big pile of rocks," said Ruth Ann. "We had no idea what they were going to do with them. We would watch the site and see what was going on every time we came by, and then one time we came through there was a trail."

The trail is the Crockett County Interpretive Trail, a decades-long dream of the Ozona Chamber of Commerce, which has its visitors center directly across the street. The Perkins, along with other special guests, were on hand for a soft opening of the trail Saturday.

"The purpose of the trail is to create an educational exhibit to preserve and talk about the heritage of the plants in this area," said chamber executive director Shanon Biggerstaff. "It enhances our visitors center and we hope will draw people off of I-10."

More than 75 plant species are in the trail, including red yucca, goldenball leadtree, mealy blue sage, Texas mountain laurel and the chocolate flower, which smells like a Hershey bar when you put your nose to the yellow bloom. There's also catclaw, one of the most despised southwestern shrubs because its hooked spines can tear clothing and flesh.

The trail has a wildlife viewing area, a watering hole for birds and butterflies and benches for people to sit. The huge rocks that sit amid the plants came from a quarry along nearby U.S. Hwy 163 and a local ranch.

The chamber partnered with the Crockett County Commissioners Court in 2001 and received a grant for a new visitors center and the trail project from the

Texas Department of Transportation, Biggerstaff said.

There were some ups and downs along the way and increased construction costs only left enough money for the new visitors center, which opened its doors in 2006. But the next year, the chamber board went ahead and hired Terry Tate of Mertzson to design the trail and used its 2008 chamber banquet to raise funds to get it started. Tate is a private contractor and an expert on native plants.

"Terry got the ball rolling," Biggerstaff explained. "He built the elevation, marked the trail, dug out and excavated."

The local Texas A&M Agri-Life Extension Office approached the chamber about displaying a rain harvesting system on the trail and the board liked the idea because native plants and water conservation go good together, she said.

The first plants were installed in November of 2011 and the chamber began raising money for signs as memorials or honorariums. Forty-eight are marked with more to come.

"It's nice to walk the trail and remember people who are from this area," Biggerstaff said.

On Saturday, sisters Irene Gonzales and Cecilia Longoria, both from Ozona did just that. They found the desert hackberry sign they gave in memory of their brother Armando Ramierz.

"Today is his birthday, too," Cecilia said. "He

would've been 56." Also enjoying the trail was Sally Oglesby, who donated some of the rocks from her property and who also was a huge help to the chamber in getting the project done.

"I'm from pioneer families on both sides and I want Ozona to remain a beautiful town and not be an eyesore," she said. "I want this trail to be an invitation for people to come in and visit and that will help our community to stay stable."

Because he's from the area, Tate already knew the type of plants he wanted in the trail.

"I did a lot of research, too," he said. "I wanted to make sure everything would fit. This trail is a work in progress. It's a long-term project for me. You'll see it evolving over time."

Some of the plants are local and some are from specialty nurseries that grew the types of plants native to the area. Tate wanted to make sure they were good and healthy and wouldn't die on him, thereby adding to the project's cost.

His wife Dorothy helped with the trail as well.

"I drove the bobcat," she said. "Terry wanted to do a natural landscape with the rocks, so he would guide me on where to put them."

VOTE: Cast ballots early starting Monday

The Primary Runoff Election is getting closer.

Early voting for the runoff will be May 19-23 at the courthouse annex. Runoff Election Day is May 27 at the Crockett County Courthouse.

"If you voted in a party primary or participated in a convention, you can only vote in that same party's runoff" said Secretary of State Nandita Berry. "If you did not vote in the March 4 Primary you may still vote and can vote in the runoff election for either party."

The Democratic Primary Ballot includes David M. Alameel and Kesha Rogers for U.S. Senator and Jim Hogan and Richard "Kinky" Friedman for Commissioner of Agriculture.

The Republican Primary Ballot includes Andrew Murr and Rob Henneke for State Representative of District 53; Francisco "Quico" Canseco and Will Hurd for U.S. Representative District 23; Dan Patrick and David Dewhurst for Lieutenant Governor; Dan Branch and Ken Paxton for Attorney General; Sid Miller and Tommy Merritt for Commissioner of Agriculture and Ryan Sitton and Wayne Christian for Railroad Commissioner.

The Texas Department of Public Safety (DPS) is reminding Texans in advance of the upcoming primary runoff election that Election Identification Certificates (EIC) are available at all Texas driver license offices for individuals in need of proper identification required to vote in elections in Texas.

Most residents already have an acceptable form of photo identification needed for voting and will not need or qualify for an EIC. If an applicant already has any of the following documents, they are not eligible to receive an EIC:

- Texas driver license - unexpired or expired no longer than 60 days at the time of voting
- Texas personal identification card - unexpired or expired no longer than 60 days

at the time of voting

- U.S. passport book or card - unexpired or expired no longer than 60 days at the time of voting

- Texas concealed handgun license - unexpired or expired no longer than 60 days at the time of voting

- U.S. Military identification with photo - unexpired or expired no longer than 60 days at the time of voting

- U.S. Citizenship Certificate or Certificate of Naturalization with photo

To apply for an EIC, applicants must visit a driver license office and complete an Application for Texas Election Certificate (DL-14C).

To qualify for an EIC, an applicant must:

- Bring documentation to verify U.S. citizenship and Identity
- Be eligible to vote in Texas (Bring a valid voter registration card or submit a

voter registration application through the Texas Department of Public Safety)

- Be a Texas resident
- Be 17 years and 10 months or older

To avoid delays or complications, DPS urges potential applicants to make sure they have the necessary documentation before arriving at the office.

The EIC receipt an individual receives will include their photo and can be used for voting until the permanent card is delivered by mail.

The EIC is free of charge to qualifying applicants and is valid for six years. There is no expiration date for an EIC for citizens 70 years of age or older. The EIC can only be used for the purpose of voting in an election and may not be used as personal identification.

Property Tax Protest and Appeal Procedures

The law gives property owners the right to protest actions concerning their property tax appraisals. You may follow these appeal procedures if you have a concern about:

- the market or appraised value of your property
- the unequal appraisal of your property
- the inclusion of your property on the appraisal roll
- any exemptions that may apply to you
- the qualification for an agricultural or timber appraisal
- the taxable status of your property
- the local governments which should be taxing your property
- the ownership of property
- the change of use of land receiving special appraisal
- any action taken by the chief appraiser, appraisal district or appraisal review board (ARB) that applies to and adversely affects you.

Review by the ARB
If you cannot resolve your problem informally with the county appraisal district (CAD) staff, you may have your case heard by the ARB.

The ARB is an independent board of citizens that reviews problems with appraisals or other concerns listed above. It has the power to order the CAD to make the necessary changes to solve problems. If you file a written request for an ARB hearing (called a notice of protest) before the deadline, the ARB will set your case for a hearing. You will receive written notice of the time, date and place of the hearing. If necessary, you may request a hearing in the evening or on a Saturday or Sunday. Prior to your hearing, you may ask to review the evidence the CAD plans to introduce at the hearing to establish any matter at issue. The law provides that before a hearing on a protest or immediately after the hearing begins, you or your agent and the CAD shall each provide the other with a copy of any written material intended to be offered or submitted to the ARB at the hearing. To the greatest extent practicable, the hearing will be informal. You or a designated agent may appear in person to present evidence or you may send notarized evidence for the ARB to review at your hearing. The CAD representative will present evidence about your case. You may cross-

examine the CAD representative. The ARB will make its decision based on the evidence presented. In most cases, the CAD has the burden of establishing the property's value by a preponderance of the evidence presented.

In certain protests, the chief appraiser has the burden of proving the property's value by clear and convincing evidence. You should review ARB hearing procedures to learn more about evidence and related matters. You can get a copy of a protest form from the appraisal district office or from the Comptroller of Public Accounts at www.window.state.tx.us/taxinfo/taxforms/50-132.pdf.

You should not try to contact ARB members outside of the hearing. The law requires ARB members to sign an affidavit saying that they have not talked about your case before the ARB hears it.

Review by the District Court, an Arbitrator or SOAH
After it decides your case, the ARB must send you a copy of its order by certified mail. If you are not satisfied with the decision, you have the right to appeal. If you choose to go to court, you must start the process by filing a petition within 60 days of the date you receive the ARB's order. In certain cases, as an alternative to filing an appeal in district court, you may file, not later than the 45th day after you receive notice of the ARB order, a request for binding arbitration with the county appraisal district. In certain cases, you may appeal to the State Office of Administrative Hearings (SOAH). An appeal to SOAH is initiated by, not later than the 30th day after you receive notice of the ARB's order, filing with the chief appraiser of the county appraisal district a notice of appeal. Appeals to district court, binding arbitration, or SOAH all require payment of certain fees or deposits.

Tax Payment
You must pay either the amount of taxes due on the portion of the taxable value not in dispute or the amount of taxes due on the property under the order from which the appeal is taken.

Deadline for Filing Protests with the ARB*

Usual Deadline
On or before May 31 (or 30 days after a notice of appraised value was mailed to you, whichever is later).

Late protests are allowed if you miss the usual deadline for good cause. Good cause is some reason beyond your control, like a medical emergency. The ARB decides whether you have good cause.

Late protests are due the day before the ARB approves records for the year. Contact your appraisal district for more information.

Special Deadlines
For change of use (the appraisal district informed you that you are losing agricultural appraisal because you changed the use of your land), the deadline is not later than the 30th day after the notice of the determination was mailed to you.

For ARB changes (the ARB has informed you of a change that increases your tax liability and the change did not result from a protest you filed), the deadline is not later than the 30th day after the notice of the determination was mailed to you.

(You may insert deadline for protests concerning omitted property if doing so would avoid taxpayer confusion.)

If you believe the appraisal district or ARB should have sent you a notice and did not, you may file a protest until the day before taxes become delinquent (usually Feb. 1) or no later than the 125th day after the date you claim you received a tax bill from one or more of the taxing units that tax your property. The ARB decides whether it will hear your case based on evidence about whether a required notice was mailed to you.

* The deadline is postponed to the next business day if it falls on a weekend or holiday.

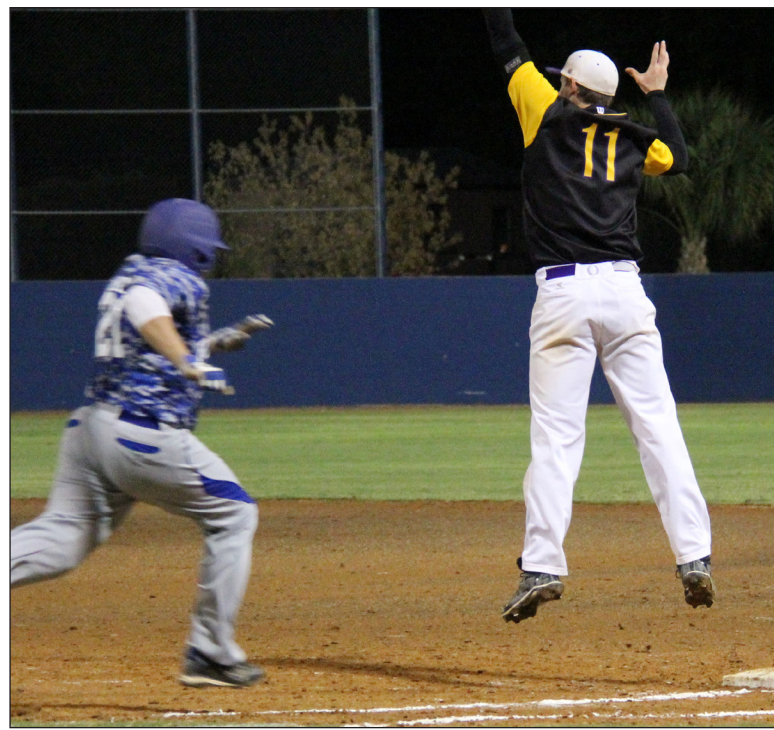

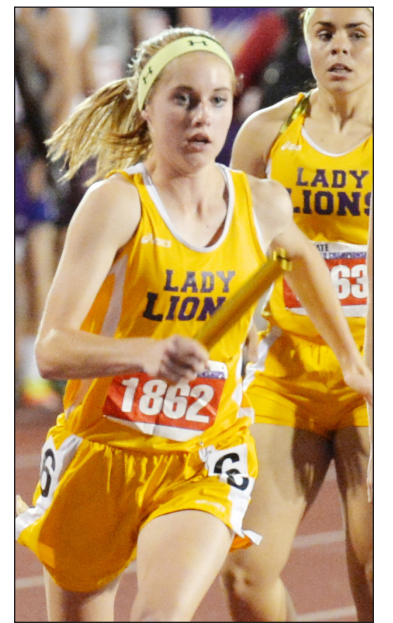
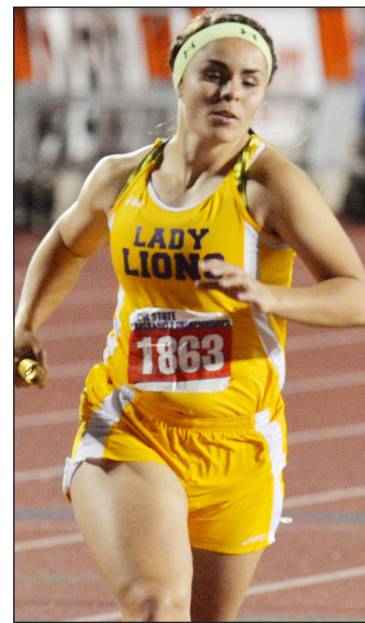

it up to 11-3 but to no avail. "I had never cleared 11 feet in competition," Moses said. "So it was exciting to do that."

Moses placed seventh last year at the state meet in pole vault clearing 9-6.

She is the first state champion for the Ozona girls track team in 33 years.

The next rush will come next year when Moses tries to defend her newly acquired title. It's a task — along with another tall objective she has already set for herself.

"I want to clear 12-6 next year," Moses said. "Coming back next year, everyone is going to expect me to defend my title."

For now, though, she can relax.

Immediately following her gold medal pole vault win, Moses competed in high jump where she placed eighth.

RODRIGUEZ WINS TWO SILVERS

Omero Rodriguez is beginning to become a familiar face at the state level.

Rodriguez has shown a keen ability to be a dangerous threat in the 3,200.

The Lions junior displayed his endurance by running strong against a viable group of runners through seven laps and showed his speed with a solid kick toward the end that allowed him to cement a second-place finish in Class 1A Division I action.

Rodriguez clocked in at 10:00.99, which was a few sec-

onds behind the pace setter.

"I was just trying to keep a good pace," said Rodriguez, who was making his first appearance in track and field. "My kick was kind of awful. I didn't feel I had a good kick. It was like I couldn't go."

In the 1600 meters, Rodriguez took silver. He ran a 4:33.75. Rodriguez took the lead in the race at the end of the third lap, and held it for more than 300 meters but was passed on the final stretch by winner Jeremy Cervantes of Forsan, who ran a 4:33.03.

Rodriguez can add his two silver track and field state medals with his state championship team medal and second place state individual medal from cross-country earlier this school year.

RELAY TEAM NINTH

In the girls 4x400 relay, the team of Jordyn Lexi Poindexter, Estefania Torralba, Nicole Higgins and Madison Childress was ninth with a time of 4:19.54.

All four Lady Lions were making their debut at the state meet.

"The mile relay did a great job with what they had that night. It was an incredible achievement for these girls to be the first Ozona girls to qualify for the state meet as a relay," said Coach Erik Thormaehlen. "I believe this team made some monumental strides towards making history this year."

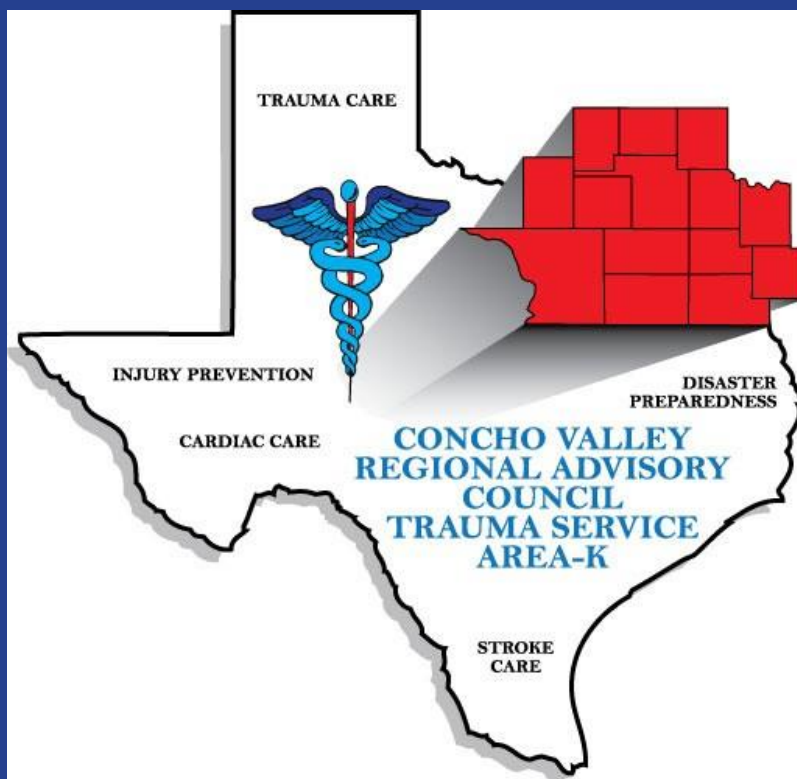

Here are some facts about distracted driving:

When your mind or attention is not focused solely on driving, you're a distracted driver. While cell phones are a major culprit, anything that takes your mind and attention away from your driving is a distraction.

There are three main types of distractions:

- Visual — taking your eyes off the road
 - Manual — taking your hands off the wheel
 - Cognitive — taking your mind off what you're doing
- Those who text and drive are 23 times more likely to be in a motor vehicle crash, according to the Virginia Tech Transportation Institute.
 - When drivers read or send a text message, their reaction time is doubled. When asked to respond to a flashing light while texting behind the wheel, drivers were more than 11 times more likely to miss the light altogether.
 - A whopping 97 percent of teens say texting while driving is dangerous, but 43 percent admit to doing so.
 - Almost all teens (nine in 10) expect a reply to a text or email within five minutes or less, which puts pressure on them to respond while driving.
 - According to 77 percent of teens, adults tell kids not to text or email while driving – yet adults do it themselves “all the time.”
 - Crashes kill more young people than any other cause, accounting for nearly half of all teen deaths in America each year. Most teens and parents are unaware of the top five dangers of teen driving: driving at night; speeding and street racing; distractions, such as cell phones/texting and too many teen passengers; low seat belt use; and alcohol use.
 - More than 3,000 U.S. teens die each year in car crashes; that's the equivalent of a commercial jet loaded with teenagers crashing once every other week for an entire year.

for work on any given day. This new law enforcement capability throughout the Capitol Complex will prove to be a valuable resource in keeping the public safe."

TEA SUBMITS PLAN TO FEDS

Texas Education Agency on April 28 announced it submitted specific details of a new teacher evaluation and support system to the U.S. Department of Education.

Part of Texas' waiver from specific provisions of the federal No Child Left Behind Act of 2001 depends on the state's submitting an alternative plan for a teacher evaluation and support system. Texas' plan will be piloted in as many as 72 school districts and charters in the 2014-2015 school year.

Education Commissioner Michael Williams said, "The Teacher Evaluation and Support System is designed to be a more effective evaluative tool to support the most important adult in Texas education — the teacher at the front of every child's classroom."

"We have heard from Texas teachers that the current evaluation system (in place since 1997) used by 86 percent of our school districts is outdated and provides little value in regard to meaningful professional feedback and growth," Williams said.

AG'S OFFICE INVESTIGATES

Identity thieves reportedly have posed as employees of the Texas Attorney General's Office to steal the identities of targeted individuals — particularly individuals who have applied for a short-term loan.

A criminal investigation has been opened, the Texas Attorney General's Office announced May 5, adding, "Under no circumstances does a representative of the Office of the Attorney General solicit payments from Texans to pay off a short-term loan or grant immediately — nor does the Attorney General's Office issue arrest warrants for this purpose. Any person who claims to be from the Attorney General's Office and demands immediate fees to resolve the resident's short-term debt or prevent an arrest for that debt is an imposter."

'CLICK IT' CAMPAIGN SET

Texas Department of Transportation's 13th annual "Click It or Ticket" campaign will run May 19 to June 1.

In 2013, there were 943 fatalities and 5,383 serious injuries in Texas resulting from crashes in which drivers or passengers were not wearing seat belts, TxDOT reported.

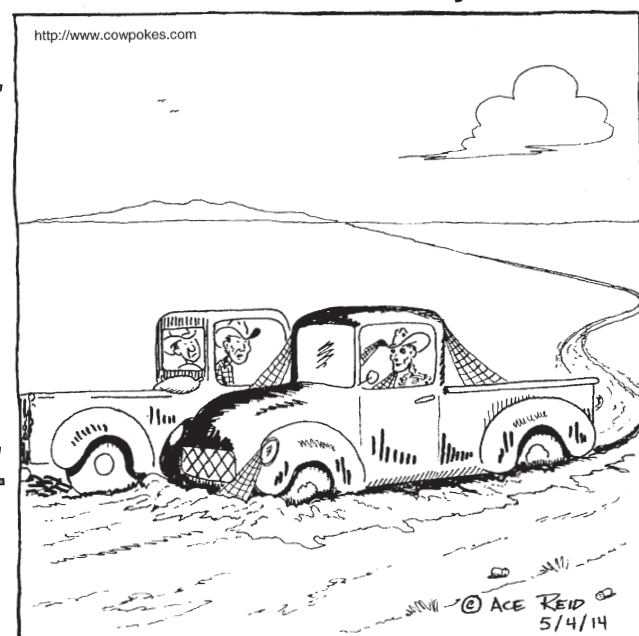

This Order does NOT prohibit outdoor burning activities related to public health and safety that are authorized by the Texas Natural Resources Commission for: (1) firefighter training; (2) public utility, natural gas pipeline or mining operations; (3) planting or harvesting or agricultural crops; or (4) burns that are conducted by an approved Prescribed Burning Association, Natural Resource Conservation Service, the and/or Texas A&M Agricultural Experiment Station, or prescribed burn manager certified under Section 153.048, Natural Resources Code, and meet the standards of Section 153.047, Natural Resources Code.

All burns shall be reported to the Crockett County Sheriff's Office (325) 392-2661 and the Fire Chief (325) 392-2626 prior to commencing, together with the name of the landowner, location involved and expert to be on hand. This Order does NOT prohibit outdoor cooking in a properly contained area which is attended at all times. In accordance with the Local Government Code 352.081 (h), a violation of this Order is a Class C misdemeanor, punishable by a fine not to exceed \$500.

This Order does NOT prohibit outdoor cooking in a properly contained area which is attended at all times. In accordance with the Local Government Code 352.081 (h), a violation of this Order is a Class C misdemeanor, punishable by a fine not to exceed \$500.
