Methodist Church. Dalan Aaron Wilson is the third magna cum laude graduate with a 99.2931 GPA. He is the son of Jana and David Wilson.

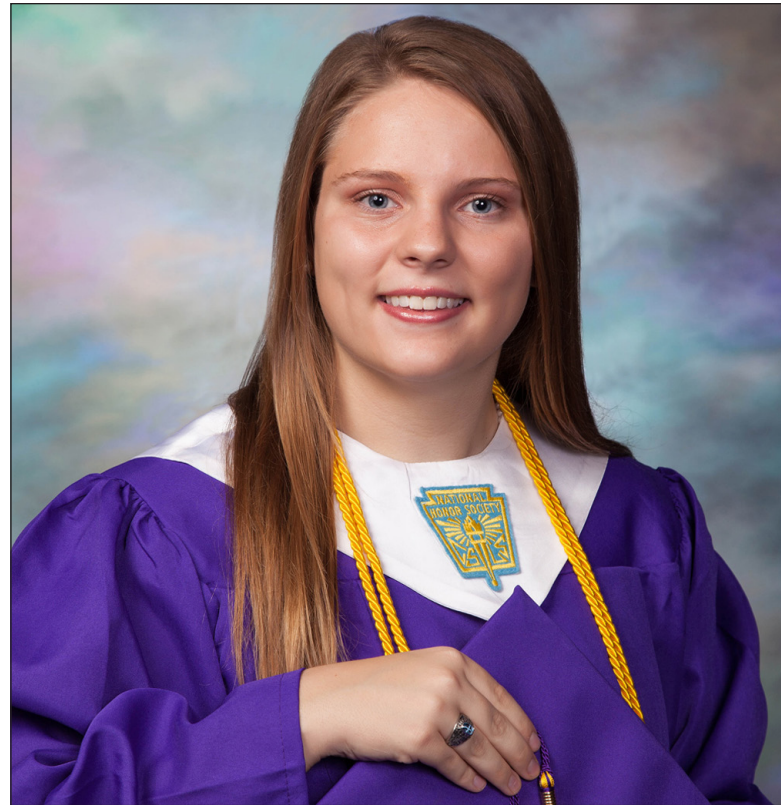
Magna cum laude graduate Alan Alexis Salazar has a 99.1206 GPA. He is the son of Susana Dominguez and Ezequiel Camarillo.

Stopping ISIS

When I travel throughout our district and meet with the people I represent, every county and town has a different set of issues they want to discuss, depending on their local industries, businesses, schools, etc. But there is one topic that I am always asked about, no matter where I am - our national security.

The recent ISIS-inspired terrorist attack in Garland, Texas brought this issue much closer to home than any of us are comfortable with. Due to the diligence and hard work of our military and intelligence agencies, we haven't seen a large-scale terrorist attack on our homeland since September 11, 2001. But our enemy has adapted its methods and is now using a digital network to radicalize individuals thousands of miles away from any ISIS camp. If we're going to defeat our enemy, we have to adapt as well.

Reports on the news describe young people of all races, genders and socioeconomic status leaving their families behind in order to travel to the Middle East to fight along-side the Islamic State. We estimate that there are approximately 20,000 Westerners who have slipped into Syria to join ISIS - perhaps even more. In early May, I traveled with fellow members of the Congressional Task Force on Foreign Fighters to Israel, Iraq, Turkey and Germany in order to learn more about how these people are making it from Europe to Syria and Iraq, and how we can stop them. And even more importantly, we looked for ways to stop these radicalized fighters from traveling back to their home country with the intent of carrying out a terrorist attack in the name of ISIS.

My trip taught me that there is more work to be done by both our allies and our own nation. Though our government has provided lists that contain the names of thousands of potential terrorists, we learned that our European partners are not comparing the names of travelers to these lists. This is a serious security gap that must be closed. I pray that it doesn't take an attack on their own soil before they see that as well. Our own government

needs to step up its use of the intelligence gathered in order to find and destroy ISIS. Last week's U.S. Special Forces attack that led to the death of ISIS Abu Sayyaf is exactly

what we need more of. My hope is that the success of this operation will lead to similar raids that allow us to gain valuable intelligence in order to dismantle their network. Combined with U.S. air strikes and our efforts to train and equip our regional partners, we can keep taking the fight to ISIS where they live.

We're also taking a serious look at how to combat ISIS where their efforts have been most startling and successful - via platforms such as YouTube and Twitter. When I was working to stop al-Qaeda as an undercover officer in the CIA, our enemy was very limited and unsophisticated in their struggle to spread their propaganda and recruit new fighters. ISIS has taken a 21st Century approach, spreading their digital tentacles throughout the western world and into the minds of our young people, trying to convince them that adventure awaits them if they will join the battle. What they really face is certain death, as these new recruits are often sent to the front of the battle lines. The enemy's efforts on this front must be countered and ultimately, shut down.

The fight against ISIS is extraordinarily complicated, but I have no doubt that our country has the wherewithal to win. We have the best trained and well-equipped Special Forces in the world, and our intelligence community is second to none. What we are missing is decisive leadership from Washington which will utilize our superior resources to set our enemy on their heels. It's my hope that our most recent victory is a sign that we've turned the corner and we are ready to do what it takes to deter and destroy ISIS.

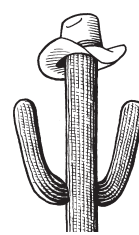
Roping Dummy

Yes, sirree, it's your rock 'em, sock 'em, double hock 'em Big Roping Dummy here with the first ever buying guide to ropes, lassos, lariats, and reatas. Here's all the latest dope on rope.

I'm in need of a new rope so I went to Consumer Reports typed in the word "ropes" and the only thing they came up with were two brands of weed whackers. Suffice it to say, Consumer Reports is lacking in the rope department. To fill this void I gathered up my ropes and retrieved my namesake roping dummy made out of a saw horse and a broken broom handle. Then I put my ropes to a complex scientific test. Here are my conclusions.

Grass Rope: When I was 10 years old my grandpa gave me my first rope which happened to be made of hay. It took me 20 years to master the grass rope because that's how long it took to get all the kinks and knots out of it. Like my wife, a grass rope can be moody and hates the fog.

It's been said that a cowboy does everything but eat with his rope and I must admit that my grass rope would make a better fork or spoon than it ever was a lasso. I couldn't catch a dead steer with it. I did like the price (it was free) and the fact that I didn't have to make the long walk and back and forth after each toss to remove it from the dummy as I

I was so accurate I was a regular roping machine. As hard as this is to believe, my reata seemingly had eyes and I roped the dummy in 6 out of 24 tries before my reata broke. It was at this point a major flaw became evident: don't tie hard and fast unless you want 2 shorter ropes.

Old timers say that a leather reata would outlast five grass ropes but that's only because the old timers knew how to braid. Another negative is the cost: \$300 at antique shops. That's a lot of money for 30 feet of rope, although granted they often can be stretched to double that length.

Maguery rope: The maguery rope is made out of the fibers of the aguava or century plant, which can also be used to make a delightful liquor. This is good because

only caught it in 4 out of 50 tries. In conclusion, I wouldn't use a grass rope to catch something I intended to keep for very long. And I must say, if I was headed to the George Strait, USTRC or NFR I would find an alternate kind of twine.

Leather Reata: After only a few tosses I could tell my leather reata was far superior to the grass rope.

you'll need a drink or two if you insist on using one. My maguery ropes are 3/8 in diameter and they cut like a chain saw. I did rope the broomstick horns on my dummy in 1 out of 4 tries until the rope cut off the horns at the base of the skull. If you use one of these I'd suggest your use gloves on both hands and I'm talking heavy duty welder gloves. Even then, expect blood.

The maguery rope does have more body and is more consistent... in cutting off an appendage or two. WARNING: I'd put horn raps on my roping dummy, if I were you.

The great trick roper Vicente Oropeza used a maguery rope and I was able to duplicate many of his tricks with my maguery, including the difficult double 8, catching the head and legs in two loops with one rope. The doctor said my deep rope burns should take six months to heal and that the hideous scars may require plastic surgery.

I understand there's an all new breed of ropes made by Cactus, Classic, King Ropes and others with names like "Shock and Awe" and "Money Maker". I would be glad to include them in next year's analysis if the makers would send me free examples of all their fabulous ropes. Postage paid of course. As to what you should do in the meantime... you don't see Trevor Brazile or Cody Ohl roping with grass, leather or maguery ropes do you?

Agreement on state budget evades House, Senate

AUSTIN — June 1 is the last day of the 84th Regular Session of the Texas Legislature. From now until then is all the time that remains for the House and Senate to decide if they're going to agree on a 2016-2017 state budget.

Both chambers could be ordered to meet around the clock until an agreed-upon budget is passed, if House Speaker Joe Straus and/or Lt. Gov. Dan Patrick deem it necessary or worthwhile. Any proposed agreement would originate in a House Bill 1 conference committee composed of five House members and five Senate members. House members are: Appropriations Committee Chair John Otto, R-Dayton and Vice Chair Sylvester Turner, D-Houston; Trent Ashby, R-Lufkin; Sarah Davis, R-Houston; and Larry Gonzales, R-Round Rock. Senate members are: Finance Committee Chair Jane Nelson, R-Flower

Mound; Juan "Chuy" Hinojosa, D-McAllen; Joan Huffman, R-Houston; Lois Kolkhorst, R-Brenham; and Charles Schwertner, R-Georgetown.

As reported repeatedly since March, the main obstacle toward agreement on a budget is the two bodies' disagreement over how to cut state taxes. The Senate voted to cut ad valorem taxes while the House voted to cut the state sales tax from 6.25 percent to 5.95 percent. Both bodies want to cut the business franchise tax, which would please Gov. Greg Abbott, who made that task one of several stated priorities for the Legislature to accomplish.

If the Legislature is unable to adopt budget in the regular session, the governor may call a special session.

GOVERNOR SIGNS 29 BILLS
Even though the Legislature

has not achieved its required, primary task — final passage of a state budget — one House bill and 28 Senate bills, as of May 15, had managed to survive the bicameral squeeze chute and earn the governor's signature.

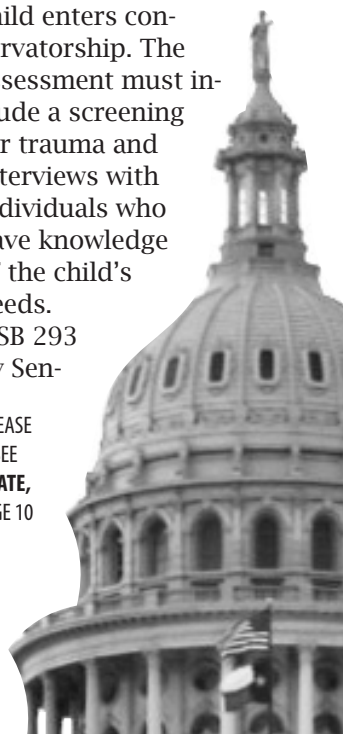
That lone House bill was HB 181 by primary author Rep. Cecil Bell, R-Magnolia, and joint author Rep. Matt Krause, R-Fort Worth. The bill, which took effect May 13, intends to reduce printing costs and the cost of correcting errors on individualized high school diplomas.

Here are three of this session's 28 successful Senate bills, beginning with SB 125 by Sen. Kel Seliger, R-Amarillo, and sponsored in the House by Rep. Dan Huberty, R-Houston. The legislation, effective Sept. 1, amends the Family Code to require the Depart-

ment of Family and Protective Services to conduct a developmentally appropriate assessment 45 days after a child enters conservatorship. The assessment must include a screening for trauma and interviews with individuals who have knowledge of the child's needs.

ASU summer music camps

Angelo State University's Department of Visual and Performing Arts has opened registration to its ASU Summer Music Camps, a redesigned program expanded to include strings and restricted to students entering seventh grade through recent high school graduates.

Two four-day camps will replace ASU's previous summer band camp program. The Color Guard, Drumline and Drum Majors Camp will run Thursday-Sunday, June 25-28. It will be followed by the Concert Band and Orchestra Camp Sunday-Thursday, June 28-July 2.

The fee for the Color Guard, Drumline and Drum Majors Camp is \$279, including housing in ASU's Centennial Village residence hall and meals, or \$176.50 for commuters. Registration for the Concert Band and Orchestra Camp is \$372 with housing and meals, or \$246.25 for commuters. The commuter fees include lunches and dinners. Private lessons will also be available at an additional cost. Junior high and high school music directors can register for a concurrent four-day program that will include a golf tournament, a barbecue and fellowship with other directors. In addition, all registrations completed on or before June 1 will receive a 10 percent discount.

Any student attending any portion of the camps must have been in a structured music program for at least one year and not have started college. During camp registration on June 28, students will perform a short audition piece to determine placement among the ensembles. The audition music may be found online at www.angelo.edu/content/files/18732-band-camp-audition-music.

Students attending the camps will choose two from among four focused courses: Rhythm Breakdown, Music Theory, Chamber Ensembles and Leadership Seminar. Each camp also will end with a public performance.

Celebrating 75 years of Soil and Water Conservation in Texas

TEMPLE - As the Texas State Soil and Water Conservation Board marks the end of its Diamond Jubilee celebration on May 29, it seems appropriate and fitting to say "Thank You" to all Texans.

We especially want to thank the Texas Legislature, a broad network of businesses, organizations and political entities for the support and trust that has been granted to our agency and the 216 soil and water conservation districts in Texas as we administer and implement the state's soil and water conservation laws and programs.

We do not take our responsibilities lightly.

The mission of the Texas State Soil and Water Conservation Board, working in conjunction with local soil and water conservation districts, is to encourage and promote the wise and productive use of natural resources through voluntary incentive conservation programs developed and carried out at the local level; in other words, local needs met by local people.

Brought on by the effects that the Dust Bowl had on our nation, there was a dire need to introduce innovative conservation programs across the nation.

Out of this adversity came some hope, in the form of V.C. Marshall, a dedicated conservationist enlisted by his peers to lead the effort in working to develop a sustainable state

conservation law for Texas.

Through Mr. Marshall's commitment, leadership, and foresight, he was able to pull together agricultural producers from across the state to work cooperatively to develop a program for Texans with a goal of preserving and sustaining our agricultural lands into the distant future.

It took some time, but all were committed and ultimately developed a working program that is still administered at the local level by local agricultural producers, through the formation of local soil and water conservation districts.

All soil and water conservation programs are voluntary and focus on helping producers conserve their soil and water resources for the betterment of the state.

Due to Mr. Marshall's excellent leadership, today there are 216 active soil and water conservation districts in Texas that provide for the soil and water conservation needs of their producers.

Currently, most of the state's farm, ranch, and timberlands are enrolled in some type of conservation plan that was developed by their local soil and water conservation district.

Conservation plans are voluntarily developed by landowners in cooperation with their local soil and water conservation district.

All individual conservation plans are developed based on science for the purpose of treating each acre according to its specific needs.

In addition, through local conservation planning and programs, all Texans can be assured that the quality and quantity of the state's water resources are being cared for by the primary stewards of the land, who as we know, are the agricultural producers.

It is they that provide the food, fiber and other renewable natural resources for the welfare of all.

As we look to the future, we must never forget the only reason the Texas State Soil and Water Conservation Board exists is because of the great work of Texas's 216 soil and water conservation districts.

And the only reason the soil and water conservation districts exist is because of local farmers and ranchers who formed them for the purpose of receiving assistance to develop and apply conservation programs on individual farms and ranches.

With our rich 75 year heritage in mind, we look forward to the future in providing programs and services through local soil and water conservation districts.

A tried and true delivery system which is so necessary to protecting the state's soil, water and related natural resources to insure a vibrant and stable economy, as well as a healthy environment for all Texans.

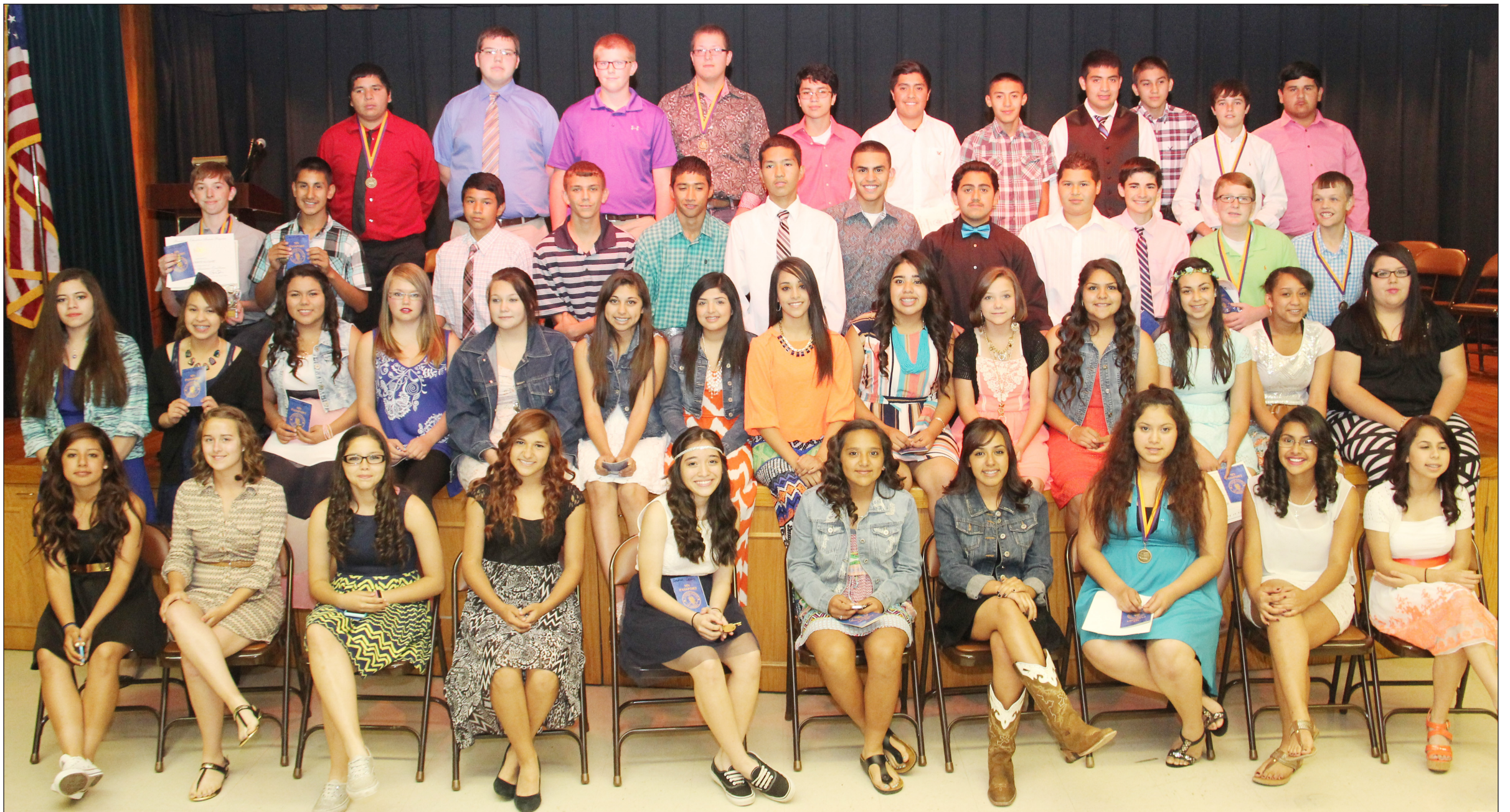

Moses, Rodriguez shine at state track meet

McKenna Moses and Omero Rodriguez brought home silver medals from the UIL State Track & Field meet over the weekend.

Moses was looking forward to defending her state title Friday in the 2A pole vault competition.

The Lady Lions junior, who won the crown by clearing 11 feet a year ago, found herself caught in a head-to-head battle with Hico's Sophie Morrow.

The duo energized the crowd by going back and forth with first-attempt clearances at 11-3 and 11-6 before Moses found trouble at 11-9.

After three missed attempts, Moses claimed the silver medal and Morrow cleared 11-9 for the gold.

"It was a great battle and I was glad it was against Sophie because she's a great competitor," Moses said. "It was good to have someone push me this year."

The 2A pole vault was moved from 1 p.m. to 7 p.m. due to inclement weather earlier in the day.

Unfortunately, Moses did not have the same type of success in high jump as she was unable to clear the initial 5-foot threshold in three attempts and was assessed a no height for the event.

Moses also ran the 1600 on Saturday placing fifth with a time of 5:48.69.

Rodriguez never made excuses, despite the sharp pain in his leg.

The Lions senior distance runner injured his calf earlier in the year, and although he

Big Lake Commissioner killed in local accident

Buddy Poynor, a life-long Big Lake resident and first term Reagan County Commissioner, was killed Sunday, May 17, 2015, in a one vehicle accident near the Crockett, Val Verde County line.

According to reports, the accident occurred at about 1 p.m. approximately one mile south of the Val Verde County line on State Highway 163. It is said that Poynor's motorcycle left the roadway on a curve.

Poynor took office as the Reagan County Commissioner for Precinct 2 just over four months ago.

"He had the biggest heart of anyone I know," County Judge Larry Isom said. "You can't replace a person like that in a community."

While Poynor's work as a commissioner was just beginning, he may be better known for his work as a pilot with

the Angel Flight Network.

During his career, Poynor flew 115 missions (345 hours) for Angel Flight carrying children and adults to doctor appointments across the state and region for free.

"During the same time period most pilots would do five to 10 missions," Shireen Pitasi, mission director for Angel Flight said. "He was a one in a million person. If we were in a pinch he would always step up. Even if that meant flying three days in a row."

Isom said that his love for people in Big Lake and Reagan County extended beyond his airplane.

"He was very humble," Isom said. "He touched countless lives in Reagan County, and did selfless things for people in need that no one will ever know about."

Poynor's death leaves a vacancy on the Reagan County Commissioners Court. Under Texas law, it will be County Judge Isom's job to appoint someone to the position.

The Wildcat expects that process to be outlined after Poynor's funeral which is set for Thursday, May 21 at 2 p.m. at Big Lake's First Baptist Church.

Game Warden Field Notes

COMPILED FROM TEXAS PARKS AND WILDLIFE DEPARTMENT LAW ENFORCEMENT REPORTS.

NO FISH TANK LICENSE

While patrolling Toledo Bend, a Newton County game warden observed a fish tank in a truck with displaying commercial markings required for selling aquatic products. Upon further investigation, the warden could find no matching valid license for selling bait. The warden issued the man a citation and the case is pending.

GONE NET FISHING

Two Freestone County game wardens patrolling Richland-Chambers Reservoir encountered three individuals

collecting firewood a little distance from their car on a county road near the lake. The wardens made contact with the individuals and saw several open containers of alcohol in their car. The individuals took the wardens back to their fish camp, where one warden found several game fish with no hook marks in their mouths. After further questioning, the individuals said they caught the fish in their nets. One warden found two cast nets. Cases are pending.

DON'T TAKE MORE THAN YOUR FILL

A Cherokee County game warden seized 18 hybrid striped bass from two individuals fishing below the spillway at Lake Palestine. The warden, who had dealt with both individuals before concerning fishing violations, had already checked both individuals that morning and found that they had each already reached their hybrid bass bag limit for the day. Cases are pending.

NO MORE CATFISH FOR YOU

A Polk County game warden patrolling the Trinity River below the Lake Livingston Dam found two individuals who had exceeded the daily bag limit for blue catfish by 26 fish. Several cases and civil restitution are pending.

ate Finance Chair Nelson and sponsored in the House by Rep. Jason Isaac, R-Dripping Springs. The legislation, which took effect April 8, amends state statutes to expand the definition of "site selection organization" for purposes of selecting a site in Texas for certain events that are eligible to receive funding from the major events trust fund, to include ESPN or an affiliate, NASCAR and the Ultimate Fighting Championship.

SB 835 by Sen. Van Taylor, R-Plano, addresses those who make fraudulent claims of military service. The legisla-

tion, effective Sept. 1, amends the Penal Code to increase the penalty for the offense of fraudulent or fictitious military record from a Class C misdemeanor to a Class B misdemeanor. A Class B misdemeanor is punishable by a fine of not more than \$2,000, confinement in jail for a term not to exceed 180 days, or both.

SCHOOL FINANCE BILL FIZZLES

Bill movement deadlines hit the Legislature last week. For example, during House floor debates on May 14, House Education Committee Chair Jimmie Don Aycok, R-Killeen, pulled down his school finance reform bill when it became clear that opposition to it would drag on long enough to prevent consideration of a mountain of other bills.

"Like many of you — I have other bills on this calendar — bills that are important. We could kill all day with this bill, easily," Aycok said.

In its 24 pages, HB 1759 addresses a range of issues, with language amending laws governing equalization of wealth level of school districts, taxation and funding formulas, transportation allotments, academic acceptability standards and consequences, and more.

Deciding such high stakes issues defaults to the courts when the Legislature does not act on them. A case brought by some 600 Texas school districts alleging unfairness in the state's law funding public education was decided in the school districts' favor by a Travis County state district court last August. The State of Texas appealed the ruling to the Texas Supreme Court. The case is pending.

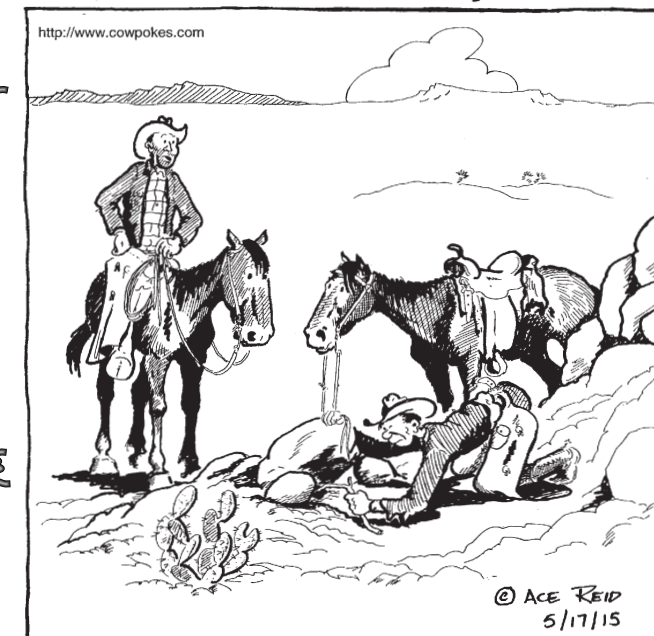
