Candidate forum set for Feb. 22

Crockett County Voters will have lots of choices in this year's upcoming March 1 Primary Election.

A public forum sponsored by the Knights of Columbus and the Crockett County Democratic and Republican Parties will be held at 6 p.m. Monday, Feb. 22, at the Civic Center.

The candidates running for positions in the March 1 Primary Election will be available to meet with the public and answer questions at that time.

Early voting begins Feb. 16 and ends Feb. 26 at the courthouse annex. Hours will be 8 a.m.-5 p.m. Monday-Friday.

The primary election day voting will be 7 a.m.-7 p.m. March 1. Polling locations are: Precinct 1 - Crockett County Courthouse Annex in the commissioners' courtroom; Precinct 2 - Crockett County Senior Center; Precinct 3 – Crockett County Civic Center; Precinct 4 – Ozona Chamber of Commerce Visitor Center.

In order to vote in per-



son, voters must show a form of photo identification. Acceptable forms of photo ID are: Texas driver license, Texas Election Identification Certificate issued by DPS, Texas personal identification card issued by DPS, Texas license to carry a handgun, U.S. military identification card containing the person's photograph, U.S. citizenship certificate containing the person's photograph or U.S. passport.

Texas Election Identification Certificates are available for any DPS driver license office, including the one in Ozona located by the Ozona Chamber of Commerce Visitor Center. Texas Election Identification Certificates are issued free of charge.

To vote by mail, apply by Feb. 19 in the Crockett County Clerk's Office in the courthouse annex. Mail-in votes must be received by 7 p.m. on election day or five days after for those voting outside the United States.

Those eligible to vote by mail include those who will be away from the country on election day and during early voting, who are sick or disabled, 65 years of age or older on election day or are confined in jail but still eligible to vote.

UIL REALIGNMENT 2016-2018 Lions district has few changes

For the next two years, the Ozona Lions will be facing familiar opponents.

At Monday's revealing of the 2016-2018 University Interscholastic League District Realignment, Ozona was placed in District 3-2A Division 1 with Christoval, Eldorado, McCamey and Anthony.

This district is similar to what the Lions have been in last year and this year. Eldorado moved up from Division II and replaced Forsan who was placed in District 4-2A Division I with Anson, Hawley, Post and Stamford.

The Lions will still have to make the 367-mile trip to Anthony, which is located on the other side of El Paso.

The UIL released conference cutoff numbers for the 2016-2018 reclassification and realignment in November, giving schools a heads up as to where they might fall.

Ozona High School submitted an enrollment of 204 students. Class 2A Division 1 football numbers range from 158-220. Class 2A has 203 schools overall.

"It's about what I expected. I think it's going to be a good competitive district for us. Hopefully we will get in the playoffs and be district champions, depending on how hard we

work this summer. I was quite surprised they pulled Forsan out moved them to a north district," said Athletic Director Edward Perez.

Perez said non-district football opponents will be Sonora, Iraan, Crane, Grape Creek, Reagan County and Rocksprings.

Also announced Monday was the new basketball districts.

Once again, Ozona's district is similar with Christoval, Eldorado, Forsan, Irion County, Miles and Winters.

Iraan and McCamey, current district opponents, were placed in District 6-2A with Anthony, El Paso Da Vinci, Van Horn, Fort Hancock and Wink.

The UIL will release spring meet and other athletic district alignments no later than April 15.

Lots of traps on Texas primary election ballots

his year's Texas primary ballots offer plenty of pitfalls for inattentive voters

As a result, some of the unlikeliest candidates lurking below the presidential races on ballots might be taking their oaths of office in a little less than a year.

That's especially true in the so-called low-information contests, where voters know a little bit less about the candidates and pay a little less attention to the difference between familiar names and those that just sound familiar.

Two Christians want to regulate oil and gas, along with a few others who adhere to the Christian faith but don't carry that last name. Wavne Christian. who was in the Republican primary for a seat on the commission in 2014, is among the seven candidates in that primary this year. So is the lesser-known Lance Christian.

The name thing isn't limited to that; in one of three



animal rightists who get ill just thinking about all the despicable things we do to our animals to keep them healthy and safe. PETA and their ilk want you to treat your cattle like humans. No, on second thought, they want you to treat your animals better than the typical human in need of medical care at the ER. Which is not that high of a standard really. Here's how I see a typical branding 20

years from now. A USDA inspector will be on hand to insure that there will be no ear notching, hot iron branding, mugging, dehorning, wrestling, or roping. Which explains why all the neighbors stayed home. Instead of calves being roped a bunch of twelve year old computer geeks will sit in comfort back at the ranch headquarters maneuvering drones over calves and gently dropping soft nets over them. A GPS will automatically inform

the medical team of the calf's location. The surgical team will consist of the following: an anesthetist, surgical veterinarian, nurse, vet tech, cowboy A, cowboy B, an ambulance driver and two PCRA certified rodeo clowns. (Not to be confused with USDA or EPA clowns.) All participants by law must be gowned and wear sterile gloves. When the mobile bovine hospital reaches the calf two cowboy paramedics wearing those cute little booties that doctors wear over their \$1,500 shoes will jumr out of the ambulance to gently retrieve the

calf from its net. They will attempt to place the calf in the sterile surgical theater in the ambulance, without the calf's mother killing them. This is where the PRCA clowns come into play. If the calf's mom displays extreme anti-social behavior it's the clown's job to distract the crazy cow long enough so that Cowboy A and Cowboy B can transport the calf in a loving manner without being gored or trampled to death.

Once in the surgical theater the anesthesiologist will swab the injection site with a topical pain killer so that the calf will not feel the anesthesiologist's needle. To reduce separation anxiety the back of the ambulance will open so that the cow can be in contact with her calf during the medical procedure. Should the cow attempt to climb into the ambulance it is the job of any surviving cowboy or clown to persuade her otherwise, without the use of a whip, rope or paddle. Should any cow persist it will be the duty of the USDA observer to call a "timeout", releasing the drugged calf to her stressed out mother and thereby gaining a permanent exemption.

After the sterile draping is in place and the calf's effected area should be cleaned then the surgical team will perform a castration or a spaying of the heifer. The vet will also administer all shots and implant a computer chip with a mandatory USDA 32 digit password. All incisions will be closed by the surgeon so that the calf will not be self conscious about his or her scar. This is especially important with heifer calves. Finally, since ranchers need some visible sign of ownership so they won't accidentally eat their own beef instead of the neighbor's, a freeze brand will be applied. White calves will be excused.

At the end of the branding instead of the traditional beef barbecue we'll see Cowboy A hanging on for dear life at the top of a Joshua tree preferring the three inch spines to the 12 inch horns of the mad momma down below. The USDA inspector and any third party observers will be locked in the front of the ambulance with all the windows rolled up, the doors locked and quivering like a leaf in a 30 mph gust. The two PRCA clowns will be running around the ambulance with a witchy cow in close pursuit.

Meanwhile, the calves that are scattered all over the ranch will be waking up from their long naps and any human survivors that are still mobile will head down to the hospital where Cowboy B was medivacced in a Life Flight helicopter. The cowboy crowd will stand vigil until he dies from his wounds or comes out of his coma.

Any costs not covered by Medicalf will be borne by the rancher. (Typically \$35,000 per calf.)

That said, the political maps drawn by lawmakers and the courts effectively protect the interests of incumbents and parties and limit voters' ability to make their

races for the Texas Supreme Court, former state Rep. Rick Green is challenging incumbent Justice Paul Green for a six-year term. And while the Green Party's candidates are not yet nominated, they might add to the muddle.

The ballot is full of rematches and things that look like rematches, incumbents, and names that sound like incumbents'. You'll find a Ray Hall in the Republican race for the state's 4th Congressional District. He might benefit from the 34-year tenure of Ralph Hall, defeated in the same primary and sent home two years ago. Can voters used to casting ballots for a Hall tell one Hall from another?

In the adjacent 3rd Congressional District, challengers are trying to do to Sam Johnson what John Ratcliffe did to Hall two years ago — knock off a long-time incumbent who is getting on in years. This sort of political grave-dancing is not unusual; the idea is that the challenger either wins or makes their name known for a later election — after the incumbent quits. Or dies. It's worth saying that the strategy fails more often than not. How strong is redistricting? That is really a question for the general election in November, but here's a

whom a North Texas lake is named — is challenging Supreme Court Justice Eva Guzman. If their names are only dimly known to voters, as is common in statewide judicial races, this one will test two bits of conventional wisdom. Do women outperform men on ballots? Do Texas Republicans favor Anglicized names over Hispanic names?

One Democratic Senate primary in San Antonio features an incumbent, Carlos Uresti, being challenged by Helen Madla, the widow of the senator Uresti defeated in a primary in 2006.

Many of those races probably will turn on campaign events and issues and the expertise of the candidates and their crews. But some might just fall victim to caprice.

If you believe voters know everything they need to know about every race in which they cast their votes, there is nothing to worry about. If you believe, on the other hand, that some voters rely on hunches, faulty memories and other hocus-pocus, then little things names and whatnot – could make all the difference.

Not all Christians are the same. Or Greens.

TxDOT awaits go-ahead signal for gridlock-reducing projects

AUSTIN — The Texas Department of Transportation on Jan. 27 reported that on average, Texas drivers in five of the state's largest metropolitan areas lose about 52 hours and \$1,200 annually due to traffic congestion.

Upon approval by its oversight body, the Texas Transportation Commission, TxDOT plans to improve drive times and reduce costs through what it calls an accelerated \$1.3 billion effort addressing gridlock in some of the state's most congested areas.

"The major metro areas of Texas — Austin, Dallas, Fort Worth, Houston and San Antonio —represent more than two-thirds of the state's population and 97 percent of the state's most congested roads," said Texas Transportation Commissioner J. Bruce Bugg Jr.

the nation. We've just completed a listening tour in these major areas and have gathered valuable local input from transportation leaders regarding their priorities and where we can quickly address some needs. This is the initial phase of a new statewide plan to address congestion," he said.

If adopted, these metro area projects will begin construction to enhance existing efforts and address gridlock on the state highway system. The projects, which add up to more than 42 miles, include interchanges, flyovers and congestion relief efforts at some of the state's worst choke points. They will be funded using \$1.3 billion made available through ending the use of diversions of highway money by other agencies, according to TxDOT.

"For years we've been committed to addressing congestion, and this year we're getting a jumpstart on that part of our core mission," said **TxDOT Executive Director** James Bass. "As the severity of congestion in the Lone Star State continues to grow, we are committed to delivering projects many Texans need and deserve to reduce the amount of time they spend in traffic."

The Texas Transportation Commission also will consider another \$800 million in additional funding for connectivity and safety, maintenance, repairs to the energy sector and border infrastructure funding. The commission is expected to vote on all these projects when it considers the quarterly Unified Transportation Plan at its monthly meeting on Feb. 25.

Is the food you eat killing your brain?


There is a misconception that our brains need glucose to function, 125 grams to be exact. Conversely, apart from some basic metabolic bodily functions that need glucose exclusively, the human body can use either glucose or ketones (derived from the consumption of fatty acids instead of sugar) for energy.

"...in fact, glucose is nowhere near as efficient as ketone bodies. Provided you eat enough protein, your body can produce glucose for its basic metabolic functions on demand via a process called gluconeogenesis, in which it transforms non-carbohydrate sources, such as amino acids (proteins) and fatty acids (fats), into glucose.' Slajerova, Martina (2015-12-01). The Keto Diet Cookbook: More Than 150 Delicious Low-Carb, High-Fat Recipes for Maximum Weight Loss and Improved Health.

Contrary to what many health authorities have led us to believe, cholesterol is vitally important for brain function and statins are detrimental to brain health. While the brain represents about 2-3% of our total body weight, our brains are comprised of about 25% of the cholesterol in our body and is localized in the brain as myelin, separate and apart from the lipoprotein cholesterol in the body. In the brain. it plays an important role in membrane function and acts as an antioxidant. Additionally, it is the raw material from which progesterone, estrogen, cortisol, testosterone, vitamin D and other hormones are made.

In fact, in a recent study available on the NIH Public Access site, researchers showed the best memory function in the elderly was those with the highest levels of cholesterol. Low cholesterol is associated with an increased risk for depression, stroke and even death. With this relatively new understanding of the role of cholesterol in brain function, it raises concerns in the recommendations for prescribing statin medications. Some estimates indicate the number of individuals taking statins to lower cholesterol may actually double within the next few years and this presents a major concern for brain health in the immediate future.

book that opened my eyes to the propaganda plaguing Americans regarding healthy eating and brain health. "Grain Brain", by Dr. David

Perlmutter, blew my mind (no pun intended) and caused me to rethink a lot of beliefs about what our bodies require for optimal health.

Then, in 2014, Perlmutter released his book, "Brain Maker" and this has turned what we thought we understood about brain health on its ear. I recommend both these books to anyone who is interested in their cognitive health.

"The brain thrives on a low-carbohydrate fat-rich, diet, which unfortunately is relatively uncommon in human populations today," he says.

"Cholesterol, for example, long vilified by the media and medical community, actually promotes neurogenesis (the birth of new brain cells) and communication between neurons, to the degree that studies have shown that higher levels of serum cholesterol correlates to more robust cognitive prowess." Says Max Lugavere, "The Optimalist" in his article, "Your "Healthy" Diet Could Be Quietly Killing Your Brain".

The carbohydrates we always thought of as good for us; "healthy grains", brown rice, whole grain bread, or quinoa; consumed over a lifetime are linked to disorders like dementia, ADHD, autism, chronic headaches, and Alzheimer's; just to mention a few. The grains have been found to cause inflammation, the actual cause of problems with our brains and heart health. By increasing the amount of fat and cholesterol we eat daily, we can not only protect but potentially, undo years of damage. Here's to your health.

WHAT QUALIFIES YOU FOR THE POSITION YOU ARE RUNNING FOR?

I prepared income taxes throughout my time in college. When I graduated with my Master's Degree, I accepted an accounting position at Pioneer Natural Resources in Midland.
