Candidate For Land Office Is Tahoka Visitor

Wes Gilbreath, candidate for the Republican nomination for commissioner of the general land office, stopped in Tahoka Thursday afternoon on a vote-seeking tour of West Texas. Gilbreath, of Houston, was accompanied by his son, Brett.

A businessman with his own investment company, Gilbreath also is a former farmer and rancher, an accounting graduate of the University of Houston, a member of Lions and Elks clubs, founder of "the most listened to Christian radio station in America," a master electrician and founder of a heavy equipment construction company, and has been active in Harris County, statewide and national politics for the Republican Party. He also has been an overseas missionary worker and he and his wife, Pat, are parents and grandparents.

Gilbreath, opposed by two other Republicans for the nomination, directed most of his comments toward incumbent land commissioner Gary Mauro, who is unopposed for the Democratic nomination. He accused Mauro of repeated conflicts of interest and mismanagement of state funds in the operation of land programs in the state. "The general land office manages the leasing, development and revenue accounting of surface and mineral interests across the state. More than 22 million acres and ten billion dollars are under the guard of the land commissioner and the numerous boards he chairs," said Gilbreath.

Depend On 'Sis' For Property Data

Texas Tech Journalism Student Many changes have occurred through the years around the courthouse in Tahoka-but one consistency that can always be found downtown is Jerry Guin, the everpresent and ever-pleasant manager of the Lynn County Abstract Company located in the basement of the

courthouse. Mrs. Guin has been working at the abstract company since 1964, when she started working for Beulah Pridmore. Ten years later, Mrs. Pridmore retired from the business and Mrs. Guin became the manager of the company, leasing the business from Mrs. Pridmore. Mrs. Guin received her original training in the abstract business when she worked for three years at the Lamesa Abstract Company.

Mrs. Guin married Homer Guin on July 12, 1958 in Tahoka and they have two children, Tommy and Claudia. Guin is a retired field inspector for the Southwest Cattle Ranchers Association with whom he was employed for 23 years.

Mrs. Guin enjoys working in the abstract business and she says having the company located in the basement of the courthouse make the job a little more interesting.

After she graduated from high school, she had problems finding employment—as many people did at that time because of an extensive drought. So she did what she says seemed like a good idea, becoming a member of the United States Air Force. While most young women at this time period were husband-shopping, Mrs. Guin was employed by Uncle Sam from February 1952 through February 1955 as a secretary

at Maxwell Air Force Base in Montgomery, Ala., and Offitt Air Force Base in Omaha, Neb.

Mrs. Guin's duties at the abstract company consists of making copies of property titles, mainly for land, and supplying the copies to potential land and property buyers. Occasionally, she makes copies for oil companies, but this is not as common as it was in the past.

These copies are needed by prospective buyers to determine if the property or land titles are clear.

In fact, she can supply all the legal information on a specific property from the last 20 years. Mrs. Guin says her work is similar to being an inves-

Now, after nearly, three decades in the business, Mrs. Guin is looking forward to retirement so she can "do just whatever she wants". Retirement would give "Sis" and "Son" as the Guins are known by townsfolks, more time to spend on their five acres of land located just north of Tahoka.

Retirement would also give them more time to spend on their hobbies, watching television and taking care of their four horses.

FHA Banquet Held Feb. 13


The Tahoka Future Homemakers of America held their annual Sweetheart Banquet, Tuesday, Feb. 13, at the First Baptist Church in Tahoka.

Babysitting Clinic Planned By FHA

by the Tahoka chapter of Future Homemakers of America, from 5 to 7 p.m. Saturday, Feb. 24, in the Home Economics building at Tahoka High School.

The clinic is for girls in the fifth through ninth grades who want to start babysitting or who want to increase their chances of being employed to babysit, according to freshman Carrie Taylor, who is organizing the clinic.

More than 40 mothers of young children were asked to complete a survey about their children and their need for sitter.

"Many of the mothers said they would go out more if they knew who to call to babysit," Carrie said.

Clinic participants will view a video and a packet of materials, make a card file of mothers of young children who sometimes need babysitters, and receive a list of do's and don't's for babysitters, compiled by the participating mothers.

Participants also will get a meal of Mexican food.

"The unique thing about this clinic," said Carrie, "is that all of the participants will get their names placed on a list which will be mailed

A babysitting clinic is scheduled to at least 50 mothers of young children in this area. These mothers can use the list to help them find babysitters."





It would be most difficult to conjure up fictional characters that would exceed the escapades of our local personalities of past days. Tahoka, not always bustling with activity, relied somewhat on its innovative pranksters with a sense of humor to enliven the community. Not all comedy was pre-conceived, but often a result of individuals who were, to say the least, "unusual." Homespun humor did contribute a feeling of intimacy to our commu-

The local post office crew was startled on one occasion to see a postal patron riding his horse into the post office lobby to get his mail. Then there was this customer waiting impatiently for his very special golf club order. When it finally arrived, the package was taken to the local coffee shop by the proud owner to allow friends and fellow golfers to see the new club. To his amazement, when the package was opened it contained not a golf club, but a large mesquite limb contoured somewhat like a driver. Culprits were soon identified.

An order for a pair of shoes from Neiman Marcus prompted a local woman to inquire repeatedly as to whether her shoes had arrived. When the package came at last, she smilingly agreed to open the box for the postal crew to admire the new shoes. A pair of run-down large sized men's shoes emerged from beneath the tissue paper, the right shoe having a hole to accommodate a corn, and the left with an opening to release a sizable bunion. (When new shoes were purchased from the next door Cobb's Department Store, sometimes the old ones were left in the store, and somehow this pair found its way into the Neiman Marcus box.)

There was a record high jump and select choice of words as one extremely excitable native reached into his mail box and encountered a small snake instead of a letter from "Aunt Maude".....Now should an informant feel it his moral duty to expose these federal violators, they are all deceased. But to compensate for these dastardly acts, no few accommodations were performed. On special occasions such as Christmas and Mother's Day, packages arriving too late to be picked up at the post office were gladly delivered to the recipients. And when bad weather was unsuitable for the elderly to get out, they often heard a knock on their front door and received special delivery of their mail.

An aged woman on a rural route left a note in her mail box, requesting the carrier to pick up a hat she had long admired at Robinson's Readyto-Wear which was now advertised for sale. It was easily identified by her descriptive note—a pink hat with guinea feathers. Duly gift-wrapped, the hat was delivered at Christmas.

Bridegrooms were sure-fire targets for local pranksters. Chaining the recent groom to the Main Street fire plug to sell a given amount of toilet tissue was a standard treatment. Another common ordeal for the unfortunate newly-wed was to be driven several miles from town, stripped of outer clothing, and be obliged to walk back to town. He rarely was able to catch a ride.

A local man brought his bride home from New York, where she was employed as a nurse, never having lived anywhere except the East. She became enthralled with the "Wild West" immediately and made every effort to adjust to our customers. "Drop-in" company, expecting to dine, was ordinary in those days. This eastern lady's two brothers-inlaw appeared one morning with a "mess" of mesquite beans, requesting that she cook them for supper, and stating they would be back. Half the day was spent trying to shell them, and the remaining daylight hours trying to cook those inedibles. She was later victimized into cooking a sand-hill crane (declared to be a goose), which was brought in by a

It would be difficult to imagine a local female character who changed her attractive appearance into a most unsightly hick-town individual, unless one witnessed her transformation and performance. The local dentist obliged by making a set of buck teeth that literally changed her facial features. She also acquired a wardrobe befitting the character she portrayed. Appearing unexpectedly at formal wedding rehearsal dinners or proper occasions with prominent guests was her specialty. The claim that she was a cousin of the host or perhaps a member of the party preceded the information that she had just arrived on the bus. Gaping, embarrassed guests attempting to be nonchalant and cordial were the results of her invasion. Many local people, too, were unable to identify her. You had to be there!

The traffic light just installed on Main Street didn't deter one elderly gentleman from driving right through, red or green. Accosted by the local law officer, he stated in no uncertain terms that he had arrived in Tahoka long before that light was erected, so he'd just drive as he al-

There were several members of one family that were reputed to be quite absent-minded in regard to trivial matters. One day the bank got a call requesting that someone step outside and check on the car the caller had parked at the bank to see if he had left the motor running. They checked. It was. The man had called from O'Donnell where he had casually ridden down with a friend, forgetting all about his own car.

The same man and his brother were driving from Post when they

suspected they had a low, if not flat, tire. The driver suggested that his brother check the tire, and the absentminded passenger just stepped right out while the car was chugging down the road. He rolled over several times, and when the driver stopped the car and backed up he said reprovingly, "Why, brother, you could get hurt doing that!"

In the very early days of this community when the town had basically only one street, a man and wife each owned a new auto- practically the only cars in town. They ran into each

A most conservative couple—the husband particularly so- had argued over and over as to the need of buying new curtains. One day the husband came in, and seeing curtains of a different color, inquired, "Ma, did you 'Rit' the curtains?" "Yeah," she replied, "I writ a check for them."

The family soon noticed that every time it rained, this individual reached for his shotgun and proceded outside. 



8.56 cents per pound. leaving a balance of 4.54 to be paid in cash.

Because the 1989 calendar year national average market price of 60.3 cents per pound is above the loan rate of 50 cents per pound, the deficiency payment rate is the difference between the target price of 73.4 cents per pound and the national average market price.

Seafood And Coronary Diseases

You may have been brought up on the cld adage that "fish is brain food." Current research indicates that more nutritionally smart people are increasing the amount of seafood in their diets, both to stay in shape and to reduce the risk of coronary disease. Three major areas of concern are calories, fat content and sodium

Americans are becoming increasingly concerned about fats in their diets, and well they should be, since coronary heart disease accounts for approximately 50 percent of all

Economist Says Cotton Farmers Face 5 Key Issues In '90 Farm Bill

sible provisions in the 1990 federal farm bill, and cotton producers should watch proposals which could affect five major issues, an agricultural economist with the Texas Agricultural Extension Service says.

The 1985 farm bill, as a whole, did what most of the involved parties wanted it to do and will act as a base for the 1990 legislation, said Stan Bevers, extension economist here. He made prediction during meetings conducted at Anson and Vernon by the Extension Service and the Texas Agricultural Experiment Station to update Rolling Plains cotton produc-

News stories already indicate the new farm bill will probably address such things as market orientation, budget balancing under the Gramm-Rudman-Hollins Bill, environmental concerns, flexibility of base acres in commodity support programs and international competitiveness, Bevers said.

Marketing loans will be one of the major issues for cotton farmers, Bevers said. "Specifically, for cotton, we have to find ways to improve the marketing loan," he said. The marketing loan is based on the international price and is designed to make U.S. cotton competitive in the world market.

The second issue, Bevers said, is to find ways to reduce the adverse impact of supply management strategies on agribusiness, the consumer and rural communities. "For the most part the government hasn't managed the supply of stocks the way it should

Cotton farmers' third concern, the economist said, is for the new farm bill to find ways to reduce costs while maintaining price and income support at a politically acceptable level.

Environmental concerns, including pesticide use, is a fourth area of the new bill of vital interest to cotton growers, Bevers said.

"The last thing, we're going to have to increase flexibility in planting, thereby allowing producers to respond to market-allocating signals," Bevers said. That means allowing flexible base acres in crop support programs, he said.

"If we've got so many acres in cotton, and we decide that the wheat market looks more attractive to us than cotton does at this point, is there a program that will allow use the flexibility to change our base acres from cotton to wheat?"

It's a good idea that could work, but would be difficult to police and very difficult to administer, the extension economist said.

of heart attacks. The higher the fat level of the fish, the better its effects on lowering cholesterol. Fish such as tuna, salmon and herring actually do a better job than leaner fish. Mackerel is probably the best source of desirable polyunsaturated. These fish contain large amounts of eicosapentanoic acid (EPA) and docosahexaenoic acid (DHA), the fatty acids that seem to be most effective in reducing the risk of heart at-

Fish and seafoods are high in proteins and yet are very low in calories. A 100-gram (3-1/2 ounce) portion of lean fish such as cod or haddock contains about 80 calories, while the same portion of a high-fat fish such as bluefish or mullet contains about 120 calories.
