Billie Hoskins of Tahoka was honored as the Outstanding Conservation Homemaker for her outstanding contributions to the Texas Soil & Water Conservation Program at the Region 1 Awards banquet on May 7. The banquet was held at 7 p.m. at Wayland Baptist University in Plainview.

The purpose of the awards program is to recognize and honor a soil and water conservation district and individual who have dedicated their efforts and talents to making wise use of renewable natural resources.

Mrs. Hoskins' contributions to conservation include helping out with the farming operations, by hoeing cotton, filling up planter boxes with cotton seed and moving the tractor from one place to another. Jack and Billie own and operate 480 acres and an additional 1300 acres which are leased out to their son and son-in-law.

They also own 160 acres of pasture land where they keep horses, cows, and calves. In pens in the back of their home they have some pigs and chickens. Up until a few years ago she made her own lard, sausage, and lye soap. She also gathered eggs from her chickens and sold them to people in town.

Billie has a large garden each year

where she grows tomatoes, okra, peas, squash, cucumbers, cantaloupes, and watermelons. Most of these vegetables are frozen or canned to be used during the winter months.

As a hobby, Billie enjoys refinishing old furniture, embroidery, and working in the yard.

## New Computer System Okayed For Tahoka Elementary School

Tahoka I.S.D. trustees met in regular session Tuesday night, swearing in new board members and giving the okay to purchase a new computer system for the elementary school, among other business.

The board, superintendent Dr. Duane Carter, and administrators met for a dinner before the meeting, prepared and served by the Home Economics teachers. Outgoing board members Thalia Burks and Nedra Young were praised for their efforts in serving on the board, and new members Mike Huffaker and Juanell Jones were welcomed to the board. Outgoing board member Richard Lopez was not present, and prospective board members Greg Henley and Mike Rivas, who are in a runoff election on June 1, were also welcomed to the dinner and meeting.

Board members and administration convened at 7:30 p.m. in the Learning Resources Center, and administered the oath of office to Huffaker and Mrs. Jones, followed by the election of officers. Delbert McCleskey was re-elected to the office of president, Gary McCord was named vice president, and Clint Gardner was named secretary of the board. Mrs. Jones was designated as the 1991 delegate to the TASSB Convention in Houston, which will be

held in September.

A new computer system for Tahoka Elementary was discussed, and board members voted unanimously to okay the purchase of an Integrated Learning System which will provide 30 IBM computer stations for use in the educational program of students in grades 2-6. The system will provide a means of individualizing an instructional program for each student in second through sixth grade, with every student provided an opportunity to work 30 minutes each school day on the system, and chapter students given an additional 30 minutes of instruction each day.

The Integrated Learning System comes with a price tag of about \$137,000, which will be funded over a three-year period, with partial funding through Chapter 1 and Technology Funds. The computer lab will be ready for use on the first day of the 1991-92 school year, and will be open from 8 a.m. until 3:30 p.m. each day. Dr. Carter estimated that with 30 computer stations, and 15 sessions per day for 300 students, the computer slots per day would be 450, at a cost of 62-cents per student per session.

This plan is based on a three year span. However, the District expects

the system to last longer than three years, and it will be updated each year.

The program is designed for grades 2-8, so the District could add a Jr. High lab in the future or additional programs could be added for adult education classes.

The hiring of three new teachers was unanimously approved by the board, with Diane Gregory and Sharilyn Ann Vernon employed as elementary teachers, and David Lyn Johnson employed as assistant coach/teacher for the high school. The board approved assignment of Nancy Kirkland from half day to full day.

Resignations of Speech Therapist Denise Huezco and teaching assistant Rachel Vega were accepted by the board, and trustees had a first reading of district policies. After a report on revised sex education guidelines and the superintendent's report, the meeting was adjourned at 1 a.m.

Present at the meeting were board members McCleskey, McCord, Clint Gardner, Brad Hammonds, Huffaker and Mrs. Jones, prospective board members Henley and Rivas, Dr. Carter, high school principal Charles Cate, assistant principal Mike Smith, elementary principal Molly Helminger, assistant to the superintendent Minnie Lou Ash, and bookkeeper Loretta Tekell.

## THS Graduate Writes Award-Winning Story

Danette Baker's article, headlined "Records show stocks bought before approval" in the Oct. 17, 1990 edition of The Prairie, West Texas State University's student newspaper, did more than break a story envied by most major Texas newspaper reporters. It also captured the attention of judges responsible for selecting recipients of the Roy W. Howard Award for Public Affairs Reporting.

Mrs. Baker, a 27-year-old senior journalism major, was one of ten student reporters selected for the nationwide award and one of five selected in the words-only category. Other winners were Elizabeth Landini, Murray State University; Marietta Nelson, Iowa State University; Jeff Ostrowski, University of Illinois; and Julie Rausch, Wichita State University. Five others won in the words-and-pictures category.

Each will receive \$1,000 and an all-expense paid trip to attend a public affairs reporting seminar Sept. 16-17 in Bloomington, Ind. The contest and the seminar are sponsored by the Indiana University School of Jour-

nalism and the Scripps Howard Foundation.

"This is one of the most prestigious awards available to a journalism student," Rick Carpenter, WTSU journalism instructor and student publication faculty sponsor, said. "Danette did a heck of a job investigating and writing a very difficult story. We are very excited and proud of her."

Mrs. Baker's award-winning article, according to Carpenter, revealed that in November 1987, WTSU officials purchased almost \$500,000 worth of Mesa Limited Partnership stock prior to depositing and endowment check donated to the University by Mesa and T. Boone Pickens.

The former Danette Phillips, daughter of Mr. and Mrs. J.W. Phillips of Tahoka, graduated from Tahoka High School in 1982. In high school she was employed by the Lynn County News. She graduated from South Plains College in Levelland in 1987. She currently lives in Dimmitt with her husband John and two-year-old daughter Brynna.

## County Youth Qualify For District 4-H Contest

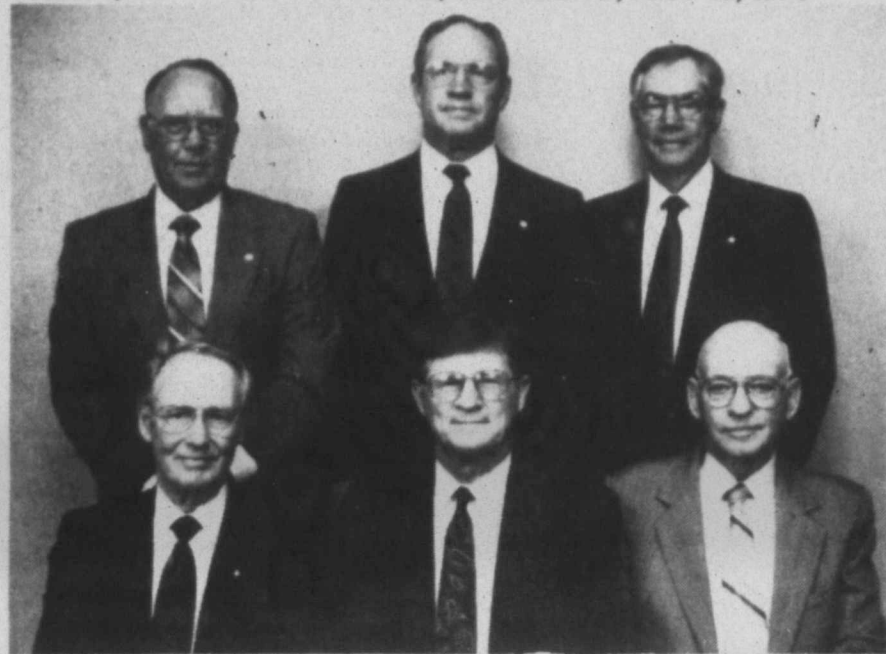

**New Home Loan Program Announced**

The Farmers Home Administration (FmHA) has implemented a new program to assist rural residents to become successful home owners. In addition to its direct housing loan program, the federal agency is now authorized to guarantee commercial loans to purchase single-family housing. "This expands our ability to provide financing for homes in rural areas," notes FmHA State Director Sox Johnson. Under the new program, FmHA guarantees a loan made by a qualified lender against a percentage of possible loss. Loans may be made by any lender, including state housing agencies, which is approved as a mortgage for federal housing mortgage insurance. Additionally, lenders approved by FmHA, the Federal National Mortgage Assn. (Fannie Mae) or the Farm Credit System may qualify for the program. FmHA is authorized to guarantee up to \$100 million in loans for single-family homes during the current fiscal year. This assistance is available for new or existing rural housing, located on individual tracts or in subdivisions, according to the State Director.

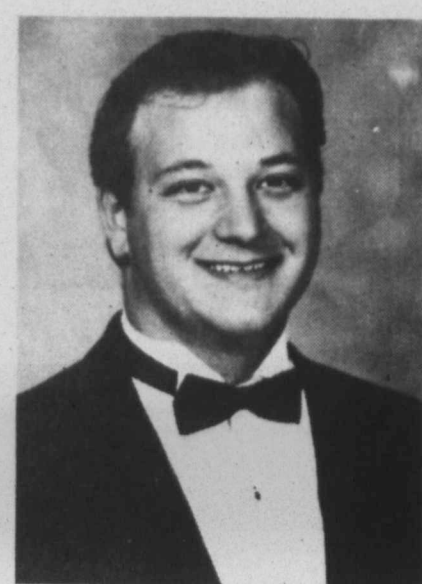
