
## **Community Thanksgiving Dinner Is Sunday Evening**

The Ministerial Association of Tahoka is sponsoring a free Community Thanksgiving Dinner Sunday, Nov. 22 from 5:00-7:00 p.m. in the Tahoka School Cafeteria.

"This dinner is open to anyone in the community who wishes to come and eat," a spokesman for the Ministerial Association stated. "There will be no food served on a carry-out basis, so we encourage families to come to the cafeteria to eat with their friends and neighbors in the community. We hope that eating a Thanksgiving meal together will remind us that though we may have differences that divide us. there is much more that unites us."

Meals will be delivered earlier to shut-ins by prior arrangement.

Although the dinner is free, donations of canned goods or dried beans or rice will be accepted for the local food bank which is administered by the Tahoka Church of Christ.

# **Defense Objection Delays Hearing On Co. Attorney**

It took only a couple of minutes for the hearing on County Attorney Jimmy Wright to skid to a halt, when the defense attorney objected to the assignment of a visiting judge on the case. The objection was sustained and the proceedings were over, before any opening statements or evidence was presented.

The delaying tactic means that the hearing will be rescheduled (the date was not yet known as of press time, but the prosecuting attorney told The News that he had requested either Monday or Tuesday of next week) and a new judge will be appointed to hear the case which seeks to remove the Lynn County Attorney from office on grounds of incompetency and official misconduct.

However, discussions are being held between the prosecution and the defense concerning the resignation of Wright, said District Attorney Ricky Smith, who is prosecuting the case. He told The News on Wednesday morning that Wright's resignation was a possibility.

The District Attorney is representing Lynn County Commissioners J.T. Miller, Don Morton, Sandy Cox-Kizer and Mike Braddock and County Judge J.F. Brandon, as petitioners. All were present for Hansard, the 106th Judicial District Tuesday's hearing.

The suit requests that Wright be temporarily suspended without pay; that the court appoint another person

trial of this matter Wright be removed permanently as County Attorney of Lynn County.

Wright was not present in the courtroom for the hearing, but was represented by attorney Dan Hurley of Lubbock.

The Honorable Judge Gene L. Delaney, senior judge of the 132nd District Court, was assigned to preside over Tuesday morning's hearing. Due to the objection, he will be removed from the case, and a new judge will be appointed by the regional administrative judge, according to District Clerk Sandra Laws.

"It makes no difference who the presiding judge was [on Tuesday morning]," explained Mrs. Laws to The News. "Either party has the right to make one objection to a visiting judge, and that's what happened. But that kind of objection can only happen once," she said.

District Atty. Smith explained that both the prosecution and the defense has the right to make one objection to a visiting judge, without stating any reason, before the hearing begins. He added, however, that it does not preclude either party from making other objections on another judge based on specific reasons.

The Honorable Judge George judge who normally presides over all other cases in district court in Lynn County, is automatically disqualified from hearing this case, says Mrs.


Larry Fuentes, former Tahoka manslaughter/intoxicated manresident arrested in North Dakota in October in connection with the 1995 death of his 18-month-old halfbrother in Tahoka, was indicted last week by a 106th District Court grand jury on a charge of capital murder.

A review earlier this year of an autopsy on the baby resulted in charges filed against Fuentes, who was 18 years old at the time of the death of the boy, Pedro Fuentes, son of Jesse and Rachel Fuentes, who lived in Tahoka on 4th St. at that time. A forensic expert on child deaths has indicated that the child died as a result of a beating.

Seven other persons were named in indictments on various charges returned by the grand jury, including the following:



# **Parent Complains To TISD Board About Son's Unexcused Absence**

Tahoka Independent School District Board of Trustees met in lengthy session last Thursday, for routine business including the district's audit report and AEIS report, but some time was spent on hearing a parent grievance at the beginning of the 5-1/ 2 hour meeting.

Edna Milinowicz presented a complaint to the board requesting that they assign a tardy rather than an unexcused absence to her son, a high school student, for his delayed attendance to ag class on Oct. 23. Represented by attorney Roderique S. Hobson, Jr., Ms. Milinowicz contended that the administration's policy assigning unexcused absences for a specific class when students are more than 20 minutes late should not be applied because the policy was not in the student or teacher's handbook. She further contended that evidence proved that her son was not at least 20 minutes late to the class.

Superintendent David Hutton presented the administration's case, contending that the consistent application of the 20 minute rule established a binding precedent and the testimony of High School Principal Jimmy Parker and ag teacher Denny Belew established that the student was at least 20 minutes late to class without permission. After rebuttals and closing state-

ments, the board deliberated in open session, then voted 6-1 to uphold the administrative decision to assign an unexcused absence to the student for that class. Trustee Carmen Chapa voted against the motion, and trust-

Each of the seven board members will submit the names of three willing citizens to comprise the 21-member committee, and a chairman will be appointed. That committee chairman will then report their findings to the board at the February 1999 meeting.

Trustees retired to closed session to meet with the district's attorney. Cal Huffaker, and to discuss personnel, returning to open session after an hour and 20 minutes. No action was taken concerning personnel matters.

Counselor Sherri McCord presented the recently received 1997-98 **TEA Academic Excellence Indicator** Report which showed average or above average student performance. in all areas.


Principals reported on their campus activities, as did Athletic Director Troy Hinds, who noted that the 100 percent of student athletes were passing at the end of the first six weeks period.


Supt. Hutton also reported plans for rebuilding the backstop at the baseball field.

# **Texas Forest Service Sells** Windbreak Trees, Offers Tips

A tree standing alone adds a cer- tree within that row. tain aesthetic quality to rural living. But the systematic planting of trees and shrubs in a windbreak becomes a management tool that effects every aspect of a farm or ranch, says a Texas Forest Service official.

Now is the time for Lynn County landowners to order windbreak seedlings produced by the Texas Forest Service West Texas Nursery in Lubbock, before preferred stock is sold out, says Robert Fewin, Texas Forest Service forester.

Windbreaks protect the soil, increase land value and crop yields, and reduce livestock weight loss and death rate. But producing a high performance windbreak requires more than just planting a line of trees.

Prior to planting a windbreak, landowners should determine: the areas or structure in need of protection; tree species adaptable to the planting region; and the planting dimensions of the break, be it a homestead, livestock, field or wildlife windbreak or a living snow fence.

A planting dimension, such as proper spacing, prevents crowding and reduces tree stress, which also decreases insect and disease susceptibility thus extending the life of the windbreak. Generally, each tree row should be planted 20 feet apart with 10- to 25-foot spacing between each

When designing a windbreak, planting multiple rows of evergreens and deciduous trees and shrubs is recommended. The purpose of the windbreak dictates the number of rows required.

Each row within a multiple row windbreak serves as a backup in case one row is lost to pest damage or other casualties. Generally, insects and diseases are confined to a species.

Also, within the multiple row structure a deciduous tree row will provide early protection. Deciduous trees are faster growing than evergreens, which are the backbone of multiple row windbreaks.

Specie diversity in a multiple row windbreak also enhances aesthetics with foliage that changes with the seasons (depending on the species).

A single row of trees may suffice for a period, but a multiple-row windbreak established with the recommended dimensions can serve for a lifetime.





Medicare Now Covers Diabetic Supplies

As of July 1, 1998, non-insulin dependant diabetics on Medicare Part B or Medicare managed-care qualify for coverage of supplies such as blood glucose monitors, test strips, and lancets. Your physician must give you a written prescription for supplies. It must state the number of test strips to be dispensed, if the patient takes insulin, and how often the patient should test his or her blood. The usual co-payments or deductibles will apply.

> NOTICE OF APPLICATION FOR A WASTE DISPOSAL PERMIT RENEWAL

City of Tahoka, P.O. Box 300, Tahoka, Texas 79373, has applied to the Texas Natural Resource Conservation Commission (TNRCC) for a renewal of Permit No. 10298-001, which authorizes the disposal of treated domestic wastewater at a daily average flow not to exceed 266,000 gallons per day via irrigation of 160 acres of land. No discharge of pollutants into water in the State is authorized by this permit.

The wastewater treatment facilities and disposal site are located approximately 0.75 milesouth of the intersection of U.S. Highway 87 and U.S. Highway 380; approximately 0.25 mile east of U.S. Highway 87 in the City of Tahoka in Lynn County, Texas. The disposal site is located in the drainage area of Double Mountain Fork of the Brazos River in Segment No. 1241 of the **Brazos River Basin** 

The Executive Director of the TNRCC has prepared a draft permit which, if approved would establish the parameters and limitations within which the facility must operate.

The Executive Director will issue the permit unless a written hearing request is filed within 30 days after newspaper publication of this notice. To request a hearing, you must submit the following: (1) your name (or for a group or association, an official representative), mailing address, daytime phone number, and fax number, if any; (2) the name of the applicant and the permit number; (3) the statement "I/we request a public hearing;" (4) a brief description of how. you would be adversely affected by the granting of the application in a way not common to the general public; (5) the location of your property relative to the applicant's operations; and (6) your proposed adjustments to the application/permit which would satisfy your concerns and cause you to withdraw your request for hearing.

If a hearing request is filed, the Executive Director will not issue the permit and will forward the application and hearing request to the TNRCC Commissioners for their consideration at a scheduled Commission meeting. If a hearing is held, it will be a legal proceeding similar to civit trials in state district court.

Requests for hearing on this application must be submitted in writing during the 30-day notice period to the Chief Clerk's Office, Mail Code 105, TNRCC, P.O. Box 13087, Austin, TX 78711-3087. Written public comments may also be submitted to the Chief Clerk's Office during the notice period.
