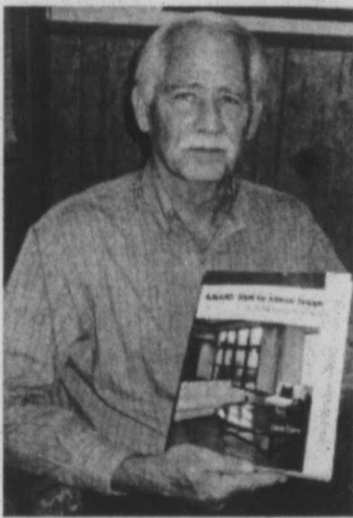

Tahoka ISD Board Elects Jimmy Dorman President

The Tahoka Independent School District Board of Trustees met in regular session last Thursday, June 12, with the first order of business administering the oath of office to newly-elected trustee Jimmie Bingham and to re-elected trustees Frank McLelland and John Hawthorne, followed by the election of officers of the board.

Trustees unanimously elected Jimmy Dorman as President of the Board and Frank McLelland as secretary of the board, and they were the only nominations to consider for those offices. However, for the position of vice president, two motions were made, with trustee Kent Kahl nominating Tony Garcia for the office, and Garcia nominating Joe Calvillo for another term as vice president. The six trustees present (Calvillo was absent from the meeting) voted 5-1 for Garcia, with Garcia voting against this motion, and casting his lone vote in favor of Calvillo. Majority vote elected Garcia as the board's new vice president.

All three officers are new to their positions for the 2008-09 TISD Board of Trustees. Former board president was Math Bartley, who did not seek reelection to the board. Calvillo was vice president, and Dorman was secretary. The newly reorganized board approved new bank signature cards and approved routine consent agenda items, setting the next regular board meeting for July 15.

Prior to discussing new business, Dorman asked the audience if there was anyone wishing to address the board. A crowd of approximately 25 teachers, staff, and local residents were present for the meeting, and several addressed comments to the board, all expressing support for Tahoka High School Principal Troy Hinds, who was also present.

"On behalf of several parents, I just want to express our support for Troy Hinds," said Bryan Reynolds. "I think his compassion for our students at this school is second to none, and we wanted the board to know how we feel, as parents. We need to make a stand to support our school and not let some things tear it down," he added.

Donna Stone, a high school teacher, said she was speaking on behalf of the teaching staff present at the meeting. "We are here in support of our principal, Troy Hinds. He gives 110%

every day at school. He is our biggest supporter in the classroom and he goes to bat for us. We wanted to let you and the community know that the teachers support him."

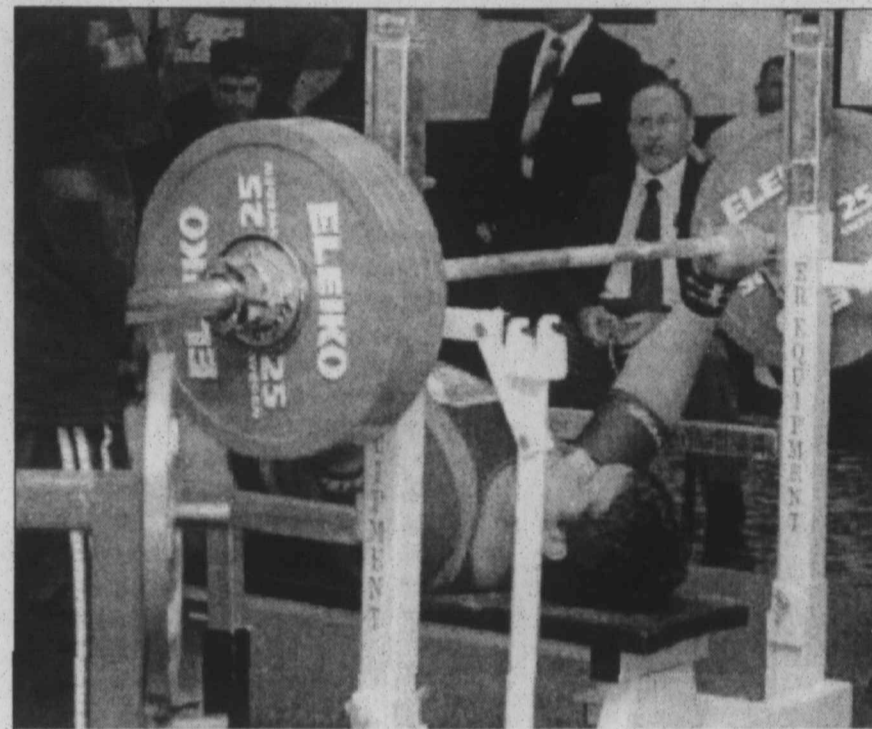
Linda Bartley and Mike Rivas also addressed similar comments to the board, and trustee Tony Garcia addressed the crowd. "Thank you all for coming in to show your support. I can't let others come in and tear down this school [reputation] - we don't need anybody to judge anyone else. We are with you and will back you up."

Hinds also made brief remarks to the group, saying, "I just want to speak on behalf of my family... we feel like we are surrounded by a lot of good people. This community has allowed my family to come back not just once, but twice, and it has been a blessing to us. I do appreciate all the words of encouragement... and I appreciate my wife Elsie and our boys."

The crowd dispersed during a break following the comments, and trustees resumed business discussions. Superintendent Jimmy Parker said he had obtained preliminary estimates on costs for air conditioning the elementary gym, and trustees agreed to advertise for bids on the project. TASB Policy Update 83 was approved, with an addition of naming Supt. Parker as the Title IX Coordinator for Tahoka ISD.

The superintendent reported two staff resignations to the board, for high school theatre arts teacher Jessica Crabb, and for Keith Oldham, a teacher/coach whose contract was approved at the last board meeting and who has since decided to accept another position instead of coming to Tahoka. Three new teaching contracts were approved, for Casey May as a kindergarten teacher, Beth Lecocq for the theatre arts/speech position at the high school, and for Jordan Criswell as an assistant coach/science teacher.

Supt. Parker showed trustees a sample gymnasium seat which could be attached to the bench seating in the high school gym, but no decisions were made as to whether to purchase the seating. He informed trustees of the annual school board convention in September and asked each one to let him know as soon as possible who would be attending with spouses, in order to reserve hotel accommodations.

Accidents In City Hurt Three Persons

Two traffic accidents in the Tahoka city limits left three persons injured during the last week.

At N. 2nd and Ave. K Tuesday afternoon a Honda Element van driven by Beth Ruth LeCocq, 28, of Lubbock, and a 2005 Toyota Scion driven by Alex A. Deleon, 17, of Tahoka were involved in a collision, in which the Honda overturned. Both drivers were taken by EMS ambulance to Lynn County Hospital for treatment of injuries.

There were no serious injuries in a collision Thursday afternoon at the intersection of Ave. L and N. 1st St., involving a Chevrolet Monte Carlo driven by Abigail Henderson, 21, and

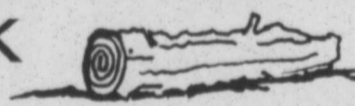
a Cadillac driven by Ray Curtis of Tahoka, who was treated for apparent minor injury at Lynn County Hospital.

At O'Donnell, sheriff's officers investigated the burglary of a 1991 pickup which was parked at the residence of the owner, Andres Delosantos, who reported the burglary Friday. Stolen from the pickup were a Sony 1000-watt amplifier valued at \$300 and two 12-inch speakers, valued at \$100 each.

Joe Calvillo of Tahoka reported to police Wednesday that his 2005 Chevrolet Avalanche had been burglarized, with a wallet and AC/con-

I KNOW A GUY who carries 50 million dollars around in his wallet. He lives in Tahoka, and I won't name him, because before you read the rest of this, somebody might rush out to hit him up for a loan, or maybe even worse, hit him upside the head.

At a restaurant the other day, he showed me a single bill in the currency of Zimbabwe (that's in Africa), which stated in English on the front, "50 million dollars."

He explained that inflation in that country is the worst in the world, and that it takes two of those 50-million-dollar notes to buy a Coke.

And I thought pesos and Italian lira were bad. I recall some years ago when we visited Italy that their money looked like Monopoly money, printed on little pieces of paper, and if I remember correctly (which is unlikely), it took a few thousand lira to equal one U.S. dollar.

I remember watching a tennis match on TV years ago, and an Italian player won it, and the top prize of what I think was about \$50,000. One of the commentators asked another, Bud Collins, how much that would be in lira, and he said, "about two pickup loads."

I guess Italy now uses the Euro dollar, which is a lot more valuable. Right now it takes only .64 of an Euro dollar to equal a U.S. dollar. It takes 10.3 Mexican pesos to make a dollar. Zimbabwe is not even listed on the currency exchange list I found on my computer.

It takes almost 43 rupees, the currency of India, to equal a dollar. So if you see a rupee lying in the street, it's worth about two and half cents, hardly worth bending over for. Certainly not enough to make you exclaim, "Whoopie—a rupee!"

“Skyrocket” Fireworks Banned in County

Due to continuing dry conditions and fire hazards, Lynn County Commissioners last Friday approved an order prohibiting the sale or use of certain fireworks in all unincorporated areas of Lynn County. The ban includes fireworks classified as “skyrockets with sticks” and “missiles with fins.”

Common fireworks, small in size and classified as Class C explosives, are not included in the ban, and may be sold/used in unincorporated areas of the county. Fireworks of any kind are not allowed within city limits.

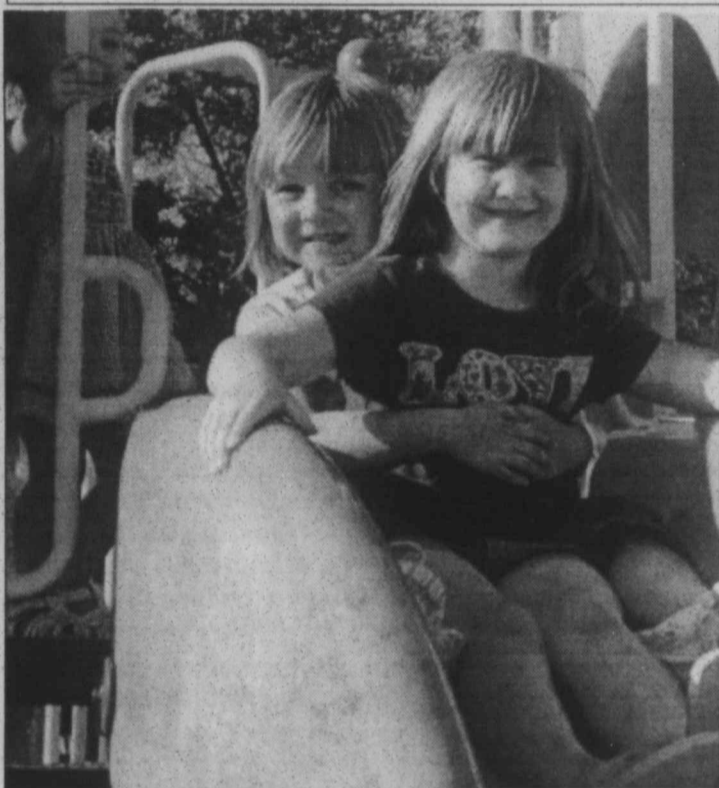

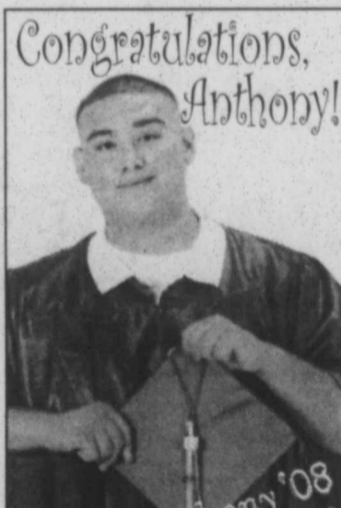
District 4-AA Softball Selections Announced

The couple will exchange vows at 6:30 p.m. on July 19, at the New Home Baptist Church in New Home.

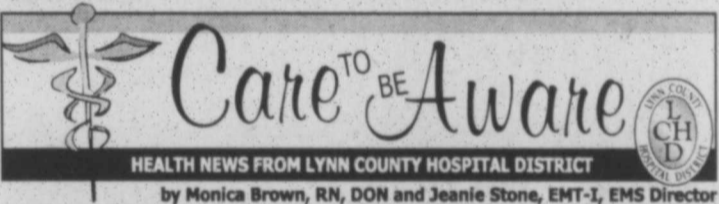
School Records To Be Destroyed

SAFE SUMMER WATER SAFETY

According to the YMCA pool and beach fun starts with a clean, safe place to swim. As responsible swimmers we need to check the following points:

- The area is supervised by a lifeguard(s).
- The water is clean and safe.
- The facility is clean and well-maintained.
- No electrical equipment or power lines are in the area.
- Emergency communications and safety equipment are available.
- The depth of the water is marked.
- Life lines separate the shallow from the deep water.

Make sure you supervise children and that they understand the rules at every water facility you visit.

Water Safety In Your Own Backyard

For safe water play in your own backyard pool, keep these water safety tips in mind:

- Use of the pool should always be supervised by an adult who knows how to swim and knows pool rules and emergency procedures.
- The area should have a secure fence surrounding the pool with childproof locks to guard against unsupervised swimming. A fence is

necessary even if the pool is located directly outside of patio doors. The gates should be locked when no adult is present.

- Establish pool rules and post them near the pool. Don't allow running or horseplay around the pool. Be careful with inflatable toys that may deflate unexpectedly. Use only unbreakable containers in the pool area.
- Be prepared for emergencies. Have a long pole, a ring buoy with a throwing line and a first aid kit close at hand. Keep emergency numbers handy. Get training in lifesaving, first aid and CPR.

To prevent injuries, make sure all divers use caution. Allow diving only where the water is deep - at least 9 feet from deck - and tell divers to check the water depth before diving.

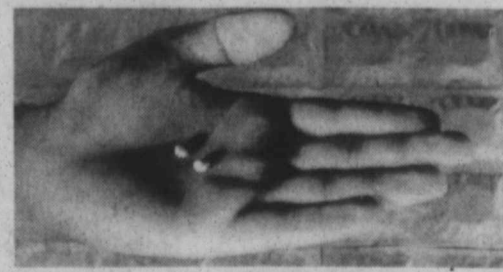

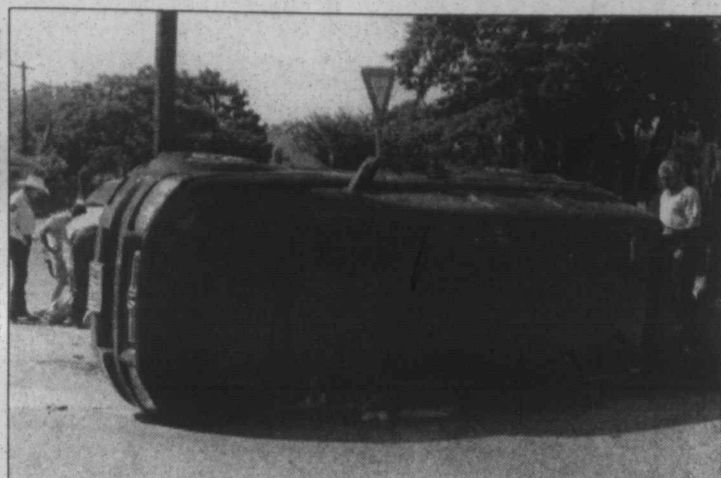

verter valued at \$50 stolen, plus an estimated \$180 damage to the vehicle. Jesus Moya of Tahoka also reported Saturday a car stereo stolen out of his 1991 model pickup. The stereo was valued at \$250.

Police also arrested a 47-year-old Tahoka man for assault/family violence after a 21-year-old woman was taken to a Lubbock hospital for treatment of injuries Monday.

Seven persons were arrested and placed in Lynn County jail during the last week, bringing the total jail population early this week to 40, including 16 held for Lubbock County and two for Gaines County. Charges resulting in arrests included four persons for driving while intoxicated, one of those with a child passenger and one on a Lubbock warrant.

Others were jailed for assault/family violence, purchase and furnishing alcohol for a minor, and fictitious insurance/inspection sticker.

Ty Cloe is Teen National Champion, Sets World Record in Powerlifting

Tahoka area residents have watched Tahoka High School athlete Ty Cloe gain recognition in high school powerlifting competitions for the past four years, setting and breaking records in UIL state powerlifting events and claiming several state championship titles in his weight class. The THS senior graduated in May, ending his high school powerlifting career, but the powerful teenager has not stopped competing. Last week Cloe set a world record in bench press and was named the Teen National Champion for the 275-pound weight class, and he has been invited to the World Powerlifting Championships in South Africa.

Because of his status in high school powerlifting competitions, Cloe was invited to compete with the Texas Lone Star Strength team at the 2008 USA Powerlifting Men's Open/Teen and Jr. Championships national competition in Killeen, Texas, held June 13-15. This annual meet is the World Qualifier for the 2008 Men's, Sub/Junior World Powerlifting Championships, set Aug. 31-Sept. 6 in South Africa.

Cloe not only placed first, claiming the Teen National Champion title for his weight

class, but he set a world record by bench-pressing 505.5 pounds, and he helped the Lone Star Strength team place first as well. He lifted 705.47 pounds in the squat competition, and 585.22 pounds in the dead lift event. Joe Lewis, head coach of the USA Sub/Junior World Team, was so impressed with Cloe's performance that he invited him to become one of eight members of the Sub/Junior USA World Team to compete in Africa this fall. The USA team is comprised of one person from each of eight weight classes in the world qualifier competitions, and the coach wanted Cloe on the team.

"Coach Lewis approached Ty immediately after the competition, and told him he wanted him on his world team - it was actually pretty exciting," said Cloe's mother, Lena, who attended the Killeen event. "Ty has spoken with his coaches at Eastern New Mexico University (where he will be attending and playing football beginning this fall) and he has been given their blessings to miss a game and some practice to be able to go compete in South Africa. We will be having fund raisers for trip expenses!" added Mrs. Cloe.

Ty's meals will be provided in the weeklong world competi-

tion in Potchefstroom, South Africa, but flight costs and accommodations will be the Cloe's responsibility. Ty's parents, Rick and Lena, plan to accompany their son on the trip.

USA Powerlifting is the leading powerlifting organization in the United States. USA Powerlifting is a member of the International Powerlifting Federation (IPF), the governing body of powerlifting internationally. The IPF is comprised of member federations from 83 countries on six continents.

Distinct from weightlifting, which is a sport made up of two lifts: the Snatch and the Clean-and-Jerk, where the weight is lifted above the head - powerlifting comprises three lifts: the Squat, Bench Press and Deadlift. Powerlifting competitions may be comprised of one, two or all three of the lifting disciplines. Athletes are categorized by sex, age and bodyweight.

Each competitor is allowed three attempts at each lift, the best lift in each discipline being added to their total. The lifter with the highest total is the winner. In cases where two or more lifters achieve the same total, the person with the lightest bodyweight wins.

teen drivers were placed out of service for drug or alcohol violations. Troopers issued 11 tickets for seatbelt violations.

Vehicle out-of-service violations included 911 trucks that needed a brake adjustment, 564 that had brake system problems, 173 that had tire or wheel problems and 251 that had light malfunctions.

DPS Commercial Vehicle Enforcement troopers, along with Highway Patrol troopers and other inspectors who have received specialized training in commercial vehicle inspection, stopped commercial vehicles to inspect safety equipment and check driver licenses, endorse-

ments and log books. Troopers also looked for possible drug or alcohol use.

The annual Roadcheck program, which stretches from Mexico to Canada, is designed to reduce commercial vehicle highway fatalities through increased vehicle safety. The Commercial Vehicle Safety Alliance, which sponsors Roadcheck, reports a significant decrease in the commercial vehicle crash rate in North America since the program's start in 1988.

Vehicles passing inspection received a CVSA decal exempting the vehicle from inspection for a 90-day period, unless they have an obvious safety defect. Troopers issued 2,054 decals during Roadcheck 2008.

DPS Roadcheck 2008 Campaign Inspects 5,824 Vehicles for Violations

During Roadcheck 2008, which ran from June 3 through June 5, DPS troopers inspected 5,824 commercial vehicles, placing 24.6 percent of them out of service for equipment violations.

During the three-day campaign, 5,824 commercial vehicles were inspected, and 1,435 of the vehicles and 178 of the drivers were found to have seri-

ous enough safety violations to be removed from service. Last year, 1,659 vehicles and 259 drivers were placed out of service.

Inspectors placed 122 drivers out of service for hours-of-service violations. Other violations ranged from false log violations to suspended, expired and cancelled licenses and having the improper endorsement. Thir-

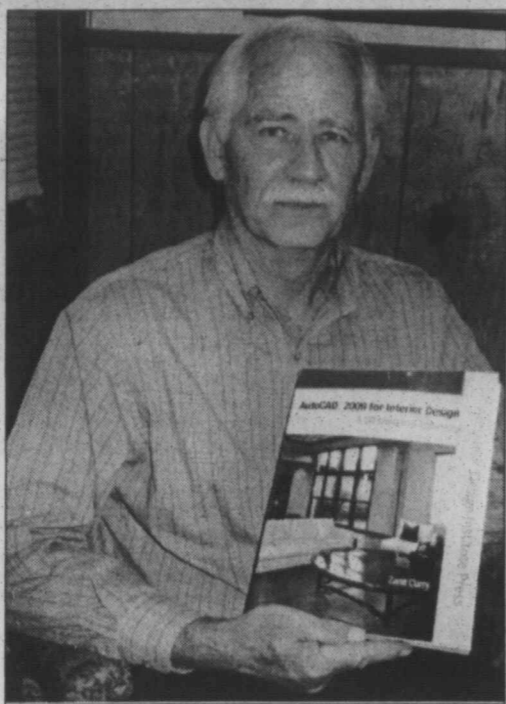

Dr. Zane Curry – Author!

Local Man Writes College Textbook For Interior Design Techniques

by JUANELL JONES

Zane D. Curry, Ph.D., an associate professor at Texas Tech University, searched in vain for years for a good textbook to help teach his interior design students how to create computer generated three-dimensional models. There weren't any textbooks in print that he felt would teach them what he wanted them to learn – so he wrote one. Last Tuesday, he received the first printed copy of "AutoCAD® 2009 for Interior Design: A 3D Modeling Approach," a 432-page college-level textbook with the author's name – Zane Curry – printed on the lower right corner.



students in his undergraduate interior design classes.

The textbook is being published by Pearson Prentice Hall™, and Autodesk® Design Institute Press – among the most prestigious publishers in the world, which is a pretty good endorsement to the high quality of the textbook to meet their exacting standards.

Dr. Curry lives a few miles west of Tahoka with his wife, Danna, who is a Tahoka ISD teacher. He is Associate Chair in the Department of Design at TTU's College of Human Sciences, teaching interior design for the past 20 years.

He has taught courses in two-dimensional (2D) and 3D computer-aided design and drafting for over 17 years at the university level. Frustrated with the lack of availability of AutoCAD® textbooks specifically aimed at interior design, Dr. Curry (who says he has never taken a 3D modeling computer class) developed innovative techniques and instructional materials for teaching computer-aided drafting and design and designed his own instructional material several years ago for use with available computer software, making it a valuable tool for his students. It was such a hit that several of his grad students contacted him later asking if they could purchase the tutorial from him to use in their interior design classes.

To their dismay, it was not available. Dr. Curry had the foresight to copyright his tutorial program, and used it only for his

And, although he is finished with this book, the publishers are already planning annual updated editions to keep up with computer software advances, and Dr. Curry will have the option of working with them on the updated versions.

"AutoCAD® skills have been – and continue to be – in high demand in most design-related fields. Almost anyone can copy and paste blocks created by someone else and make a drawing look well-done, but an individual who can create his or her own 3D models when the design solution demands originality will

be better off by far," Dr. Curry explains on a page inside the front cover of his new book. "This book was designed to provide interior design students with a basic understanding of 3D modeling commands and techniques using the AutoCAD® program and its inherent features. The practical chapters and chapter exercises were designed to increase in degree of complexity as students progress through the book. This approach allows students to learn and apply the processes to their own design solutions," he adds.

"The information in this book won't make students better designers – it's simply a tool that will allow them to create and present their own design solutions. That's what is exciting to me," Dr. Curry says.

Apparently, other educators in the field of interior design agree. Dr. Curry's book was reviewed nationally three times by his peers before it was sent to press, and he says he has received a good deal of interest from educators at other universities who have inquired about the availability of his new book.

With the book now in print, perhaps Dr. Curry can take a few moments of relaxation time, perhaps enjoying hobbies that include playing music (many Tahokans have heard Dr. Curry playing drums with the band at the annual Christmas open house at First National Bank of Tahoka), fishing, drawing and painting ... and maybe he will talk to his wife, too.

DPS Warns To Check Out Alarm Companies

The Texas Department of Public Safety is urging Texas residents to make sure that any alarm salesperson, company or alarm installer that they hire is licensed by the State of Texas.

"We urge anyone who is considering hiring an alarm company or installer to check whether they are actually licensed in Texas, as required by state law," said Capt. Ren Earl Bowie of the DPS Private Security Bureau. "Alarm installers and salespersons are required to undergo a criminal background check before being licensed, to help ensure the safety of the public."

The Private Security Bureau has initiated investigations in Houston and San Antonio following reports that numerous unlicensed salespersons, installers and companies have been aggressively marketing their services to residents in those cities. Other cities may also have experienced an influx of these salespeople. DPS is working with the alarm industry trade associations to investigate these claims.

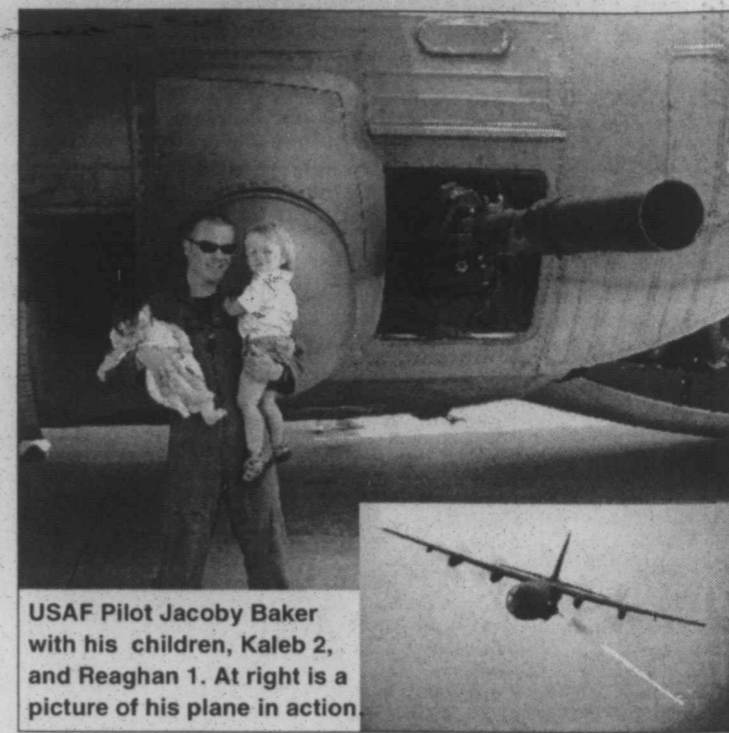

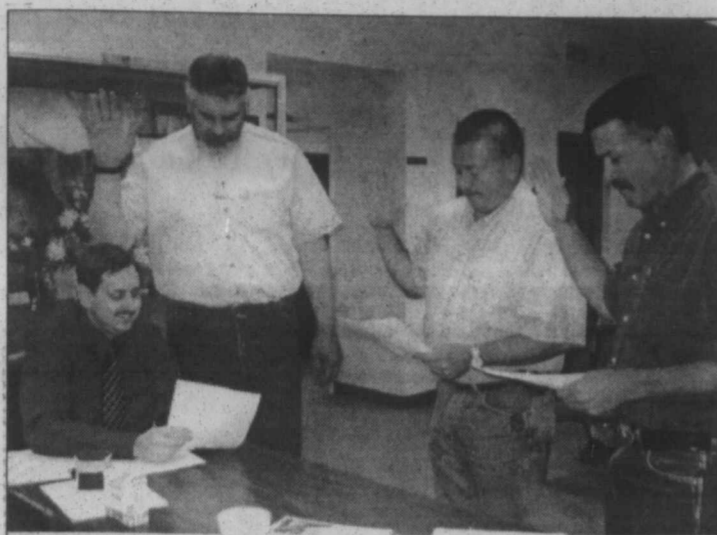
