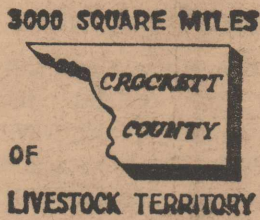

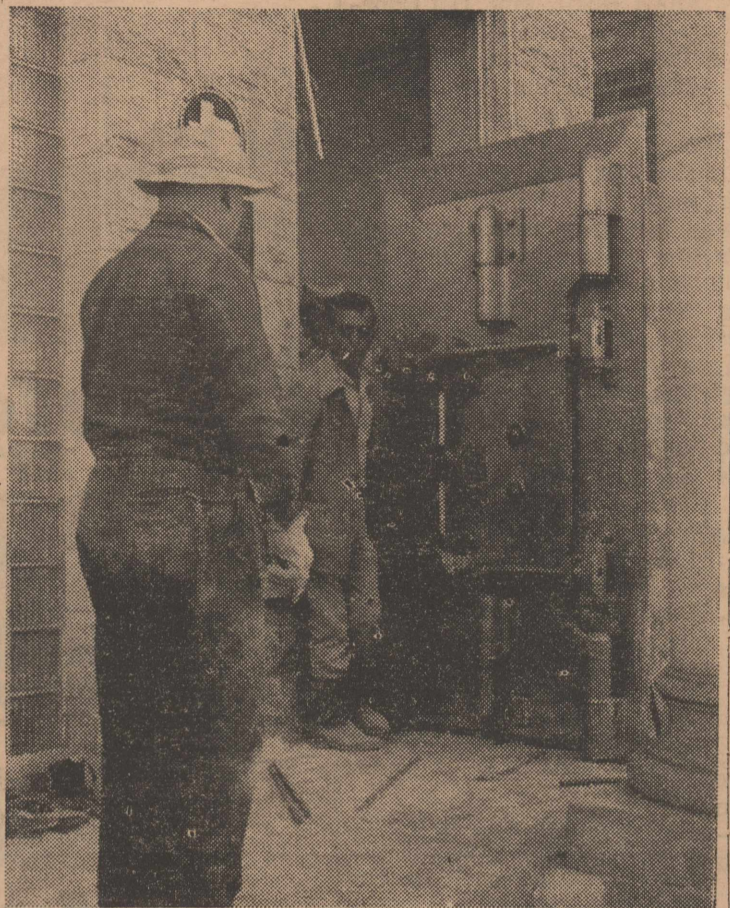

Slow Falling Rains Soak Most Areas of County

Crockett County has been blessed with three days and nights of slow falling rain, the aftermath of a cold front which struck Ozona Thursday night dropping temperatures and chilling residents with a cold north wind.

The mercury rose Monday and a light mist began to fall from heavily overcast skies, turning to rain during the night. The official reading at 8:00 a. m. Wednesday was .67 of an inch. However, with showers continuing throughout the day Wednesday the total amount of moisture was estimated at around one inch in town.

Ranchlands in the county generally received up to 1 inch of rain, with heavier amounts reported in the east and south parts.

Rash of Traffic Accidents Keep Patrolmen Busy

A rash of accidents kept Highway Patrolmen Orvil Perry and Del Copeland busy the past week. There were no personal injuries, but property damage ran into several hundred dollars. All but two of the accidents occurred in Ozona and deer on the road were responsible for the two county mishaps.

Thursday afternoon a 1962 GMC pick-up belonging to Henry Lucas and parked in front of his residence at Crockett Heights was hit in the rear by a 1965 GMC pickup driven by William Thorp of Mertzon. Thorp made a wide swing while turning out of a side road, hitting the parked vehicle. Damage to both pick-ups amounted to \$600. Another accident Thursday at the intersection of Hwy. 163 and 3rd St. damaged a 1958 Plymouth driven by Juan Montes, Jr. and a 1958 Ford pickup, driven by Andres Galindo. Attempting to turn onto 3rd street, Galindo pulled out in front of the Montez car as it was traveling south on the highway.

Monday morning at 1:45, 7 miles south on the Pandale road a 1964 Chevrolet driven by Lavan Gotcher of Pyrote hit a deer head-on and damaged the vehicle to the extent of \$400. A similar mishap occurred Monday night.

HITCHCOCK REPORTS —

Ignition System Failure Caused Jet Plane Crash

Major William E. Hitchcock, who, with Lt. Col. James Mullins, parachuted safely from a U. S. Air Force jet fighter plane when its engines quit over Ozona on October 16, visited Ozona briefly yesterday.

Major Hitchcock has completed his flight training time and will be on leave to visit his family in Sacramento, Calif., until Dec. 31 when he will report for duty in Vietnam.

Major Hitchcock reported that Col. Mullins, who suffered a back injury in ejecting from the stricken plane, has recovered and has resumed his flight training. He too is scheduled for Vietnam duty, possibly in late January 1968.

Air Force experts have determined from examining bits of the far-flung wreckage of the plane, which exploded on impact with the earth, that massive electrical failure which shut off fuel to the engines caused the wreck. The fault in the plane has been corrected by addition of a small rubber insulator, Major Hitchcock said, so that the same accident can not happen again.

Six Proposed Amendments To The Much Patched Texas Constitution To Be Decided By Voters Nov. 11

Taxpayers of Texas will be called upon to pass judgment on six proposed amendments to the already much patched constitution of Texas at the general election Saturday, Nov. 11.

These proposed amendments will be the only issues to be decided at the coming election and without the attraction of personalities and political fanfare, the response is likely to be somewhat meager. The legislature has again made a change in the method of voting, this time substituting the "scratch" method for the block check system. Each "For" and "Against" before each amendment is preceded by a square and the voter must indicate by a check or x in the square which will indicate his choice in each instance.

Herewith is a brief analysis of each proposal up for decision at the coming election.

Proposition No. 1 on the ballot you will vote for or against "the constitutional amendment allowing counties to put all county taxes into one general fund. The section formerly set a maximum levy for each of the four county funds, providing that the total should not exceed 80 cents on the \$100 valuation. A 1956 amendment eliminated the separate maximums so long as the total did not exceed 80 cents. The new proposal would add the following words: "Any county may put all tax money collected into one general fund without regard to the purpose or source of each tax."

Proponents say this provision would make for more flexible administration of county funds while opponents express apprehension that lump sum handling might result in loss of some internal cash controls that safeguard assets of the county.

The No. 2 proposal would allow municipalities and other political subdivisions located in hospital districts to support mental health and mental retardation services. This amendment is intended to clear up some of the cures' past performances in creating hospital districts and providing for exclusive finance of health services within them. 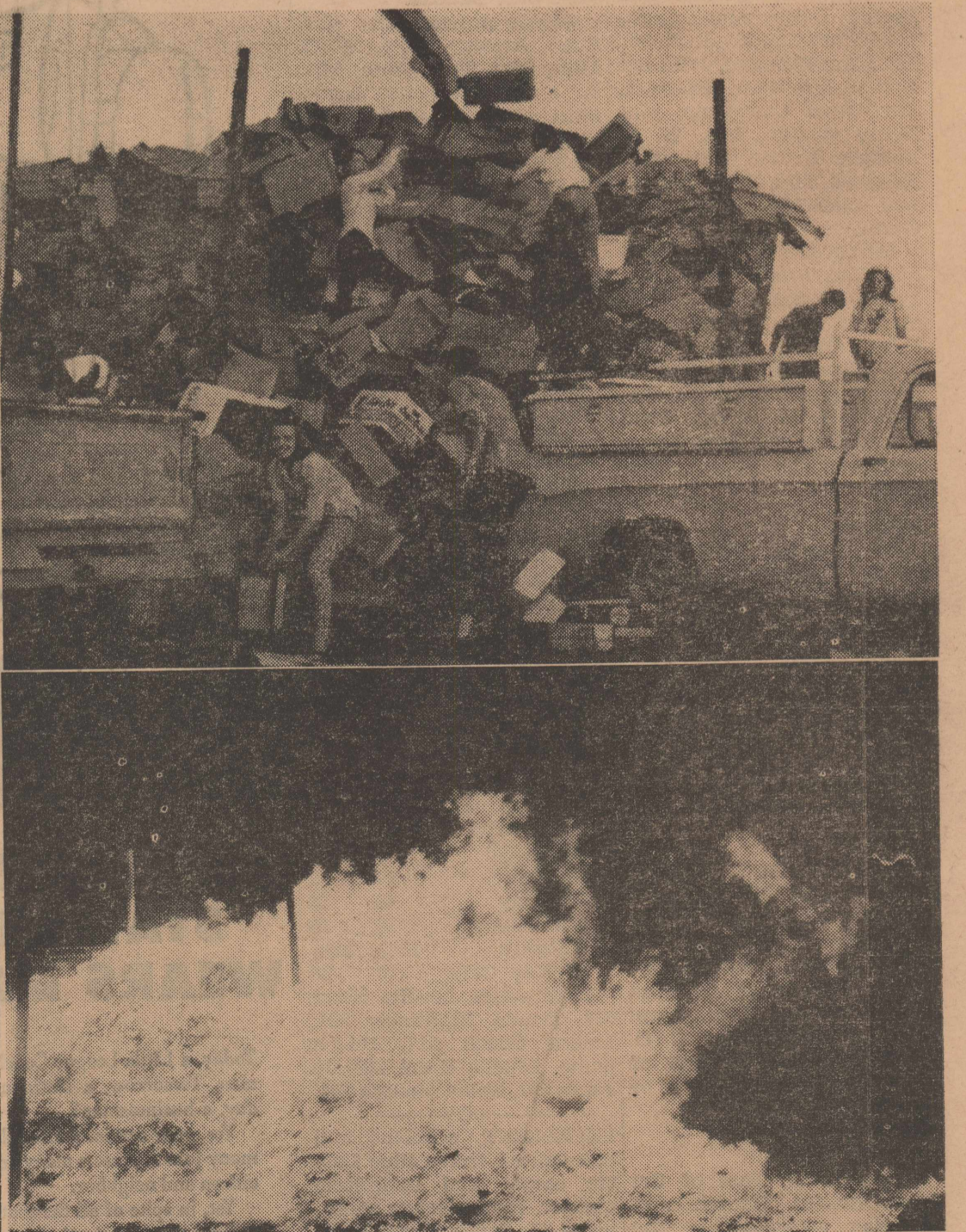

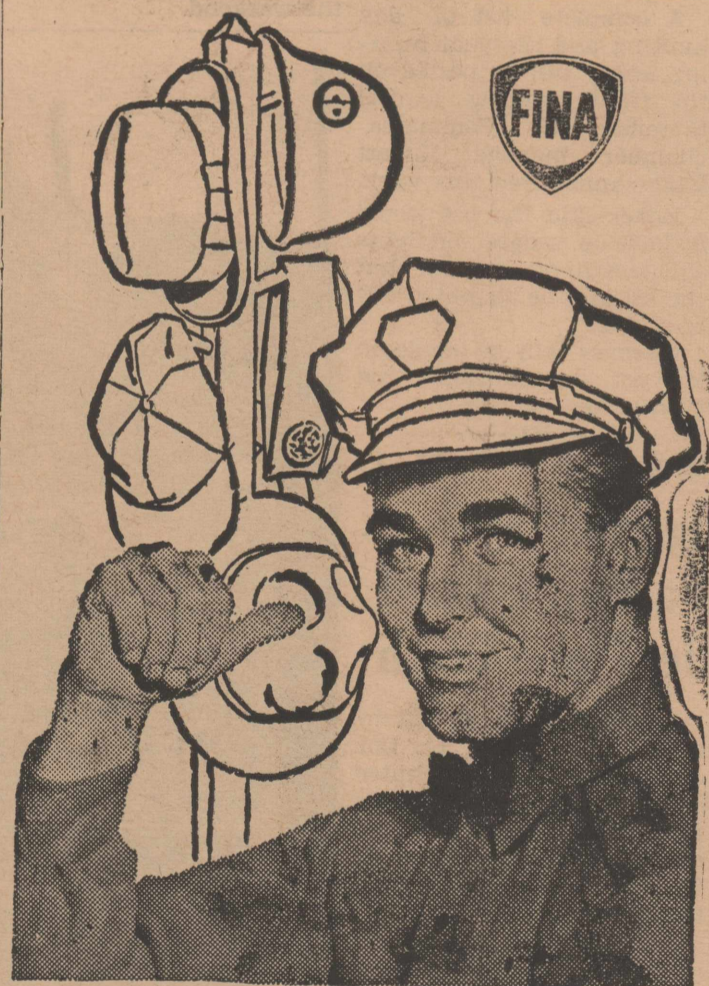

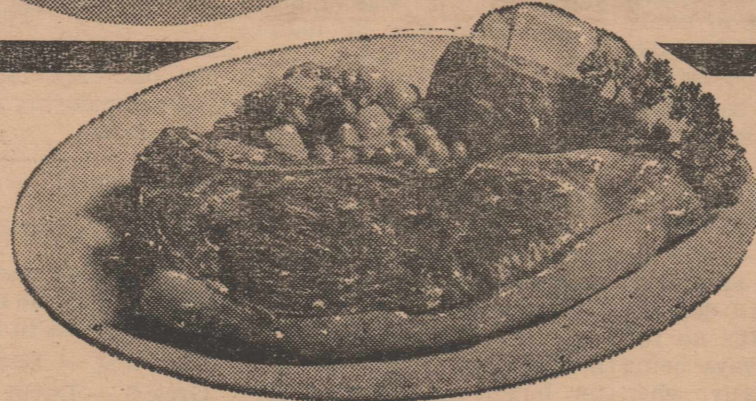

almighty Seniors took first in the sign contest with their Brave grave. Next, Dale Wy-singer won the car contest with a fine job of decorating his car.

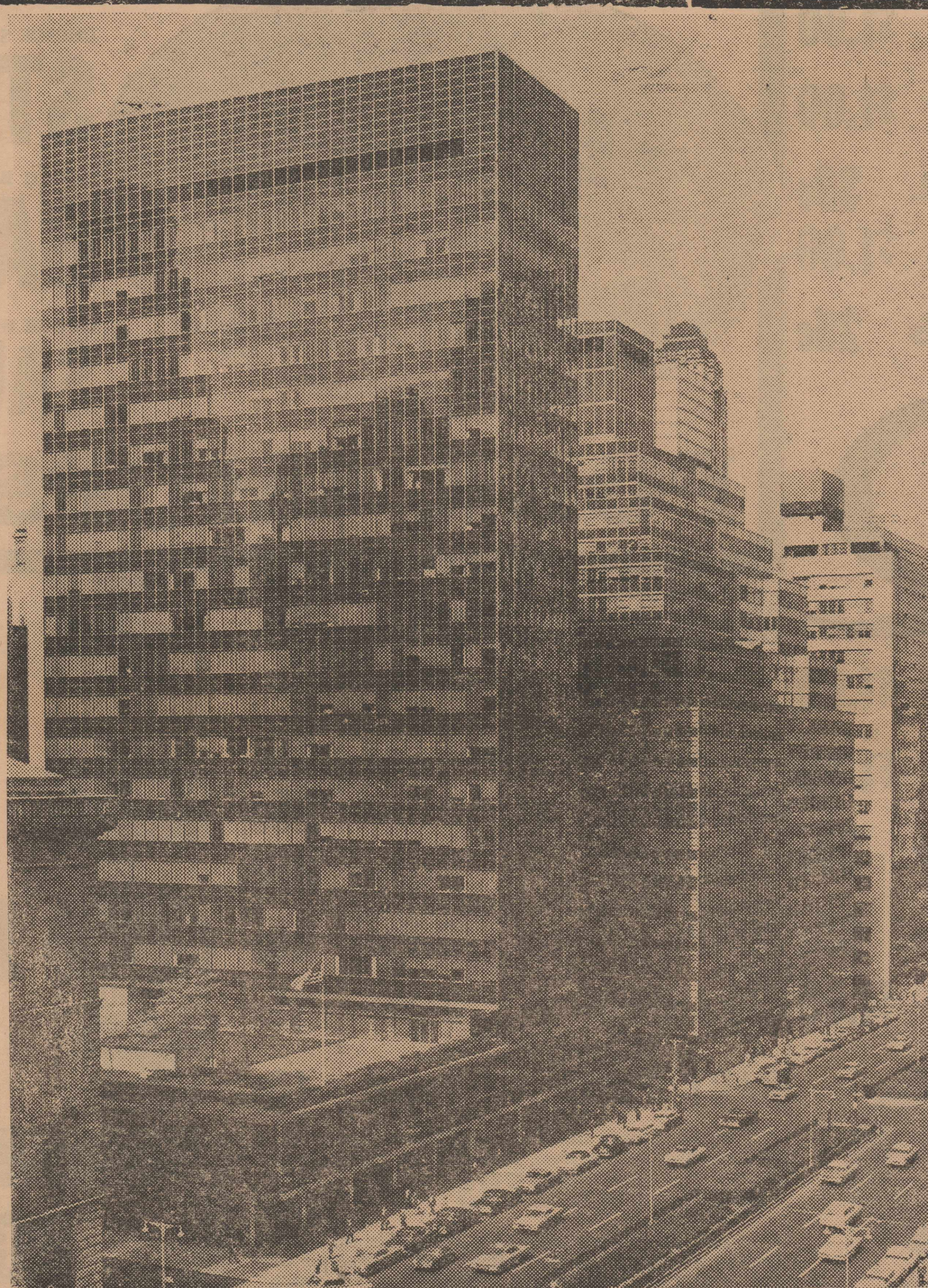



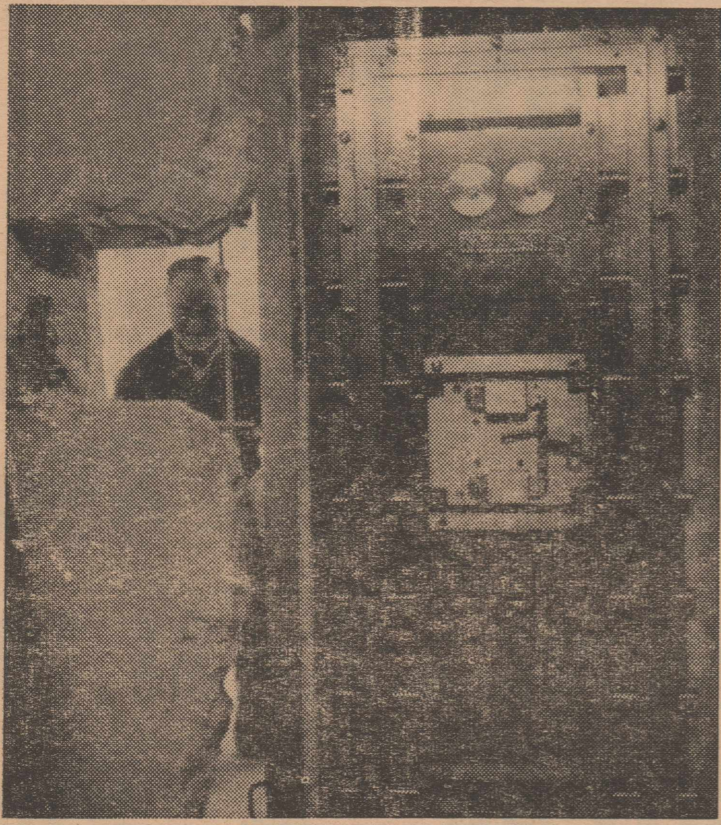

maximum salary of such an official while he is hospitalized or incapacitated as a result of such injury.

While this is a select group chosen for special treatment, it is not clear how far this coverage would extend. It is uncertain, for example, whether the term "law enforcement official" include such people as the county fire marshal, county attorney, county health officer, justice of the peace or judge of a county court, and whether the term would include some or all of the members of their staffs.

It is also uncertain what constitutes injury in the course of official duties; for example, some law enforcement officials are considered as being on 24-hour duty. There would be no limit on the amount, type or cost of medical expenses. Obviously, in some cases such expense could be very large. And there is no limit to the time in which the county would be obligated to pay medical expenses — even for life.

The No. 5 proposal would authorize issuance of state bonds to acquire and develop sites as state parks. The proposition would authorize the issuance of \$75,000,000 in general obligation bonds of the state for acquiring and developing park sites. The State Parks and Wildlife Department would operate, maintain and improve the parks. The interest rate is not to exceed 4½ percent. Interest and principal on the bonds would be paid by receipts from admission charges to State Parks, providing that if in any years such receipts were not sufficient, the amendment would appropriate a sufficient amount to cover the principal and interest due.

The bonds, together with \$7,000,000 of estimated federal aid, would finance a program which the Parks and Wildlife Dept. believes would be "a self-supporting program, financed by a nominal entrance fee at state parks."

The No. 6 proposal on the ballot would allow paid non-elective state officers and employees to hold other non-elective positions under the state or the United States.

Land fund amendment — providing more state bonds for veterans to buy land and extending the life of the program. This proposal would call for the issuance of another \$200,000,000 in bonds at an increased interest rate.

This is the third time this amendment has been submitted to a vote. It was defeated in 1963 and again in 1965. The changes proposed this time are, in most instances, word for word the same as in the two previous elections.

The first provision for a veterans land program was adopted in 1946. It authorized sale of \$25,000,000 in bonds. In 1951 this was increased by \$75,000,000 and in 1956 another \$100,000,000 was approved. All of these bonds have been sold. The proposed amendment would allow issuance of another \$200,000,000 for continuation of the program.

The No. 4 proposal would provide for county payment of medical and hospital bills for law enforcement officials injured in the course of duty. The proposed amendment would "authorize" each county to pay all medical expense, all doctor bills, and all hospital bills for a sheriff, deputy, constable, and other county and precinct law enforcement officials injured in the course of their duties. It would provide further that the counties "shall" pay the
