### "Detente" and National Defense

Shortly before their recent meeting at Vienna, Soviet Foreign Minister Gromyko took the unusual step of criticizing U.S. Secretary of State Kissinger by name on the grounds that he, Kissinger, favors detente, but also a high level of U.S. defense spending. Gromyko claimed indignantly that this was a contradiction.

The Russians, in other words, insist that detente implies a situation under which they grow stronger while we grow ever weaker. We think far too many Americans give detente this same kind of Russian interpretation.

To them we would cite the words of Eugene V. Rostow, former Under Secretary of State for Political Affairs and now chairman of the Foreign Policy Task Force of the Coalition For A Democratic Majority. Summarizing the Task Force's report, he writes: "Mr. Nixon did not end the 'Cold War,' achieve 'detente,' and substitute 'negotiation for confrontation.' A condition of 'detente' with the Soviet Union has been an unremitting goal of our foreign policy since President Roosevelt's time. It has not been achieved. There has been no improvement in our relations with the Soviet Union, save in the realm of public relations and wishful thinking. Soviet policy is exactly what it has been since 1944 or 1945, except that its pressures are greater and more diverse than ever, and more difficult to deal with, because they are backed by more force."

The Rostow Task Force, analyzing the U.S. defense posture in the face of the Soviet military build-up, does not recommend a crash program, seeking to catch up to the Soviets in every category, overnight. But it does recommend an increase in expenditures, particularly for the Navy, for ready forces, and for certain critical weapons and weapon systems designed to "maintain a prudent deterrent against aggression."

We agree with Mr. Rostow and his associates on the Task

Two key problems that face us today are: (1) how to stimulate our economy; and, (2) how to develop the productive capacity through capital formation that will provide for a healthy growing economy and future. The first problem is short-term; the second is long-term, and sometimes these two needs can be in conflict.

This past week, I supported the President's veto of a summer public employment jobs program. The cost would have been nearly \$5 billion to be spent on a variety of public works jobs which the government would create. The intent of this bill was good, and had it not added so much to our deficit, I might have supported it, but this bill would have put us into an even larger deficit

than has been forecast. It seemed to me that it would take capital needed for longterm economic development and put it into short-term jobs. Consumers would have more money to spend for goods without a corresponding rise in our capacity to produce the goods wanted by consumers; therefore, prices would rise,

Currently, federal, state, and local governments already spend about one out of every three dollars in this country and I would like to leave more of the choices about spending up to the individual. This past year was the

Force. We don't know what Kissinger said to Gromyko in Vienna, but we believe that the Task Force program is the only kind of answer we can give the Russians that will offer any hope of the real detente that has so far eluded us.

### Mayaguez Aftermath

President Ford and Secretary of State Kissinger have both moved swiftly to try and capitalize on the political fallout of the Mayaguez affair. The President rejected a new isolationism and has again proclaimed that the U.S. will honor its pledge to defend South Korea. Meanwhile Kissinger, in Europe, was reaffirming the U.S. commitment to West Berlin specifically and to Western Europe generally.

This is all to the good. The world must believe that the U.S. will to act has not been shattered by the trauma of our southeast Asia defeats and that we are not in fact turning toward a new isolationism. This is so self-evidently important that we are sure it must have been the major, and not the minor, consideration as the administration debated its response to the Cambodian seizure of the ship. At that psychological moment we desperately needed something that would give some credence to our international word. 

Tips For Gardeners From the Ozona Garden Club Mrs. Bailey Post

It has been my pleasure to visit several beautifully landscaped gardens the past week, and to see the colorful plantings of so many varieties and kinds of perennials, annuals, bulbs, potted plants, trees and shrubs. With a little extra care most any plant you really want will grow in Ozona, except perhaps the most exotic ones.

The Ozona Garden Club made their annual garden tour to the hillside garden of the J.W. Howell's last week. The flower beds around the entire landscape featured at this time many varieties of day lilies, geraniums, daisies, caladiums and potted plants. The spacious and well groomed lawn with the large native live oaks and fruit trees to give shade and beauty, make the patio a perfect area to relax and enjoy the out of doors for the summer.

June is an excellent time to plant caladium tubers, since the soil is warm enough for rapid growth. There are many varieties to choose from to plant in beds, planters and pots to be placed in groups. Among the most popular include candidum (white), blaze (red) and pink cloud. Plant the tubers 12 to 18 inches apart and 2 inches deep in soil with organic matter added. Keep soil moist, but not wet. Afte they come up they may need water everyday if no rain.

Now is the time to make notes of the varieties of roses you may want to add to your planting. Many will be in bloom all summer in yards and at the nurseries. Floribundas are better adapted to hot weather conditions than hybrid teas. They provide colorful garden displays and make good cut flowers. To conserve growth energy, always snip off flower clusters as soon as they fade. Give plenty of

water during dry spells, and feed every six to eight weeks with a complete fertilizer. Some good varieties include Summer Snow (white), Betty Prior (pink) and Europeana (red), Little Darling (yellow blend), and the 1975 All American Floribunda, Rose Parade. The beautiful as well as useful vegetable gardens are beyond imagination almost, until you actually see the many kinds of vegetables that are being grown in Ozona. There may be others using the new drip irrigation system demonstrated by Mr. Peavy, Area Horticulturist of Fort Stockton earlier in the year, but the garden of Mr. and Mrs. Carl Montgomery is really something to see. Others are reqping a great harvest of fine vegetables too. Some of you that didn't have spring gardens may want to prepare space for

one this fall, and it isn't too early to start. Vegetables planted in pots are very popular too and you can watch them grow right on your patio.

their actions. Most of the reported cases of abuse occur to children under 3 years of age, who are unable to defend themselves. Child abuse happens in all economic levels and cultural groups in our society. Usually one parent inflicts the injuries and the other parent passively accepts the situation.

Once a child is abused, chances are he may be again. Lashing, bashing, scalding, burning, shaking, kicking, biting or suffocating a child are some of the kinds of physical abuses which cause serious injury or death.

But parents can also abuse a child emotionally by failing to provide the love and affection the child needs or by restricting his social experiences outside the home. And it's difficult for a person who has sustained continual abuse as
