Sterling Livestock Show Here Monday

Judging Starts at 8:00 A. M.

Sterling County youngsters will be competing for \$350 in prize money, eleven trophies, ribbons and banners, and two silver belt buckles Monday, January 17, the date of the Sterling County Livestock Show. This is the big day for the 4-H Club and FFA members in Sterling. They will be showing market lambs, registered breeding sheep, market steers, and market pigs.

The lambs must be in the barn Sunday afternoon for the weighing after which the classes will be set up based on weights. Steers will be weighed by 8:00 A.M. Monday morning on the large scales at Stockman's Supply. All pigs will show in one class.

Judging will start at 8:00 A.M. Monday with Fred Wilkinson, county agent of Crane County, doing the judging. Trophies and awards will be presented at 2:00 P.M. in the show arena and the auction sale will follow at 2:30. Again this year, a barbecued lamb will be sold at Chinese auction to raise funds for the show.

Officers of the Livestock Show Association are S. K. Horwood, president; Charles Probandt, vice-president; and Danny Stewart, treasurer. The county agent and ag teacher serve as secretaries. Marvin Foster is superintendent of this year's show with Bill Davis as assistant superintendent. Auctioneer is Riley King; the sale clerks are Worth Durham, Charles Probandt, Hugh Lackey and Don Viktorin. Billy Ralph Bynum is in charge of resale lambs.

The concession stand will be operated by the mothers of the 4-H and FFA members with proceeds going to the two groups. Lunch will be served in the community center by the Women's Society of Christian Service of the Methodist Church.

Trophies for the various champions have been donated by a number of local individuals, businesses and clubs. A pion finewool lamb of the rotating plaque for the championship is given by Lee Reed; Ross Foster sponsors a permanent trophy for the finewool champion. The champion crossbred lamb exhibitor receives the Charlie Davis trophy. Ralph Davis sponsors the trophy for the champion medium wool lamb. In the Rambouillet breeding sheep show, the Noratadata Club gives the trophy for the champion ewe; the Epsilon Zeta sponsors the trophy for the champion ram; and Betty Jo Wright provides the trophy for the champion flock. Riley King sponsors the trophy for the champion Hampshire ram and Brooks Dry Goods provides the award for the champion ewe. A trophy for the champion market barrow is provided by Reynolds Foster. Paisano Trucking Company sponsors the trophy for the champion steer.

Holland Jewelry of San Angelo provides two silver belt buckles for the outstanding showmen. One goes to the lamb showman and one to the breeding sheep showman.

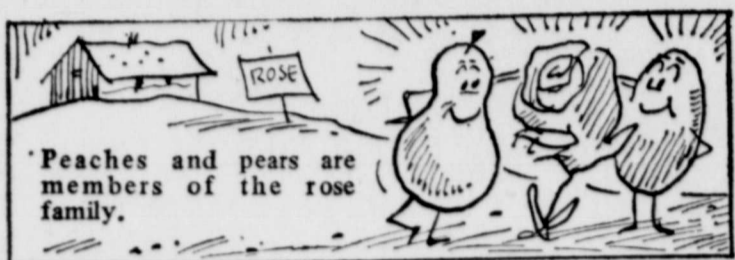

Social Security Tips CHECK YOUR SOCIAL SECURITY RECORD

"How do I know my work under social security is being credited to my record, and how do I find out about it? This is one of the questions most frequently asked," says J. M. Talbot, social security manager.

In explaining the process involved in reporting social security, Mr. Talbot said, "When you work for wages, your employer deducts social security tax from your paycheck each pay day. At the end of each calendar quarter, he submits your name and number with payment for these taxes to Internal Revenue. Internal Revenue forwards copies to social security's main office in Baltimore, Maryland. Your wages are then posted to your record. The same process is followed for a self-employed person except that his earnings are recorded yearly."

Mr. Talbot states that the possibility of an error being made in the process does exist. He recommends that you request a statement of your earnings at least every three years.

All you have to do to secure the statement is to send a post card request available at your social security office to Baltimore, Maryland. If the reply you receive is incorrect in any way, contact the Social Security Office at 3000 West Harris Avenue (P. O. Box 3808) in San Angelo, Texas, or see the representative when he is in your area.

Each calendar quarter, the Social Security Administration receives employer reports of earnings showing incorrect social security numbers of employees, according to J.M. Talbot, social security manager. These incorrect reports, in many cases, happen when a girl has married but does not have her name changed on social security records.

Mr. Talbot stated that when a girl marries, she should complete a 'Request for Change in Social Security Record' form. After completing the form and returning it to the social security office with her old card, she will be issued a new social security card with the same number but showing the new name.

If the name and number reported by an employer do not match the name and number on file with the Social Security Administration, the earnings might not get to the proper account. This could result in a later loss of social security benefits or in a smaller benefit being paid.

"Did you know that if you operate any type of agricultural business, the hired workers you have in that business may be covered by social security?" J. M. Talbot, social security manager, asks.

Any employee who works and earns \$150 or more for one employer during any year or works at least 20 days on a time basis for an agriculture business, is covered by social security. Even part-time employees could meet the earnings or work test. You, as their employer, would be liable to withhold social security tax from the employee's check, match that tax yourself, and report the earnings at the end of the year.

DISABLED WIDOWS BENEFITS

"Two years have passed and many persons are still not aware of the change in the social security law which provides monthly benefits for disabled widows at age 50," said J. M. Talbot, social security manager.

Since the law became effective in February, 1968, more than 32,000 disabled widows have qualified for monthly payments, Mr. Talbot estimated however that another 30,000 widows who might qualify for these benefits have never applied.

"The requirements for disabled widows' benefits are apparently not as well known as those for the more familiar widows' benefits at age 62, or reduced widows' benefits at age 60," Mr. Talbot continued.

To qualify for benefits a widow, age 50 to 60, must have an impairment so severe that it keeps her from engaging in any work. The condition must also be expected to last for at least twelve months.

The widow's disability must have begun before her husband's death or not later than seven years after his death. A widow who has previously been entitled to benefits if she becomes disabled before payments to the children end or within seven years after they end.

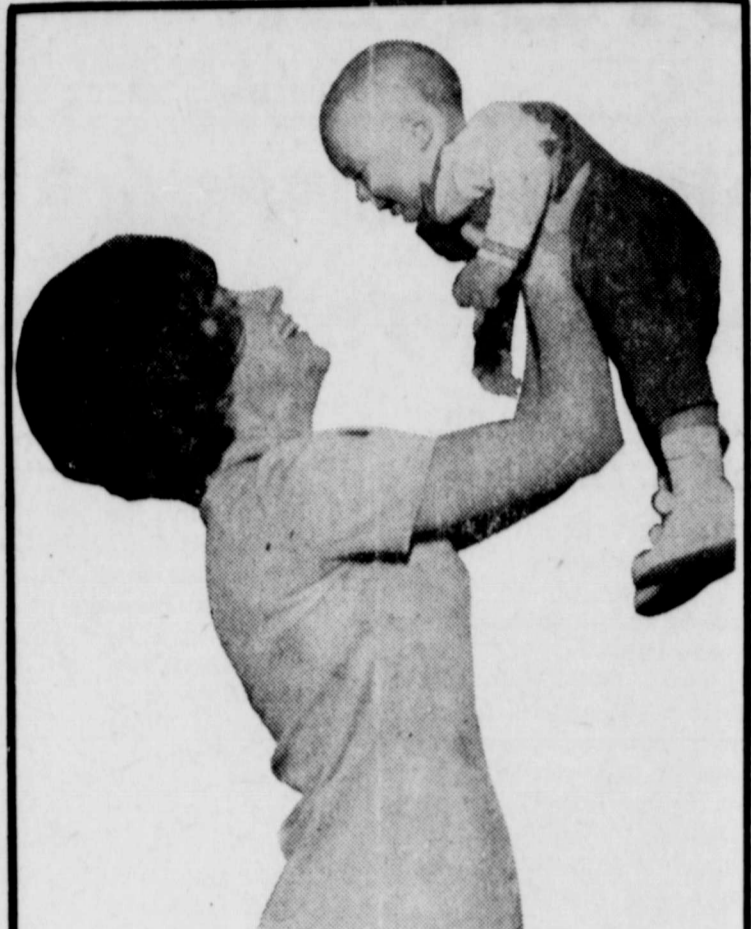

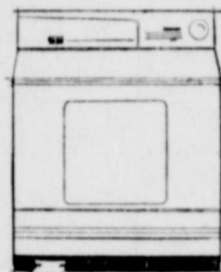
REWARD NOTICE

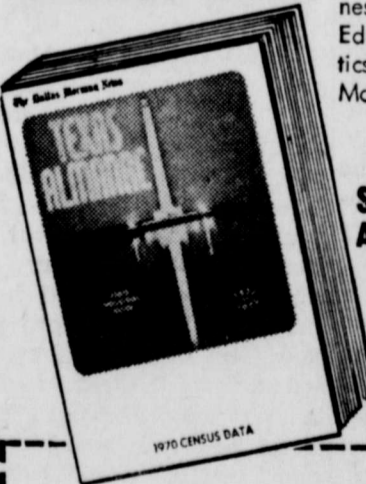

Rosson Announces for Legislature

Renal B. Rosson has announced he would seek the Democratic Nomination for candidacy for election to the office of State Representative of the 63rd Legislative District of Texas which, under the recent Apportionment Act, is composed of Borden, Coke, Dawson, Howard, Scurry and Sterling Counties.

Rosson was born at Breckenridge, Stephens County, Texas and moved to Scurry County with his parents in 1928, where he attended public schools and was graduated from Snyder High School. Upon completion of high school, Rosson enrolled in Texas Technological College in Lubbock. After attending Texas Tech three and one-half years Rosson entered the Army Air Forces for a four year tour of duty. He served with the 15th Air Force in Italy where he participated in 46 missions during World War II, and was awarded the Distinguished Flying Cross, Air Medal with four oak leaf clusters, and Purple Heart. He is now a captain in the Air Force Reserves, retired.

After his discharge from military duty in 1945, Rosson again entered Texas Technological College where he received his BBA degree in June, 1946. In September of that year he entered the University of Texas Law School at Austin, Texas and as graduated with an LLB Law degree in June, 1949.

Upon graduation Rosson and his wife, the former Dorothy Murphree returned to Snyder and now reside at 2510 31st Street. The have one son, Kyle, age 15. Rosson was in private practice of law until he assumed the duties of the office of District Attorney of the 132nd Judicial District in October, 1952, where he served for two terms. He has been engaged in the active practice of law in Snyder, Texas for more than 15 years.

He is a Baptist, a member of the Lions Club, a past president of the Scurry County Bar Association, a member of the American Legion, VFW, and is a Farm Bureau member as well as being active in other civic affairs. He was raised on a stock farm and presently has interests in farming and stock raising operations.

As a member of the Legislature since 1959, he has served on many of the important committees in the House of Representatives including the Appropriations Committee. At the present time he is chairman of the Mental Health and Retardation Committee, Vice chairman of the Judiciary Committee, and a member of the Conservation and Reclamation, Criminal Jurisprudence, and Public Education Committees. He is also a member of the Texas Civil Judicial Council which makes studies and recommendations for needed changes in the civil laws of our state.

Rosson states that he has enjoyed the work of this office, and greatly appreciates the opportunity to represent an area of West Texas in the Texas Legislature. He is also deeply appreciative of the cooperation which he has received from the people in the past, and feels

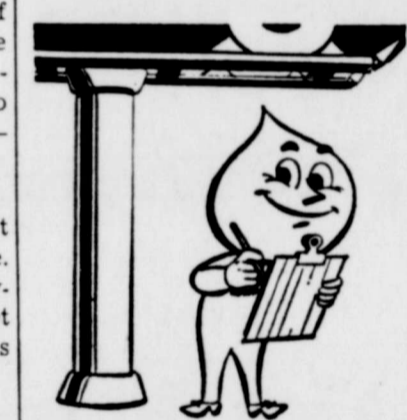
